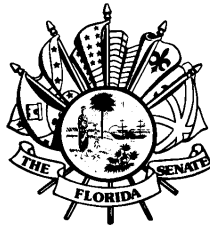

BILLS ON CALENDAR

BILLS ON THIRD READING

CS/CS/SB's 834, 1140 & 1612 by the Committee on Fiscal Policy, the Committee on Health, Aging and Long-Term Care, Brown-Waite, Meek and others

Nursing Home Facilities; (THIS BILL COMBINES S834,1140,1612) requires State Long-Term Care Ombudsman Office to establish statewide toll-free telephone number; directs AHCA to contract for consumer satisfaction surveys for nursing home residents; provides certificate-of-need preference for Gold Seal licensees; authorizes agency to require certain facilities to increase staffing; establishes additional Alzheimer's disease memory disorder clinic, etc. Amends FS. Effective Date: 07/01/1999 except as otherwise provided.

Read the second time and amended on April 21, 1999

SB 1084 by Senator Burt

Children In Need of Services/Shelter; amends requirements for placing child in staff-secure shelter; provides for waiver of right to counsel in prescribed circumstances; amends criteria & provides time limits for placement of child in physically secure shelter; provides for judicial review of status of child who is placed in such shelter; provides for referral of child to CFS Dept. for dependency or mental health services, etc. Amends 984.225,.226. Effective Date: Upon becoming law.

Read the second time and amended on April 21, 1999

CS/SB 1902 by the Committee on Children and Families and Senator Clary

Juvenile Justice Dept./CFS Dept.; provides for waiver of specified provisions of law; directs department to consult with Executive Office of Governor in implementing waiver authority; requires report & monthly status reports; requires comprehensive reorganization plan; requires CFS Dept. & Juvenile Justice Dept. to develop & submit to Legislature proposed plan to realign boundaries of districts of those departments, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 21, 1999

CS/CS/SB 338 by the Committees on Fiscal Policy, Children and Families and Senator Cowin

Kayla McKean Child Protection Act; creates said act; requires that judge report known or suspected child abuse; requires that CFS Dept. accept certain reports of child abuse for investigation; provides additional requirements for dept. re recording calls on central abuse hotline; creates State Child Abuse Death Review Committee; provides for counties to establish local child abuse death review committees, etc. Amends FS. Effective Date: 07/01/1999.

Read the second time on April 21, 1999

SB 8 by Senator Jones

Relief/Jose & Johammes Pena/Hialeah; provides for relief of Jose Pena, as Personal Representative of Estate of Carmen Pena, deceased, & individually, as surviving father of Katherine Pena & Richard Pena, minor children of Carmen Pena & Jose Pena, deceased; provides for relief of Johammes Pena, surviving son of Carmen Pena; compensates them for death of Carmen Pena, Katherine Pena, & Richard Pena as result of negligence of City of Hialeah. Effective Date: Upon becoming law.

TRUST FUND BILLS

CS/SB 1734 by the Committee on Fiscal Policy and Senator Casas

Veterans' Affairs Tobacco Settlement; creates Department of Veterans' Affairs Tobacco Settlement Trust Fund; provides for sources of moneys & purposes; provides for reversion of funds to Department of Banking & Finance Tobacco Settlement Clearing Trust Fund; provides for future review & termination or re-creation of trust fund. Creates 292.085. Effective Date: 07/01/1999.

Reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 1954 by the Committee on Fiscal Policy and Senator Casas

AHCA Tobacco Settlement Trust Fund; creates Agency for Health Care Administration Tobacco Settlement Trust Fund; provides for sources of moneys & purposes; provides for reversion of funds to Banking & Finance Settlement Clearing Trust Fund; provides for future review & termination or re-creation of trust fund. Creates 20.425. Effective Date: 07/01/1999.

Reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 1960 by the Committee on Fiscal Policy and Senator Casas

Tobacco Settlement TF/Health Dept.; renames current Tobacco Settlement Trust Fund as Department of Health Tobacco Settlement Trust Fund; provides for sources of moneys & purposes; provides for reversion of funds to Department of Banking & Finance Tobacco Settlement Clearing Trust Fund for Children & Elders. Amends 20.435; repeals 569.20. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 1962 by the Committee on Fiscal Policy and Senator Casas

Tobacco Settlement Clearing TF; creates Department of Banking & Finance Tobacco Settlement Clearing Trust Fund; provides for sources of moneys; provides for exemption from various service charges; provides purposes; provides for investment of such moneys; provides for disbursement of funds to tobacco settlement trust funds of various agencies; proclaims that trust fund is exempt from constitutional termination. Creates 17.41. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 1964 by the Committee on Fiscal Policy and Senator Casas

DBPR Tobacco Settlement TF; creates Department of Business & Professional Regulation Tobacco Settlement Trust Fund; provides for sources of moneys & purposes; provides for reversion of funds to Department of Banking & Finance Tobacco Settlement Clearing Trust Fund; provides for future review & termination or re-creation of trust fund. Creates 569.205. Effective Date: 07/01/1999.

Reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 1966 by the Committee on Fiscal Policy and Senator Casas

CFS Dept. Tobacco Settlement TF; creates Department of Children & Family Services Tobacco Settlement Trust Fund; provides for sources of moneys & purposes; provides for reversion of funds to Department of Banking & Finance Tobacco Settlement Clearing Trust Fund; provides for future review & termination or re-creation of trust fund. Creates 20.195. Effective Date: 07/01/1999.

Reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 1968 by the Committee on Fiscal Policy and Senator Casas

Elderly Affairs Tobacco TF; creates Department of Elderly Affairs Tobacco Settlement Trust Fund; provides for sources of moneys & purposes; provides for reversion of funds to Department of Banking & Finance Tobacco Settlement Clearing Trust Fund; provides for future review & termination or re-creation of trust fund. Creates 430.42. Effective Date: 07/01/1999.

Reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB's 2422, 1952 by the Committee on Fiscal Policy, Senators Latvala and Casas

Lawton Chiles Endowment Fund; (THIS BILL COMBINES S2422,1952) creates Lawton Chiles Endowment Fund for Health & Human Services; provides for administration of endowment by State Board of Administration; establishes Connie Mack Biomedical Research Program within said fund; creates Biomedical Research Advisory Council within Health Dept.; requires Secretary of Health to award grants & fellowships, in consultation with council, etc. Creates 215.5601, .5602. Effective Date: 07/01/1999.

Reported favorably as a committee substitute by the Committee on Fiscal Policy

GENERAL BILLS

CS/CS/SB 1566 by the Committees on Fiscal Policy, Commerce and Economic Opportunities and Senator Kirkpatrick

Economic Development; revises provisions re powers & duties of Tourism, Trade, & Economic Development Office; specifies responsibilities for Enterprise Florida, Inc.; creates Seaport & Freight Mobility Development Office within State Public Transportation Administrator's Office; amends provision re disposition of motor vehicle license tax moneys; authorizes issuance of certificates of notarial authority & apostilles to civil-law notaries, etc. Amends FS. Effective Date: 07/01/1999.

Reported favorably as a committee substitute by the Committee on Commerce and Economic Opportunities, and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/SB 1560 by the Committees on Fiscal Policy, Commerce and Economic Opportunities and Senator Kirkpatrick

Economic Development/Rural Areas; provides requirements for future land use element of local government comprehensive plan re rural areas; authorizes Office of Tourism, Trade, & Economic Development to recommend to Legislature additions to or deletions from list of standard industrial classifications used to determine eligible business for purposes of Rural Job Tax Credit Program; creates Rural Economic Development Initiative within said office, etc. Amends FS. Effective Date: 07/01/1999.

Reported favorably as a committee substitute by the Committee on Commerce and Economic Opportunities, and reported favorably as a committee substitute by the Committee on Fiscal Policy

SB 178 by the Committee on Comprehensive Planning, Local and Military Affairs

Wireless 911 Telephone Services; provides legislative findings, purposes, & intent; provides definitions; provides duties of DMS; creates Wireless 911 Board; imposes monthly fee for certain 911 telephone service; provides rate; provides for adjusting rate; exempts fee from state & local taxes; prohibits local governments from imposing additional fees re such service; prohibits certain activities re wireless 911 telephone service, etc. Creates 365.172. Effective Date: 07/01/1999.

Reported favorably, with one amendment, by the Committee on Comprehensive Planning, Local and Military Affairs, and reported favorably by the Committee on Fiscal Policy

SB 180 by the Committee on Comprehensive Planning, Local and Military Affairs

911 Telephone Info/Confidentiality; provides for confidentiality of certain records re identification of persons who request emergency services by accessing 911 telephone number; provides for confidentiality of certain info. submitted to Wireless 911 Advisory Board or DMS by providers of wireless 911 services; provides for future legislative review & repeal; takes effect on effective date of SB 178, but shall not take effect if such legislation does not become law, etc. Creates 365.174. Effective Date: Contingent.

Reported favorably, with one amendment, by the Committee on Comprehensive Planning, Local and Military Affairs, and withdrawn from the Committee on Rules and Calendar

SB 182 by the Committee on Comprehensive Planning, Local and Military Affairs

Wireless Emergency Telephone Fund; creates Wireless Emergency Telephone System Fund within DMS; provides criteria for fund; provides for distribution & use of moneys in fund; requires Auditor General to annually audit fund; requires report; takes effect on effective date of SB 178, but shall not take effect unless enacted by three-fifths vote of membership of each house of Legislature. Creates 365.173. Effective Date: Contingent.

Reported favorably, with one amendment, by the Committee on Comprehensive Planning, Local and Military Affairs, and reported favorably by the Committee on Fiscal Policy

CS/SB 1614 by the Committee on Criminal Justice and Senator Brown-Waite

Sentencing/Drug Trafficking; redefines offense of trafficking in cannabis; defines term "cannabis plant"; provides mandatory minimum prison terms & mandatory fine amounts for trafficking in cannabis, cocaine, illegal drugs, phencyclidine, methaqualone, amphetamine, or flunitrazepam; revises requirements for court in applying sentencing multiplier for drug-trafficking offenses; reenacts various provisions to incorporate amendment in references, etc. Amends FS. Effective Date: 07/01/1999.

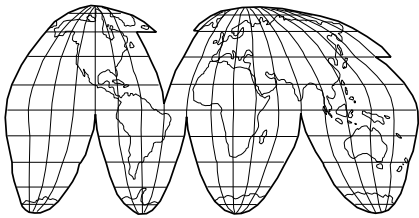

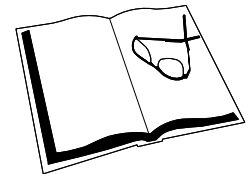
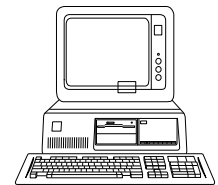
