Rules of Evidence/Sexual Battery; provides for certain rules of evidence applicable to criminal prosecution of crime of sexual battery to apply in any civil action brought under Florida Civil Rights Act involving perpetration or alleged perpetration of such crime. Amends 794.022. Effective Date: Upon becoming law.

Reported favorably by the Committee on Judiciary

SB 150 by Senator Horne

Property Exempt from Legal Process; exempts certain debtor's interests from attachment, garnishment, or legal process. Amends 222.25. Effective Date: Upon becoming law.

Reported favorably by the Committees on Judiciary and Finance and Taxation

CS/SB 178 by the Committee on Judiciary and Senator Brown-Waite

Duration of Real Property Liens; revises period of duration of certain liens; provides for application to existing liens. Amends 55.10. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Judiciary and the Committee on Finance and Taxation, reports the committee substitute favorably, with one amendment

CS/SB 208 by the Committee on Commerce and Economic Opportunities and Senator Geller

Consumer Protection; revises rules of construction to provide date of applicability for conforming state consumer protection & enforcement with federal law; amends provision re business or commercial entity within definition of term "consumer" for purposes of Consumer Protection law; authorizes action on behalf of governmental entity for damages caused by violation of specified provisions, etc. Amends Ch. 501. Effective Date: 07/01/2001.

Reported favorably by the Committee on Criminal Justice and reported favorably as a committee substitute by the Committee on Commerce and Economic Opportunities

SB 210 by Senator Saunders and others

Ad Val Tax/Nonprofit Homes for Aged; amends provision re exemptions for nonprofit homes for aged; specifies that exemption applicable to such homes residents of which meet certain income limitations applies to individual units or apartments of such homes; clarifies provisions re qualification for alternative exemption provided by that section for those portions of home in which residents do not meet income limitations, etc. Amends 196.1975. Effective Date: Upon becoming law.

Reported favorably by the Committees on Comprehensive Planning, Local and Military Affairs, and Finance and Taxation

CS/SB 240 by the Committee on Criminal Justice and Senator Smith

Sentencing; requires that prisoner sentenced for crime committed during incarceration in state correctional system serve sentence for such crime in state system, regardless of length of sentence imposed. Amends 944.17. Effective Date: 07/01/2001.

Reported favorably as a committee substitute by the Committee on Criminal Justice and withdrawn from the Committees on Appropriations Subcommittee on Public Safety and Judiciary, and Appropriations

SB 274 by Senator Lee

Official Florida Statutes Adoption; adopts Florida Statutes 2001 & designates portions thereof that are to constitute official law of state; provides that Florida Statutes 2001 shall be effective immediately upon publication; provides that general laws enacted during 1999 regular session & prior thereto & not included in Florida Statutes 2001 are repealed, etc. Amends 11.2421,.2422,.2424,.2425. Effective Date: 60 days after sine die.

Reported favorably by the Committee on Rules and Calendar

SB 308 by Senator Saunders

Political Committee; modifies definition of "political committee". Amends 106.011. Effective Date: Upon becoming law.

Reported favorably, with one amendment, by the Committee on Ethics and Elections

SB 412 by Senator Bronson and others

Civil Actions/Firearms & Ammunition; provides legislative findings re lawful manufacture, distribution, & sale of firearms & ammunition; prohibits civil actions on behalf of state or other political subdivision against manufacturers, distributors, & dealers of firearms or ammunition & firearms trade associations; provides for actions by state or other political subdivision for breach of contract or warranty, etc. Creates 790.331.
