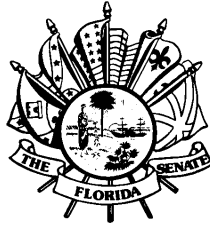

### BILLS ON THIRD READING

#### **CS/SB 1704 by the Committee on Education, Senator Sullivan and others**

**Education/Teachers & Educators;** revises definition of "other instructional staff" to include adjunct educators; deletes provisions re salary supplements provided to teachers selected to teach at certain low-performing schools; requires review by principal prior to reassigning teacher; requires assistance in accessing resources for teachers teaching out-of-field; authorizes athletic coaching certificate for full-time & part-time positions, etc. Amends FS. Effective Date: 07/01/2001.

*Read the second time and amended on April 20, 2001*

*Similar to CS/CS/HB 1193 in Messages*

#### **CS/CS/SB's 1970, 164 by the Committees on Banking and Insurance, Governmental Oversight and Productivity, Senators Latvala, Geller and others**

**Governmental Reorganization;** (THIS BILL COMBINES S1970,164) establishes Office of Chief Financial Officer; creates Financial Services Dept.; provides for Commissioner of Financial Institutions Office; transfers Banking & Finance Dept. & DOI to Financial Services Dept.; authorizes State Fire Marshal Div. to adopt rules re firefighter safety inspections; requires division to conduct study, etc. Amends Chs. 17, 20, 633. Effective Date: 07/01/2001 except as otherwise provided.

*Compare to CS/CS/HB 681 in Messages*

#### **CS/CS/SB 2108 by the Committees on Appropriations, Education, Senator Pruitt and others**

**Education Governance Reorganization;** provides process for authorizing community colleges to offer baccalaureate degree programs; requires Campus Board of University of South Florida St. Petersburg; adds to State University System the New College in Sarasota; redesignates St. Petersburg Junior College as "St. Petersburg College"; abolishes Board of Regents, State Board of Community Colleges, & Postsecondary Education Planning Commission, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

*Read the second time and amended on April 25, 2001*

---

#### **CS/SB 660 by the Committee on Appropriations and Senator Brown-Waite**

**Money Transmitters' Code;** eliminates examination fees; provides that person registered under specified provision is exempt from registration fee required to engage in activities under certain provisions; provides for extended registration period; provides for notice of branch location openings & closings; provides fees for branch locations & authorized vendors, etc. Amends 560.119,.204-.208, 560.307,.308; repeals 560.118(1)(d) & (e). Effective Date: 10/01/2001.

---

#### **CS/CS/SB 366 by the Committees on Appropriations, Criminal Justice, Senator Villalobos and others**

**DNA Evidence;** provides for examination of DNA evidence collected at time crime is investigated; provides procedure under which defendant who has been found guilty may petition trial court to order examination of DNA evidence; provides for preservation of evidence for which testing of DNA may be requested; requires FDLE to add certain felony offenses in scheduled order to DNA data bank's enumerated offenses, etc. Amends Ch. 943; creates 925.11. Effective Date: 10/01/2001 except ss. 3 & 4 shall take effect 07/01/2001.

**CS/CS/SB 144 by the Committees on Judiciary, Criminal Justice and Senator Geller**

**Computer Crimes;** revises "Computer Pornography & Child Exploitation Act of 1986" to clarify certain penalties; prohibits transmissions of child pornography & any image, information, or data harmful to minors; prohibits transmission of material harmful to minors by electronic device or equipment; creates offenses against computer equipment or supplies, computers, computer system, & computer networks, etc. Amends Chs. 847, 815, 16.56, 827.071, 905.34. Effective Date: 07/01/2001.

*Read the second time and amended on April 30, 2001*

---

**CS/SB 1318 by the Committee on Criminal Justice and Senator Saunders**

**Correctional Facilities;** defines offense of battery of facility employee by throwing, tossing, or expelling certain fluids or materials on employee of correctional facility of state or local govt. or secure facility operated & maintained by DOC or Juvenile Justice Dept. or other facility employee, so as to cause or attempt to cause such employee to come into contact with fluid or material, etc. Creates 784.074,.078; amends 806.13, 921.0022, 945.35. Effective Date: 10/01/2001.

---

**CS/SB's 1864, 2086 by the Committee on Criminal Justice, Senators Bronson, Burt and others**

**Violent Crime & Drug Control Council;** renames Fla. Violent Crime Council as Fla. Violent Crime & Drug Control Council; prescribes duties & responsibilities of said council; renames Violent Crime Emergency Account as Violent Crime Investigative Emergency & Drug Control Strategy Implementation Account; prohibits interception of police communications for certain purposes, etc. Amends Ch. 943, 760.40, 985.3065; creates 843.167. Effective Date: 07/01/2001.

*Read the second time and amended on April 30, 2001*

*Identical to CS/HB 1425 in Messages*

---

**CS/SB 1932 by the Committee on Criminal Justice and Senator Laurent**

**Drug Traffic Program/Orange Co.;** authorizes creation of pilot program in Orange County to intercept illegal drug shipments through package delivery services; provides that person who willfully keeps or maintains or aids or abets another in keeping or maintaining certain types of places where controlled substances are unlawfully used, kept, sold, or delivered commits offense of keeping or maintaining public nuisance, etc. Amends Chs. 823, 877, 893. Effective Date: 07/01/2001 except as otherwise provided.

*Read the second time and amended on April 30, 2001*

---

**CS/SB 1956 by the Committee on Commerce and Economic Opportunities, Senator Latvala and others**

**Motor Vehicle Dealers/Deceptive Acts;** conforms length limitation for motor home to that established in State Uniform Traffic Control law; provides that motor home vehicle sales agreement that prohibits disclosure of its terms is void; prohibits certain unfair or deceptive acts by motor vehicle dealers; repeals provision re licensure sanctions for dealers who fail to disclose certain new vehicle damages to purchaser, etc. Amends 320.01,.699, 681.115; repeals 320.27(9)(n). Effective Date: 10/01/2001.

---

**SB 106 by Senator Campbell and others**

**Grandparent Visitation;** provides for court-ordered visitation for grandparents & great-grandparents under certain circumstances; provides for appointment of guardian ad litem & family mediation if court makes preliminary finding that minor is threatened with demonstrable significant mental or emotional harm without such visitation; requires court-ordered evaluation of child if mediation fails; applies the Uniform Child Custody Jurisdiction Act, etc. Amends FS. Effective Date: 07/01/2001.

---

**CS/CS/SB 374 by the Committees on Judiciary, Children and Families, Senator Carlton and others**

**Elderly & Disabled/Public Guardians;** defines term "position of trust & confidence"; prescribes civil remedies for theft & other offenses in which victim is elderly person or disabled adult; provides that violation of patient rights is not cause of action under act; provides guidelines for registration of public guardians; raises amount of claim that may be settled by natural guardian of minor without necessity of appointment of legal guardian, etc. Amends Ch. 744, 772.11, 825.101. Effective Date: Upon becoming law.

---

**CS/SB 1084 by the Committee on Judiciary and Senator Villalobos**

**Decedent's Medical Records/Presuits;** authorizes release of certain records re medical care & treatment of decedent upon request of certain persons. Amends 766.104. Effective Date: 07/01/2001.

*Similar to HB 947 in Messages*

## **CS/SB 1558 by the Committee on Health, Aging and Long-Term Care and Senator Saunders**

**Health Care Practitioner Regulation;** provides legislative intent & findings re Medical Quality Assurance Trust Fund & function administered by Health Dept.; provides requirements for rules re biennial renewal of licenses; requires dept. to charge initial license fees; provides for administration of national examinations & termination of state-administered written examinations; provides limitation on duties of certain boards, etc. Amends FS. Effective Date: 07/01/2001 except as otherwise provided.

*Read the second time and amended on April 30, 2001*

---

## **SB 414 by the Committee on Health, Aging and Long-Term Care**

**Public Records/Antitrust Issues;** abrogates repeal of provisions re confidential information submitted to Attorney General's Office for review of antitrust issues. Amends 408.185. Effective Date: 07/01/2001.

*Similar to **HB 401** in the Committees on Health, Aging and Long-Term Care, Governmental Oversight and Productivity, and Rules and Calendar*

---

## **CS/SB 1778 by the Committee on Children and Families, Senator Cowin and others**

**Domestic Violence;** cites act as "Family Protection Act"; requires that staff who conduct child protective investigations receive training on removing perpetrator of domestic violence from home by use of injunction; requires that court order person to serve minimum term of imprisonment as part of any sentence imposed for offense of such violence that intentionally caused bodily harm to another person, etc. Amends FS. Effective Date: 07/01/2001.

*Read the second time and amended on April 30, 2001*

*Similar to **HB 1673** in Messages*

## **CS/SB 1652 by the Committee on Health, Aging and Long-Term Care and Senator Crist**

**Nursing Homes & Health Care Facility;** revises membership & terms of Governor's Panel on Excellence in Long-Term Care; provides for selection of panel chair; provides definition; provides conditions under which prohibition against payment of referral fees by assisted living facilities does not apply. Amends 400.235,.4195. Effective Date: Upon becoming law.

*Read the second time and amended on April 30, 2001*

## **CS/SJR 526 by the Committee on Ethics and Elections, Senator Meek and others**

**Supervisors of Elections;** constitutional amendment under which supervisors of elections in all counties of state, including charter counties, would be elected on nonpartisan basis. Amends s. 1, Art. VIII.

*Read the second time and amended on April 30, 2001*

---

## **HB 657 by the Committee on Rules, Ethics & Elections (PRC) and Representative Goodlette**

**Official Florida Statutes Adoption;** adopts Florida Statutes 2001 & designates portions thereof that are to constitute official law of state; provides that Florida Statutes 2001 shall be effective immediately upon publication; provides that general laws enacted during 2000 regular session & prior thereto & not included in Florida Statutes 2001 are repealed, etc. Amends 11.2421,.2422,.2424,.2425. Effective Date: 60 days after sine die.

*Substituted for **SB 274** (Lee), read the second time and amended on April 30, 2001*

---

## **CS/SB 1468 by the Committee on Governmental Oversight and Productivity and Senator Latvala**

**Land Acquisition & Management;** revises goals & performance measures for Florida Forever projects of DEP & water management districts; defines "conservation lands"; exempts Greenway lands from certain public notice & hearing requirements prior to sale, lease, exchange, or grant of easement; revises conditions under which certain lands titled to board of trustees may be declared surplus lands, etc. Amends Chs. 253, 259, 298.22, 369.255; repeals 259.101(8). Effective Date: 07/01/2001.

*Read the second time and amended on April 30, 2001*

---

## **HB 399 by the Committee on State Administration (SGC) and Representative Brummer**

**Public Record/Emergency "911" Number;** amends provision which provides exemption from public records requirements for information that reveals name, address, telephone number, or personal information about, or other information that would identify, person requesting emergency service or reporting emergency; reenacts such exemption & removes October 2, 2001, repeal thereof scheduled under OGSR Act of 1995; corrects cross reference. Amends 365.171. Effective Date: 10/01/2001.

*Substituted for **SB 384** (Constantine) and read the second time on April 30, 2001*

---

## **SB 2240 by Senator Garcia**

**Warranty Associations/Motor Vehicles;** defines term "additive product"; redefines terms "motor vehicle service agreement" & "salesperson"; provides for submission of financial reports to DOI in computer-readable form; provides that motor vehicle service agreement company is not required to be licensed as salesperson to solicit, sell, issue, or otherwise transact motor vehicle service agreements issued by company, etc. Amends Ch. 634, 624.124, 628.4615. Effective Date: Upon becoming law except as otherwise provided.

*Read the second time and amended on April 30, 2001*

---

**CS/SB 1922 by the Committee on Agriculture and Consumer Services and Senator Geller**

**State Government;** amends provision re special risk membership; authorizes Agric. & Consumer Services Dept. to lease or lend equipment to governmental entities that have fire/rescue responsibilities; revises references re pasteurized milk ordinance & milk sanitation; prescribes requirements re veterinarians who may inspect animals for disease; prohibits trespass upon specified legally posted agricultural sites, etc. Amends FS. Effective Date: 07/01/2001 except as otherwise provided.

*Read the second time and amended on April 30, 2001*

---

**CS/SB 408 by the Committee on Regulated Industries and Senator Smith**

**Interruption of Electric Utilities;** provides electric utilities with complete defense in certain actions for certain law enforcement assistance activities. Creates 768.138. Effective Date: Upon becoming law.

*Read the second time and amended on April 30, 2001*

---

**SB 482 by Senator Pruitt**

**Statutory Accounting Principles;** defines terms "statutory accounting principles"; provides for what constitutes asset of insurer; revises provision concerning liability; provides for valuation of bonds; revises requirements for collateral loans; provides transition selection for statutory accounting principles; redefines certain assets or liabilities in determination of financial condition of HMO, etc. Amends Ch. 625, 624.610, 641.183,.19,.35. Effective Date: Upon becoming law.

*Read the second time and amended on April 30, 2001*

---

**CS/CS/SB 710 by the Committees on Judiciary, Governmental Oversight and Productivity and Senator Crist**

**Fla. Effective Date: 07/01/2001.

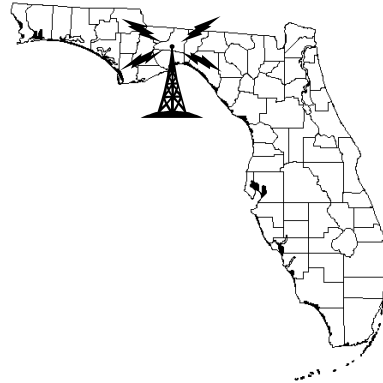
