CS/SB 2 by the Committee on Governmental Oversight and Productivity, Senator Burt and others

FRS/Special Risk Class; provides for repurchase of prior service credit for certain members of Special Risk Class or Special Risk Administrative Support Class of Fla. Retirement System who retired or terminated employment before July 1, 2000; provides for one-time cost-of-living increase for certain retired members of FRS who have service credit earned between September 30, 1978, & January 1, 1993, in Special Risk Class of FRS, etc. Amends 121.091. Effective Date: 07/01/2001.

Read the second time and amended on May 3, 2001

CS/HB 367 by the Council for Smarter Government, Representatives Brummer and Cantens

Judicial Nominating Commissions; specifies membership composition & requirements of judicial nominating commissions; provides limitations; provides for terms; abolishes prior offices; provides for suspension or removal; requires racial, ethnic, gender, & geographical diversity of commission memberships; specifies members of certain judicial nominating commissions as state officers; repeals provision re said commissions, etc. Creates 43.291; amends 112.3145; repeals 43.29. Effective Date: 07/01/2001.

Substituted for **CS/CS/SB 1470** (Cowin), read the second time and amended on May 3, 2001

CS/CS/CS/SB's 310, 380 by the Committees on Appropriations, Finance and Taxation, Comprehensive Planning, Local and Military Affairs, Senators Constantine and Carlton

Growth Management; (THIS BILL COMBINES S310,380) revises elements of comprehensive plans; requires intergovernmental coordination between local governments & district school boards; requires certain interlocal agreements; prohibits local government that fails to adopt required element from amending its local comprehensive plan; allows school district to levy by referendum additional millage for school operational purposes, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on May 3, 2001

CS/SB's 128, 1598 by the Committee on Finance and Taxation, Senators Lee, King and others

Taxation; (THIS BILL COMBINES S128,1598) allows certain school districts to levy, by referendum, additional district school taxes; provides limitations on uses of resulting revenues; revises application of sales tax exemption for sale of drinking water in bottles or other containers; exempts property occupied or used by certain regional transmission organizations from tax on lease or rental of or license in real property, etc. Amends Chs. 236, 199, 212, 201. Effective Date: 01/01/2002.

Read the second time and amended on May 3, 2001

HB 251 by Representative Kilmer and others

Sales Tax Exempt/Clothes & Supplies; specifies period during which sale of clothing, school supplies, & certain other items shall be exempt from such tax; defines "clothing" & "school supplies" for purposes of exemption; provides exceptions; provides for rules. Effective Date: Upon becoming law.

Substituted for **CS/SB 156** (Cowin), read the second time and amended on May 3, 2001

HB 21 by Representatives Fasano, Kyle and others

Intangible Personal Property Taxes; reduces rate of annual tax; reduces rates of tax on securities in Florida's Future Investment Fund, to conform; increases exemptions for taxpayers who are natural persons; creates exemptions for taxpayers who are not natural persons. Amends 199.032,.033,.185. Effective Date: 01/01/2002.

Read the second time and amended on May 3, 2001

HJR 951 by the Committee on Crime Prevention, Corrections & Safety (HCC), Representatives Bilirakis and Kyle

Excessive Punishment; constitutional amendment to authorize death penalty for capital crimes; authorizes retroactive changes in method of execution; changes current prohibition against cruel or unusual punishment to prohibition against cruel & unusual punishment, etc. Amends s. 17, Art. I.

Substituted for **SJR 124** (Burt) and read the second time on May 3, 2001

SB 878 by Senator Webster

Educator Professional Liability Ins.; provides legislative intent; requires educator professional liability insurance coverage for all full-time instructional personnel; provides for specific appropriations in General Appropriations Act; extends such coverage at cost to part-time instructional personnel & to all administrative personnel. Creates 231.800. Effective Date: 07/01/2001.

Read the second time and amended on May 2, 2001 and read the third time on May 3, 2001

Similar to **CS/HB 409** in the Committees on Education, Governmental Oversight and Productivity, Appropriations Subcommittee on Education, and Appropriations

HB 1545 by the Committee on Education Appropriations (FRC), Representative Lynn and others

Schools/Performance Reporting; requires designation & publication of district performance grades; revises minimum requirements of Fla. Education Finance Program to include minimum classroom expenditure requirements & associated reporting; authorizes Legislature to require school district that fails to meet minimum classroom expenditure requirements, at a ment 229.57, 236.02, 237.041,.081; creates 236.08102. Effective Date: Upon becoming law.

Substituted for **SB 1710** (Webster) and read the second time on May 3, 2001

CS/HB 1927 by the Council for Competitive Commerce, the Committee on Insurance (CCC), Representative Waters and others

Workers' Compensation; requires certain entities actively engaged in construction industry to secure payment of compensation under Workers' Compensation law, after certain date; provides for consideration of public employer workplace safety program in rate-setting; provides additional criterion for determining certain value of nonprofessional attendant care provided by family member, etc. Amends Ch. 440, 627.0915. Effective Date: 01/01/2002 except as otherwise provided.

Substituted for **CS/SB 1188** (Latvala), read the second time and amended on May 3, 2001

CS/SB 986 by the Committee on Education, Senator Sullivan and others

Higher Education; provides process for authorizing community colleges to offer baccalaureate degree programs; creates fiscally autonomous campuses of University of South Florida; requires Campus Board of University of South Florida Sarasota/Manatee; establishes mission, goals, & board of trustees for New College of Florida; redesignates St. Petersburg Junior College as "St. Petersburg College", etc. Amends 240.3836, 527, 2011. Effective Date: 07/01/2001.

Read the second time and amended on May 3, 2001

CS/CS/SB's 336, 190 by the Committees on Appropriations, Comprehensive Planning, Local and Military Affairs, Senators Constantine, Clary and others

Florida Building Code; (THIS BILL COMBINES S336,190) delays date by which relocatables used as classrooms must meet certain standards; specifies certain low-energy window standards for relocatable classrooms; exempts certain facilities from plans reviews & inspections by local governments; authorizes water well contractors to install, repair, or modify specified equipment in accordance with code; provides requirements for inspection of elevators, etc. Amends FS. Effective Date: 01/01/2002 except as otherwise provided.

Read the second time and amended on May 1, 2001

CS/CS/HB 1053 by the Council for Ready Infrastructure, the Committee on Transportation (RIC), Representatives Russell and Slosberg

Transportation; requires airport authority or other governing body operating publicly owned public-use airport to utilize most recently approved noise exposure map; revises language re organization of DOT; changes Turnpike District into turnpike enterprise; adds seaport security projects to types of projects eligible for certain funds; provided for legislative review of uniform wetland mitigation assessment method rule, etc. Amends FS. Effective Date: 07/01/2001.

Substituted for **CS/CS/SB 2056** (Sebesta), read the second time and amended on May 3, 2001

CS/SB 1558 by the Committee on Health, Aging and Long-Term Care and Senator Saunders

Health Care Practitioner Regulation; provides legislative intent & findings re Medical Quality Assurance Trust Fund & function administered by Health Dept.; provides requirements for rules re biennial renewal of licenses; requires dept. to charge initial license fees; provides for administration of national examinations & termination of state-administered written examinations; provides limitation on duties of certain boards, etc. Amends FS. Effective Date: 07/01/2001 except as otherwise provided.

Read the second time and amended on April 30, 2001

Similar to HB 1867 in Messages

CS/SB 256 by the Committee on Transportation, Senator Mitchell and others

Transportation Disadvantaged TF; imposes fee for registration of certain trucks, trailers, & motorcycles & for tag transfers & temporary tags to be deposited into Transportation Disadvantaged Trust Fund. Amends 320.03. Effective Date: 10/01/2001.

Read the second time and amended on May 3, 2001

CS/CS/SB 2224 by the Committees on Appropriations, Banking and Insurance and Senator Clary

Labor & Employment Security; transfers Workers' Compensation Division from LES Dept. to Insurance Dept.; transfers various functions, powers, duties, personnel, & assets re workers' compensation to DOE, AHCA, & Insurance Dept.; provides for certain employees of division to be given hiring priority by DOI; provides pay & employment guidelines for such employees; creates Workers' Compensation Division in DOI, etc. Amends FS. Effective Date: 10/01/2001 except as otherwise provided.

Read the second time on May 2, 2001

Similar to **HB 1655** in the Committees on Banking and Insurance, Governmental Oversight and Productivity, Appropriations Subcommittee on General Government, and Appropriations

SB 484 by the Committee on Commerce and Economic Opportunities

Public Records/Economic Development; expands definition of term "economic development agency" to include, for purposes of confidentiality of records, Fla. Commercial Space Financing Corp. & any public economic development agency of county or municipality; abrogates scheduled repeal of public records exemption for information concerning business location, relocation, or expansion plans; clarifies exception to confidentiality provided by such exemption, etc. Amends 288.075. Effective Date: 10/01/2001.

Motion to reconsider by Senator Diaz de la Portilla adopted on May 3, 2001

Similar to CS/HB 1541 in Messages

CS/SB 1784 by the Committee on Appropriations and Senator Horne

State Planning & Budgeting; removes requirement for Executive Office of Governor to consider certain findings re information technology in its review of long-range program plans of executive agencies; revises requirements of legislative budget requests re total number of positions & to unit-cost data; provides for agency & judicial branch incentive & savings program; provides restrictions on expenditure of funds for court settlements negotiated by state, etc. Amends FS. Effective Date: 07/01/2001.

Read the second time on May 3, 2001

SB 1314 by Senator Saunders

Public Records/Parents ID/Newborns; provides exemption from public records requirements for information that identifies parents who leave newborn infants at emergency medical services stations; provides exception; provides for future review & repeal; provides finding of public necessity. Amends 383.51. Effective Date: Contingent.

Read the second time and amended on May 3, 2001

Similar to **HB 477** in the Committees on Health, Aging and Long-Term Care, Governmental Oversight and Productivity, and Rules and Calendar

CS/CS/SB 2214 by the Committees on Finance and Taxation, Judiciary and Senator Burt

Tobacco; specifies procedures by which tobacco manufacturer may become "participating manufacturer" or "subscribing participating manufacturer"; directs wholesalers to pay surcharges required by chapter; prohibits specific practices by tobacco product manufacturers, importers, distributing agents, wholesale dealers, exporters or others; provides for imposition of public health tobacco equity surcharge, etc. Amends Ch. 210, 17.41, 215.5601. Effective Date: Upon becoming law.

Read the second time on May 2, 2001 and amended on May 3, 2001

HB 1737 by the Fiscal Responsibility Council and Representative Johnson

Growth Management; clarifies language; provides for compilation & transmittal by local govt. of list of persons who will receive information statement concerning state land planning agency's notice of intent to find comprehensive plan or plan amendment in compliance or not in compliance; revises requirements re publication by agency of its notice of intent; deletes requirement that notice be sent to certain persons, etc. Amends 163.3184,.3187. Effective Date: Upon becoming law.

Read the second time and amended on May 3, 2001

CS/CS/HB 1121 by the Council for Smarter Government, the Committee on Local Government & Veterans Affairs (SGC) and Representative Byrd

Driver Licenses/Co. Tax Collectors; provides legislative intent re delivery of driver license services; authorizes county tax collectors to serve as exclusive agents of HSMV; provides application process for county tax collectors to serve as exclusive agents; creates Cost Determination & Allocation Task Force & establishes duties & responsibilities; provides for development of transition plans to transfer certain responsibilities to tax collectors. Amends 322.02,.135. Effective Date: Upon becoming law.

Substituted for **CS/CS/SB 1276** (Lee) and read the second time on May 3, 2001

CS/CS/HB 269 by the Council for Lifelong Learning, the Committee on Education Appropriations (FRC), Representatives Murman, Lacasa, Byrd, Mack, Melvin, Diaz-Balart, Cantens, Bense, Argenziano, Lynn and others

Sharpening the Pencil Act; creates said act; provides legislative intent re school district best financial management practices reviews; provides OPPAGA with primary responsibility for completion of best financial practices reviews; provides for appearance of school officials before Legislature upon failure to implement adopted action plan; specifies use of cost savings, etc. Amends Ch. 230, 11.51, 233.43, 235.2197; repeals 11.515. Effective Date: 07/01/2001.

Substituted for **CS/SB 1780** (Horne) and read the second time on May 3, 2001

CS/SB 2096 by the Committee on Regulated Industries and Senator Sullivan

CPA/License Reinstatement; provides authority for reinstatement of certain licensees whose licenses have become void. Amends 473.313. Effective Date: 07/01/2001.

Read the second time on May 3, 2001

HB 1419 by the Committee on Tourism (CCC), Representatives Trovillion, Maygarden and others

Historic Preservation; eliminates general provisions re historic preservation boards of trustees & responsibilities of Dept. of State with respect thereto; eliminates Historic Pensacola Board of Trustees; provides powers & duties of Historical Resources Div.; requires employment of state archaeologist; requires employment of state historic preservation officer & other personnel; creates Florida Historical Commission, etc. Amends Chs. 266, 267, 607.1901, 872.05. Effective Date: 01/01/2002 except as otherwise provided.

Substituted for **SB 2114** (Clary) and read the second time on May 3, 2001

CS/SB 1534 by the Committee on Criminal Justice and Senator Crist

Department of Corrections; revises requirements for dept. re calculating credit allowed to defendant for time served; provides for disciplinary hearing officer rather than disciplinary committee to determine forfeiture of gain-time; eliminates requirement that dept. provide remediation programs for officers who cannot comply with continuing education requirements because of learning disabilities, etc. Amends FS. Effective Date: 07/01/2001.

Read the second time and amended on May 3, 2001

HB 579 by Representative Crow

Uniform Commercial Code; cites act as Uniform Commercial Code-Secured Transactions; provides for effectiveness & attachment of security agreements; provides for perfection & priority of security interests; prescribes rights of third parties; prescribes filing procedures for perfection of security interest; provides that, for goods bought for personal, family, or household purposes, buyer's right of replevin vests upon acquisition of special property, etc. Amends FS. Effective Date: 01/01/2002.

Substituted for **CS/SB 386** (Campbell) and read the second time on May 3, 2001

HB 1845 by the Committee on Information Technology (RIC), Representative Hart and others

Criminal Use of Personal Information; provides that willful & fraudulent use of personal identification information of another individual is felony of second degree if value of pecuniary benefit services received, payment sought to be avoided, or injury or fraud perpetrated is of specified amount or more; provides for reclassification of certain offenses involving criminal use of said information if offense was facilitated by use of public record, etc. Amends 817.568, 921.0022. Effective Date: 07/01/2001.

Substituted for **CS/SB 524** (Burt) and read the second time on May 3, 2001

CS/CS/HB 721 by the Council for Competitive Commerce, the Committee on Agriculture & Consumer Affairs (CCC), Representative Stansel and others

Public Records/Agricultural Records; provides exemption from public records requirements for certain individual agricultural records reported to Agriculture & Consumer Services Dept. in connection with its duties re pollution reduction under total maximum daily load program for water bodies; provides for future review & repeal; provides finding of public necessity. Amends 403.067. Effective Date: Upon becoming law.

Substituted for **SB 1380** (Laurent) and read the second time on May 3, 2001

SB 636 by Senator Pruitt and others

High School Grades; requires certain reports of academic achievement; alters required ranges of percentage grades that equate to letter grades & grade points. Amends 230.23, 232.2463. Effective Date: 07/01/2001.

Read the second time and amended on May 3, 2001

SB 1948 by Senator Crist

Drivers' Licenses/Selective Service; provides for compliance with federal requirements by certain applicants for drivers' licenses or identification cards; directs HSMV to forward certain information to federal Selective Service System re certain applicants; provides described notice to applicants; directs dept. to include described statement on certain applications for drivers' licenses or identification cards. Creates 322.0515. Effective Date: 07/01/2001.

Read the second time on May 3, 2001

Identical to HB 635 in Messages

CS/SB 2172 by the Committee on Appropriations, Senator Sullivan and others

State Universities; requires approval of certain student fee modifications, rather than just increases, by certain committees; provides for establishment of student governments at each state university with authority to establish certain procedures & to provide for election or removal of student government officers; provides for student governments at community colleges; conforms provisions, etc. Amends Ch. 240, 447.203,.301. Effective Date: 07/01/2001.

Read the second time on May 3, 2001

CS/SB 1010 by the Committee on Comprehensive Planning, Local and Military Affairs and Senator Garcia

Public Libraries; extends repeal date of provision authorizing operating grants; requires Division of Library & Information Services to facilitate extension of free library services through interlocal agreement; requires reports. Amends 257.17. Effective Date: Upon becoming law.

Read the second time on May 3, 2001

Identical to CS/HB 337 in Messages

HB 1749 by the Fiscal Responsibility Council and Representative Johnson

Fla. Black Business Investment Board; provides that board shall be not-for-profit corporation & not entity of state government; revises provisions re appointment of executive director; revises provisions re duties of board re developing memoranda of understanding with certain entities & increases number of black business enterprises in construction projects; provides intent re operation of board & return on investment, etc. Amends Ch. 288; creates 288.7092. Effective Date: 07/01/2001.

Substituted for **CS/SB 1772** (Diaz de la Portilla), read the second time and amended on May 3, 2001

CS/SB 822 by the Committee on Governmental Oversight and Productivity and Senator Dyer

Government Accountability; provides that property of state or monetary recovery made on behalf of state is not subject to lien; clarifies current requirement that contractor on certain state contracts must allow access to public records unless records are exempt; provides for injunctions without bond when sought by state or its agencies; authorizes Risk Management Division to enter into indemnification agreements for supersedeas bonds, etc. Amends FS. Effective Date: 07/01/2001.

Read the second time and amended on May 2, 2001

HB 1707 by the Fiscal Responsibility Council and Representative Dockery

Energy Management; removes provisions which direct DMS to provide for energy management plan for state agencies, & which require state agencies to submit certain energy data to dept.; provides that dept. may develop such plan. Amends 255.257. Effective Date: Upon becoming law.

Read the second time on May 3, 2001

HB 1711 by the Fiscal Responsibility Council, Representative Dockery and others

DMS/Construction Management Services; eliminates authority of DMS to enter into contracts with nonstate entities for construction management services; repeals specified provision to conform. Repeals 255.31(3), 235.017(2)(e). Effective Date: 07/01/2001.

Read the second time on May 3, 2001

HB 1717 by the Fiscal Responsibility Council and Representative Dockery

Dairy Industry Division; eliminates Dairy Industry Division within Agriculture & Consumer Services Dept.; repeals provisions re powers & duties of said division & qualifications & duties of director of division; amends provisions to conform; includes powers & duties of division within powers & duties assigned to Food Safety Div. of said dept.; renames Food Safety Div. to Dairy & Food Safety Div. Repeals 570.40,.41; amends 20.14, 570.18,.29,.50,.51. Effective Date: 07/01/2001.

Read the second time on May 3, 2001

HB 1719 by the Fiscal Responsibility Council, Representative Dockery and others

DMS/Motor Vehicles/Aircraft; revises language re powers & duties of DMS; authorizes department to contract for maintenance of motor vehicles; deletes reference to special purpose aircraft re annual report to Legislature. Amends 287.16. Effective Date: 07/01/2001.

Read the second time on May 3, 2001

HB 1741 by the Fiscal Responsibility Council, Representative Maygarden and others

Children & Family Services; adds Seminole Co. to list of counties whose sheriffs provide protective investigative services; modifies definition of "support coordinator" in provisions re developmental disabilities; adds another category of families eligible for cash assistance, for federal reporting purposes; provides for transfer of certain funds to CFS Dept. for prevention of domestic & sexual violence, etc. Amends Chs. 39, 393, 414, 938, 943; repeals 402.185. Effective Date: 07/01/2001.

Read the second time and amended on May 3, 2001

HB 1743 by the Fiscal Responsibility Council and Representative Ball

Juvenile Justice Advisory Board; repeals certain provisions which created Juvenile Justice Advisory Board; amends certain provisions to remove references to said board. Repeals 985.401; amends 20.316, 216.136, 985.227,.315,.317,.404. Effective Date: 07/01/2001.

Read the second time on May 3, 2001

CS/SB 812 by the Committee on Criminal Justice and Senator Crist

Death Sentence/Age Requirement; provides that only criminals who were 17 years of age or older at time crime was committed may be sentenced to death; amends provision to conform. Creates 921.1415; amends 775.082. Effective Date: Upon becoming law.

Read the second time on May 3, 2001

CS/SB 1330 by the Committee on Education, Senator Miller and others

Student Financial Assistance; creates Vocational Student Assistance Grant Program; authorizes alternative payment procedures for Ioan forgiveness program; increases percentage of funds from financial aid fee to be used for need-based financial aid for students at state universities & community colleges; extends & places limit upon eligibility period for Fla. Bright Futures Scholarship Program; authorizes certain grants for part-time students, etc. Amends FS. Effective Date: 07/01/2001 except as otherwise provided.

Read the second time and amended on May 3, 2001

Similar to **CS/CS/HB 1509** in the Committees on Education, Appropriations Subcommittee on Education, and Appropriations

CS/HB 137 by the Council for Smarter Government, Representative Goodlette and others

Probate; provides for right of inheritance re adoption; revises language re recovery of payments made on behalf of certain Medicaid-eligible persons; amends provisions re opening of decedent's safe-deposit box & re Florida Probate Code; revises language re share of spouse; increases monetary amount of certain shares; provides that aliens shall have same right of inheritance as citizens, etc. Amends FS. Effective Date: 01/01/2002.

Substituted for **CS/SB 402** (Burt) and read the second time on May 3, 2001

CS/HB 175 by the Committee on Crime Prevention, Corrections & Safety (HCC), Representative Machek and others
