CS/SB 664 (3R) by the Committee on Regulated Industries and Senator Carlton—

Real Estate Professionals; requires educational courses that are prerequisites to licensure as broker, broker-salesperson, or salesperson or maintenance or renewal of such licensure to be made available by means of distance learning; amends provision re real estate appraisers to require distance learning to be made available for continuing education courses, etc. Amends 475.17,.182,.451,.618; reenacts 475.05. Effective Date: 07/01/2002.

CS/SB 674 (3R) by the Committee on Comprehensive Planning, Local and Military Affairs and Senator Miller—

Fire Hydrants; requires owners of private fire hydrants to contract with licensed professionals or local fire control authorities to inspect & service such hydrants. Effective Date: 07/01/2002.

Read the second time on February 21, 2002

CS/SB 598 (3R) by the Committee on Children and Families and Senator Peaden—

Community Mental Health Services; requires that CFS Dept. use certain funds to expand provision of crisis services & community mental health services; requires that new funds for crisis services or community mental health services be appropriated in lump-sum category; requires that spending plan include schedule for phasing in new community mental health services, etc. Effective Date: Upon becoming law.

SB 1090 (3R) by Senator Meek-

Student Courses/Withdrawal/Military; requires rules & policies by district school boards, community college district boards of trustees, & university boards of trustees re student withdrawal from courses due to military service; provides that student shall not suffer academic or financial penalties; authorizes refund of fees. Effective Date: 07/01/2002.

SB 208 (3R) by Senator Wasserman Schultz-

School Facilities; provides example of school-within-a-school; modifies small-school student-population limits; provides for exceptions to small-schools requirements. Amends 230.23, 235.2157. Effective Date: 07/01/2002.

Read the second time on February 21, 2002

CS/SB 1430 (3R) by the Committee on Transportation, Senator Garcia and others—

Road & Bridge Designations; designates portion of roadway in City of Miami in Miami-Dade Co. as "Enrique Valledor Way"; designates portion of U.S. Hwy. 41 in White Springs as "Martin Luther King, Jr., Memorial Highway"; designates portion of Semoran Blvd. in Orlando, Orange Co., as "Toni Jennings Blvd."; designates Miami Gardens Dr. as "Ronald A. Silver Blvd."; designates "Senator Ginny Brown-Waite Highway" in Hernando Co.; directs DOT to erect suitable markers, etc. Effective Date: Upon becoming law.

Read the second time and amended on February 21, 2002

SB 2028 (3R) by Senator Pruitt—

Corporate Income Tax; provides for adoption of 2002 version of Internal Revenue Code; provides for retroactivity. Amends 220.03. Effective Date: Upon becoming law.

Read the second time on February 21, 2002

CS/SB 180 (3R) by the Committee on Finance and Taxation and Senator Silver—

Excise Tax on Documents; provides that tax imposed under this section applies to certificates of title issued in judicial sale of real property pursuant to court order or final judgement issued in foreclosure proceeding; provides method for computing tax; provides that this act is to clarify, not change, law; provides for retroactive applicability; revises verification requirement for notation on certain recorded documents. Amends 201.02, 132. Effective Date: Upon becoming law.

CS/SB 1120 (3R) by the Committee on Finance and Taxation and Senator Rossin—

Non-ad Valorem Assessments; amends provision re uniform method for levy, collection, & enforcement of non-ad valorem assessments; specifies circumstances in which local government must adopt non-ad valorem assessment roll at public hearing; revises procedure for adoption of non-ad valorem assessment roll by independent special fire control district; revises provisions governing notice of non-ad valorem assessment hearings, etc. Amends 197.3632, 191.011, 192.0105. Effective Date: 07/01/2002.

SB 358 (3R) by Senator Sebesta and others—

Motor Vehicle Accidents/Distractions; requires report on motor vehicle accidents caused by all types of driver distractions; preempts regulation of operator or passenger use of commercial mobile radio services to state. Creates 316.0075. Effective Date: Upon becoming law.

Read the second time and amended on February 21, 2002

CS/SB 366 (3R) by the Committee on Transportation and Senator Crist—

Traffic Control/Move Over Act; creates said act; provides requirements re authorized emergency vehicles making use of visual signals when parked; provides for disposition of fines; authorizes use of emergency lights & sirens on certain vehicles; authorizes wreckers to use amber rotating or flashing lights under certain circumstances, etc. Amends 316.126,.2397, 318.18,.21. Effective Date: 07/01/2002.

Read the second time and amended on February 21, 2002

SB 266 (3R) by Senator Dyer-

Solid Waste Collection; clarifies provisions re treatment of existing solid waste contracts in areas affected by merger or incorporation of municipalities; exempts solid-waste or recovered-materials collection vehicles from prohibition against leaving engine running when vehicle is unattended; clarifies definition of term "displacement". Amends 165.061, 316.1975, 403.70605. Effective Date: 07/01/2002.

Read the second time and amended on February 21, 2002

CS/SB 428 (3R) by the Committee on Comprehensive Planning, Local and Military Affairs and Senator Miller—

Adult Entertainment Establishments; revises prohibition against locating adult entertainment establishment within specified distance from school; requires that such establishment be approved by county or municipality & district school board. Amends 847.0134. Effective Date: 07/01/2002.

Read the second time on February 21, 2002

CS/SB 1268 (3R) by the Committee on Regulated Industries and Senator Campbell—

Florida State Boxing Commission; requires one member of Fla. State Boxing Commission to be licensed physician; provides for provisional certification of competitiveness of mixed martial arts & kickboxing matches; requires minimum permit fee for mixed martial arts events; clarifies provisions re weights & classes of participants; prescribes glove weights for mixed martial arts participants; revises provisions re physician's attendance at boxing matches, etc. Amends Ch. 548. Effective Date: Upon becoming law

Read the second time on February 21, 2002

CS/SB 1176 (3R) by the Committee on Education and Senator Garcia—

Alcoholic Bev./Students/Curriculum; provides exemption for giving or serving to certain underage students alcoholic beverages that are delivered as part of required curriculum at specified accredited institutions; provides exemption for possession of alcoholic beverages by underage students in specified circumstances. Amends 562.11,.111. Effective Date: 07/01/2002.

CS/CS/SB 182 (3R) by the Committees on Finance and Taxation, Criminal Justice and Senator Silver—

Instant Bingo Games; cites act as "Evelyn Wiesman-Price Act"; defines terms "instant bingo" & "deal"; provides rules for operation of instant bingo games; provides penalties. Amends 849.0931. Effective Date: 07/01/2002.

Read the second time and amended on February 21, 2002

CS/CS/SB 566 (3R) by the Committees on Regulated Industries, Comprehensive Planning, Local and Military Affairs and Senator Sebesta—

Bingo Games/Elderly or Disabled; authorizes bingo games for residents or clients of certain facilities for elderly or disabled, & their guests; provides conditions; provides for use of proceeds; provides exemption from local regulation & fees. Effective Date: 07/01/2002

SB 8 (3R) by Senator Campbell—

Relief/Hopkins & Bowman; provides for relief of Towanna Denise Hopkins, incompetent, by & through Willie Lee Hopkins, her father & legally appointed guardian, Robert Keith Bowman, Jr., son of Towanna Denise Hopkins, & Willie Lee Hopkins, individually; authorizes & directs Fla. Board of Regents, University of South Florida, & USF Health Sciences Center Insurance Company to compensate them for injuries & damages, etc. Effective Date: Upon becoming law.

CS/SB 10 (3R) by the Committee on Health, Aging and Long-Term Care and Senator Villalobos—

Relief/Mark Schwartz; provides for relief of Mark Schwartz, a minor, for injuries sustained as result of negligence of employees of Coral Springs Medical Center. Effective Date: Upon becoming law.

Read the second time on February 14, 2002

CS/SB 24 (3R) by the Committee on Finance and Taxation and Senator Campbell—

Relief/Margaret B. Helm/Martin Co.; provides for relief of Margaret B. Helm for injuries & damages sustained as result of negligence of Martin Co. Volunteer Fire Dept.; specifies use of funds appropriated; provides for reimbursement of Medicaid Brain & Spinal Cord Injury Program & Vocational Rehabilitation Services expenditures. Effective Date: Upon becoming law.

SB 26 (3R) by Senator Latvala—

Relief/Skowroneks/Clearwater; provides for relief of Eva Skowronek as widow of Wieslaw Skowronek & for relief of Anna Marie, Victor, & Hubert Alexander Skowronek, children of Wieslaw Skowronek, for death of Wieslaw Skowronek as result of negligence of City of Clearwater. Effective Date: Upon becoming

Read the second time on February 14, 2002

SB 30 (3R) by Senator Jones—

Relief/Hilda De Paz/Miami-Dade Co.; provides for relief of Hilda De Paz; authorizes & directs Miami-Dade Co. to compensate Hilda De Paz for personal injuries she suffered due to negligence of county employees. Effective Date: Upon becoming law.

Read the second time on February 14, 2002

CS/SB 32 (3R) by the Committee on Finance and Taxation and Senator Lawson—

Relief/Jose & Johammes Pena/Hialeah; provides for relief of Jose Pena, as Personal Representative of Estate of Carmen Pena, deceased, & individually, as surviving father of Katherine Pena & Richard Pena, deceased minor children of Carmen Pena & Jose Pena; provides for relief of Johammes Pena, surviving son of Carmen Pena; compensates them for death of Carmen Pena, Katherine Pena, & Richard Pena as result of negligence of City of Hialeah. Effective Date: Upon becoming law.

Relief/Rosemary Falkinburg; provides for relief of Rosemary Falkinburg; authorizes & directs City of West Palm Beach to compensate Ms. Falkinburg for personal injuries she suffered due to negligence of city employee. Effective Date: Upon becoming law.

SB 44 (3R) by Senator Pruitt-

Relief/James Torrence; provides for relief of James Torrence; authorizes & directs Palm Beach Co. Health Care District to compensate him for personal injuries resulting from surgery negligently performed by health care district employee. Effective Date: Upon becoming law.

CS/SB 46 (3R) by the Committee on Finance and Taxation and Senator Pruitt—

Relief/Sharon & Victor Dixon, Sr.; provides for relief of Sharon Dixon & Victor Dixon, Sr.; authorizes & directs School Board of Indian River Co. to compensate them for wrongful death of their minor child, Victor Dixon, Jr., due to negligence of employee of school board. Effective Date: Upon becoming law.

Read the second time on February 14, 2002

SB 50 (3R) by Senator Campbell—

Relief/Lawrence Bigney; provides for relief of Lawrence Douglas Bigney; authorizes & directs Sheriff's Office of Palm Beach Co. to compensate him for personal injuries suffered due to unlawful acts of employee of sheriff's office. Effective Date: Upon becoming law.

Read the second time on February 14, 2002

CS/SB 52 (3R) by the Committee on Finance and Taxation and Senator Villalobos—

Relief/Calderon/Miami-Dade Co.; provides for relief of Jessica Ann Calderon, personal representative of Estate of Roberto Luis Calderon, Sean Ryan Calderon, minor child of Roberto Luis Calderon & Jessica Ann Calderon, & Lily Ann Calderon, minor child of Roberto Luis Calderon & Jessica Ann Calderon, compensates them for wrongful death of Roberto Luis Calderon as result of negligence of Miami-Dade Co. employee. Effective Date: Upon becoming law.

Read the second time on February 14, 2002

CS/SB 56 (3R) by the Committee on Finance and Taxation and Senator Silver—

Relief/Joseph Arvay/Vero Beach; provides for relief of Joseph Arvay; directs City of Vero Beach to compensate Mr. Arvay for injuries caused by negligence of city police officer. Effective Date: Upon becoming law.

Read the second time on February 14, 2002

CS/SB 60 (3R) by the Committee on Finance and Taxation and Senator Jones—

Relief/Joshua England/Monroe Co.; provides for relief of Joshua England, a minor; authorizes & directs District School Board of Monroe Co. to compensate Joshua England for personal injuries that he suffered due to negligence of school board employees; provides for use of such funds; provides for forfeiture & reversion of funds; provides for trustee qualifications. Effective Date: Upon becoming law.
