**SB 266 by Senator Dyer—**

Amends 455.271, 473.313, 489.116. Effective Date: 07/01/2002.

**SB 350 by Senator Futch—**

**Parking Permits/Disabled Persons;** provides that certain advanced registered nurse practitioners & physician assistants may provide certification of disability required for issuance of such permits. Amends 320.0848. Effective Date: 07/01/2002.

**SB 358 by Senator Sebesta and others—**

**Motor Vehicle Accidents/Distractions;** requires report on motor vehicle accidents caused by all types of driver distractions; preempts regulation of operator or passenger use of commercial mobile radio services to state. Creates 316.0075. Effective Date: Upon becoming law.

*Reported favorably by the Committee on Transportation and reported favorably, with one amendment, by the Committee on Comprehensive Planning, Local and Military Affairs, and withdrawn from the Committees on Appropriations Subcommittee on General Government and Appropriations*

**CS/SB 364 by the Committee on Children and Families and Senator Peaden—**

**Developmental Disabilities;** redefines term "retardation" to revise certain requirements for standardized intelligence test used to make such determination; requires that CFS Dept. adopt rule for supported-living programs; requires dept. to adopt rules for administering certain waivers & delivering services to persons who have developmental disabilities; provides for health care decisions for persons having developmental disability. Amends 393.063,.501, 765.401. Effective Date: 07/01/2002.

*Reported favorably as a committee substitute by the Committee on Children and Families, and withdrawn from the Committees on Appropriations Subcommittee on Health and Human Services, and Appropriations*

**CS/SB 366 by the Committee on Transportation and Senator Crist—**

**Traffic Control/Move Over Act;** creates said act; provides requirements re authorized emergency vehicles making use of visual signals when parked; provides penalty; provides for disposition of fines; authorizes wreckers to use amber rotating or flashing lights under certain circumstances. Amends 316.126,.2397. Effective Date: 07/01/2002.

*Reported favorably as a committee substitute by the Committee on Transportation*

**SB 414 by the Committee on Health, Aging and Long-Term Care—**

**Long-term Care Ombudsman Program;** increases maximum membership of local long-term care ombudsman councils; requires State Long-Term Care Ombudsman Council to publish complaint information quarterly; specifies training requirements for employees of State Long-Term Care Ombudsman & its volunteers. 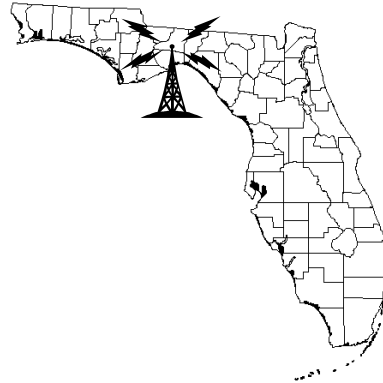
