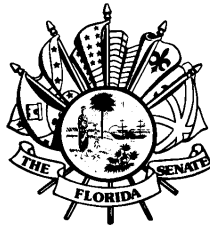

Homeowners' Associations/U. S. Flag; provides that any homeowner may display United States flag; prohibits association documents from placing certain restrictions on display of United States flag; provides for retroactive application of act. Amends 720.304, .3075. Effective Date: Upon becoming law.

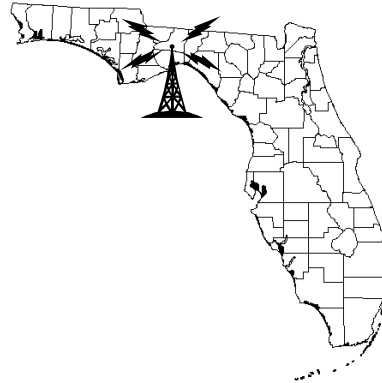
