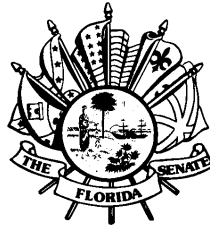

GENERAL BILLS

CS/CS/SB 1610 (3R) by the Committees on Finance and Taxation, Regulated Industries and Senator Pruitt—

Communications Services Tax; amends provision re tax exemption on sale of communications services to religious or educational institutions; provides exception to requirement that dealers separately state communications services tax on bills & invoices; clarifies that E911 fee applies to certain customers; requires DOR to submit report on accuracy of 2001 state & local tax rates to Governor, Senate President, & House of Representatives Speaker, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on March 13, 2002

*Similar to **CS/HB 1511 (HC)** in Messages*

HB 1943 (3R) by the Fiscal Responsibility Council, Representative Lacasa and others—

Appropriations; provides moneys for annual period beginning July 1, 2002, & ending June 30, 2003, to pay salaries, & other expenses, capital outlay - buildings, & other improvements, & for other specified purposes of various agencies of State government. Effective Date: 07/01/2002 or upon becoming law.

*Substituted for **SB 2500 (SUB)** (Appropriations), read the second time and amended on March 18, 2002*

SB 2502 (3R) by the Committee on Appropriations—

Appropriations Implementing Bill; increases percentage of funds from financial aid fee to be used for need-based financial aid; prohibits State University System employees from enrolling in tuition-free courses; authorizes CFS Dept. to transfer funding between certain services; provides for additional positions to operate additional prison bed capacity under certain circumstances; provides for use of Emergency Management, Preparedness, & Assistance TF, etc. Amends FS. Effective Date: 07/01/2002 except as otherwise provided.

Read the second time and amended on March 14, 2002

*Compare to **HB 1945 (HC)** in the Committee on Appropriations*

CS/SB 1108 (3R) by the Committee on Appropriations and Senator Silver—

Health Care; provides for feasibility study re outsourcing specified functions of Dentistry Board; requires agency to contract for evaluation of Fla. Kidcare program; revises provisions governing purchase of goods & services for Medicaid recipients; revises disproportionate share/financial assistance program for rural hospitals; requires AHCA to conduct pilot program for subacute pediatric transitional care center, etc. Amends Ch. 409, 499.012. Effective Date: 07/01/2002.

Read the second time and amended on March 14, 2002

CS/SB 1116 (3R) by the Committee on Appropriations and Senator Silver—

Children & Family Services Dept.; provides for use of funds by department; prescribes specified contract requirement; requires department to operate domestic violence program; specifies amount of funds available for use by department & FDLE; repeals provisions re funding for Prevention of Domestic & Sexual Violence Program; abrogates repeal of community partnership matching grant program; authorizes sale of hospital & provides for use of proceeds, etc. Amends FS. Effective Date: 07/01/2002.

Read the second time on March 14, 2002

CS/CS/SB 1654 (3R) by the Committees on Appropriations, Judiciary and Senator Burt—

Increase of Judges & Justices; increases number of judges in specified judicial circuits; increases number of judges in specified county courts; increases number of judges in specified district courts of appeal; provides for appointment by Governor. Amends 26.031, 34.022, 35.06. Effective Date: 07/01/2002 except as otherwise provided.

Read the second time and amended on March 14, 2002

HB 813 (3R) by Representatives Dockery, Greenstein, Lacasa, Goodlette, Harrington, Atwater, Alexander, Gannon and others—

Everglades Restoration; provides for distribution of proceeds from excise taxes on documents to pay debt service on Everglades restoration bonds; authorizes issuance of said bonds to finance or refinance cost of acquisition & improvement of land, water areas, & related property interests & resources for purpose of implementing Comprehensive Everglades Restoration Plan; provides that certain project components shall be exempt from permit requirements, etc. Amends FS. Effective Date: 07/01/2002 except as otherwise provided.

*Substituted for **CS/SB 684 (SUB)** (Brown-Waite), read the second time and amended on March 15, 2002*

CS/SB 2270 (3R) by the Committee on Criminal Justice and Senator Cowin—

Arrest Without Warrant; authorizes law enforcement officer to make arrest without warrant when there is probable cause to believe that person has committed assault upon law enforcement officer, firefighter, emergency medical care provider, public transit employees or agents, or certain other officers or has committed assault or battery upon any employee of receiving facility, etc. Amends 901.15, 947.141,.22. Effective Date: 10/01/2002.

Read the second time and amended on March 18, 2002

*Identical to **CS/HB 1447 (HC)** in Messages*

SB 2144 (3R) by Senator Campbell—

Wrongful Death/Surviving Spouse; provides presumption re minor child's recovery of damages resulting from wrongful death of child's parents. Amends 768.21. Effective Date: 07/01/2002.

Read the second time and amended on March 18, 2002

*Similar to **CS/HB 795 (HC)** in Messages*

SB 1998 (3R) by Senator Dawson—

Litter Law Violation/Community Svc.; requires that community service imposed for certain violations be performed in specified areas. Amends 403.413. Effective Date: 07/01/2002.

Read the second time on March 18, 2002

CS/SB 1824 (3R) by the Committee on Children and Families, Senator Peaden and others—

Sexually Violent Offenders; requires agency with jurisdiction over person convicted of sexually violent offense to provide earlier notice of offender's anticipated release; revises time for preparing assessment as to whether offender is sexually violent predator; requires detainees to be segregated from other patients; revises catchline. Amends 394.913,.917,.929. Effective Date: 07/01/2002.

Read the second time on March 18, 2002

*Similar to **HB 949 (HC)** in the Committees on Criminal Justice and Children and Families*

CS/SB 306 (3R) by the Committee on Criminal Justice and Senator Burt—

Driver's Licenses & ID Cards; prohibits person from knowingly selling, manufacturing, or delivering, or offering to sell, manufacture, or deliver, any blank, forged, stolen, fictitious, counterfeit, or unlawfully issued driver's license or identification card or any instrument in similitude of such license or such card; provides penalty; authorizes investigations of violations of this section. Amends 322.212. Effective Date: 10/01/2002.

Read the second time and amended on March 18, 2002

SB 1600 (3R) by Senator Clary—

Public Records/Physicians/Reports; provides exemptions from public-records requirements for information contained in reports made by physicians & osteopathic physicians of adverse incidents occurring in office practice settings; provides for future review & repeal; provides findings of public necessity. Creates 458.353, 459.028. Effective Date: Upon becoming law.

Read the second time on March 18, 2002

HB 585 (3R) by Representative Goodlette and others—

Fla. Uniform Principal & Income Act; creates said act; provides general principles; provides trustee's power to adjust between principal & income; provides for unitrust alternative to certain trusts where power to adjust is unavailable or not exercised; provides for judicial control of certain discretionary powers; provides limitations; provides for determinations & distributions of net income, etc. Creates 738.101-.804; repeals 738.01-.15. Effective Date: 01/01/2003.

*Substituted for **CS/CS/SB 1166 (SUB)** (Posey) and read the second time on March 18, 2002*

CS/HB 715 (3R) by the Council for Ready Infrastructure, Representatives Bense, Haridopolos and others—

Transportation; provides for process for governmental entities & sign owners to enter into relocation & reconstruction agreements re outdoor advertising signs; extends period within which certain transportation facilities needed to serve new development must be in place or under actual construction; defines "federal-aid primary highway system", etc. Amends 163.3180, 334.044, 339.135, 479.15; creates 70.20, 479.25. Effective Date: 07/01/2002.

*Substituted for **CS/SB 728 (SUB)** (Latvala) and read the second time on March 18, 2002*

SB 2274 (3R) by Senator Jones—

Florida Rescue Workers' Day; designates September 11 of each year as "Florida Rescue Workers' Day," in recognition of sacrifices made by Florida rescue workers in face of unthinkable tragedy. Effective Date: Upon becoming law.

Read the second time and amended on March 18, 2002

SB 626 (3R) by Senator Saunders—

Laser Lighting Devices; defines term "laser lighting device"; provides that it is second degree misdemeanor to knowingly & willfully shine beam of laser lighting device at law enforcement officer in such manner as to cause law enforcement officer to believe that firearm is pointed at him or her; provides penalty. Creates 784.062. Effective Date: 10/01/2002.

Read the second time and amended on March 18, 2002

SB 2130 (3R) by Senator Lawson—

Registered Contractors; provides for grandfathering of certain contractors who have passed certain oral examinations. Amends 489.118. Effective Date: 07/01/2002.

Read the second time and amended on March 18, 2002

CS/CS/HB 457 (3R) by the Council for Ready Infrastructure, the Committee on Transportation (RIC), Representative Spratt and others—

Road & Bridge Designations; designates new U.S. Highway 27 bridge in City of Moore Haven as "Mamie Langdale Memorial Bridge"; designates old Nassau Sound Bridge in Nassau & Duval Counties as "George Crady Bridge"; designates New River Bridge in Bradford & Union Counties as "John S. 'Steve' Dennard Bridge"; designates portion of Semoran Boulevard in City of Orlando, Orange Co., as "Toni Jennings Boulevard", etc. Effective Date: Upon becoming law.

Read the second time and amended on March 18, 2002

HB 1993 (3R) by the Procedural & Redistricting Council, Representative Byrd and others—

Congressional Districts; amends provision re official census for congressional redistricting & applicable definitions; divides state into congressional districts (plan H062C002); amends provision re contiguity for areas specified for inclusion in one district which are entirely surrounded by other districts; provides for nomination & election of candidates from congressional districts created in 2002, etc. Amends Ch. 8. Effective Date: Contingent.

*Substituted for **CS/SB 594 (SUB)** (Latvala), read the second time and amended on March 19, 2002*

CS/SB 1714 (3R) by the Committee on Health, Aging and Long-Term Care and Senator Brown-Waite—

Nursing Homes/Electronic Monitoring; requires AHCA to conduct pilot project to demonstrate use of electronic monitoring equipment in nursing homes; establishes requirements for nursing homes participating in pilot project; establishes procedures for use of said equipment; provides for conditional consent to monitoring; prohibits admission of tapes as evidence in civil litigation against nursing home, licensed health care practitioner, or staff of nursing home, etc. Effective Date: Upon becoming law.

Read the second time and amended on March 19, 2002

CS/SB 2302 (3R) by the Committee on Finance and Taxation and Senator Pruitt—

Tax Administration; eliminates provisions for temporary exemption certificates; reinstates retroactively sales tax exemption for parent-teacher organizations & parent-teacher associations; replaces definition of term "section 38 property" with express definition of terms "industrial machinery & equipment" & "motion picture & video equipment"; provides for treatment of Indian tribes under Unemployment Compensation Law, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on March 19, 2002

CS/HB 1225 (3R) by the Council for Healthy Communities, Representatives Arza, Garcia and others—

Motor Vehicle Racing Contests; revises provisions prohibiting specified contests & competitions in motor vehicle; revises penalties for violation; provides penalties for certain participation in such contests or competitions; provides for impounding vehicle. Amends 316.191. Effective Date: 10/01/2002.

*Substituted for **CS/CS/SB 1738 (SUB)** (Smith), read the second time and amended on March 19, 2002*

CS/SB 2084 (3R) by the Committee on Regulated Industries and Senator Holzendorf—

Underground Facility Damage; revises legislative intent re Underground Facility Damage Prevention & Safety Act; redefines terms "business hours," "excavate," & "system"; defines terms "design services," "positive response," "premark," & "tolerance zone"; provides for free-access notification system; revises procedures for excavation & notification; revises liability provisions; revises noncriminal & criminal penalties, etc. Amends Ch. 556. Effective Date: 10/01/2002.

Read the second time on March 19, 2002

Similar to CS/HB 1475 (HC) in Messages

CS/HB 1407 (3R) by the Council for Smarter Government, the Committee on State Administration (SGC), Representatives Brummer and Cantens—

Public Buildings/Security; creates Capitol Police within FDLE; provides transfer of funds; provides for powers & duties of DMS re firesafety & security responsibilities; provides for investigations by Capitol Police; provides that persons arrested or detained by Capitol Police shall be delivered to sheriff; provides for procurement of equipment by FDLE, etc. Amends Chs. 20, 281, 287, 288, 943. Effective Date: Upon becoming law except as otherwise provided.

Substituted for CS/CS/SB 1144 (SUB) (Garcia) and read the second time on March 19, 2002

CS/SB 2262 (3R) by the Committee on Banking and Insurance, Senator Meek and others—

Florida Fair Lending Act; provides legislative findings; specifies prohibited acts re high-cost home loans; specifies required disclosures for high-cost home loans; requires lenders of high-cost home loans to provide notice to borrowers prior to taking foreclosure actions; allows borrower to cure default; provides that lender who violates this act forfeits interest in high-cost home loan; preempts regulation of high-cost home loans to state, etc. Effective Date: 10/02/2002.

Read the second time and amended on March 19, 2002

CS/SB 2108 (3R) by the Committee on Education, Senator Saunders and others—

Public Facilities & Roads; designates renovated transplant housing unit at University of Florida's Shands Hospital as "Gerold L. Schiebler/Shands Transplant Housing Complex"; designates School of Business & Industry building at Florida Agricultural & Mechanical University as "Sybil C. Mobley Business Building"; designates proposed entrance pavilion for John & Mable Ringling Museum of Art as John McKay Center for the Arts, etc. Effective Date: Upon becoming law.

Read the second time and amended on March 19, 2002

CS/SB 2192 (3R) by the Committee on Banking and Insurance and Senator Sanderson—

Solvency of Insurers & HMOs; provides for effect of certain DOI orders; revises liabilities that workers' compensation insurer must include on its financial statements; specifies inclusion of certain losses & claims under liabilities of HMO under certain circumstances; provides for investment of funds of HMO in excess of certain reserves & surplus under certain circumstances; defines term "health care risk contract", etc. Amends Chs. 624, 641, 625.041, 627.481. Effective Date: 10/01/2002 except as otherwise provided.

Read the second time and amended on March 19, 2002

CS/SB 2202 (3R) by the Committee on Appropriations and Senator Sullivan—

H. Lee Moffitt Cancer Center/USF; assigns duties of Board of Regents of H. Lee Moffitt Cancer Center & Research Institute at University of South Florida to Florida Board of Education; provides for utilization & governance of lands; revises provisions re corporate subsidiaries of not-for-profit corp.; provides for applicability of sovereign immunity provisions; authorizes creation & support of interdisciplinary oncology program, etc. Amends 240.512. Effective Date: 07/01/2002.

Read the second time on March 19, 2002

HB 281 (3R) by the Committee on State Administration (SGC) and Representative Brummer—

Public Records & Meetings Exemption; amends provision which provides exemption from public records requirements for certain risk-based capital information held by Insurance Dept. & from public meeting requirements for hearings conducted by dept. re actions re such information; reenacts such exemptions & removes October 2, 2002, repeal thereof scheduled under OGSR Act of 1995; clarifies language. Amends 624.40851. Effective Date: 10/01/2002.

Substituted for CS/SB 238 (SUB) (Posey), read the second time and amended on March 19, 2002

CS/SB 1406 (3R) by the Committee on Regulated Industries and Senator Pruitt—

Public Records/Telecommunications; provides exemption from public-records requirements for information received by taxing authority or its agency in connection with certain audits of records of provider of telecommunication services; provides for future legislative review & repeal; provides that act is remedial & applies regardless of when audit was begun; provides finding of public necessity. Effective Date: Upon becoming law.

Read the second time on March 19, 2002

Similar to CS/HB 1487 (HC) in Messages

CS/CS/SB 1550 (3R) by the Committees on Appropriations, Children and Families and Senator Silver—

Child Care/Home Operator Training; increases introductory course requirement for operators of large family child care homes; provides automatic exemption from certain training requirements for personnel having specified degrees, credentials, courses, or waivers in specified areas; provides for extension until 2004 to implement child care facility director credential requirement; authorizes creation of public-private child care sites, etc. Amends 402.3131, .305, .313, 110.151. Effective Date: 07/01/2002.

Read the second time and amended on March 19, 2002

CS/CS/SB 1156 (3R) by the Committees on Appropriations, Education and Senator Wise—

Students/Disability/Graduation Tests; provides definition; provides eligibility for accommodations in taking Florida Comprehensive Assessment Test or High School Competency Test required for high school graduation; directs Governor to appoint validity panel to make recommendations on impacts of specific accommodations; provides requirements for eligibility for standard high school diploma; provides for adoption of rules; provides for funding for accommodations. Creates 232.2464. Effective Date: 01/01/2003.

Read the second time and amended on March 19, 2002

CS/SB 364 (3R) by the Committee on Children and Families and Senator Peaden—

Developmental Disabilities; requires that CFS Dept. adopt rule for supported-living programs; requires dept. to adopt rules for administering certain waivers & delivering services to persons who have developmental disabilities; authorizes patient whose legal disability is removed to amend or revoke recognition of medical proxy & any uncompleted decision made by that proxy, etc. Amends 393.063, .501, 765.104, .401. Effective Date: 07/01/2002.

Read the second time and amended on March 19, 2002

HB 219 (3R) by Representative Ball and others—

Open House Parties; revises definitions; prohibits persons age 18 or older from allowing open house parties at any residence if alcoholic beverages or drugs are possessed or consumed by minor; provides penalty. Amends 856.015. Effective Date: 07/01/2002.

*Substituted for **SB 380 (SUB)** (Futch), read the second time and amended on March 19, 2002*

CS/SB 2132 (3R) by the Committee on Governmental Oversight and Productivity and Senator Sanderson—

Florida Retirement System; redefines term "retired state officer or employee" or "retiree"; revises membership requirements of Elected Officers' Class of system to include certain sheriffs & clerks of circuit court; amends provision re employer contributions to Public Employee Optional Retirement Prog.; creates provision re benefits payable under program; authorizes DMS to contract with private company to administer disability benefit program, etc. Amends Chs. 121, 110. Effective Date: 07/01/2002.

Read the second time and amended on March 19, 2002

*Similar to **CS/HB 807 (HC)** in Messages*

CS/SB 2134 (3R) by the Committee on Governmental Oversight and Productivity and Senator Sanderson—

FRS Contributions Clearing/TF; creates FRS Contributions Clearing Trust Fund, to be administered by DMS as retirement clearing trust fund not subject to termination pursuant to s. 19(f), Art. III of State Constitution; provides for sources of moneys & purposes; provides for exemption from general revenue service charges. Creates 121.4503. Effective Date: Upon becoming law.

Read the second time and amended on March 19, 2002

*Identical to **HB 1575 (HC)** in Messages*

CS/SB's 1906, 550 (3R) by the Committee on Comprehensive Planning, Local and Military Affairs, Senators Peaden and Constantine—

Growth Management; (THIS BILL COMBINES S1906,550) requires that membership of all local planning agencies or equivalent agencies that review comprehensive plan amendments & rezonings include nonvoting representative of district school board; requires local governments to consider water-supply data & analysis in their potable-water & conservation elements; requires that public educational facilities element include certain provisions, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on March 19, 2002

CS/CS/SB 2254 (3R) by the Committees on Health, Aging and Long-Term Care, Children and Families and Senator Brown-Waite—

Supportive Housing; directs Secretary of Children & Family Services to establish workgroup to review issues associated with services & supports provided through state-funded supportive housing; provides for membership & staff of workgroup; requires workgroup to prepare recommendations; requires inclusion of recommendations in state plan. Effective Date: Upon becoming law.

Read the second time on March 19, 2002

CS/CS/SB 2012 (3R) by the Committees on Judiciary, Children and Families and Senator Peaden—

Child Support; authorizes DOR to adopt rules for administrative proceedings to establish child-support obligations; revises pilot program for administrative establishment of child-support obligations; provides for withholding of specified portion of noncustodial parent's unemployment compensation; authorizes Administrative Hearings Division to render income deduction order, etc. Amends 120.80, 409.2557, .2563. Effective Date: Upon becoming law.

Read the second time and amended on March 19, 2002

*Similar to **HB 1689 (HC)** in Messages*

HB 2011 (3R) by the Fiscal Responsibility Council, Representative Dockery and others—

Florida Lottery; provides rules for allocation of lottery revenues & expenditure of funds for public education. Amends 24.121. Effective Date: 07/01/2002.

*Substituted for **CS/SB 1570 (SUB)** (Burt) and read the second time on March 19, 2002*

SB 412 (3R) by the Committee on Health, Aging and Long-Term Care—

Managed Care Ombudsman Committees; amends provision re district managed care ombudsman committees; requires formation of said committee in each district of AHCA; specifies that committee members serve in voluntary capacity; eliminates authorization for committees to conduct site visits with agency; requires AHCA to adopt rules re conflicts of interest for committees; amends provision re immunity from liability & limitation on testimony for said committees, etc. Amends Ch. 641. Effective Date: 07/01/2002.

Read the second time on March 19, 2002

HB 285 (3R) by the Committee on State Administration (SGC) and Representative Brummer—

Public Record/Victim & Witness Info.; amends provision which provides exemption from public records requirements for certain information re victim or witness who has been identified or certified for protective services or relocation services; reenacts such exemption & removes October 2, 2002, repeal thereof scheduled under OGS Act of 1995; clarifies language. Amends 914.27. Effective Date: 10/01/2002.

*Substituted for **SB 394 (SUB)** (Crist) and read the second time on March 19, 2002*

CS/CS/SB 990 (3R) by the Committees on Appropriations, Regulated Industries and Senator Campbell—

Business Regulation; provides for annual rather than biannual inspections of transient & nontransient apartments; revises requirements for testing & certification of food service managers; requires that elevator service maintenance contracts be made available to DBPR upon request for oversight purposes; requires Board of Accountancy to require, by rule, licensees to undergo periodic peer review as condition of license renewal, etc. Amends Chs. 399, 471, 473, 509. Effective Date: Upon becoming law.

Read the second time and amended on March 19, 2002

CS/SB 1262 (3R) by the Committee on Health, Aging and Long-Term Care and Senator Brown-Waite—

Public Health Emergency; revises rulemaking authority of Health Dept. re its power to impose quarantine, including requiring vaccination; specifies terms under which public health emergency is declared; provides for consultation for, notice, & duration of declaration of public health emergency; provides immunity from civil damages under Good Samaritan Act for actions taken in response to situations during declared emergency, etc. Amends 381.0011, .00315, 768.13. Effective Date: Upon becoming law.

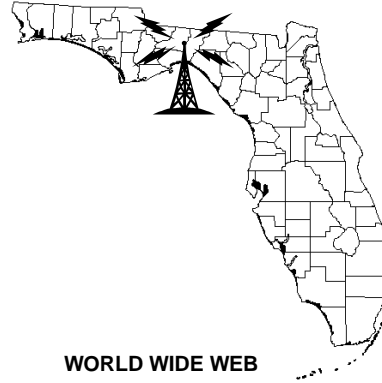
