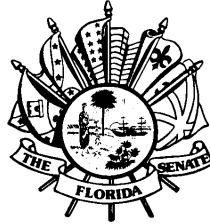

GENERAL BILLS

HB 1943 (3R) by the Fiscal Responsibility Council, Representative Lacasa and others—

Appropriations; provides moneys for annual period beginning July 1, 2002, & ending June 30, 2003, to pay salaries, & other expenses, capital outlay - buildings, & other improvements, & for other specified purposes of various agencies of State government. Effective Date: 07/01/2002 or upon becoming law.

*Substituted for **SB 2500 (SUB)** (Appropriations), read the second time and amended on March 18, 2002*

SB 2502 (3R) by the Committee on Appropriations—

Appropriations Implementing Bill; increases percentage of funds from financial aid fee to be used for need-based financial aid; prohibits State University System employees from enrolling in tuition-free courses; authorizes CFS Dept. to transfer funding between certain services; provides for additional positions to operate additional prison bed capacity under certain circumstances; provides for use of Emergency Management, Preparedness, & Assistance TF, etc. Amends FS. Effective Date: 07/01/2002 except as otherwise provided.

Read the second time and amended on March 14, 2002

*Compare to **HB 1945 (HC)** in the Committee on Appropriations*

CS/HB 1641 (3R) by the Council for Healthy Communities and Representative Evers—

Law Enforcement; requires Criminal Justice Standards & Training Commission to conduct inquiries of criminal justice training instructors; authorizes physician assistants to examine law enforcement officers as condition of employment; deletes requirement to provide remediation program for certain officers; removes requirement that certain exams be adopted by commission, etc. Amends Ch. 943, 316.640, 790.065. Effective Date: 07/01/2002.

*Substituted for **CS/SB 2288 (SUB)** (Futch), read the second time and amended on March 20, 2002*

CS/SB 1108 (3R) by the Committee on Appropriations and Senator Silver—

Health Care; provides for feasibility study re outsourcing specified functions of Dentistry Board; requires agency to contract for evaluation of Fla. Kidcare program; revises provisions governing purchase of goods & services for Medicaid recipients; revises disproportionate share/financial assistance program for rural hospitals; requires AHCA to conduct pilot program for subacute pediatric transitional care center, etc. Amends Ch. 409, 499.012. Effective Date: 07/01/2002.

Read the second time and amended on March 14, 2002

CS/SB 1116 (3R) by the Committee on Appropriations, Senator Silver and others—

Children & Family Services Dept.; provides for use of funds by department; prescribes specified contract requirement; requires department to operate domestic violence program; specifies amount of funds available for use by department & FDLE; repeals provisions re funding for Prevention of Domestic & Sexual Violence Program; abrogates repeal of community partnership matching grant program; authorizes sale of hospital & provides for use of proceeds, etc. Amends FS. Effective Date: 07/01/2002.

Read the second time on March 14, 2002

CS/CS/SB 1654 (3R) by the Committees on Appropriations, Judiciary and Senator Burt—

Increase of Judges & Justices; increases number of judges in specified judicial circuits; increases number of judges in specified county courts; increases number of judges in specified district courts of appeal; provides for appointment by Governor. Amends 26.031, 34.022, 35.06. Effective Date: 07/01/2002 except as otherwise provided.

Read the second time and amended on March 14, 2002

HB 813 (3R) by Representatives Dockery, Greenstein, Lacasa, Goodlette, Harrington, Atwater, Alexander, Gannon and others—

Everglades Restoration; provides for distribution of proceeds from excise taxes on documents to pay debt service on Everglades restoration bonds; authorizes issuance of said bonds to finance or refinance cost of acquisition & improvement of land, water areas, & related property interests & resources for purpose of implementing Comprehensive Everglades Restoration Plan; provides that certain project components shall be exempt from permit requirements, etc. Amends FS. Effective Date: 07/01/2002 except as otherwise provided.

*Substituted for **CS/SB 684 (SUB)** (Brown-Waite), read the second time and amended on March 15, 2002*

HB 1993 (3R) by the Procedural & Redistricting Council, Representative Byrd and others—

Congressional Districts; amends provision re official census for congressional redistricting & applicable definitions; divides state into congressional districts (plan H062C002); amends provision re contiguity for areas specified for inclusion in one district which are entirely surrounded by other districts; provides for nomination & election of candidates from congressional districts created in 2002, etc. Amends Ch. 8. Effective Date: Contingent.

*Substituted for **CS/SB 594 (SUB)** (Latvala), read the second time and amended on March 19, 2002*

CS/SB 2302 (3R) by the Committee on Finance and Taxation and Senator Pruitt—

Tax Administration; eliminates provisions for temporary exemption certificates; reinstates retroactively sales tax exemption for parent-teacher organizations & parent-teacher associations; replaces definition of term "section 38 property" with express definition of terms "industrial machinery & equipment" & "motion picture & video equipment"; provides for treatment of Indian tribes under Unemployment Compensation Law, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on March 19, 2002

CS/SB 2132 (3R) by the Committee on Governmental Oversight and Productivity and Senator Sanderson—

Florida Retirement System; redefines term "retired state officer or employee" or "retiree"; revises membership requirements of Elected Officers' Class of system to include certain sheriffs & clerks of circuit court; amends provision re employer contributions to Public Employee Optional Retirement Prog.; creates provision re benefits payable under program; authorizes DMS to contract with private company to administer disability benefit program, etc. Amends Chs. 121, 110. Effective Date: 07/01/2002.

Read the second time and amended on March 19, 2002

Similar to CS/HB 807 (HC) in Messages

CS/SB 590 (3R) by the Committee on Governmental Oversight and Productivity—

FRS/Contribution Rates; provides legislative purpose & intent to establish uniform contribution rate system for FRS; provides for establishment of uniform rates; provides allocations to Public Employee Optional Retirement Program accounts; provides for allocations to provide disability coverage for Public Employee Optional Retirement Program participants; provides for contributions for Social Security & for retiree health insurance subsidy, etc. Amends Ch. 121. Effective Date: 06/30/2002 except as otherwise provided.

Read the second time and amended on March 19, 2002

Compare to HB 1973 (HC) in the Committees on Governmental Oversight and Productivity, Appropriations Subcommittee on General Government, and Appropriations

CS/SB 1464 (3R) by the Committee on Comprehensive Planning, Local and Military Affairs and Senator Constantine—

Growth Management; creates Local Government Comprehensive Planning Certification Program to be administered by DCA; provides for rights of affected persons to challenge local government compliance with certification agreements; requires local governments within coastal high-hazard areas to address certain issues in evaluation & appraisal of their comprehensive plans; provides for plan amendment re certain roadways in specified counties, etc. Amends Ch. 163. Effective Date: Upon becoming law.

Read the second time and amended on March 20, 2002

CS/HB 1683 (3R) by the Council for Ready Infrastructure, the Committee on Utilities & Telecommunications (RIC) and Representative Maygarden—

Switched Network Access Rates; revises provisions for Lifeline Assistance Plan service; provides for certification & maintenance of claims by Public Counsel Office; requires certain local exchange telecommunications companies to provide specified materials re plan; requires state agencies to provide such material to affected applicants; revises provisions re caps on rates, etc. Amends 364.10, .163; creates 364.164. Effective Date: Upon becoming law.

Substituted for CS/SB 988 (SUB) (Campbell) and read the second time on March 20, 2002

CS/SB 660 (3R) by the Committee on Governmental Oversight and Productivity and Senator Garcia—

Public Records/Investigatory Records; exempts certain investigatory records of Commission for Independent Education; provides for future review & repeal; provides statement of public necessity. Creates 246.1112. Effective Date: Contingent.

Read the second time and amended on March 20, 2002

CS/CS/HB 1057 (3R) by the Council for Healthy Communities, the Committee on Crime Prevention, Corrections & Safety (HCC), Representatives Simmons, Slosberg and others—

Driving & Boating Under Influence; reduces number of convictions required for felony DUI; requires mandatory placement of ignition interlock device under certain circumstances; revises conditions for conviction in cases of accident, serious bodily injury, or death; reduces number of convictions required for felony BUI; requires person to submit to blood test under certain circumstances; provides for evidence & criteria for involuntary admission & treatment, etc. Amends FS. Effective Date: 07/01/2002.

Substituted for CS/CS/CS/SB 1024 (SUB) (Burt), read the second time and amended on March 20, 2002

CS/SB 2206 (3R) by the Committee on Education, Senator Mitchell and others—

Vocational Rehabilitation; conforms organizational provisions to transfer of Vocational Rehabilitation Div. & Blind Services Div. from LES Dept. to DOE; provides that DOE is designated state agency for implementing federal vocational rehabilitation requirements; requires Vocational Rehabilitation Div. to develop 5-year plan re general vocational rehabilitation programs; provides quality assurance & performance requirements for Voc. Rehab. Div., etc. Amends FS. Effective Date: Upon becoming law.

Read the second time on March 20, 2002

Similar to CS/CS/HB 1825 (HC) in Messages

CS/SB 1428 (3R) by the Committee on Regulated Industries and Senator Garcia—

Real Estate Brokers/Trustees; prescribes additional entities that receive ownership interest in trust property when named trustee; clarifies that specified provision applies to real estate brokers acting as trustees; provides exceptions; revises provisions governing time within which disclaimer of interest in certain property may be made; provides for effect of disclaimer of tenancy-by-entirety property, etc. Amends 475.01, 689.071, .21. Effective Date: Upon becoming law.

Read the second time on March 20, 2002

Similar to CS/HB 29 (HC) in the Committee on Judiciary

CS/SB's 1416, 1884 (3R) by the Committee on Education, Senators Garcia and Wasserman Schultz—

Inspector General's Office/Education; (THIS BILL COMBINES S1416,1884) establishes Inspector General's Office within Commissioner of Education's Office; provides for organization of Inspector General's Office & provides responsibilities; requires Inspector General's Office to conduct, coordinate, or request investigations; provides powers, duties, & responsibilities of office. Amends 229.003,.0073. Effective Date: Upon becoming law.

Read the second time and amended on March 20, 2002

SB 1572 (3R) by Senator Villalobos—

Funds of DOE; eliminates provisions exempting funds held in trust for student organizations from requirements governing deposit & disbursement of funds; eliminates provisions limiting employment period for certain personnel administering grants or projects; authorizes demonstration program to be called Learning Gateway; authorizes demonstration projects in specified counties, etc. Amends 229.085. Effective Date: 01/07/2003.

Read the second time and amended on March 20, 2002

CS/CS/SB 1562 (3R) by the Committees on Governmental Oversight and Productivity, Education and Senator Villalobos—

Public Records & Meetings; provides that claims files of self-insurance programs adopted under this section are exempt from public-disclosure requirements; provides that certain university & college student records as prescribed by university & college board of trustees are exempt from public-disclosure requirements; provides that university & college boards of trustees adopt rules re employee records, etc. Creates 240.213(6); reenacts & amends 240.237,.253. Effective Date: 01/07/2003.

Read the second time and amended on March 20, 2002

CS/SB 1560 (3R) by the Committee on Education and Senator Villalobos—

Adult, Technical, & Community Educ.; revises provisions governing registration of adult students; revises provisions governing funding of adult & technical education programs; revises provisions governing postsecondary student fees; authorizes use of certain fee revenues to provide child care; revises provisions governing Florida Literacy Corps; authorizes demonstration program to be called Learning Gateway; provides for funding, etc. Amends Ch. 239. Effective Date: 01/07/2003.

Read the second time and amended on March 20, 2002

SB 1984 (3R) by Senator Villalobos—

Institutional Assessment TF/DOE; creates said trust fund within DOE; provides for trust fund to be used for operations of Commission for Independent Education; provides for annual carryforward of funds; authorizes commission to establish contingency fund & Student Protection Fund within trust fund; provides for funds in Student Protection Fund to be used to assist students in completing their education under certain circumstances, etc. Creates 246.143. Effective Date: Contingent.

Read the second time and amended on March 20, 2002

CS/SB 2022 (3R) by the Committee on Education and Senator Villalobos—

Independent Postsecondary Education; eliminates references to nonpublic colleges in provisions stating legislative findings & intent; restricts participation in statewide course numbering system to institutions that provide resident instruction; creates Commission for Independent Education within DOE; provides for licensure of institutions; provides requirements for students of foreign medical schools; requires antihazing policies, etc. Amends Ch. 246. Effective Date: 01/07/2003.

Read the second time and amended on March 20, 2002

SB 1540 (3R) by Senator Villalobos—

DOE Reorganization; provides for head of DOE & for its executive director; prescribes powers & duties of State Board of Education; prescribes powers & duties of Education Commissioner; authorizes demonstration program to be called Learning Gateway; authorizes demonstration projects in specified counties; authorizes designated agencies to provide confidential information to such program, etc. Amends 20.15. Effective Date: 01/07/2003.

Read the second time and amended on March 20, 2002

CS/SB 1590 (3R) by the Committee on Education and Senator Villalobos—

Education; eliminates obsolete references to "area" re technical centers operated by school districts; changes term "distance learning" to "distance education"; eliminates obsolete references to State Board of Community Colleges & Board of Regents; authorizes demonstration program to be called Learning Gateway; provides for funding, etc. Amends Chs. 230, 241, 244. Effective Date: 01/07/2003.

Read the second time and amended on March 20, 2002

CS/CS/SB 1586 (3R) by the Committees on Appropriations, Education and Senator Villalobos—

Education Governance; authorizes State Board of Education to adopt rules re child abuse prevention training; provides for said board to adopt rules & procedures re educational benefits provisions for officers & firefighters killed in line of duty; provides that public education is function of state; creates "Education Investment Act"; requires school districts to develop plan for foreign-language curriculum, etc. Amends FS. Effective Date: 01/07/2003 except as otherwise provided.

Read the second time and amended on March 20, 2002

CS/SB 658 (3R) by the Committee on Governmental Oversight and Productivity and Senator Garcia—

Public Records/Community Colleges; expands exemption for university direct-support organizations, including meetings & records of community college direct-support organizations; provides for future review & repeal; provides finding of public necessity. Amends 240.2996. Effective Date: 01/07/2003.

Read the second time on March 20, 2002

CS/SB's 2488, 2314 (3R) by the Committee on Education, Senators Sullivan and Cowin—

Public School Student Progression; (THIS BILL COMBINES S 2488,2314) revises guidelines for allocation of school district remedial & supplemental instruction resources; prescribes content of academic improvement plans; requires parental notification of reading deficiency; prohibits social promotion & provides standards for exemptions from mandatory-retention requirements; authorizes demonstration program to be called Learning Gateway, etc. Amends 232.245. Effective Date: 07/01/2002.

Read the second time and amended on March 20, 2002

CS/SB 1190 (3R) by the Committee on Criminal Justice, Senator Posey and others—

Sheriffs; provides exception from bonding requirements for special deputies in event of certain terrorist acts; revises provisions re submission of budgets by sheriffs. Amends 30.09,.49. Effective Date: 07/01/2002.

Read the second time on March 20, 2002

*Identical to **HB 1427 (HC)** in Messages*

CS/SB 982 (3R) by the Committee on Governmental Oversight and Productivity, Senator Brown-Waite and others—

Public Records/Building Plans; creates public-records exemption for building plans, blueprints, schematic drawings, or diagrams of specified facilities owned or operated by agency; provides for retroactive application to existing records; provides for future review & repeal. Amends 119.07. Effective Date: Upon becoming law.

Read the second time on March 20, 2002

*Similar to **CS/HB 735 (HC)** in Messages*

SB 396 (3R) by the Committee on Criminal Justice—

Public Records/Violent Crime Council; abrogates future repeal of exemptions from public-records & public-meetings requirements which are granted for meetings & records of meetings of Florida Violent Crime & Drug Control Council at which active criminal investigative or intelligence information is discussed. Amends 943.031. Effective Date: 10/01/2002.

Read the second time on March 20, 2002

*Similar to **HB 287 (HC)** in the Committees on Criminal Justice and Rules and Calendar*

CS/CS/SB 438 (3R) by the Committees on Appropriations, Criminal Justice, Senator Brown-Waite and others—

Piracy of Transportation; specifies elements constituting offenses of aggravated aircraft piracy, vessel piracy, ground transport piracy, & aggravated ground transport piracy; specifies offenses constituting offenses of aggravated vessel piracy; provides penalties & definitions; amends provision re offense severity ranking chart of Criminal Punishment Code; conforms provisions to changes made by act. Amends 860.16, 921.0022; creates 860.161,.162. Effective Date: 07/01/2002.

Read the second time and amended on March 20, 2002

CS/CS/CS/HB 519 (3R) by the Council for Lifelong Learning, the Committees on Health & Human Services Appropriations (FRC), Colleges & Universities (LLC), Representatives Murman, Fasano, Green, Harrell and others—

Nursing Shortage Solution Act; amends provision re Nursing Student Loan Forgiveness Program to revise provisions re loan payment; amends provision re Nursing Scholarship Program to revise eligibility provisions; creates Sunshine Workforce Solutions Grant Program; revises provisions re eligibility for licensure by endorsement to practice professional or practical nursing; provides exemption from licensure for nurse licensed in territory of U.S., etc. Amends Ch. 464, 240.4075,.4076. Effective Date: Upon becoming law.

*Substituted for **CS/SB 1618 (SUB)** (Saunders), read the second time and amended on March 20, 2002*

CS/CS/SB 2338 (3R) by the Committees on Commerce and Economic Opportunities, Governmental Oversight and Productivity and Senator Villalobos—

Fla. Minority Business Loan Program; creates Fla. Minority Business Loan Mobilization Program for certain purposes; provides for program administration by DMS; authorizes state agencies to disburse specified amount of contract award to assist certain minority business enterprise vendors in obtaining working capital financing; provides for working capital agreements & lines of credit; provides requirements & limitations, etc. Creates 288.706. Effective Date: 10/01/2002.

Read the second time on March 20, 2002

*Similar to **CS/HB 1323 (HC)** in Messages*

CS/HB 777 (3R) by the Council for Competitive Commerce and Representative Kilmer—

Public Records/Business Information; creates public records exemption for specified business information received under capital investment tax credit program, qualified defense contractors tax refund program, qualified target industry tax refund program; high impact sector performance program, & quick action closing fund program; specifies that exemption does not preclude publication of aggregate data or release of names of qualifying businesses & refund amounts, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

*Substituted for **CS/SB 2430 (SUB)** (Diaz de la Portilla), read the second time and amended on March 20, 2002*

CS/CS/CS/SB 502 (3R) by the Committees on Finance and Taxation, Governmental Oversight and Productivity, Transportation and Senator Sebesta—

Transportation Department; transfers Toll Operations Ofc. to turnpike enterprise; redesignates turnpike district as turnpike enterprise; prohibits DOT from exercising its powers of eminent domain solely to acquire property for business opportunities on Fla. Turnpike; creates "Florida High-Speed Rail Authority Act"; authorizes authority to purchase, lease, exchange, or acquire land, property, or buildings necessary to secure or utilize rights-of-way, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on March 20, 2002

*Compare to **CS/HB 261 (HC)** in Messages*

HB 1977 (3R) by the Committee on Fiscal Policy & Resources (FRC) and Representative Wallace—

Procurement/Competitive Solicitation; specifies manner in which notice of decisions & intended decisions concerning procurement are to be provided; provides procedures applicable to protest of contract solicitation or award; eliminates requirement for annual adjustments of purchasing categories; revises purpose, duties, & functions of DMS; provides that eligible users may purchase from state term contracts, etc. Amends FS. Effective Date: 07/01/2002.

*Substituted for **CS/SB 1132 (SUB)** (Garcia) and read the second time on March 20, 2002*

CS/HB 1673 (3R) by the Council for Smarter Government, the Committee on State Administration (SGC), Representative Brummer and others—

Public Records/SS Numbers; creates exemption from public records requirements for all social security numbers held by agency or its agents, employees, or contractors; provides conditions under which social security numbers may be provided to commercial entity; provides requirements & restrictions re collection & disclosure of such numbers by agency; restricts release of social security numbers contained in official records, etc. Creates 119.072. Effective Date: Upon becoming law.

*Substituted for **CS/CS/SB 1588 (SUB)** (Burt) and read the second time on March 20, 2002*

SB 2454 (3R) by Senator Dyer—

Personal Assistive Mobility Devices; defines term "electric personal assistive mobility device"; provides regulations for said devices. Amends 316.003; creates 316.2068. Effective Date: Upon becoming law.

Read the second time and amended on March 20, 2002

HB 1963 (3R) by the Fiscal Responsibility Council and Representative Johnson—

Fla. Coastal Management Program; transfers all powers, duties, & functions of said program from Community Affairs Dept. to DEP. Amends 380.205, .24, .285. Effective Date: 07/01/2002.

*Substituted for **CS/SB 1064 (SUB)** (Brown-Waite) and read the second time on March 20, 2002*

CS/HB 1679 (3R) by the Council for Smarter Government, the Committee on State Administration (SGC) and Representative Brummer—

Study Committee on Public Records; creates said committee; amends provision re electronic access to official records to revise declared state purpose re such access; provides that county recorders may not place images or copies of specified public records on publicly available Internet website for general public display; provides certain notice requirements & requires publication of notice by county recorders & clerks of court, etc. Amends 28.2221. Effective Date: Upon becoming law.

*Substituted for **CS/CS/SB 668 (SUB)** (Burt) and read the second time on March 20, 2002*

CS/SB 1186 (3R) by the Committee on Appropriations, Senator Clary and others—

Economic Development; provides for levy of infrastructure sales surtax & school capital outlay surtax by two-thirds vote & requires certain educational facility planning prior to levy of school capital outlay surtax; provides for additional uses of moneys in Rural Infrastructure Fund; revises terminology re certain incentive payment schedules, etc. Amends FS Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on March 20, 2002

*Similar to **HB 743 (HC)** in Messages and similar to **CS/CS/HB 779 (HC)** in Messages*

CS/SB 1844 (3R) by the Committee on Commerce and Economic Opportunities, Senator King and others—

Economic Development; creates Joint Legislative Committee on Tax Exemptions; provides for periodic expiration & review of tax exemptions under certain provision; provides that sales of goods or services that are neither expressly taxable nor expressly exempt from taxation by specified date become taxable; creates "Fla. 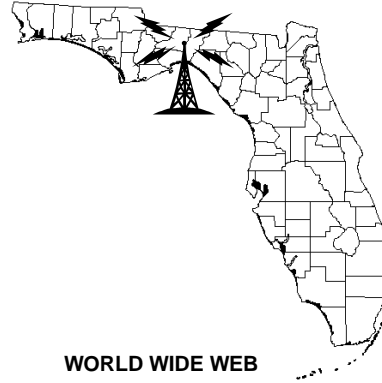
