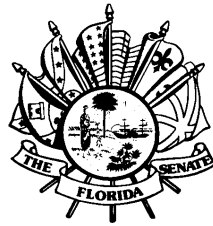

Illegal Use of Nets; revises civil & criminal penalties for use of certain illegal fishing nets; provides civil & criminal penalties for flagrant violations; provides definition; provides for civil penalties for violations of certain statutes considered major violations; reenacts provisions re illegal use of nets, to incorporate amendment in references thereto. Amends 370.021; reenacts 370.092(3) & (4), 370.093. Effective Date: 07/01/2004.

DNA Evidence; extends period following sentencing during which petition may be filed or considered by court to order testing of criminal DNA evidence; provides retroactivity. Amends 925.11. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Judiciary and reported favorably as a committee substitute by the Committee on Criminal Justice and the Committee on Governmental Oversight and Productivity, reports the committee substitute favorably and withdrawn from the Committees on Appropriations Subcommittee on Criminal Justice, Appropriations, and Rules and Calendar

CS/CS/CS/SB 1104 (SO) by the Committees on Appropriations, Comprehensive Planning, Natural Resources and Senator Dockery—

Water Resources; requires local governments to address water supply sources necessary to meet projected water use demand included in comprehensive plans; requires local governments to update work plans for building water supply facilities to incorporate revised regional water supply plans; provides legislative findings & intent re landscape irrigation design, etc. Amends Chs. 163, 373; creates 373.2234. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Natural Resources and reported favorably as a committee substitute by the Committee on Comprehensive Planning and reported favorably as a committee substitute by the Committee on Appropriations Subcommittee on General Government and withdrawn from the Committee on Appropriations with subcommittee recommendation

CS/CS/CS/SB 1624 (SO) by the Committees on Finance and Taxation, Governmental Oversight and Productivity, Banking and Insurance and Senator Sebesta—

Banking Regulation; authorizes Financial Services Commission to require electronic submission of forms, documents, or fees; authorizes commission to prescribe requirements for destroying books, accounts, records, & documents; revises provisions to specify continuing education for certain professions; requires licensure of mortgage brokerage businesses; revises certain fingerprinting requirements, etc. Amends FS. Effective Date: 10/01/2004.

SB 1774 (SO) by Senator Villalobos and others—

Records/Sexual Predators & Offenders; requires that each state or governmental subdivision search records of sexual predators & offenders maintained by FDLE before appointing or employing person to work or volunteer at park, playground, day care center, or other place where children regularly congregate; authorizes use of department's toll-free telephone number or Internet site to conduct search. Effective Date: Upon becoming law.

Reported favorably, with one amendment, by the Committee on Criminal Justice and reported favorably by the Committee on Governmental Oversight and Productivity, and withdrawn from the Committee on Comprehensive Planning

CS/CS/SB 1712 (SO) by the Committees on Appropriations, Agriculture, Senator Argenziano and others—

Agricultural Economic Development; provides cause of action for landowners aggrieved by certain changes to agricultural land use; provides requirements re purchase of lands for which agricultural lease exists; provides for public workshop on development of regional water supply plans that include consideration of population projections; provides for memoranda of agreement re qualification for agricultural related exemptions. Amends FS. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Agriculture and the Committee on Natural Resources reports the committee substitute favorably, with four amendments and withdrawn from the Committee on Regulated Industries and reported favorably as a committee substitute by the Committee on Appropriations Subcommittee on General Government and withdrawn from the Committee on Appropriations with subcommittee recommendation

CS/CS/CS/SB 1748 (SO) by the Committees on Appropriations, Judiciary, Health, Aging, and Long-Term Care, Senator Jones and others—

Multiservice Senior Centers; amends definition; encourages each multiservice senior center to have functioning automated external defibrillator; requires training, maintenance, & location registration; provides immunity from liability under Good Samaritan Act & Cardiac Arrest Survival Act; authorizes Elderly Affairs Dept. to adopt rules; requires dept. to arrange for purchase of such defibrillators, etc. Amends 430.203,.206. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Health, Aging, and Long-Term Care, and reported favorably as a committee substitute by the Committee on Judiciary and reported favorably as a committee substitute by the Committee on Appropriations Subcommittee on Health and Human Services, and withdrawn from the Committee on Appropriations with subcommittee recommendation

CS/SB 1934 (SO) by the Committee on Banking and Insurance, Senator Atwater and others—

State Vehicles/Law Enforcement; provides that term "official state business" shall be construed to permit use of state vehicles by law enforcement officers for going to & from lunch breaks & incidental stops for personal errands; provides for reimbursement for certain off-duty use; provides for rules. Amends 287.17, 284.311. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Banking and Insurance, and the Committee on Appropriations Subcommittee on General Government reports the committee substitute favorably and withdrawn from the Committee on Appropriations with subcommittee recommendation

SB 2714 (SO) by Senator Villalobos—

Radio Transmission; prohibits person from making radio transmission in this state unless person obtains license or exemption from licensure from Federal Communications Commission; prohibits unlicensed radio transmission that interferes with licensed public or commercial radio station; provides criminal penalties, etc. Creates 877.27; amends 16.56. Effective Date: 07/01/2004.

Reported favorably by the Committee on Communication and Public Utilities, and reported favorably by the Committee on Criminal Justice

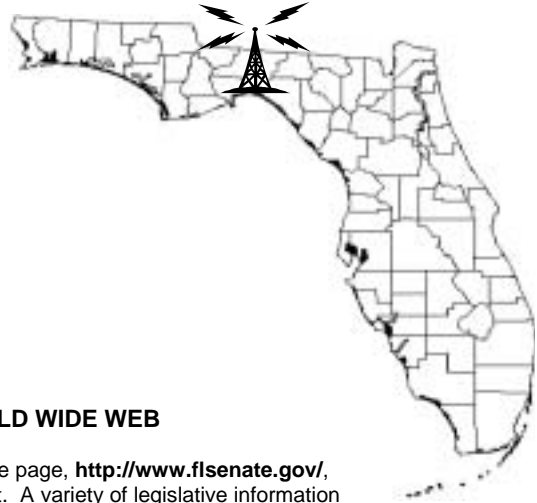
