SB 2714 (SO) by Senator Villalobos-

Radio Transmission; prohibits person from making radio transmission in this state unless person obtains license or exemption from licensure from Federal Communications Commission; prohibits unlicensed radio transmission that interferes with licensed public or commercial radio station; provides criminal penalties, etc. Creates 877.27; amends 16.56. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Appropriations Subcommittee on Transportation and Economic Development, and withdrawn from the Committee on Appropriations with subcommittee recommendation

CS/SB 2736 (SO) by the Committee on Finance and Taxation and Senator Lawson—

Taking of Fish & Shellfish; increases fee for trap number required for commercial crawfish trapping; provides for use of portion of fee; clarifies that crawfish traps are included in trap retrieval program of Fish & Wildlife Conservation Commission; assesses crawfish trap owners retrieval fee assessed other trap owners; provides for waiver of retrieval fee under certain circumstances; provides for use of revenues from retrieval fees, etc. Amends 370.14,.143. Effective Date: 07/01/2004.

CS/SB 2772 (SO) by the Committee on Natural Resources and Senator Clary—

State's Natural Resources; authorizes DEP to use methods established under federal regulations to calculate compensation for damage to state's natural resources; provides that if federal methods are not used, methods currently specified by law remain applicable. Amends 376.121. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Natural Resources and withdrawn from the Committees on Appropriations Subcommittee on General Government and Appropriations

CS/CS/SB 3036 (SO) by the Committees on Appropriations, Education, Senator Carlton and others—

Early Childhood Education; creates Fla. Prekindergarten Education Program; implements s. 1(b) & (c), Art. IX of State Constitution; authorizes parents to enroll their children in program delivered by child development provider, summer program delivered by public school, or school-year program delivered by public school; requires DOE to adopt statewide kindergarten screening; requires certain students to take statewide screening, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Reported favorably as a committee substitute by the Committee on Education and reported favorably as a committee substitute by the Committee on Appropriations Subcommittee on Education and withdrawn from the Committee on Appropriations with subcommittee recommendation

SB 314 (SO) by Senator Campbell and others—

Motor Vehicle Title Certificates; requires HSMV to maintain certain records for 10 years. Amends 319.23. Effective Date: 07/01/2004.

Reported favorably by the Committees on Transportation, Governmental Oversight and Productivity, and Appropriations Subcommittee on Transportation and Economic Development, and withdrawn from the Committee on Appropriations with subcommittee recommendation

Identical to **HB 11 (HC)** in the Committees on Transportation, Governmental Oversight and Productivity, Appropriations Subcommittee on Transportation and Economic Development, and Appropriations

CS/CS/SB 586 (SO) by the Committees on Children and Families, Judiciary and Senator Lynn—

Family Court Efficiency; authorizes Supreme Court to create system to identify cases re individuals & families within court system; provides for modifying court order in subsequent civil proceeding; eliminates provisions giving grandparents equal standing as parents for evaluating custody arrangements; requires CFS Dept. to approve parenting courses; establishes requirements re provision of approved courses, etc. Creates 25.375; amends Chs. 39, 61, 741.30, 409.2579. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Judiciary and reported favorably as a committee substitute by the Committee on Children and Families, and the Committee on Appropriations Subcommittee on Article V Implementation and Judiciary, reports the committee substitute favorably and withdrawn from the Committee on Appropriations with subcommittee recommendation

CS/SB 616 (SO) by the Committee on Governmental Oversight and Productivity and Senator Constantine—

State Retirement Commission; increases size of commission from three to five members; revises quorum requirements of State Retirement Commission. Amends 121.22,.24. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Productivity, and the Committee on Appropriations reports the committee substitute favorably

CS/CS/SB 650 (SO) by the Committees on Governmental Oversight and Productivity, Criminal Justice, Senator Fasano and others—

Law Enforcement Officers/Complaints; provides that all identifiable witnesses be interviewed whenever possible prior to b eginning investigative interview of accused law enforcement officer; requires that complaint & all witness statements be provided to law enforcement officer before beginning investigative interview. Amends 112.532. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Criminal Justice and reported favorably as a committee substitute by the Committee on Governmental Oversight and Productivity

Similar to **HB 431 (HC)** in the Committees on Criminal Justice and Governmental Oversight and Productivity

CS/CS/SB 448 (SO) by the Committees on Criminal Justice, Children and Families, Senator Margolis and others—

Elder Abuse & Neglect; reclassifies offense of aggravated abuse of elderly person or disabled adult from second degree felony to first degree felony; amends provision re ID & investigation of elder abuse training for certified law enforcement officers; provides for establishment of memory disorder clinic at Morton Plant Hospital in Pinellas Co.; provides for Fla. Mental Health Institute in Pinellas Co., etc. Amends 825.102, 921.0022, 430.502. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Home Defense, Public Security, and Ports, and the Committee on Governmental Oversight and Productivity, reports the committee substitute favorably, with two amendments and reported favorably as a committee substitute by the Committee on Criminal Justice and withdrawn from the Committees on Appropriations Subcommittee on Health and Human Services, and Appropriations

CS/SB 694 (SO) by the Committee on Health, Aging, and Long-Term Care and Senator Saunders—

Certified Nursing Assistants; provides that person must pass required background screening as part of certification process for certified nursing assistants; revises requirements for conducting background screening; requires AHCA to post information re background screening in its database; requires that database be available to employers & prospective employers, etc. Amends 464.203, 400.211,.215. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Health, Aging, and Long-Term Care, and the Committee on Criminal Justice reports the committee substitute favorably, with two amendments

CS/CS/SB 1376 (SO) by the Committees on Appropriations, Criminal Justice and Senator Haridopolos—

Habitual Misdemeanor Offenders; provides definitions; specifies alternatives for sentencing habitual misdemeanor offender; provides that such alternatives are imprisonment, commitment, or detention; specifies minimum & maximum time period for such alternatives; provides criminal penalties; limits applicability of sentencing alternatives. Creates 775.0837. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Criminal Justice and reported favorably as a committee substitute by the Committee on Appropriations Subcommittee on Criminal Justice and withdrawn from the Committee on Appropriations with subcommittee recommendation

SB 1684 (SO) by Senator Cowin and others-

DOC Employees/Additional Employment; provides that officer or employee of DOC is not prohibited from accepting other employment or secondary employment under certain conditions. Amends 944.38. Effective Date: Upon becoming law.

Reported favorably by the Committees on Criminal Justice, Governmental Oversight and Productivity, and Appropriations Subcommittee on Criminal Justice and withdrawn from the Committee on Appropriations with subcommittee recommendation

SB 1768 (SO) by Senator Smith-

Possession/Firearms/Felon/Delinquent; includes ammunition among specified items for which possession by felon or delinquent constitutes felony of second degree; provides penalties; includes ammunition among specified items for which possession by violent career criminal subjects such criminal to mandatory minimum prison sentence; amends provision re offense severity ranking chart to conform; provides applicability, etc. Amends 790.001,.23,.235, 921.0022; reenacts 790.01(5). Effective Date: 10/01/2004.

Reported favorably by the Committee on Criminal Justice and withdrawn from the Committees on Appropriations Subcommittee on Criminal Justice and Appropriations

CS/SB 2342 (SO) by the Committee on Natural Resources and Senator Alexander—

Water Mgmt. Districts/Boundaries; revises boundaries of Southwest Florida Water Management District & South Florida Water Management District; provides for transfer of land & other incidentals from SWFWMD to SFWMD; revises membership of governing board of Southwest Florida Water Management District. Amends 373.069,.0691,.073. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Natural Resources and the Committee on Governmental Oversight and Productivity, reports the committee substitute favorably

CS/SB 2696 (SO) by the Committee on Banking and Insurance and Senator Atwater—

Insurance/Public Construction; defines terms; limits authority of certain public agencies to purchase owner-controlled insurance programs for public construction projects; establishes purchase requirements; requires insurers issuing commercial general liability policies to offer coverage for completed operations liability for certain contractors to extent that coverage is not provided under owner-controlled insurance program, etc. Creates 255.0517, 627.441. Effective Date: 10/01/2004.

Reported favorably as a committee substitute by the Committee on Banking and Insurance, and withdrawn from the Committees on Appropriations Subcommittee on General Government and Appropriations
