Water Resources; requires local governments to address water supply sources necessary to meet projected water use demand included in comprehensive plans; requires local governments to update work plans for building water supply facilities to incorporate revised regional water supply plans; provides legislative findings & intent re landscape irrigation design, etc. Amends Chs. 163, 373; creates 373.2234. Effective Date: Upon becoming law.

**Banking Regulation**; authorizes Financial Services Commission to require electronic submission of forms, documents, or fees; authorizes commission to prescribe requirements for destroying books, accounts, records, & documents; revises provisions to specify continuing education for certain professions; requires licensure of mortgage brokerage businesses; revises certain fingerprinting requirements, etc. Amends FS. Effective Date: 10/01/2004.

Read the second time on April 21, 2004

### SB 1774 (3R) by Senator Villalobos and others—

Records/Sexual Predators & Offenders; requires that each state or governmental subdivision search records of sexual predators & sexual offenders maintained by FDLE before appointing or employing person to work or volunteer at park, playground, day care center, or other place where children regularly congregate; authorizes use of department's Internet site to conduct search; provides exception. Effective Date: Upon becoming law.

Read the second time and amended on April 21, 2004

## CS/CS/SB 1712 (3R) by the Committees on Appropriations, Agriculture, Senator Argenziano and others—

Agricultural Economic Development; provides cause of action for landowners aggrieved by certain changes to agricultural land use; provides that large scale comprehensive plan amendment adopted as result of informal mediation may be approved without regard to statutory frequency limits; provides requirements re purchase of lands for which agricultural lease exists; requires WMDs to inform landowners of option for consumptive use permit, etc. Amends FS. Effective Date: 07/01/2004.

## CS/CS/CS/SB 1748 (3R) by the Committees on Appropriations, Judiciary, Health, Aging, and Long-Term Care, Senator Jones and others—

Multiservice Senior Centers; amends definition; encourages each multiservice senior center to have functioning automated external defibrillator; requires training, maintenance, & location registration; provides immunity from liability under Good Samaritan Act & Cardiac Arrest Survival Act; authorizes Elderly Affairs Dept. to adopt rules; requires dept. to arrange for purchase of such defibrillators, etc. Amends 430.203,.206. Effective Date: Upon becoming law.

## CS/SB 1934 (3R) by the Committee on Banking and Insurance, Senator Atwater and others—

State Vehicles/Law Enforcement; provides that term "official state business" shall be construed to permit use of state vehicles by law enforcement officers for going to & from lunch breaks & incidental stops for personal errands; provides for reimbursement for certain off-duty use; provides for rules. Amends 287.17, 284.311. Effective Date: 07/01/2004.

Read the second time on April 21, 2004

### SB 2714 (3R) by Senator Villalobos—

Radio Transmission; prohibits person from making radio transmission in this state unless person obtains license or exemption from licensure from Federal Communications Commission; prohibits unlicensed radio transmission that interferes with licensed public or commercial radio station; provides criminal penalties, etc. Creates 877.27; amends 16.56. Effective Date: 07/01/2004.

## CS/CS/SB 2388 (3R) by the Committees on Appropriations, Education, Senator Pruitt and others—

Community College/Baccalaureate; redesignates specified community colleges to conform to changes made by act; provides requirements for board of trustees of community college authorized to grant baccalaureate degrees; requires that said board of each community college adopt policy ensuring that faculty who teach upper-division courses that are component part of baccalaureate program adhere to specified classroom contact hours as set forth in law, etc. Amends FS. ### CS/CS/SB 2520 (3R) by the Committees on Governmental Oversight and Productivity, Military and Veterans' Affairs, Base Protection, and Spaceports and Senator Jones—

Fla. Wrek-reation Diving Trail Act; provides popular name of Great Florida Wrek-reation Diving Trail Act; creates Florida MARAD & U.S. Navy Vessel Placement Council within Tourism, Trade, & Economic Development Office; provides membership, organization, administrative support, & duties of council; provides that council is subject to public records & public meetings requirements; requires council to request & receive interagency comments, etc. Effective Date: Upon becoming law.

## CS/SB 2646 (3R) by the Committee on Appropriations and Senator Webster—

Trust Funds/Terminations; terminates specified trust funds within Dept. of State, HSMV, & DCA; provides for disposition of balances in & revenues of TFs; abrogates provisions re termination of Welfare Transition TF within Workforce Innovation Agency; provides that certain contributions received in connection with driver's lic. application or motor vehicle registration are not income of revenue nature for purposes of service charge imposed on certain TFs, etc. Amends FS. Effective Date: 07/01/2004.

## CS/SB 2736 (3R) by the Committee on Finance and Taxation and Senator Lawson—

Taking of Fish & Shellfish; increases fee for trap number required for commercial crawfish trapping; provides for use of portion of fee; clarifies that crawfish traps are included in trap retrieval program of Fish & Wildlife Conservation Commission; assesses crawfish trap owners retrieval fee assessed other trap owners; provides for waiver of retrieval fee under certain circumstances; provides for use of revenues from retrieval fees, etc. Amends 370.14,.143. Effective Date: 07/01/2004.

## CS/SB 2772 (3R) by the Committee on Natural Resources and Senator Clary—

State's Natural Resources; designates Ocala Limestone as state rock; designates calcite as state mineral; designates Eocene Heart Urchin as state fossil; authorizes DEP to use methods established under federal regulations to calculate compensation for damage to state's natural resources; provides that if federal methods are not used, methods currently specified by law remain applicable. Amends 376.121; creates 15.0337,.0338,.0339. Effective Date: 07/01/2004.

### CS/CS/SB 3036 (3R) by the Committees on Appropriations, Education, Senator Carlton and others—

Early Childhood Education; creates Fla. Prekindergarten Education Program; implements s. 1(b) & (c), Art. IX of State Constitution; authorizes parents to enroll their children in program delivered by child development provider, summer program delivered by public school, or school-year program delivered by public school; requires DOE to adopt statewide kindergarten screening; requires certain students to take statewide screening, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

## HB 11 (3R) by Representative Adams and others—

**Motor Vehicle Title Certificates**; requires HSMV to maintain certain records for 10 years. Amends 319.23. Effective Date: 07/01/2004.

## CS/CS/SB 586 (3R) by the Committees on Children and Families, Judiciary and Senator Lynn—

Family Court Efficiency; authorizes Supreme Court to create system to identify cases re individuals & families within court system; provides for modifying court order in subsequent civil proceeding; eliminates provisions giving grandparents equal standing as parents for evaluating custody arrangements; requires CFS Dept. to approve parenting courses; establishes requirements re provision of approved courses, etc. Creates 25.375; amends Chs. 39, 61, 741.30, 409.2579. Effective Date: 07/01/2004.

Read the second time and amended on April 21, 2004

## CS/SB 616 (3R) by the Committee on Governmental Oversight and Productivity and Senator Constantine—

State Retirement Commission; increases size of commission from three to five members; revises quorum requirements of State Retirement Commission; provides that, when employee works in another state full time, his or her permanent disability may be certified by physicians licensed in that state. Amends 121.22, 24, 091. Effective Date: 07/01/2004.

Read the second time and amended on April 21, 2004

## HB 431 (3R) by Representative H. Gibson and others—

Law Enforcement Officer/Interview; requires that all identifiable witnesses to complaint against law enforcement officer or correctional officer be interviewed, whenever possible, prior to the investigative interview of accused officer. Amends 112.532. Effective Date: 07/01/2004.

Substituted for **CS/CS/SB 650 (SUB)** (Fasano), read the second time and amended on April 21, 2004

## CS/CS/SB 448 (3R) by the Committees on Criminal Justice, Children and Families, Senator Margolis and others—

Elder Abuse & Neglect; reclassifies offense of aggravated abuse of elderly person or disabled adult from second degree felony to first degree felony; provides that Elderly Affairs Dept. may fund efforts to dispel stereotypes concerning mature residents in this state; provides for establishment of memory disorder clinic at Morton Plant Hospital in Pinellas Co.; provides for Fla. Mental Health Institute in Pinellas Co., etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 21, 2004

### CS/SB 694 (3R) by the Committee on Health, Aging, and Long-Term Care and Senator Saunders—

**Certified Nursing Assistants**; provides that person must pass required background screening as part of certification process for certified nursing assistants; revises requirements for conducting background screening; requires AHCA to post information re background screening in its database; requires that database be available to employers & prospective employers, etc. Amends 464.203, 400.211,.215. Effective Date: Upon becoming law.

Read the second time and amended on April 21, 2004

### CS/CS/SB 1376 (3R) by the Committees on Appropriations, Criminal Justice and Senator Haridopolos—

Habitual Misdemeanor Offenders; provides definitions; specifies alternatives for sentencing habitual misdemeanor offender; provides that such alternatives are imprisonment, commitment, or detention; specifies minimum & maximum time period for such alternatives; provides criminal penalties; limits applicability of sentencing alternatives. Creates 775.0837. Effective Date: Upon becoming law.

### SB 1684 (3R) by Senator Cowin and others—

**DOC Employees/Additional Employment;** provides that officer or employee of DOC is not prohibited from accepting other employment or secondary employment under certain conditions. Amends 944.38. Effective Date: Upon becoming law.

#### SB 1768 (3R) by Senator Smith—

Possession/Firearms/Felon/Delinquent; includes ammunition among specified items for which possession by felon or delinquent constitutes felony of second degree; provides penalties; includes ammunition among specified items for which possession by violent career criminal subjects such criminal to mandatory minimum prison sentence; amends provision re offense severity ranking chart to conform; provides applicability, etc. Amends 790.001,23,235, 921.0022; reenacts 790.01(5). Effective Date: 10/01/2004.

## CS/SB 2342 (3R) by the Committee on Natural Resources and Senator Alexander—

Water Mgmt. Districts/Boundaries; revises boundaries of Southwest Florida Water Management District & South Florida Water Management District; provides for transfer of land & other incidentals from SWFWMD to SFWMD; provides that SWFWMD shall take final agency action on permit applications received before July 1, 2004; provides that on or after July 1, 2004, any matters re such permits shall be regulated by SFWMD, etc. Amends 373.069..0691. Effective Date: 07/01/2004.

## CS/SB 2696 (3R) by the Committee on Banking and Insurance and Senator Atwater—

Insurance/Public Construction; defines terms; limits authority of certain public agencies to purchase owner-controlled insurance programs for public construction projects; establishes purchase requirements; requires insurers issuing commercial general liability policies to offer coverage for completed operations liability for certain contractors to extent that coverage is not provided under owner-controlled insurance program, etc. Creates 255.0517, 627.441. Effective Date: 10/01/2004.

Read the second time and amended on April 21, 2004

### CS/CS/SB 316 (3R) by the Committees on Appropriations, Children and Families and Senator Lynn—

**Substance Abuse/Intervention**; provides additional legislative findings & purposes re treatment of substance abuse; authorizes court to require certain persons to undergo treatment following adjudication; authorizes court to order specified persons to submit to substance abuse assessment upon showing of good cause in connection with shelter hearing or petition for dependency; revises eligibility requirements for participation in pretrial intervention programs, etc. Amends FS. Effective Date: 07/01/2004.

## CS/CS/SB 2822 (3R) by the Committees on Appropriations, Agriculture and Senator Argenziano—

Private Investigative Services; increases minimum age required for certain licensees; revises agency insurance requirements & limits such requirements to security agencies; requires Agric. & Consumer Services Dept. to establish by rule criteria for approval of continuing education courses & providers & form for certificates of completion; provides examination fees for private investigators & private investigator interns, etc. Amends Ch. 493. Effective Date: 07/01/2004.

## CS/SB 218 (3R) by the Committee on Criminal Justice and Senator Crist—

Crimes Against Minors; revises elements of crimes of kidnapping minor child & false imprisonment of minor child; revises elements of crime of luring or enticing minor child for unlawful purpose; requires that, prior to meeting of Parole Commission, victim of crime be given documents & evidence re granting, denying or revoking of inmate's parole, etc. Amends & Reenacts FS. Effective Date: 10/01/2004.

### SB 182 (3R) by Senator Atwater and others—

**Certificates of Need**; exempts certain health-care-related projects involving percutaneous coronary intervention from certificate of need review; provides requirements by which certain hospitals may obtain exemption. Amends 408.036. Effective Date: 07/01/2004.

## CS/SB 262 (3R) by the Committee on Military and Veterans' Affairs, Base Protection, and Spaceports and Senator Fasano—

**Tourism;** revises membership of Florida Commission on Tourism; revises membership of board of directors of Florida Tourism Industry Marketing Corporation, to conform. Amends 288.1223,.1226. Effective Date: Upon becoming law.

### SB 292 (3R) by Senator Lynn—

**Charter Technical Career Centers;** provides guidelines re funding for dual enrollment instruction of public school students provided at Volusia/Flagler Advanced Technology Center. Amends 1002.34. Effective Date: 07/01/2004.

### CS/SB 872 (3R) by the Committee on Appropriations and Senator Peaden—

Welfare Transition Trust Fund; creates said trust fund within Military Affairs Dept.; provides for use of funds & source of funds; provides for review & termination or re-creation of trust fund. Effective Date: 07/01/2004.

## CS/SB 1072 (3R) by the Committee on Commerce, Economic Opportunities, and Consumer Services and Senator Campbell—

Wekiva Parkway & Protection Act; provides legal description of Wekiva Study Area; provides guiding principles for Wekiva Parkway Design Features & Construction; provides that title of all lands acquired for Wekiva Parkway shall vest in State of Fla. or St. Johns River Water Management Dist.; requires DOT to purchase certain lands subject to legislative appropriation; provides for coordination of land use & water supply with Wekiva Study Area, etc. Creates 369.314-.324; amends 163.3184. Effective Date: 07/01/2004.

### CS/CS/CS/CS/SB 1372 (3R) by the Committees on Appropriations, Finance and Taxation, Criminal Justice, Health, Aging, and Long-Term Care and Senator Saunders—

Internet Pharmacies; exempts Internet pharmacies from registration requirements applicable to nonresident pharmacies; prohibits distribution of medicinal drugs by Internet pharmacy without permit; requires Internet pharmacies to be permitted & provides requirements therefor; requires Internet pharmacy & pharmacist designated by that pharmacy to serve as prescription dept. manager or its equivalent to be licensed in state of location, etc. Amends FS, Effective Date: 07/01/2004.


