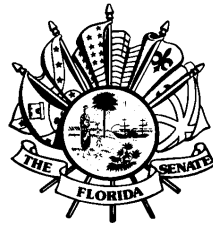

## BILLS ON THE CALENDAR

### BILLS ON THIRD READING

#### **CS/SB 2736 (3R) by the Committee on Finance and Taxation and Senator Lawson—**

**Taking of Fish & Shellfish;** increases fee for trap number required for commercial crawfish trapping; provides for use of portion of fee; clarifies that crawfish traps are included in trap retrieval program of Fish & Wildlife Conservation Commission; assesses crawfish trap owners retrieval fee assessed other trap owners; provides for waiver of retrieval fee under certain circumstances; provides for use of revenues from retrieval fees, etc. Amends 370.14,.143. Effective Date: 07/01/2004.

*Read the second time on April 21, 2004*

---

#### **CS/CS/SB 3036 (3R) by the Committees on Appropriations, Education, Senator Carlton and others—**

**Early Childhood Education;** creates Fla. Prekindergarten Education Program; implements s. 1(b) & (c), Art. IX of State Constitution; authorizes parents to enroll their children in program delivered by child development provider, summer program delivered by public school, or school-year program delivered by public school; requires DOE to adopt statewide kindergarten screening; requires certain students to take statewide screening, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

*Read the second time and amended on April 21, 2004*

---

#### **CS/SB 2342 (3R) by the Committee on Natural Resources and Senator Alexander—**

**Water Mgmt. Districts/Boundaries;** revises boundaries of Southwest Florida Water Management District & South Florida Water Management District; provides for transfer of land & other incidentals from SWFWMD to SFWMD; provides that SWFWMD shall take final agency action on permit applications received before July 1, 2004; provides that on or after July 1, 2004, any matters re such permits shall be regulated by SFWMD, etc. Amends 373.069,.0691. Effective Date: 07/01/2004.

*Read the second time and amended on April 21, 2004*

---

#### **CS/SB 1062 (3R) by the Committee on Health, Aging, and Long-Term Care and Senator Bennett—**

**Health Care Facilities;** authorizes AHCA to issue inactive licenses to nursing homes for all or portion of their beds under certain circumstances; provides that certain entities providing oncology or radiation therapy services are exempt from licensure requirements of specified provisions; requires report by AHCA re licensure of emergency departments located off premises of hospitals; provides for retroactive application, etc. Amends FS. Effective Date: Upon becoming law.

*Read the second time and amended on April 21, 2004*

---

#### **SB 2446 (3R) by Senator Dockery—**

**Ellwood Robinson Pipping, Jr. Act;** creates "Ellwood Robinson 'Bob' Pipping, Jr., Memorial Act"; provides purpose; authorizes DOT to enter into contract with group or organization for installation & maintenance of plaques, markers, monuments, memorials, or various retired military equipment at rest stops; provides for committee to approve proposals for contracts; requires approval by said committee for such contracts; provides conditions for approval, etc. Effective Date: Upon becoming law.

*Read the second time and amended on April 22, 2004*

---

#### **CS/SB 2694 (3R) by the Committee on Appropriations and Senator Pruitt—**

**Lake Okeechobee Protection Program;** provides legislative findings & intent re implementation & funding of Lake Okeechobee Watershed Phosphorus Control Program & Lake Okeechobee Protection Program; provides for implementation & funding of Lake Okeechobee Protection Plan. Amends 373.4595. Effective Date: 07/01/2004.

*Read the second time on April 22, 2004*

---

**CS/CS/CS/SB 478 (3R) by the Committees on Finance and Taxation, Comprehensive Planning, Regulated Industries, Senator Margolis and others—**

**Residential Property/Sale;** requires seller to give notice to prospective purchaser of residential property concerning ad valorem taxes on property; specifies form of notice. Creates 689.261. Effective Date: 10/01/2004.

*Read the second time and amended on April 22, 2004*

---

**CS/SB 2196 (3R) by the Committee on Banking and Insurance and Senator Geller—**

**Insurance Payments/Escrow Accounts;** requires insurer to reinstate, under certain circumstances, insurance policy that is cancelled due to failure of lender to pay premium for which sufficient escrow funds are on deposit; requires that lender reimburse property owner for any penalties or fees paid for purposes of reinstating policy; requires property insurers to reinstate canceled policy as required by specified provision, etc. Amends 501.137, 627.4133. Effective Date: 07/01/2004.

*Read the second time on April 22, 2004*

---

**CS/CS/SB 2372 (3R) by the Committees on Governmental Oversight and Productivity, Health, Aging, and Long-Term Care and Senator Clary—**

**Physical Fitness & Health;** requires Health Department to undertake certain actions to promote healthy lifestyles & body weight; authorizes DOH to adopt rules; provides that act is contingent on appropriation; requires Florida Sports Foundation to allocate certain proceeds from sale of license plates for additional purposes. Amends 320.08058. Effective Date: 07/01/2004.

*Read the second time and amended on April 22, 2004*

---

**CS/CS/SB 2336 (3R) by the Committee on Judiciary and the Committee on Criminal Justice (Haridopolos)—**

**Probation & Community Control;** deletes provisions authorizing DOC to collect certain fees as part of administrative probation; prohibits private entity from providing probation or supervision services to certain offenders; provides for submission of blood or other biological specimens as standard condition of probation; authorizes court to impose special terms & conditions of probation or community control, etc. Amends FS. Effective Date: 07/01/2004.

*Read the second time on April 22, 2004*

---

**CS/SB 2766 (3R) by the Committee on Comprehensive Planning and Senator Constantine—**

**Emergency Planning/Right-to-Know Act;** updates reference to substances listed in Emergency Planning & Community Right-to-Know Act. Amends 252.85. Effective Date: 07/01/2004.

*Read the second time on April 22, 2004*

**CS/SB 2566 (3R) by the Committee on Ethics and Elections and Senator Dockery—**

**Absentee Ballots;** removes requirement that voter's signature on absentee ballot must be witnessed; revises Voter's Certificate & instructions to absent electors to remove requirement of attesting witness; requires that supervisor of elections compare elector's signature to verify registration; amends provision re absentee ballots received from overseas voters, to conform, etc. Amends 101.64,.65,.68,.6921,.6923,.6952,.657. Effective Date: 07/01/2004.

*Read the second time and amended on April 22, 2004*

---

**CS/CS/SB 2430 (3R) by the Committees on Appropriations, Banking and Insurance and Senator Crist—**

**Collection Practices;** requires applicant to apply to Financial Regulation Office to register as commercial collection agency; provides procedures by which said agency may reinstate its registration; provides that out-of-state consumer collection agency otherwise subject to this state's jurisdiction is subject to sanctions for committing prohibited practices; authorizes office to conduct investigations of consumer complaints, etc. Amends Ch. 559. Effective Date: 10/01/2004.

*Read the second time on April 22, 2004*

---

**CS/CS/SB 2428 (3R) by the Committees on Governmental Oversight and Productivity, Banking and Insurance and Senator Crist—**

**Public Records Exemption;** creates exemption from public-records requirements for documents produced during investigation or examination of commercial collection agency or consumer collection agency conducted by Financial Regulation Office; provides for future legislative review & repeal; provides statement of public necessity. Creates 559.5472. Effective Date: Contingent.

---

**CS/CS/SB 206 (3R) by the Committees on Appropriations, Governmental Oversight and Productivity and Senator Fasano—**

**Florida Council on Deafness;** creates said council; provides for appointment of members & organization of council; requires staff of DOE to assist council in its duties; provides role, purpose, powers, duties, & responsibilities of council. Effective Date: Upon becoming law.

*Read the second time on April 22, 2004*

---

**SB 220 (3R) by Senator Crist—**

**Official State Flagship;** designates official state flagship. Creates 15.0465. Effective Date: Upon becoming law.

*Read the second time and amended on April 22, 2004*

---

**SB 1596 (3R) by Senator Smith and others—**

**Frivolous Actions/Filed by Prisoner;** provides that if court finds that prisoner brought frivolous or malicious collateral criminal proceeding that is filed after specified date, prisoner is subject to disciplinary procedures under rules of DOC. Amends 944.279. Effective Date: 10/01/2004.

*Read the second time on April 22, 2004*

---

**SB 2198 (3R) by Senator Saunders—**

**Homestead Exemption/Fraudulent Act;** provides value-based sliding scale of criminal penalties for claiming homestead exemption if funds for homestead were unlawfully obtained through performance of fraudulent act. Amends 196.131. Effective Date: 07/01/2004.

*Read the second time on April 22, 2004*

---

**CS/SB 2088 (3R) by the Committee on Regulated Industries and Senator Bennett—**

**Fire Alarm System Contractors;** provides criminal penalty for installing, servicing, testing, repairing, improving, or inspecting fire alarm system without being in compliance with specified provision. Amends 633.702. Effective Date: 10/01/2004.

*Read the second time on April 22, 2004*

---

**CS/SB 2138 (3R) by the Committee on Health, Aging, and Long-Term Care, Senator Wilson and others—**

**Jessie Trice Cancer Prevention;** expands Jessie Trice Cancer Prevention Program within Health Dept. statewide; deletes references to pilot programs. Amends 381.91. Effective Date: 07/01/2004.

*Read the second time on April 22, 2004*

---

**CS/SB 2562 (3R) by the Committee on Banking and Insurance and Senator Dockery—**

**Money Transmitters;** defines term "unsafe & unsound practice" for purposes of Money Transmitters' Code to include failure to comply with specified provisions of Federal Regulations Code re money & finance; includes business by electronic transfer in business that registrants who sell or issue payment instruments or transmit funds may conduct, etc. Amends 560.103,.109,.114,.129,.208. Effective Date: Upon becoming law.

*Read the second time on April 22, 2004*

---

**CS/SB 2666 (3R) by the Committee on Regulated Industries and Senator Aronberg—**

**Landlords & Tenants;** provides for tenant liability under specific duration rental agreement for liquidated damages under certain circumstances; provides criteria for notice by landlord. Amends 83.575. Effective Date: Upon becoming law.

*Read the second time on April 22, 2004*

---

**SB 1830 (3R) by Senator Smith—**

**Indian Reservation/Criminal Offenses;** specifies that state's jurisdiction over criminal offenses committed within Indian reservations does not apply to Indian reservations of Miccosukee Tribe of Indians of Fla.; provides exception for such reservations re applicability of civil & criminal laws of state; reenacts provision re transfer of land to United States in trust for Seminole & Miccosukee Tribes, to incorporate amendment in references thereto. Amends 285.16; reenacts 285.061(3). Effective Date: Upon becoming law.

*Read the second time on April 22, 2004*

---

**CS/CS/SB 2340 (3R) by the Committees on Appropriations, Governmental Oversight and Productivity and Senator Bennett—**

**Florida Administrative Weekly;** requires forms incorporated by reference to display specified information; requires electronic publication of Florida Administrative Weekly on Internet website managed by Department of State; prescribes content & website search requirements; provides for free public access to such website; provides for training courses for agencies currently publishing materials in Florida Administrative Weekly, etc. Amends 120.55,.551. Effective Date: 07/01/2004 except as otherwise provided.

*Read the second time on April 22, 2004*

---

**SB 534 (3R) by Senator Lynn—**

**Road & Bridge Designations;** designates Browning-Pearce Memorial Highway in St. Johns & Putnam Counties, Jerome A. Williams Memorial Highway in Putnam Co., James C. Penney Memorial Boulevard in Clay Co., C. Fred & Marvin Arrington Bridge in Leon Co., & Howard E. Futch Memorial Highway in Brevard & Osceola Counties; designates St. Johns River Bridge on I-4 at Seminole/Volusia County line as "St. Johns River Veterans Memorial Bridge"; directs DOT to erect suitable markers. Effective Date: Upon becoming law.

*Read the second time and amended on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdraw (April 21, 2004)*

*Compare to **HB 9 (HC)** in the Committee on Transportation*

---

**CS/SB 552 (3R) by the Committee on Transportation, Senator Dawson and others—**

**L. E. Buie Bridge/Riviera Beach;** designates Skypass Bridge in City of Riviera Beach as L. E. Buie Memorial Bridge; directs DOT to erect suitable markers. Effective Date: Upon becoming law.

*Read the second time on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdraw (April 21, 2004)*

---

**CS/SB 630 (3R) by the Committee on Transportation, Senator Argenziano and others—**

**Road & Bridge Designations;** designates bridge located on I-75 at Lake Panasoffkee area exit in Sumter County as "Florida Veterans Memorial Bridge"; directs DOT to erect suitable markers; extends Fla. Arts Trail through Jefferson & Madison Counties; designates Arthur L. Andrews Bridge in Wakulla Co.; designates Forest Ranger Edward O. Peters Memorial Highway in Levy Co.; designates Skypass Bridge in City of Riviera Beach as "L. E. Buie Memorial Bridge". Effective Date: 07/01/2004.

*Read the second time and amended on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdrawn (April 21, 2004)*

**CS/CS/CS/CS/SB 2488 (SO) by the Committees on Appropriations, Finance and Taxation, Governmental Oversight and Productivity, Banking and Insurance and Senator Alexander—**

**Florida Hurricane Catastrophe Fund;** redefines & defines terms; provides for State Board of Administration to specify interest due on delinquent remittances; revises conditions of, amounts of, & procedures re reimbursement contracts; revises maximum rates of, procedures relating to, & types of insurance subject to emergency assessments; revises provisions re reinsurance; deletes expired provisions. Amends 215.555. Effective Date: Upon becoming law except as otherwise provided.

*Reported favorably as a committee substitute by the Committee on Banking and Insurance, and reported favorably as a committee substitute by the Committee on Governmental Oversight and Productivity, and reported favorably as a committee substitute by the Committee on Finance and Taxation, and withdrawn from the Committee on Appropriations Subcommittee on General Government and reported favorably as a committee substitute by the Committee on Appropriations*

**CS/SB 2552 (SO) by the Committee on Criminal Justice and Senator Villalobos—**

**Adjudication of Guilt;** prohibits withholding of adjudication of guilt upon defendants in felony cases in certain circumstances; provides exceptions; provides appellate review in certain circumstances; provides for state's right to appeal withholding of adjudication in certain circumstances; repeals Rule 3.670, Florida Rules of Criminal Procedure, re rendition of judgment, to extent of inconsistency with act, etc. Creates 775.08435; amends 924.07. Effective Date: 07/01/2004 except as otherwise provided.

*Reported favorably as a committee substitute by the Committee on Criminal Justice and the Committee on Judiciary reports the committee substitute favorably and withdrawn from the Committees on Appropriations Subcommittee on Criminal Justice and Appropriations*

*Similar to **HB 869 (HC)** in the Committees on Criminal Justice, Judiciary, Appropriations Subcommittee on Criminal Justice, and Appropriations*

**SB 1792 (SO) by Senator Garcia—**

**Criminal Justice Standards Comm.;** revises membership of Criminal Justice Standards & Training Commission; provides for inspection & copying of certain records; tolling certain time limitations re investigations; authorizes officer who is under investigation, or officer's attorney, to review certain documents re investigation; requires Criminal Justice Professionalism Program within FDLE to review disciplinary penalties imposed against officer, etc. Amends 943.11, 1395. Effective Date: 07/01/2004.

*Reported favorably, with one amendment, by the Committee on Criminal Justice and reported favorably by the Committees on Governmental Oversight and Productivity, and Judiciary*

**CS/CS/CS/SB 708 (SO) by the Committees on Appropriations, Finance and Taxation, Education and Senator Atwater—**

**Local Government Accountability;** revises duties of Legislative Auditing Committee; clarifies that local governments are authorized to provide health insurance; revises definition of "governmental entity" to include counties & district school boards; revises provisions governing notice of bids & disposition of bonds; revises provisions governing issuance of bonds by municipality; revises reporting requirements of newly created special districts, etc. Amends FS. Effective Date: Upon becoming law.

*Reported favorably by the Committee on Comprehensive Planning and reported favorably, with one amendment, by the Committee on Governmental Oversight and Productivity, and reported favorably as a committee substitute by the Committee on Education and reported favorably as a committee substitute by the Committee on Finance and Taxation, and reported favorably as a committee substitute by the Committee on Appropriations Subcommittee on Transportation and Economic Development, and withdrawn from the Committee on Appropriations with subcommittee recommendation*

**SB 1716 (SO) by Senator Carlton—**

**Classroom for Kids Program/Funds;** modifies formula to be used in allocating funds from Classrooms for Kids appropriation. Amends 1013.735. Effective Date: Upon becoming law.

*Reported favorably by the Committees on Education and Appropriations Subcommittee on Education and withdrawn from the Committee on Appropriations with subcommittee recommendation*

**CS/CS/SB 96 (SO) by the Committees on Appropriations, Agriculture and Senator Alexander—**

**Citrus Dept./Fla. Citrus Commission;** requires Citrus Dept. to develop process for persons liable for equalizing excise tax to elect to not pay portion of tax; prohibits dept. from expending any remaining amount of excise tax moneys for advertising, marketing, or public-relations activities; provides for dismissal of certain claims; requires Fla. 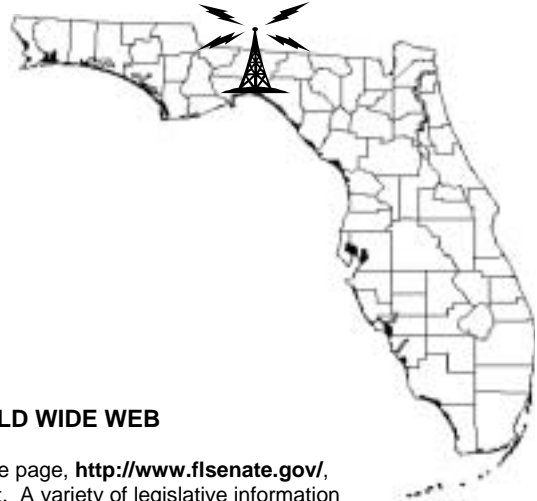
