CS/CS/SB 3036 (3R) by the Committees on Appropriations, Education, Senator Carlton and others—

Early Childhood Education; creates Fla. Prekindergarten Education Program; implements s. 1(b) & (c), Art. IX of State Constitution; authorizes parents to enroll their children in program delivered by child development provider, summer program delivered by public school, or school-year program delivered by public school; requires DOE to adopt statewide kindergarten screening; requires certain students to take statewide screening, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 21, 2004

CS/SB 2342 (3R) by the Committee on Natural Resources and Senator Alexander—

Water Mgmt. Districts/Boundaries; revises boundaries of Southwest Florida Water Management District & South Florida Water Management District; provides for transfer of land & other incidentals from SWFWMD to SFWMD; provides that SWFWMD shall take final agency action on permit applications received before July 1, 2004; provides that on or after July 1, 2004, any matters re such permits shall be regulated by SFWMD, etc. Amends 373.069,.0691. Effective Date: 07/01/2004.

Read the second time and amended on April 21, 2004

CS/CS/CS/CS/SB 2488 (3R) by the Committees on Appropriations, Finance and Taxation, Governmental Oversight and Productivity, Banking and Insurance and Senator Alexander—

Florida Hurricane Catastrophe Fund; redefines & defines terms; provides for State Board of Administration to specify interest due on delinquent remittances; revises conditions of, amounts of, & procedures re reimbursement contracts; revises maximum rates of, procedures relating to, & types of insurance subject to emergency assessments; requires insurers to make rate filing or certification for policies covered under act, etc. Amends 215.555. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 23, 2004

HB 869 (3R) by Representative Gelber and others—

Adjudication of Guilt; prohibits withholding of adjudication of guilt upon defendants in felony cases in certain circumstances; provides exceptions; provides appellate review in certain circumstances; provides for state's right to appeal withholding of adjudication in certain circumstances; repeals Rule 3.670, Florida Rules of Criminal Procedure, re rendition of judgment, to extent of inconsistency with act, etc. Creates 775.08435; amends 924.07. Effective Date: 07/01/2004 except as otherwise provided.

SB 1792 (3R) by Senator Garcia—

Criminal Justice Standards Comm.; revises membership of Criminal Justice Standards & Training Commission; provides for inspection & copying of certain records; tolling certain time limitations re investigations; authorizes officer who is under investigation, or officer's attorney, to review certain documents re investigation; requires Criminal Justice Professionalism Program within FDLE to review disciplinary penalties imposed against officer, etc. Amends 943.11,.1395. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/CS/CS/SB 708 (3R) by the Committees on Appropriations, Finance and Taxation, Education and Senator Atwater—

Local Government Accountability; revises duties of Legislative Auditing Committee; specifies requirements for petition for municipal audit; clarifies that local governments are authorized to provide health insurance; revises definition of "governmental entity" to include counties & district school boards; revises provisions governing notice of bids & disposition of bonds; authorizes pilot program to be established by rural health network in Monroe Co., etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2004

SB 1716 (3R) by Senator Carlton—

Classroom for Kids Program/Funds; modifies formula to be used in allocating funds from Classrooms for Kids appropriation. Amends 1013.735. Effective Date: Upon becoming law.

Read the second time on April 23, 2004

CS/CS/SB 96 (3R) by the Committees on Appropriations, Agriculture and Senator Alexander—

Citrus Dept./Fla. Citrus Commission; requires Citrus Dept. to develop process for persons liable for equalizing excise tax to elect to not pay portion of tax; prohibits dept. from expending any remaining amount of excise tax moneys for advertising, marketing, or public-relations activities; provides for dismissal of certain claims; requires Fla. Citrus Commission to include report by internal auditor of dept. as agenda item at each regularly scheduled meeting. Amends 601.155. Effective Date: 07/01/2004.

Read the second time on April 23, 2004

CS/CS/SB 2184 (3R) by the Committees on Appropriations, Education, Senator Miller and others—

Student Achievement; cites act as "Fla. Partnership for Minority & Underrepresented Student Achievement"; provides legislative intent; creates Fla. Partnership for Minority & Underrepresented Student Achievement; provides purposes & duties of partnership; provides duties of DOE & participating partner; provides for funding partnership; authorizes State Board of Education to adopt rules, etc. Creates 1007.35. Effective Date: 07/01/2004.

Read the second time on April 23, 2004

CS/CS/SB 2216 (3R) by the Committees on Appropriations, Health, Aging, and Long-Term Care, Senator Jones and others—

Public Health Care; expands environmental health enforcement authority of DOH; authorizes dept. to issue citations or order payment of fines; provides additional criteria for release of HIV preliminary test results; requires hospitals licensed under specified provisions to implement program offering immunizations against influenza virus & pneumococcal bacteria to all patients who have attained specified age, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time on April 23, 2004

CS/CS/SB 2288 (3R) by the Committees on Judiciary, Banking and Insurance and Senator Clary—

Unclaimed Property; revises criteria for presuming as unclaimed certain bank deposits & funds in financial organizations, funds owing under life insurance policies, funds held by business associations, & property held in safe-deposit box or other safekeeping repository, respectively; provides presumptions for certain unclaimed demand, savings, or checking accounts with more than one beneficiary, etc. Amends Ch. 717, 212.02, 322.142, 395.3025. Effective Date: 10/01/2004.

Read the second time and amended on April 23, 2004

CS/SB 2640 (3R) by the Committee on Children and Families, Senator Villalobos and others—

Parenting Coordination Program; creates parenting coordination program; authorizes court to appoint & discharge parenting coordinator in certain proceedings; provides that communications with parenting coordinator are not confidential except in certain situations; requires court to determine party's financial ability to pay for certain services under certain circumstances; specifies powers & duties of parenting coordinator, etc. Amends 61.046; creates 61.125. Effective Date: 10/01/2004.

Read the second time and amended on April 23, 2004

SB 2810 (3R) by Senator Alexander—

State University Athletic Fees; authorizes fee increase to defray costs of changing competitive divisions; provides that increase may exceed limit on fee increases; limits such increase to not more than \$2 per credit hour; requires that such increase be approved by athletic fee committee; provides that increase may not be included in calculating amount a student receives for certain scholarship programs. Amends 1009.24. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2004

CS/CS/CS/SB 160 (3R) by the Committees on Appropriations, Judiciary, Children and Families and Senator Lynn—

Child Support; redefines term "support order" for purposes of specified provisions, to include order of administrative agency; provides for continuation of support obligation at same amount after emancipation until any arrearage is satisfied; provides for insurance claim data exchange; authorizes insurer to participate in data match system; requires DOR, with assistance of DOC, to identify inmates with child support obligations, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 23, 2004

CS/CS/SB 2826 (3R) by the Committees on Finance and Taxation, Judiciary and Senator Lynn—

Public Records; exempts from public-records requirements certain records obtained by DOR under insurance claim data exchange system; provides for expiration of exemption; provides for future legislative review & repeal; provides findings of public necessity. Amends 409.25661. Effective Date: Contingent.

Read the second time on April 23, 2004

CS/SB 602 (3R) by the Committee on Children and Families, Senator Smith and others—

Children's Advocacy Centers/Funding; imposes additional court cost against persons who plead guilty or nolo contendere to, or who are found guilty of, certain crimes against minors; requires clerk of court to deposit proceeds of court cost into State Treasury for deposit into specified trust fund to be used to fund children's advocacy centers; requires compliance with specified statutory provisions in order for such center to receive certain funding, etc. Creates 938.10; amends 39.3035. Effective Date: 07/01/2004.

CS/SB 606 (3R) by the Committee on Children and Families, Senator Smith and others—

Child Advocacy Trust Fund/CFS Dept.; creates said trust fund within Children & Family Services Dept.; provides for sources of funds & purposes; specifies use of collected funds; requires development of allocation methodology for distributing funds deposited in trust fund; provides for funds to establish children's advocacy centers; provides for future legislative review & termination or re-creation of trust fund. Effective Date: Contingent.

Read the second time on April 23, 2004

CS/SB 1172 (3R) by the Committee on Transportation and Senator Peadar—

License Plates/Service Charges; increases certain service charges for certificates of title & license plates, certain stickers, or registration certificates. Amends 319.32, 320.04. Effective Date: 07/01/2004.

Read the second time on April 23, 2004

CS/CS/SB 1464 (3R) by the Committee on Appropriations and the Committee on Health, Aging, and Long-Term Care (Saunders)—

Patient Safety; creates Florida Patient Safety Corporation, which shall be registered, incorporated, organized, & operated in compliance with specified provision; authorizes corporation to create not-for-profit subsidiaries; requires Patient Safety Center at FSU College of Medicine to study return on investment by hospitals from implementing computerized physician order entry & other information technologies re patient safety, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2004

SB 2718 (3R) by Senator Klein—

Business Corp. Act/Shareholders; clarifies corporate action entitling shareholder to certain appraisal rights & payments for shares; provides requirements, procedures, & limitations on court actions; requires corporate payments under certain circumstances; revises certain notice requirements for dissolved corporations; revises procedure to clarify exemption for certain claims against said corporations being barred, etc. Amends 607.1302, 1407; creates 607.1330; reenacts FS. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2004

CS/SB 2986 (3R) by the Committee on Education and Senator Constantine—

Education Personnel; provides for expunging of criminal history records of applicants for employment at certain schools; requires charter school employees & governing board members to undergo background screening; provides for postsecondary institutions to create educator preparation institutes; provides employment criteria for substitute teachers; requires background screening for certain noninstructional personnel & contractors with school dist., etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2004

CS/SB 1678 (3R) by the Committee on Governmental Oversight and Productivity (Wise)—

Public Records; authorizes petition for order to make public records pertaining to certain investigations by CFS Dept.; provides certain restrictions re electronic recordkeeping systems & proprietary software; provides that reproductions from electronic recordkeeping system of specified documents & records of certain state offices shall be treated as originals for purpose of their admissibility in evidence, etc. Amends FS. Effective Date: 10/01/2004.

Read the second time and amended on April 23, 2004

SB 2016 (3R) by Senator Diaz de la Portilla—

Home Inspection Services; provides for licensure of persons providing home inspection services; provides legislative intent & definitions; creates Florida Home Inspection Advisory Council; provides licensure requirements, including grandfathering provisions; provides exemptions; requires liability insurance; exempts from duty to provide repair cost estimates; provides for reciprocity; provides continuing education requirements, etc. Creates 501.935. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/SB 1970 (3R) by the Committee on Judiciary, Senator Campbell and others—

Mediation Alternatives/Judicial; deletes language re disclosure of specified information made during court-ordered mediation; provides immunity from liability for trainees in Supreme Court's mentorship program; provides immunity from liability for persons serving as mediators in specified circumstances; provides for creation of Mediation Confidentiality & Privilege Act, etc. Amends 44.102.,107.,201, 61.183; creates 44.401-.406. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/SB 2136 (3R) by the Committee on Health, Aging, and Long-Term Care and Senator Saunders—

Emergency Medical Services; requires that recipient of funds from Emergency Medical Services TF return unexpended funds to DOH at end of grant period; authorizes electronic submission of application for certification as emergency medical technician or paramedic; provides requirements for background screening for applicants for initial certification as said technician or paramedic & for renewal of certification, etc. Amends 401.113.,27.,2701; creates 401.27001. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

HB 295 (3R) by Representative Patterson and others—

Fleeing Law Enforcement Officer; provides additional classification for offense of fleeing or attempting to elude law enforcement officer; provides additional classification for offense of aggravated fleeing or eluding; provides & revises criminal penalties for offenses of fleeing or attempting to elude such officer & aggravated fleeing or eluding with serious bodily injury or death, etc. Amends 316.1935, 921.0022; reenacts 318.17(1), 322.61(1)(d). Effective Date: 07/01/2004.

CS/SB 2268 (3R) by the Committee on Banking and Insurance (Posey)—

Workers' Compensation; provides members of limited liability companies similar authority to elect exemption from workers' compensation coverage as corporate officers; provides exceptions for limitations on benefits for mental & nervous injuries; provides for carriers & self-insured employers to verify whether benefit recipients are concurrently listed as employees of employing unit; revises penalties re applications for coverage, etc. Amends Ch. 440, 921.0022. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2004

CS/CS/SB 2270 (3R) by the Committee on Appropriations and the Committee on Banking and Insurance (Posey)—

Workers' Compensation; establishes three tiers of employers eligible for coverage under plan; provides for criteria & rates for each tier; provides legislative intent to create state workers' compensation mutual fund under certain conditions; prohibits insurers from providing coverage to any person who is affiliated person of person who is delinquent in payment of premiums, assessments, penalties, or surcharges owed to plan, etc. Amends 627.311. Effective Date: 07/01/2004 except as otherwise provided.

Read the second time and amended on April 23, 2004

CS/SB 2472 (3R) by the Committee on Criminal Justice and Senator Haridopolos—

Motor Vehicle Speed Competitions; defines "conviction"; specifies that offense applies to motor vehicles; revises penalties for violation of prohibitions against described motor vehicle speed competitions; provides for application of Florida Contraband Forfeiture Act. Amends 316.191. Effective Date: 10/01/2004.

Read the second time on April 23, 2004

CS/CS/SB 1060 (3R) by the Committees on Judiciary, Children and Families, Senator Campbell and others—

Child Support Guidelines; revises certain child care cost guidelines; revises formula for determining child support obligations re child care costs & federal tax credits for child & dependent care expenses; provides for modification of temporary support orders; reenacts specified provisions incorporating amendments to specified provision in references thereto. Amends & reenacts FS. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/CS/SB's 1154, CS/SB 1462 (3R) by the Committees on Appropriations, Health, Aging, and Long-Term Care, Senator Peaden and others—

Health Practitioner Workforce Data; (THIS BILL COMBINES CS/S1154 & CS/1462) creates Fla. Health Care Practitioner Workforce Database within Health Dept.; gives priority in database for information concerning allopathic & osteopathic physicians; revises requirements for updating info submitted by designated health care professionals for licensure & license renewal, etc. Creates 381.03015; amends Chs. 456, 458, 459, 460, 461. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/CS/CS/SB 1680 (3R) by the Committees on Appropriations, Finance and Taxation, Health, Aging, and Long-Term Care, Senator Saunders and others—

Health Care Licensing Procedures Act; amends provisions re health care clinics; provides requirements for licensee that discontinues operation; amends provision re Drug-Free Workplace Act; amends & repeals provision re Birth Center Licensure Act; amends & repeals provisions re Community Substance Abuse & Mental Health Services Act; encourages physicians & patients to discuss end-of-life care & to specify when advance directive be part of patient's medical record, etc. Amends FS. Effective Date: 10/01/2004.

Read the second time and amended on April 23, 2004

SB 1828 (3R) by Senator Smith—

Home-invasion Robbery; provides additional offense classifications & revises penalties for said robbery; provides that it is first degree felony punishable by term of imprisonment not exceeding life imprisonment to commit said robbery in course of which firearm or other deadly weapon is carried; amends provision re Criminal Punishment Code offense severity ranking chart re said robberies, etc. Amends 812.135, 921.0022; reenacts 943.325(1). Effective Date: Upon becoming law.

Read the second time on April 23, 2004

CS/CS/SB 2170 (3R) by the Committees on Appropriations, Health, Aging, and Long-Term Care and Senator Peaden—

Department of Health; requires hospitals to offer immunizations against influenza virus & pneumococcal bacteria to all patients 65 years of age or older during specified time periods, subject to availability of vaccines; requires continuing education concerning domestic violence, HIV & AIDS; requires that pharmacy permit be issued only to person or corporate officers who are 18 years of age or older & of good moral character, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/SB's 2796, CS/SB 1418 (3R) by the Committee on Criminal Justice, the Committee on Agriculture (Argenziano), Senators Sebesta, Aronberg and others—

Animal Cruelty; (THIS BILL COMBINES S2796,CS/S1418) increases certain minimum mandatory fines & periods of incarceration for certain acts of cruelty to animals; provides definition; provides that it is first-degree misdemeanor for person to intentionally drag or fell by tail a bovine animal in organized sports exhibition; provides clarification re techniques or practices that are not prohibited. Amends 828.12,.121. Effective Date: 07/01/2004.

Read the second time on April 23, 2004

CS/CS/SB 2820 (3R) by the Committees on Governmental Oversight and Productivity, Natural Resources and Senator Argenziano—

Fish & Wildlife Conservation Comm.; reorganizes commission; provides responsibilities & duties of executive director; revises administrative structure of commission; authorizes DMS & Executive Office of Governor to establish & approve new sections, subsections, & offices as initiated by commission; provides for employee bonds at request of commission; requires commission to publish Florida Wildlife Magazine, etc. Amends Chs. 20, 370, 372, 403. Effective Date: 07/01/2004.

Read the second time on April 23, 2004

CS/SB 1762 (3R) by the Committee on Health, Aging, and Long-Term Care and Senator Saunders—

Trauma Care; requires hospitals & trauma centers to provide data on moderate-to-severe brain or spinal cord injuries to Health Dept.; revises components for local & regional trauma services system plans; requires that boundaries of trauma regions administered by DOH be coterminous with boundaries of regional domestic security task forces established within FDLE, etc. Amends Ch. 395, 381.74,.745. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/CS/SB 2884 (3R) by the Committees on Appropriations, Education and Senator Carlton—

State Universities; revises eligibility criteria for Fla. Bright Futures Scholarship Program; awards incentive funds to state universities; requires university boards of trustees to provide students with billing statement that reflects true cost of student's education; creates Florida-Scripps Research Compact; creates FSU Center for Performing Arts direct-support organization, etc. Amends 1009.531,.24, 1011.94; creates 1011.901, 1004.63,.451. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/SB 2762 (3R) by the Committee on Criminal Justice and Senator Smith—

Driving Under Influence; provides that previous conviction for offense of driving under influence is sufficient evidence to establish such conviction; provides that such evidence may be rebutted or contradicted. Amends 316.193. Effective Date: 07/01/2004.

Read the second time on April 23, 2004

CS/CS/SB 544 (3R) by the Committees on Governmental Oversight and Productivity, Comprehensive Planning and Senator Bennett—

Local Government Prompt Payment Act; provides short title; revises provisions re timely payment for purchases of construction services; revises deadlines for payment of subcontractors, sub-subcontractors, materialmen, & suppliers on construction contracts for public projects; provides for timely payment for purchases of construction services by public entity; prohibits contract provision that makes payment contingent upon certain conditions, etc. Amends Chs. 218, 255, 725.09, 95.11. Effective Date: 10/01/2004.

Read the second time and amended on April 23, 2004

CS/CS/SB 2698 (3R) by the Committees on Transportation, Banking and Insurance and Senator Atwater—

Auto Fraud Prevention Act of 2004; defines terms "insurance recovery vehicle," "salvage recovery vehicle," & "salvage company"; provides prohibitions on sale of such vehicles; requires affidavit with application for title of used motor vehicles not previously issued certificate of title; revises definition of "total loss"; revises provisions for issuance to insurer of certificate of destruction & certificate of title upon total loss of vehicle, etc. Amends 319.14,.23,.30. Effective Date: Upon becoming law.

Read the second time on April 23, 2004

CS/CS/CS/SB 1184 (3R) by the Committees on Judiciary, Health, Aging, and Long-Term Care, Comprehensive Planning, Senator Campbell and others—

Condominium & Community Association; provides immunity from liability for certain info. provided by associations to prospective purchasers or lienholders under certain circumstances; revises notification & voting procedures re any vote to forego retrofitting of common areas of condominiums & cooperatives with fire sprinkler systems; restricts application of certain amendments restricting owners' rental rights, etc. Amends Ch. 720, 718.111,.112,.503,.110, 768.1325, 719.1055. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

CS/SB 1928 (3R) by the Committee on Commerce, Economic Opportunities, and Consumer Services and Senator Atwater—

Movie Theaters/Recording Devices; provides that person who knowingly operates audiovisual recording function of any device in motion picture theater without express written consent of theater owner commits felony of third degree; provides immunity to theater owner for detaining person in violation of act while awaiting arrival of law enforcement officer; provides exception to immunity, etc. Effective Date: 07/01/2004.

Read the second time and amended on April 23, 2004

HB 221 (3R) by Representative Peterman and others—

Assisting Self-murder; revises element of offense; provides legislative findings; provides definitions; provides criminal penalties; ranks offense of assisting self-murder on offense severity ranking chart of Criminal Punishment Code; reenacts provisions incorporating amendment to specified provision, in reference thereto. Amends 782.08, 921.0022; reenacts 790.065(2)(c). Effective Date: 07/01/2004.

Relief/Bronwen Dodd; provides for relief of Bronwen Dodd; authorizes & directs District School Board of Escambia Co. to compensate Bronwen Dodd for personal injuries that she suffered due to negligence of employee of school board; provides for attorney's fees & costs. Effective Date: Upon becoming law.

CS/SB 16 (3R) by the Committee on Finance and Taxation and Senator Posey—

Relief/Smith/Hughes/Truitt; provides for relief of Debra Smith, Pamela Hughes, Michael Truitt, & Charles Hughes; authorizes & directs Indian River Co. 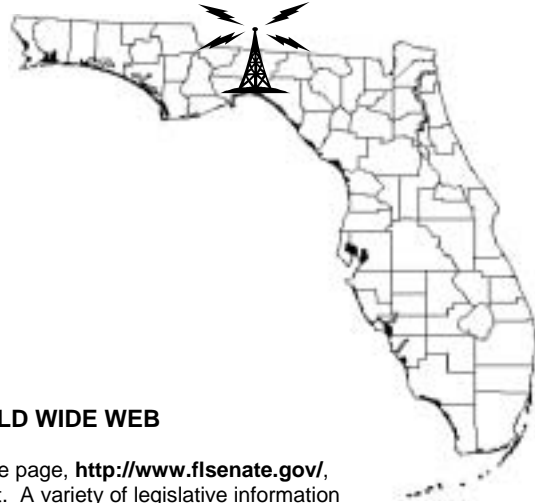
