IX of State Constitution; authorizes parents to enroll their children in program delivered by child development provider, summer program delivered by public school, or school-year program delivered by public school; requires DOE to adopt statewide kindergarten screening; requires certain students to take statewide screening, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

HB 349 (3R) by Representative Barreiro—

Relief/Kelly & Taylor/Hillsborough; provides for relief of Alana Kelly & Richard F. Taylor, Sr.; compensates them for death of their son, Richard F. Taylor, Jr., caused by negligence of Hillsborough County School Board employee; provides for attorney's fees & costs. Effective Date: Upon becoming law.

Substituted for **SB 22 (SUB)** (Hill) and read the second time on April 23, 2004 and read the third time on April 24, 2004

CS/SB 2284 (3R) by the Committee on Criminal Justice, Senator Villalobos and others—

Probation & Community Control; provides additional criteria for mandated participation in substance abuse program; requires that substance abuse treatment be considered a basic support service in release orientation program for certain offenders; requires law enforcement officers to assist probation officers in making warrantless arrests; authorizes DOC to contract for collection of electronic monitoring fees, etc. Amends Chs. 944, 948, 947.22; creates 903.0473. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 26, 2004

CS/SB 2572 (3R) by the Committee on Comprehensive Planning and Senator Garcia—

Airport Zoning/Education Facilities; provides exceptions from certain airport zoning prohibitions for placement of educational facilities in certain counties; amends provisions to conform. Amends 333.03, 1013.36. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

CS/CS/SB 1178 (3R) by the Committees on Appropriations, Health, Aging, and Long-Term Care, Senator Miller and others—

Florida Healthy People 2010 Program; provides for DOH to monitor & report on Florida's status re Healthy People 2010 goals & objectives currently tracked by dept.; requires dept. to work with various groups to educate health care professionals on racial & ethnic issues in health, to recruit & train health care professionals from minority backgrounds, & to promote certain research; defines term "cost-effective", etc. Creates 381.736; amends 409.901,.912. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

SB 2132 (3R) by Senator Argenziano—

Construction Industries Fund; renames Fla. Construction Industries Recovery Fund as Fla. Homeowners' Construction Recovery Fund; declares legislative intent; provides for hearings & for service of notice; provides limit on disbursements re single contract; revises guidelines for making payments from fund; provides criminal penalties for specified fraudulent acts; requires certain information re building permits to be reported to DBPR, etc. Amends Ch. 489, 468.631. Effective Date: 07/01/2004.

CS/CS/CS/SB 2480 (3R) by the Committees on Transportation, Agriculture, Commerce, Economic Opportunities, and Consumer Services, Senator Alexander and others—

Agricultural Equipment Manufacturers; clarifies intent of Agricultural Equipment Manufacturers & Dealers Act to provide for regulation of conduct of manufacturers, distributors, & dealers of equipment primarily designed for or used in agriculture; provides requirements for sale or lease of new equipment; revises criteria for determining whether agricultural equipment qualifies for exemption from maximum width & length limits, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

CS/SB 2654 (3R) by the Committee on Criminal Justice, Senator Jones and others—

Carrying Of Concealed Weapons; prohibits carrying of concealed weapon or firearm within district legislative offices, within Capitol Building & specified surrounding buildings & in certain adjacent areas; provides exemption for secured weapons or firearms in vehicles parked within parking garage attached to any of specified buildings, or in manner designated by Capitol Police. Amends 790.06. Effective Date: 07/01/2004.

CS/CS/SB 2804 (3R) by the Committees on Comprehensive Planning, Natural Resources, Senator Dockery and others—

Florida Greenways & Trails; revises legislative intent re development & completion of Fla. National Scenic Trail; requires private landowner's written authorization to DEP for public access to private land that has been designated part of state's trail system; amends eligibility requirements for appointees of trail-user community to include users of off-road highway vehicles; revises general powers of DEP re greenways & trails, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time on April 26, 2004

HB 1807 (3R) by the Committee on Public Safety & Crime Prevention and others—

Burglary; provides legislative findings & intent; provides for special rules of statutory construction; provides retroactive applicability. Amends 810.015. Effective Date: Upon becoming law.

Substituted for **CS/SB 2856 (SUB)** (Smith) and read the second time on April 26, 2004

SB 2574 (3R) by Senator Garcia and others—

Commercial Relations/Electronic Mail; creates specified provisions re unsolicited commercial electronic mail; prohibits person from initiating or assisting in initiation of unsolicited commercial electronic mail under certain circumstances; provides that provider of Internet access service is not required to undertake certain actions re such mail; authorizes Legal Affairs Dept. to enforce act; provides statute-of-limitations period, etc. Creates 668.60-.6075. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

SB 3010 (3R) by Senator Constantine—

Retired Teachers/Reemployment; authorizes district school boards to reemploy certain retired teachers under certain circumstances; deletes certain reemployment criteria & limitations; provides legislative intent pertaining to funding & implementation; provides that certain reemployment & retirement benefits are available to instructional personnel employed by developmental research schools & Fla. School for Deaf & Blind, etc. Amends 238.181. Effective Date: Upon becoming law.

Read the second time and amended on April 26, 2004

SB 3012 (3R) by Senator Campbell—

Judgment Liens; revises provisions re satisfaction of judgments & decrees; eliminates authority of judges to act under these provisions when there is no clerk of court; revises procedures for acquiring such lien; revises provisions re foreign judgments to apply only to out-of-country foreign judgments; revises provisions re designation of homestead property by owner prior to levy to include foreign judgments, etc. Amends Chs. 55, 56, 222.01, 319.27, 679.1021. Effective Date: Upon becoming law except as otherwise provided.

Read the second time on April 26, 2004

CS/SB 2918 (3R) by the Committee on Governmental Oversight and Productivity and Senator Atwater—

Deaf & Blind School; requires Auditor General to conduct audits of accounts & records of Fla. School for Deaf & Blind; provides that school is component of delivery of public education within Florida's K-20 education system; revises procedure for legislative budget requests of said school; provides duties of Blind Services Div; authorizes division to create blind services direct-support organization, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 26, 2004

CS/SB 538 (3R) by the Committee on Regulated Industries and Senator Lynn—

Stacy Young Act; defines term "amateur sanctioning organization"; provides Fla. State Boxing Commission responsibility for, & authority to adopt rules re approval of said organizations for amateur boxing & kickboxing matches held in state; authorizes commission to adopt by rule, or incorporate by reference into rule, health & safety standards of certain specified boxing & kickboxing organizations, etc. Amends Ch. 548. Effective Date: Upon becoming law.

SB 2532 (3R) by Senator Siplin-

Three Kings Day; designates January 5 as "Three Kings Day". Creates 683.33. Effective Date: 07/01/2004.

CS/CS/SB 546 (3R) by the Committees on Appropriations, Education, Senator Bennett and others—

District School Taxation; authorizes certain expenditures from district school tax revenues to pay insurance premiums; provides for future repeal; amends provision re method of fixing millage, to conform; provides for future repeal. Amends 1011.71, 200.065. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

CS/SB 1900 (3R) by the Committee on Appropriations, Senator Klein and others—

Public Education/State Universities; provides for terms of members appointed to Emerging Technology Commission; provides for filling any vacancy that occurs during term of member of commission; delays expiration of Florida Technology Development Act; creates Florida State University Center for Performing Arts Direct Support Organization; creates Florida-Scripps Research Compact, etc. Amends 1004.225,.55; creates 1004.451,.63. Effective Date: Upon becoming law.

CS/SB 702 (3R) by the Committee on Governmental Oversight and Productivity and Senator Saunders—

Patient Safety Data/Pub. Rec.; provides that information contained in patient safety data or other records maintained by Fla. Patient Safety Corporation & its subsidiaries, advisory committees, or contractors which identifies patient which identifies person or entity reporting patient safety data, or which identifies health care practitioner or health care facility is confidential & exempt from disclosure under public-records requirements, etc. Creates 381.0273. Effective Date: Contingent.

Read the second time and amended on April 26, 2004

CS/SB 2412 (3R) by the Committee on Finance and Taxation, Senator Sebesta and others—

Florida High-Speed Rail Authority; redefines terms "authority" & "high-speed rail system"; revises tax exemption of authority & its agents & contractors; provides for annual redetermination of eligibility for exemption; provides for recapture of taxes when exemption is used inappropriately; provides for rules. Amends 341.8203,.840. Effective Date: 01/01/2005.

Read the second time on April 26, 2004

SB 2420 (3R) by Senator Campbell—

Seniors' Services; authorizes each county to create independent special district to provide funding for seniors' services; requires approval by majority vote of electors to annually levy ad valorem taxes not to exceed certain maximum; clarifies that county may provide seniors' services or create special district to provide such services by general or special law; authorizes county to create dependent special district to provide certain services for seniors, etc. Effective Date: Upon becoming law.

SB 2924 (3R) by Senator Aronberg—

Child Support Disbursements; requires Revenue Dept. to use reasonable efforts to locate persons to whom collections or refunds are owed, including disclosing information on Internet. Amends 409.2558. Effective Date: 07/01/2004.

CS/SB 444 (3R) by the Committee on Governmental Oversight and Productivity, Senator Geller and others—

Abrogating Offensive Place Names; provides legislative findings that certain place names are offensive or derogatory; requires Fla. Historical Commission & Historic Resources Div. to aid state agencies & local governments in identifying geographic sites having offensive or derogatory place names; directs said agencies & governments to identify such sites by specified date; requires state & local governments to update maps & markers with new place names, etc. Creates 267.0625. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

SB 2426 (3R) by Senator Crist—

Electronic Monitoring/Pretrial; requires vendors that provide electronic monitoring services to register certain information with clerk of court; authorizes bail bond agents to contract with government entities to provide electronic monitoring services in certain circumstances; provides specifications for electronic monitoring equipment; authorizes pretrial release subject to electronic monitoring, etc. Amends 648.387, 948.09; creates 903.0472. Effective Date: 10/01/2004.

Read the second time and amended on April 26, 2004

SB 1440 (3R) by Senator Sebesta and others—

Voter Education/High School Seniors; requires district school boards & county supervisors of elections jointly to provide program of voter education for high school seniors; provides guidelines for content of educational program; requires that program of voter education be conducted during school hours. Effective Date: 07/01/2004.

Read the second time on April 26, 2004

CS/CS/SB 1604 (3R) by the Committees on Appropriations, Comprehensive Planning, the Committee on Military and Veterans' Affairs, Base Protection, and Spaceports (Fasano) and others—

Military Affairs; provides for exchange of information re proposed land use decisions between counties & local governments & military installations; provides for future land use plan element of comprehensive plans to include compatibility with military installations; revises certain requirements re scholarships for children of deceased veterans; revises eligibility requirements for military dependents applying for John M. McKay Scholarship, etc. Amends FS. Effective Date: Upon becoming law.

CS/CS/SB 2262 (3R) by the Committees on Education, Children and Families, Senator Smith and others—

Psychotropic Medications/Minors; creates Center for Juvenile Psychotropic Studies within Psychiatry Dept. of College of Medicine of University of Florida; provides purpose of center; creates advisory board; requires center to work with CFS Dept., Juvenile Justice Dept., AHCA, & DOH; requires certain data re dependent minors for whom psychotropic medications have been prescribed to be made available to center, as legally allowed, etc. Amends FS, Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

SB 2754 (3R) by Senator Argenziano-

Construction Contracting; revises provisions re timely payment for purchases of construction services; revises deadlines for payment of subcontractors, sub-subcontractors, materialmen, & suppliers on construction contracts for public projects; provides that certain restrictions in bonds issued for public works projects are unenforceable; revises notice requirement concerning disbursement of payments on construction loans, etc. Amends Chs. 218, 255, 713, 95.11. Effective Date: 10/01/2004.

Read the second time and amended on April 26, 2004

CS/CS/SB 2994 (3R) by the Committees on Appropriations, Banking and Insurance and Senator Posey—

Financial Services Department; authorizes Chief Financial Officer to provide certain services on a fee basis under certain circumstances; revises collateral safekeeping requirements; provides that regulation of certain viatical settlement agreements & providers is within exclusive jurisdiction of Insurance Regulation Office under specified provisions; revises reporting requirements for unclaimed property, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

CS/SB 2548 (3R) by the Committee on Comprehensive Planning and Senator Bennett—

Consolidation & Recordation of Lands; provides for assembly & readjustment of certain land plats; revises requirements of future land use plan elements of required comprehensive plan to address antiquated subdivisions & consolidation of certain properties for certain purposes; includes antiquated subdivisions under certain community redevelopment plan requirements; requires submittal of certain approved plats to certain entities, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on April 26, 2004

CS/CS/SB 1700 (3R) by the Committees on Finance and Taxation, Ethics and Elections, Senator Cowin and others—

Constitutional Amendments; requires Secretary of State to submit certain proposed constitutional amendments to Financial Impact Estimating Conference; requires Attorney General to immediately petition Supreme Court for review of certain financial impact statements; requires said conference to produce financial information statement & summary; prescribes placement of financial impact statement on ballot, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on April 26, 2004

CS/CS/SB 2616 (3R) by the Committees on Criminal Justice, Natural Resources and Senator Atwater—

Water Management District Employees; requires water management districts with structure or facilities identified as critical infrastructure by Regional Security Task Force to conduct fingerprint-based criminal history checks of current or prospective employees & other persons allowed regular access to restricted access areas pursuant to applicable security plans; requires that fingerprints of applicants & employees to be submitted to FDLE & FBI for processing, etc. Creates FS. Effective Date: Upon becoming law.

Read the second time and amended on April 26, 2004

SB 224 (3R) by Senator Crist and others—

Death Sentence; provides that only criminals who were 18 years of age or older at time crime was committed may be sentenced to death; amends specified provision to conform. Creates 921.1415; amends 775.082. Effective Date: Upon becoming law.

Read the second time on April 26, 2004

CS/CS/SB 2026 (3R) by the Committees on Governmental Oversight and Productivity, Regulated Industries and Senator Pruitt—

Professions Regulation/DBPR; revises Management Privatization Act; authorizes DBPR, pursuant to board, commission, or council request, to establish & contract with nonprofit corporation to perform support services specified pursuant to contract for applicable profession; revises requirements for monitoring of continuing education compliance; defines term "third party provider" for purposes of public lodging & public food service establishments, etc. Amends FS. Effective Date: 07/01/2004.

CS/SB 2158 (3R) by the Committee on Governmental Oversight and Productivity and Senator Fasano—

Surplus State-Owned Land/Pub. Rec.; provides time-limited exemption from public records requirements for info. re valuation of surplus state-owned land before associated agreement for purchase, exchange, or disposal is first considered for approval by Board of Trustees of Internal Improvement Trust Fund; authorizes State Lands Div. in DEP to disclose valuation information under certain circumstances, notwithstanding confidentiality requirement, etc. Amends 253.034. Effective Date: 07/01/2004.

Read the second time on April 26, 2004

CS/SB 2054 (3R) by the Committee on Criminal Justice and Senator Campbell—

Sexual Predators & Offenders; amends definition of term "conviction"; provides that offender who has been designated as sexually violent predator under civil commitment proceedings provided in specified provision, meets criteria for designation as sexual predator under Fla. Sexual Predators Act; clarifies circumstances re registration requirements applicable to sexual predators, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time on April 26, 2004

HB 1629 (3R) by Representative Farkas and others—

Affordable Health Care; requires certain licensed facilities to provide public Internet access to certain financial information; requires licensed facilities to make certain patient charge & performance outcome data available on Internet websites; creates Florida Health Insurance Plan for certain purposes; creates Discount Medical Plan Organizations; provides for insurance rebates for healthy lifestyles, etc. Amends FS. Effective Date: 07/01/2004 except as otherwise provided.

Substituted for **CS/CS/CS/SB 2910 (SUB)** (Peaden) and read the second time on April 26, 2004

CS/SB 2060 (3R) by the Committee on Regulated Industries and Senator Smith—

Non-quota Alcoholic Beverage License; authorizes issuance of said license to certain sporting & recreational lodges; requires that serving hours conform to certain local ordinances; provides rulemaking authority. Amends 565.02. Effective Date: 07/01/2004.

Read the second time on April 26, 2004

CS/SB 1074 (3R) by the Committee on Judiciary and Senator Fasano—

Limitation of Action/Sexual Offenses; authorizes prosecution of specified sexual offenses within 1 year after identity of accused is established or should have been established through analysis of DNA evidence, notwithstanding time limitations otherwise prescribed by law; provides for application. Amends 775.15. Effective Date: 07/01/2004.

Read the second time on April 26, 2004

CS/CS/CS/SB 1174 (3R) by the Committees on Governmental Oversight and Productivity, Natural Resources, Comprehensive Planning, Senator Bennett and others—

Planning & Development Study Comm.; creates 2005 Planning & Development Study Commission; provides for its membership & requirements for voting; provides for appointments by Governor, President of Senate, & Speaker of House of Representatives; requires commission to review state's growth management programs & laws & make recommendations; requires public hearings; requires DCA to provide staff support; provides for expiration of commission, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 26, 2004

SB 1592 (3R) by Senator Siplin and others—

FCAT/Parents' Review; authorizes student's parent & accompanying student to review questions & student's answers to those questions on the criterion-referenced portion of Fla. Comprehensive Assessment Test; requires DOE to honor requests within certain time period; delays date by which Commissioner of Education must approve use of specified standardized tests as alternative to grade 10 FCAT, etc. Amends 1008.23,.22, 1003.433; repeals 1008.301. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 26, 2004

CS/SB 1600 (3R) by the Committee on Governmental Oversight and Productivity and Senator Sebesta—

Construction Services/Prompt Payment; revises provisions re timely payment for purchases of construction services; revises deadlines for payment of subcontractors, sub-subcontractors, materialmen, & suppliers on construction contracts for public projects; revises direct contract provision requirement; protects rights of certain persons to enforce certain contract, lien, or bond remedies or constractual obligations under certain circumstances, etc. Amends FS. Effective Date: 10/01/2004.

Read the second time and amended on April 26, 2004

HB 1899 (3R) by the Committee on Judiciary and others—

Construction Defects; provides requirements for filing actions alleging construction defects; requires abatement, upon timely motion, of certain actions filed that do not comply with certain requirements; provides requirements & procedures for making, accepting, or rejecting settlement offers; specifies legal obligation to make certain repairs or monetary payments under certain circumstances; revises certain contract content provisions, etc. Amends Ch. 558. Effective Date: 07/01/2004.

Substituted for **CS/SB 3046 (SUB)** (Bennett) and read the second time on April 26, 2004

CS/SB 540 (3R) by the Committee on Natural Resources and Senator Bennett—

Manatee Protection; creates exception from penalties for activities that are otherwise prohibited if activity is reasonably necessary in order to prevent loss of human life or vessel in distress or to render necessary assistance to persons or vessel in distress; requires Fish & Wildlife Conservation Comm. to implement enhanced manatee protection study; provides goals for said research re decisions based on sound science-based policies, etc. Amends Ch. 370, 372.072. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

CS/SB 560 (3R) by the Committee on Health, Aging, and Long-Term Care and Senator Bennett—

Health Care; provides legislative findings & intent; amends provision re grounds for discipline, penalties, & enforcement applicable to health care practitioners; provides that practitioner's failure to disclose his or her training in health care advertisements & in professional relationships with patients constitutes grounds for disciplinary action; provides exceptions; provides penalties, etc. Amends 456.072. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

SB 2082 (3R) by Senator Aronberg—

Children/Recreation Program/Pub.Rec.; provides exemption from public records requirements for information that would identify or help to locate child who participates in government-sponsored recreation programs or camps or parents or guardians of such child, including, but not limited to, name, home address, telephone number, social security number, & photograph of such child, & names & locations of schools attended by such child, etc. Amends 119.07. Effective Date: Upon becoming law.


