CS/SB 2412 (3R) by the Committee on Finance and Taxation, Senator Sebesta and others—

Florida High-Speed Rail Authority; redefines terms "authority" & "high-speed rail system"; revises tax exemption of authority & its agents & contractors; provides for annual redetermination of eligibility for exemption; provides for recapture of taxes when exemption is used inappropriately; provides for rules. Amends 341.8203,.840. Effective Date: 01/01/2005.

Read the second time on April 26, 2004

CS/CS/CS/SB 1174 (3R) by the Committees on Governmental Oversight and Productivity, Natural Resources, Comprehensive Planning, Senator Bennett and others—

Planning & Development Study Comm.; creates 2005 Planning & Development Study Commission; provides for its membership & requirements for voting; provides for appointments by Governor, President of Senate, & Speaker of House of Representatives; requires commission to review state's growth management programs & laws & make recommendations; requires public hearings; requires DCA to provide staff support; provides for expiration of commission, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 26, 2004, and read the third time on April 27, 2004

CS/CS/SB 2842 (3R) by the Committees on Appropriations, Health, Aging, and Long-Term Care, Senator Atwater and others—

Trauma Care Center Care Services; requires hospitals & trauma centers to provide data on moderate-to-severe brain or spinal cord injuries to DOH; revises requirements for DOH's development of state trauma system plan; provides additional civil penalties for certain traffic infractions; provides penalty for specified violation of traffic control signal devices & for failure to submit to test for impairment or intoxication, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

CS/SB's 244, SB 1566 (3R) by the Committee on Finance and Taxation, Senators Cowin, Webster and others—

Fla. Sales Tax Relief Act; (THIS BILL COMBINES S244,1566) specifies periods during which sale of clothing, wallets, bags, school supplies, & books shall be exempt from such tax; defines terms "clothing," "school supplies," & "books" for purposes of exemption; provides that exemption does not apply to sales within certain theme parks, entertainment complexes, public lodging establishments, or airports; provides for rules by Revenue Dept. Effective Date: Upon becoming law.

Read the second time on April 26, 2004

CS/SB 2302 (3R) by the Committee on Finance and Taxation and Senator Haridopolos—

Communications Services; specifies period during which actual cost of operating substitute communications system is exempt from tax on communications services; creates Government-Owned Communications Study Comm. to review provision of communications services by local govts.; prohibits certain rate changes of PSC from taking effect before specified date, etc. Amends 202.16.,19.,20.,21. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 27, 2004

SB 2922 (3R) by Senator Miller—

Moffitt/Alzheimer's Centers/Pub. Rec; clarifies public records exemption for proprietary confidential business info. owned or controlled by not-for-profit corporation operating H. Lee Moffitt Cancer Center & Research Institute & its subsidiaries re trade secrets; creates public records exemption for proprietary confidential business info. owned or controlled by Fla. Alzheimer's Center & Research Institute; provides statement of public necessity, etc. Amends 1004.43,.445. Effective Date: Upon becoming law.

HB 1751 (3R) by the Committee on Education K-20 and others—

International Certificate of Educ.; adds International Certificate of Education Programs to list of public school choice options & to list of rigorous academic programs included in parent guide; adds Advanced International Certificate of Education programs to acceleration mechanisms requiring postsecondary institution collaboration; revises list of courses designated as advanced level fine arts courses, etc. Amends Ch. 1002, 1007, 1009, 1011; reenacts 1011.69(2). Effective Date: 07/01/2004.

*Substituted for **SB 2968 (SUB)** (Clary), read the second time and amended on April 28, 2004*

CS/CS/CS/SB 1698 (3R) by the Committees on Governmental Oversight and Productivity, Children and Families, Banking and Insurance and Senator Lynn—

Foster Care Services; prohibits certain members of community alliance from receiving funds from CFS Dept. or community-based lead agency; provides additional requirements for eligible lead community-based provider to compete for privatization project; creates provision re education of abused, neglected, & abandoned children; requires agreements between CFS Dept. & district school boards or other local educational entities, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 28, 2004

CS/SB 2448 (3R) by the Committee on Health, Aging, and Long-Term Care and Senator Saunders—

Public Health; authorizes funds from Tobacco Settlement Clearing Trust Fund to be disbursed to Biomedical Research Trust Fund in DOH; establishes Women's Health Strategy Officer & Minority Health Officer in DOH; designates Emergency Medical Services Div. & Community Health Resources as "Division of Emergency Medical Operations"; creates Disability Determinations Div., etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 28, 2004

CS/CS/SB 1456 (3R) by the Committees on Appropriations, Governmental Oversight and Productivity and Senator Sebasta—

Transportation; authorizes secretary of DOT to appoint additional assistant secretary & deputy assistant secretaries or directors; revises planning procedures of metropolitan planning organizations; provides that permit-delegation agreement between DOT & governmental entity does not apply to facilities of electric utilities; amends provisions re Tampa Bay Commuter Rail Authority Act, etc. Amends FS. Effective Date: Upon becoming law.

Read the second time and amended on April 28, 2004

CS/CS/SB 162 (3R) by the Committees on Judiciary, Comprehensive Planning and Senator Bennett—

Land Development Regulations; limits effect of judicial determinations concerning certain development orders pursuant to adopted land development regulations under Local Government Comprehensive Planning & Land Development Regulation Act; provides exception; provides for retroactive application. Amends 163.3167. Effective Date: Upon becoming law.

Read the second time and amended on April 28, 2004

HB 1757 (3R) by the Committee on Education K-20 and others—

Carey Baker Freedom Flag Act; provides popular name; requires flag of U.S. to be displayed in each classroom in public K-20 educational institutions; provides for procurement of flags. Amends 1000.06. Effective Date: 07/01/2004.

HB 679 (3R) by Representative Henriquez and others—

Sales Representatives/Commissions; revises definitions; provides for application to certain persons as well as businesses; includes services as well as products; provides for application to retail as well as wholesale transactions; increases damages under certain actions for compliance; specifies nonapplication to certain licensed persons performing services within scope of their license. Amends 686.201. Effective Date: Upon becoming law.

*Substituted for **CS/SB 1842 (SUB)** (Miller) and read the second time on April 28, 2004*

HB 1121 (3R) by Representative Green and others—

Volunteers/Free Clinics/Health Care; provides qualifications for volunteer, uncompensated services; extends protection of sovereign immunity to free clinics as health care providers; provides for waiver of biennial license renewal fees & fulfillment of portion of continuing education hours for specified health care practitioners who provide services, without compensation, to low-income recipients as agents of governmental contractors, etc. Amends 766.1115, 381.00593. Effective Date: Upon becoming law.

*Substituted for **CS/SB 1374 (SUB)** (Saunders) and read the second time on April 28, 2004*

CS/SB 1226 (3R) by the Committee on Health, Aging, and Long-Term Care (Saunders)—

Long-term-care Service Delivery; requires area agency on aging board under Elderly Affairs Dept. to annually appoint executive director; provides that dept. may take intermediate measures against an area agency on aging if it exceeds its authority or fails to adhere to terms of its contract with dept., adhere to statutory provisions or departmental rules, properly determine client eligibility or manage program budgets, etc. Amends 20.41, 409.912, Ch. 430. Effective Date: Upon becoming law.

Read the second time and amended on April 28, 2004

CS/SB 1588 (3R) by the Committee on Transportation, Senator Constantine and others—

Specialty License Plates; revises requirements for establishing said plate; requires submission of sample plate; increases number of motor vehicle owners who must indicate, according to scientific sample survey, that they intend to purchase proposed specialty plate; requires DOT, in cooperation with local tax collectors & Prison Rehabilitative Industries & Diversified Enterprises, Inc., to study possibility of using direct-to-customer distribution, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 28, 2004

CS/CS/SB 1280 (3R) by the Committees on Appropriations, Children and Families, Senator Peaden and others—

Children & Family Services Dept.; removes developmental disabilities program from said dept.; establishes Agency for Persons with Disabilities for purpose of providing services to persons with developmental disabilities, including institutional services; provides that it is second-degree felony for employee to engage in sexual misconduct with certain developmentally disabled clients, certain mental health patients, or certain forensic clients, etc. Amends FS. Effective Date: 07/01/2004 except as otherwise provided.

Read the second time and amended on April 28, 2004

CS/SB 1782 (3R) by the Committee on Health, Aging, and Long-Term Care and Senator Saunders—

Guardianship; cites act as "Joining Forces for Public Guardianship Act"; provides legislative findings & intent re Joining Forces for Public Guardianship program; provides for administration of program by Statewide Public Guardianship Office; provides eligibility for grant awards; recommends that courts consider appointing guardian advocate for persons with developmental disabilities as less restrictive form of guardianship, etc. Amends FS. Effective Date: 07/01/2004 except as otherwise provided.

Read the second time and amended on April 28, 2004

CS/SB 1820 (3R) by the Committee on Home Defense, Public Security, and Ports (Dockery)—

Seaport Security Standards; provides for legislative review of seaports not in substantial compliance with statewide minimum security standards by November 2005; requires Legislature to review certain security costs; prohibits expenditure of state funds without certification of need by Office of Ports Administrator within FDLE; creates Fla. Institute for Nuclear Detection & Security at Nuclear Engineering & Radiological Sciences, etc. Amends 311.12; creates 1004.63. Effective Date: Upon becoming law.

Read the second time and amended on April 28, 2004

CS/CS/SB 1982 (3R) by the Committees on Finance and Taxation, Communication and Public Utilities and Senator Posey—

Electric Transmission Line Siting; changes short title to "Fla. Electric Transmission Line Siting Act"; revises provisions for applicability, certification, & exemptions under act; requires that application contain starting point & ending point of transmission line specifically defined by applicant & verified by commission; subjects hydrogen fueling stations to fire safety regulations, etc. Amends Ch. 403, 373.441, 633.022. Effective Date: Upon becoming law.

Read the second time on April 28, 2004

CS/CS/SB 2042 (3R) by the Committees on Appropriations, Children and Families, Senator Lynn and others—

Suicide Prevention; creates Statewide Office for Suicide Prevention in Drug Control Office; creates Suicide Prevention Coordinating Council within Drug Control Office; creates interagency workgroup for state agencies within coordinating council in order to coordinate state agency plans for suicide prevention; authorizes coordinating council to seek & accept grants or funds from any source to support its operation, etc. Creates 397.3335, 3336. Effective Date: 07/01/2004.

Read the second time on April 28, 2004

HB 585 (3R) by Representative Benson—

Florida Building Code; requires Florida Building Commission to expedite adoption & implementation of Florida Building Code; requires such adoption pursuant to certain requirements of law; waives application of certain update & amendment requirements & administrative rule provisions. Effective Date: Upon becoming law.

Substituted for CS/CS/SB's 520 & CS/SB 494 (SUB) (Constantine), read the second time and amended on April 28, 2004

CS/CS/SB 2704 (3R) by the Committees on Governmental Oversight and Productivity, Children and Families and Senator Atwater—

Identity of Child/Pub. Rec.; provides that personal identifying information of child or child's parent or guardian held by children's service council, juvenile welfare board, or other entity created under that section or by special law is exempt from requirement that public records be open to inspection & duplication; provides for future repeal & legislative review under Open Government Sunset Review Act of 1995; provides statement of public necessity, etc. Amends 125.901. Effective Date: 07/01/2004.

Read the second time on April 28, 2004

CS/CS/SB 354 (3R) by the Committees on Appropriations, Education, Senator Constantine and others—

Middle Grades Reform Act; creates said act; provides purpose & intent; requires implementation of new or revised reading & language arts courses; provides for implementation of rigorous reading requirement in certain schools; requires study of academic performance of middle grade students & schools with recommendations for increase in performance; requires personalized middle school success plan for certain students, etc. Creates 1003.415; amends 1001.42, 1008.25, 1012.34. Effective Date: Upon becoming law.

Read the second time on April 28, 2004

HB 1127 (3R) by Representative Harrington and others—

Preserving Florida's History; provides additional responsibilities of Historical Resources Div. of Dept. of State re preserving archaeological sites & artifacts; authorizes division to enter into memorandum of agreement with Univ. of West Florida for purposes of network of regional public archaeology centers; creates Discovery of Florida Quincentennial Commemoration Commission within Dept. of State for certain purposes, etc. Amends Ch. 267. Effective Date: Upon becoming law.

Substituted for CS/SB 2246 (SUB) (Carlton) and read the second time on April 28, 2004

CS/SB 1578 (3R) by the Committee on Education and Senator Dawson—

Prescriptions/Medications to Minors; provides that refusal of parent, legal guardian, or other person responsible for child's welfare to administer or consent to administration of psychotropic medication does not by itself constitute grounds for taking child into custody; prohibits unauthorized administration of medication by personnel associated with child care entities; allows such personnel to recommend that medical practitioner evaluate student, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 28, 2004

CS/CS/SB 3006 (3R) by the Committees on Governmental Oversight and Productivity, Ethics and Elections and Senator Cowin—

Public Records/Electronic Filings; creates exemption from public-records requirements for user identification & passwords held by the Department of State pursuant to certain provision; creates exemption from public records requirements for records, reports, & files stored in the electronic filing system pursuant to certain provision; provides for expiration of exemption & for future legislative review & repeal; provides findings of public necessity. Creates 106.0706. Effective Date: Contingent.

Read the second time on April 28, 2004

HB 599 (3R) by Representative Culp and others—

Stolen Property; creates inference that certain persons accepting used property knew or should have known that property was stolen if property conspicuously displays specified information; specifies actions such persons may take to avoid inference; provides exceptions. Amends 812.022. Effective Date: 07/01/2004.

Substituted for CS/CS/SB 1380 (SUB) (Argenziano), read the second time and amended on April 28, 2004

CS/SB 2322 (3R) by the Committee on Comprehensive Planning and Senator Haridopolos—

Communications Services Taxes; provides requirements for dealers making certain sales for resale; clarifies inclusion of certain fees & costs in tax rate; authorizes DOR or dealer to make an adjustment in event of reallocation of revenue away from local government; continues authorization for certain counties to expend moneys derived from "911" fee for nonemergency telecommunications; deletes limitation imposed under pilot project, etc. Amends Ch. 202, 365.171. Effective Date: 07/01/2004 except as otherwise provided.

Read the second time and amended on April 28, 2004

CS/SB 3000 (3R) by the Committee on Education and Senator Diaz de la Portilla—

Charter Schools; revises authorized purposes of charter schools; provides for designation as one charter school of schools in charter school feeder pattern under certain circumstances; clarifies Fla. Building Code & Fla. Fire Prevention Code compliance requirements for charter schools; requires agreement re allocation & use of impact fees; requires study of transportation issues by DOE; corrects name of charter lab school, etc. Amends 1002.33,.32. Effective Date: 07/01/2004.

Read the second time and amended on April 28, 2004

CS/CS/SB 2682 (3R) by the Committees on Commerce, Economic Opportunities, and Consumer Services, Banking and Insurance, Senator Aronberg and others—

Credit Counseling Services; provides definitions; prohibits certain persons from accepting certain fees or costs from debtors under certain circumstances; provides exceptions; provides disclosure & financial reporting requirements for debt management or credit counseling services; provides disbursement of funds requirements; provides civil penalties; provides for awards of attorney's fees & costs, & for criminal penalties, etc. Creates 817.801-.806. Effective Date: 07/01/2004.

Read the second time and amended on April 28, 2004

CS/CS/SB 546 (3R) by the Committees on Appropriations, Education, Senator Bennett and others—

District School Taxation; authorizes certain expenditures from district school tax revenues to pay insurance premiums; provides for future repeal; amends provision re method of fixing millage, to conform; provides for future repeal. Amends 1011.71, 200.065. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

HB 349 (3R) by Representative Barreiro—

Relief/Kelly & Taylor/Hillsborough; provides for relief of Alana Kelly & Richard F. Taylor, Sr.; compensates them for death of their son, Richard F. Taylor, Jr., caused by negligence of Hillsborough County School Board employee; provides for attorney's fees & costs. Effective Date: Upon becoming law.

Substituted for SB 22 (SUB) (Hill) and read the second time on April 23, 2004 and read the third time on April 24, 2004

SB 534 (3R) by Senator Lynn—

Road & Bridge Designations; designates Browning-Pearce Memorial Highway in St. Johns & Putnam Counties, Jerome A. Williams Memorial Highway in Putnam Co., James C. Penney Memorial Boulevard in Clay Co., C. Fred & Marvin Arrington Bridge in Leon Co., & Howard E. Futch Memorial Highway in Brevard & Osceola Counties; designates St. Johns River Bridge on I-4 at Seminole/Volusia County line as "St. Johns River Veterans Memorial Bridge"; directs DOT to erect suitable markers. Effective Date: Upon becoming law.

Read the second time and amended on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdrawn (April 21, 2004)

CS/SB 552 (3R) by the Committee on Transportation, Senator Dawson and others—

L. E. Buie Bridge/Riviera Beach; designates Skypass Bridge in City of Riviera Beach as L. E. Buie Memorial Bridge; directs DOT to erect suitable markers. Effective Date: Upon becoming law.

Read the second time on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdrawn (April 21, 2004)

CS/SB 630 (3R) by the Committee on Transportation, Senator Argenziano and others—

Road & Bridge Designations; designates bridge located on I-75 at Lake Panasoffkee area exit in Sumter County as "Florida Veterans Memorial Bridge"; directs DOT to erect suitable markers; extends Fla. Arts Trail through Jefferson & Madison Counties; designates Arthur L. Andrews Bridge in Wakulla Co.; designates Forest Ranger Edward O. Peters Memorial Highway in Levy Co.; designates Skypass Bridge in City of Riviera Beach as "L. E. Buie Memorial Bridge". Effective Date: 07/01/2004.

Read the second time and amended on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdrawn (April 21, 2004)

CS/SB 2664 (SO) by the Committee on Natural Resources and Senator Smith—

Vessel Safety; provides exception for purposes of law enforcement to provisions requiring display of lighted lamps; provides legislative intent to authorize state & local law enforcement agencies to operate in federally designated safety zones, security zones, regulated navigation areas, & naval vessel protection zones; prohibits entrance to such zone by swimming, diving, wading, or similar means, etc. Amends Ch. 327, 316.217, 901.15. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Natural Resources and the Committee on Home Defense, Public Security, and Ports, reports the committee substitute favorably and the Committee on Criminal Justice reports the committee substitute favorably, with one amendment and withdrawn from the Committees on Appropriations Subcommittee on General Government and Appropriations

Similar to HB 1613 (HC) in Messages

CS/CS/SB 2722 (SO) by the Committees on Appropriations, Governmental Oversight and Productivity and Senator Atwater—

State Financial Matters Management; provides that DMS, rather than agencies acting on their own behalf, can lease space for agencies; authorizes dept. to participate in large-scale leases; specifies permissible lengths for contract terms & renewal & extension periods for certain executive agency contracts re office space, real property, or improvements; amends provision re Fla. Single Audit Act; amends provision re legislative budget requests, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Productivity, and withdrawn from the Committees on Regulated Industries and Appropriations Subcommittee on General Government and reported favorably as a committee substitute by the Committee on Appropriations and withdrawn from the Committee on Rules and Calendar

CS/SB's 2346, SB 516 (SO) by the Committee on Ethics and Elections, Senators Lee, Constantine and others—

Advertising Campaign Exposure Act; (THIS BILL COMBINES S2346,516) cites act as "Florida Advertising Campaign Exposure Act"; redefines terms "political committee," "contribution," "expenditure," "independent expenditure," "communications media," & "political advertisement"; defines term "electioneering communication"; modifies contribution reporting requirements for committees of continuous existence, etc. Amends 106.011,.04,.07,.071,.143; repeals 106.148. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Ethics and Elections, and withdrawn from the Committees on Judiciary and Rules and Calendar

CS/CS/SB 3004 (SO) by the Committees on Judiciary, Ethics and Elections and Senator Cowin—

Elections; provides additional purpose for statewide voter registration applications; provides that electors in line to vote at closing of polls must be allowed to vote; revises guidelines for absentee envelopes; revises provisions re time for contesting election; authorizes political parties to have certain number of at-large poll watchers; requires sworn complaints to Fla. Elections Comm. to be based upon personal knowledge of complainant, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Reported favorably as a committee substitute by the Committee on Ethics and Elections, and reported favorably as a committee substitute by the Committee on Judiciary and withdrawn from the Committees on Appropriations Subcommittee on Transportation and Economic Development, Appropriations, and Rules and Calendar

SM 2818 (SO) by Senator Haridopolos—

Protection From Terrorists/Weapons; requests Congressional Delegation of State of Florida to support President's effort to protect U.S. from terrorists & prevent proliferation of weapons of mass destruction.

Reported favorably, with one amendment, by the Committee on Home Defense, Public Security, and Ports, and withdrawn from the Committee on Rules and Calendar

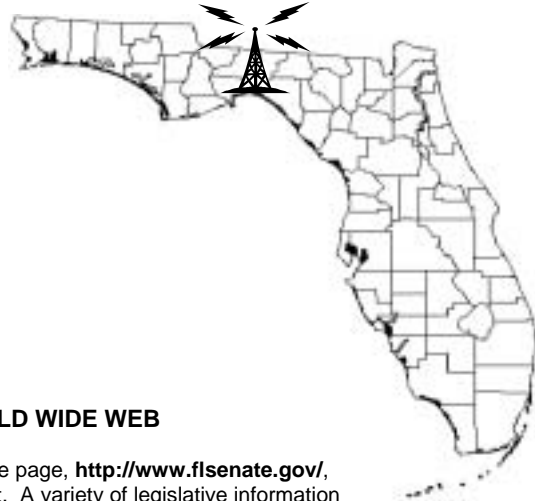
