BILLS ON THE CALENDAR

BILLS ON THIRD READING

CS/SB's 2346, SB 516 (3R) by the Committee on Ethics and Elections, Senators Lee, Constantine and others—

Advertising Campaign Exposure Act; (THIS BILL COMBINES S2346,516) cites act as "Florida Advertising Campaign Exposure Act"; modifies prohibitions on activities of committees of continuous existence; creates exemptions to disclaimer requirements for certain public policy advertisements; provides exceptions to prohibition against making certain contributions or expenditures in connection with campaign or activities of political committee, etc. Amends FS. Effective Date: 07/01/2004 except as otherwise prohibited.

Read the second time and amended on April 29, 2004

CS/SB's 244, SB 1566 (3R) by the Committee on Finance and Taxation, Senators Cowin, Webster and others—

Fla. Sales Tax Relief Act; (THIS BILL COMBINES S244,1566) specifies periods during which sale of clothing, wallets, bags, school supplies, & books shall be exempt from such tax; defines terms "clothing," "school supplies," & "books" for purposes of exemption; provides that exemption does not apply to sales within certain theme parks, entertainment complexes, public lodging establishments, or airports; provides for rules by Revenue Dept. Effective Date: Upon becoming law.

Read the second time on April 26, 2004

Compare to **HB 237 (HC)** in the Committees on Finance and Taxation, Appropriations Subcommittee on General Government, and Appropriations

SB 2922 (3R) by Senator Miller-

Moffitt/Alzheimer's Centers/Pub. Rec; clarifies public records exemption for proprietary confidential business info. owned or controlled by not-for-profit corporation operating H. Lee Moffitt Cancer Center & Research Institute & its subsidiaries re trade secrets; creates public records exemption for proprietary confidential business info. owned or controlled by Fla. Alzheimer's Center & Research Institute; provides statement of public necessity, etc. Amends 1004.43,.445. Effective Date: Upon becoming law.

Read the second time and amended on April 27, 2004

Similar to **HB 147 (HC)** in the Committees on Health, Aging, and Long-Term Care, Governmental Oversight and Productivity, and Rules and Calendar

CS/SB 2412 (3R) by the Committee on Finance and Taxation, Senator Sebesta and others—

Florida High-Speed Rail Authority; redefines terms "authority" & "high-speed rail system"; revises tax exemption of authority & its agents & contractors; provides for annual redetermination of eligibility for exemption; provides for recapture of taxes when exemption is used inappropriately; provides for rules. Amends 341.8203,.840. Effective Date: 01/01/2005.

Read the second time on April 26, 2004

CS/CS/SB 2842 (3R) by the Committees on Appropriations, Health, Aging, and Long-Term Care. Senator Atwater and others—

Trauma Care Center Care Services; requires hospitals & trauma centers to provide data on moderate-to-severe brain or spinal cord injuries to DOH; revises requirements for DOH's development of state trauma system plan; provides additional civil penalties for certain traffic infractions; provides penalty for specified violation of traffic control signal devices & for failure to submit to test for impairment or intoxication, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

CS/SB 2302 (3R) by the Committee on Finance and Taxation and Senator Haridopolos—

Communications Services; specifies period during which actual cost of operating substitute communications system is exempt from tax on communications services; creates
Government-Owned Communications Study Comm. to review provision of communications services by local govts.; prohibits certain rate changes of PSC from taking effect before specified date, etc. Amends 202.16,.19,.20,.21. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 27, 2004

CS/CS/SB 2704 (3R) by the Committees on Governmental Oversight and Productivity, Children and Families and Senator Atwater—

Identity of Child/Pub. Rec.; provides that personal identifying information of child or child's parent or guardian held by children's service council, juvenile welfare board, or other entity created under that section or by special law is exempt from requirement that public records be open to inspection & duplication; provides for future repeal & legislative review under Open Government Sunset Review Act of 1995; provides statement of public necessity, etc. Amends 125.901. Effective Date: 07/01/2004.

Read the second time on April 28, 2004

CS/SB 2322 (3R) by the Committee on Comprehensive Planning and Senator Haridopolos—

Communications Services Taxes; provides requirements for dealers making certain sales for resale; clarifies inclusion of certain fees & costs in tax rate; authorizes DOR or dealer to make an adjustment in event of reallocation of revenue away from local government; continues authorization for certain counties to expend moneys derived from "911" fee for nonemergency telecommunications; deletes limitation imposed under pilot project, etc. Amends Ch. 202, 365.171. Effective Date: 07/01/2004 except as otherwise provided.

Read the second time and amended on April 28, 2004

HB 1613 (3R) by Representative M. Davis and others—

Vessel Safety; provides exception for purposes of law enforcement to provisions requiring display of lighted lamps; revises requirements for reports to FDLE of Fish & Wildlife Conservation Comm. of certain accidents involving vessels; provides legislative intent to authorize state & local law enforcement agencies to operate in federally designated safety zones, security zones, regulated navigation areas, & naval vessel protection zones, etc. Amends FS. Effective Date: Upon becoming law.

Substituted for **CS/SB 2664 (SUB)** (Smith), read the second time and amended on April 29, 2004

HB 769 (3R) by Representative Jennings and others—

Career Education; allows charter technical career center sponsors to submit full-time enrollment membership data as defined in charter agreement; provides for career education certification on high school diploma; requires district school boards to submit guidance reports to Education Commissioner & provides requirements thereof; redesignates adult technical education programs as workforce education programs, etc. Amends FS. Effective Date: 07/01/2004.

Substituted for **CS/SB 1452 (SUB)** (Bennett) and read the second time on April 29, 2004

CS/SB 2326 (3R) by the Committee on Education and Senator Bennett—

Juvenile Justice Education; requires gender-specific programming within Juvenile Justice Dept. for children in this state; increases percentage of Fla. Education Finance Program funding generated by students in juvenile justice programs which must be spent on instructional costs; requires workgroup to suggest strategies for meeting requirements of No Child Left Behind Act & for rewarding such programs for high performance, etc. Amends FS. Effective Date: 07/01/2004.

Read the second time and amended on April 29, 2004

CS/CS/SB 2894 (3R) by the Committees on Health, Aging, and Long-Term Care, Children and Families, Senator Webster and others—

Mental Health & Vocational Rehab; provides for implementation & expansion of program for self-directed mental health & vocational rehabilitation services for adults; authorizes development & implementation of pilot project for children; provides eligibility & other program requirements; provides authority to request certain federal waivers & to request & use certain grants; provides for transfer of certain funds, etc. Amends 394.9084. Effective Date: 07/01/2004.

Read the second time and amended on April 29, 2004

HB 349 (3R) by Representative Barreiro—

Relief/Kelly & Taylor/Hillsborough; provides for relief of Alana Kelly & Richard F. Taylor, Sr.; compensates them for death of their son, Richard F. Taylor, Jr., caused by negligence of Hillsborough County School Board employee; provides for attorney's fees & costs. Effective Date: Upon becoming law.

Substituted for **SB 22 (SUB)** (Hill) and read the second time on April 23, 2004 and read the third time on April 24, 2004

CS/CS/SB 546 (3R) by the Committees on Appropriations, Education, Senator Bennett and others—

District School Taxation; authorizes certain expenditures from district school tax revenues to pay insurance premiums; provides for future repeal; amends provision re method of fixing millage, to conform; provides for future repeal. Amends 1011.71, 200.065. Effective Date: 07/01/2004.

Read the second time and amended on April 26, 2004

SB 534 (3R) by Senator Lynn—

Road & Bridge Designations; designates Browning-Pearce Memorial Highway in St. Johns & Putnam Counties, Jerome A. Williams Memorial Highway in Putnam Co., James C. Penney Memorial Boulevard in Clay Co., C. Fred & Marvin Arrington Bridge in Leon Co., & Howard E. Futch Memorial Highway in Brevard & Osceola Counties; designates St. Johns River Bridge on I-4 at Seminole/Volusia County line as "St. Johns River Veterans Memorial Bridge"; directs DOT to erect suitable markers. Effective Date: Upon becoming law.

Read the second time and amended on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdrawn (April 21, 2004)

CS/SB 552 (3R) by the Committee on Transportation, Senator Dawson and others—

L. E. Buie Bridge/Riviera Beach; designates Skypass Bridge in City of Riviera Beach as L. E. Buie Memorial Bridge; directs DOT to erect suitable markers. Effective Date: Upon becoming law.

Read the second time on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdrawn (April 21, 2004)

CS/SB 630 (3R) by the Committee on Transportation, Senator Argenziano and others—

Road & Bridge Designations; designates bridge located on I-75 at Lake Panasoffkee area exit in Sumter County as "Florida Veterans Memorial Bridge"; directs DOT to erect suitable markers; extends Fla. Arts Trail through Jefferson & Madison Counties; designates Arthur L. Andrews Bridge in Wakulla Co.; designates Forest Ranger Edward O. Peters Memorial Highway in Levy Co.; designates Skypass Bridge in City of Riviera Beach as "L. E. Buie Memorial Bridge". Effective Date: 07/01/2004.

Read the second time and amended on March 25, 2004, referred to Rules and Calendar (April 2, 2004) and withdrawn (April 21, 2004)

SB 2732 (SO) by Senator Smith—

Juvenile Justice System; requires gender-specific programming within Juvenile Justice Dept. for children in this state; requires OPPAGA to conduct analysis of gender-specific programs in department; provides certain gender-specific information to be included in analysis. Amends 985.02. Effective Date: Upon becoming law.

Reported favorably by the Committee on Criminal Justice and withdrawn from the Committees on Governmental Oversight and Productivity, Appropriations Subcommittee on Criminal Justice, and Appropriations

CS/CS/SB 3004 (SO) by the Committees on Judiciary, Ethics and Elections and Senator Cowin—

Elections; provides additional purpose for statewide voter registration applications; provides that electors in line to vote at closing of polls must be allowed to vote; revises guidelines for absentee envelopes; revises provisions re time for contesting election; authorizes political parties to have certain number of at-large poll watchers; requires sworn complaints to Fla. Elections Comm. to be based upon personal knowledge of complainant, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Reported favorably as a committee substitute by the Committee on Ethics and Elections, and reported favorably as acommittee substitute by the Committee on Judiciary and withdrawn from the Committees on Appropriations Subcommittee on Transportation and Economic Development, Appropriations, and Rules and Calendar

CS/CS/SB 2722 (SO) by the Committees on Appropriations, Governmental Oversight and Productivity and Senator Atwater—

State Financial Matters Management; provides that DMS, rather than agencies acting on their own behalf, can lease space for agencies; authorizes dept. to participate in large-scale leases; specifies permissible lengths for contract terms & renewal & extension periods for certain executive agency contracts re office space, real property, or improvements; amends provision re Fla. Single Audit Act; amends provision re legislative budget requests, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Productivity, and withdrawn from the Committees on Regulated Industries and Appropriations Subcommittee on General Government and reported favorably as a committee substitute by the Committee on Appropriations and withdrawn from the Committee on Rules and Calendar

SM 2818 (SO) by Senator Haridopolos—

Protection From Terrorists/Weapons; requests Congressional Delegation of State of Florida to support President's effort to protect U.S. from terrorists & prevent proliferation of weapons of mass destruction.

Reported favorably, with one amendment, by the Committee on Home Defense, Public Security, and Ports, and withdrawn from the Committee on Rules and Calendar

SENATE BILLS ON SECOND READING

SB 38 (2R) by Senator Dawson-

Relief/Kamel & Dimitri/Palm Beach; provides for relief of Ashraf Kamel & Marguerite Dimitri for wrongful death of their minor child, Jean A. Pierre Kamel, as result of negligence of Palm Beach County School Board; provides for payment of court costs. Effective Date: Upon becoming law.

Recommended favorably, with one amendment, by The Special Master on Claim Bills and reported favorably by the Committee on Education

SB 110 (2R) by Senator Bennett-

Water & Wastewater Systems/Rates; authorizes Fla. Public Service Commission to approve rates allowing utilities to recover full costs of alternative water supply facilities; increases limitation on gross annual revenues under which water or wastewater utility may qualify to obtain staff assistance from said commission in changing rates & charges. Amends 367.081,.0814. Effective Date: Upon becoming law.

Reported favorably by the Committee on Communication and Public Utilities, and reported favorably, with one amendment, by the Committee on Governmental Oversight and Productivity

CS/SB 138 (2R) by the Committee on Criminal Justice, Senator Lynn and others—

Theft/Criminal Punishment Code; requires that unattended semitrailer have kingpin locking device attached to semitrailer; provides that failing to provide locking device is noncriminal traffic infraction; provides that unattended semitrailer may be towed under specified conditions; provides that it is unlawful to possess or use fifth wheel to commit or attempt to commit theft, etc. Amends 316.1975, 921.0022; creates 316.526, 812.0147; reenacts 812.014(1) & (2). Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Criminal Justice and withdrawn from the Committees on Appropriations Subcommittee on Criminal Justice and Appropriations

CS/CS/SB 154 (2R) by the Committees on Criminal Justice, Education, Senator Saunders and others—

School Dist. Employees & Contractors; requires background screening, initially & periodically, of charter school employees, contractors & members of governing board, of persons certified under Personnel provisions & of adjunct educators; requires FDLE to search all fingerprint records for arrest records; directs dept. to report arrest record to school district employing person, etc. Amends 1002.33, 1012.32,.56,.57; creates 1012.465. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Education and reported favorably as a committee substitute by the Committee on Criminal Justice and withdrawn from the Committees on Appropriations Subcommittee on Education and Appropriations

CS/SB 174 (2R) by the Committee on Education, Senator Clary and others—

Lottery/Unclaimed Prize Money; provides for deposit of percentage of unclaimed prize money in Educational Enhancement Trust Fund; revises provisions re allocation of revenues for public education; conforms provisions. Amends 24.115,.121, 1010.70. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Education and the Committee on Finance and Taxation, reports the committee substitute favorably and withdrawn from the Committee on Appropriations

Subcommittee on General Government and the Committee on Appropriations reports the committee substitute favorably

CS/CS/SB 288 (2R) by the Committees on Judiciary, Criminal Justice and Senator Lynn—

Right to Speedy Trial; creates time limits within which person charged with crime by information or indictment must be brought to trial; permits state attorneys to file demand for speedy trial; provides conditions that must be met in order to do so; requires that trial judge schedule calendar call upon filing of demand for speedy trial in order to schedule trial; prescribes conditions under which trial court may extend trial date. Creates 918.0151. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Criminal Justice and reported favorably as a committee substitute by the Committee on Judiciary and withdrawn from the Committees on Appropriations Subcommittee on Article V Implementation and Judiciary, and Appropriations

SB 296 (2R) by Senator Fasano—

State Liens/Literary Accts./Felon; provides for definitions concerning sale of literary accounts & memorabilia by & on behalf of convicted felon; provides for lien in favor of state on proceeds or profits of sale of literary accounts, materials, & memorabilia payable to or accruing to convicted felon, representative of such felon, or profiteer of felony; provides for distribution of proceeds or profits of such sale, etc. Amends 944.512, 960.291. Effective Date: 07/01/2004.

Reported favorably by the Committee on Judiciary and reported favorably, with one amendment, by the Committee on Criminal Justice

SB 326 (2R) by Senator Saunders and others-

Culpable Negligence/DUI; provides that it is first-degree misdemeanor for person to commit culpable negligence by driving vehicle under influence of alcohol or drugs while accompanied in vehicle by person younger than specified age. Amends 784.05. Effective Date: 07/01/2004.

Reported favorably by the Committees on Criminal Justice and Judiciary

CS/CS/SB 330 (2R) by the Committees on Finance and Taxation, Comprehensive Planning, Senator Saunders and others—

Community Contribution Tax Credit; requires Tourism, Trade, & Economic Development Office to reserve portions of certain annual tax credits for eligible sponsors of certain low-income housing projects; revises definition to delete provisions authorizing office to reserve certain portions of available annual tax credits for certain low-income housing purposes; increases amount of available annual community contribution tax credits, etc. Amends 212.08, 220.03,.183, 624.5105. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Comprehensive Planning and the Committee on Commerce, Economic Opportunities, and Consumer Services, reports the committee substitute favorably and reported favorably as a committee substitute by the Committee on Finance and Taxation

SM 336 (2R) by Senator Constantine and others—

Sales Tax Deduction/Federal Taxpayer; requests Congress of United States to enact H.R. 720, Sales Tax Equity Act of 2003, which would provide sales-tax deduction for federal taxpayers who reside in states that do not impose state income tax.

Reported favorably by the Committee on Finance and Taxation, and withdrawn from the Committee on Rules and Calendar

CS/SB 344 (2R) by the Committee on Health, Aging, and Long-Term Care and Senator Saunders—

Massage Therapy Regulation; exempts certain settings where massage therapy is rendered from licensure & inspection requirements for massage establishments. Amends 480.034. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Health, Aging, and Long-Term Care, and the Committee on Finance and Taxation, reports the committee substitute favorably

CS/CS/SB 362 (2R) by the Committees on Appropriations, Education and Senator Constantine—

Charter Schools/ Employees/Salaries; requires charter of charter school to contain information concerning salary or salary range of each position in said school & explanation of method used in determining salaries or salary ranges; prohibits charter school employee's salary & benefits from exceeding maximum salary & benefits adopted for equivalent position in dist. school system by district school board in whose district school is located, etc. Amends 1002.33. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Education and the Committee on Governmental Oversight and Productivity, reports the committee substitute favorably and reported favorably as a committee substitute by the Committee on Appropriations Subcommittee on Education and withdrawn from the Committee on Appropriations with subcommittee recommendation and withdrawn from the Committee on Rules and Calendar

CS/SB 366 (2R) by the Committee on Banking and Insurance, Senator Fasano and others—

Residential Property Ins./Notices; increases time period when insurer must give notice before nonrenewing, canceling, or terminating residential property insurance policy. Amends 627.4133. Effective Date: 01/01/2005.

Reported favorably as a committee substitute by the Committee on Banking and Insurance, and the Committee on Commerce, Economic Opportunities, and Consumer Services, reports the committee substitute favorably

CS/CS/SB 618 (2R) by the Committees on Governmental Oversight and Productivity, Ethics and Elections, Senator Cowin and others—

Early Voting; requires supervisors of elections to allow electors to vote early; provides requirements for location & number of early voting facilities; specifies period & hours of operation; requires supervisors of elections to provide notice of early voting; provides for periodic examination of equipment during early voting; authorizes Dept. of State to adopt emergency rules for 2004 election cycle, etc. Amends 101.657,5612,5613,62; creates 101.659. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Ethics and Elections, and reported favorably as acommittee substitute by the Committee on Governmental Oversight and Productivity

CS/SB 640 (2R) by the Committee on Comprehensive Planning and Senator Miller—

Adult Entertainment Establishments; revises prohibition against locating adult entertainment establishment within specified distance from school; requires that such establishment be approved by county or municipality & district school board. Amends 847.0134. Effective Date: 07/01/2004.

Reported favorably as a committee substitute by the Committee on Comprehensive Planning and the Committee on Education reports the committee substitute favorably

SB 698 (2R) by Senator Smith-

Parole Commission; requires that, prior to meeting of Parole Commission, victim of crime be given documents & evidence re granting, denying, or revoking of inmate's parole; requires that inmate convicted of kidnapping whose parole release order has been vacated by court be reinterviewed at 5-year intervals following vacated release order, etc. Amends 947.06,.16,.174. Effective Date: 07/01/2004.

Reported favorably by the Committee on Criminal Justice

CS/SB 704 (2R) by the Committee on Governmental Oversight and Productivity and Senator Wise—

Prescription Wholesaler/Pub. Rec.; exempts certain personal identifying information submitted as part of application as prescription drug wholesaler or out-of-state prescription drug wholesaler from disclosure as public record; provides for future legislative review & repeal; provides findings of public necessity. Amends 499.012. Effective Date: Upon becoming law.


