#### CS/SB 654 (2R) by the Committee on Governmental Oversight and Productivity, Senator Fasano and others—

Firefighter & Police Pensions; authorizes DOR to create & maintain database for use by insurers that report & remit excise tax on property insurance premiums & on casualty insurers premiums; provides incentives to insurers for using database & penalties for failure to use database; defines term "extra benefits" re pension plans for firefighters; provides for meaning of term "extra benefits" re pension plans for municipal police officers, etc. Amends Chs. 175, 185. Effective Date: Upon becoming law.

Effective Date: 07/01/2004.

Askew Student Life Center"; designates university residence hall at FSU as "Sherrill Williams Ragans Hall"; provides for erection of markers. Effective Date: Upon becoming law.

**Firearms/Sale & Delivery;** delays, until October 1, 2009, repeal of provisions requiring criminal history record check by FDLE prior to sale or delivery of firearm to person other than licensed importer, manufacturer, dealer, or collector. Amends 790.065. Effective Date: Upon becoming law.
