Health Care Initiatives; authorizes DOH to issue chiropractic medicine faculty certificate for certain faculty who have accepted appointment at publicly funded state university or college; authorizes chiropractic medicine degree program at FSU; renames Fla. Alzheimer's Center & Research Institute as Johnnie B. Byrd, Sr., Alzheimer's Center & Research Institute; designates Life Sciences Bldg. at FSU as "James E. 'Jim' King, Jr., Bldg."; creates Florida Cancer Council, etc. Amends FS. Effective Date: Upon becoming law except as otherwise provided.

Geriatric Specialty Nursing; cites act as "Clara Ramsey Care of the Elderly Act"; requires Agency for Workforce Innovation to establish pilot program for delivery of certified geriatric specialty nursing education; provides requirements for persons to become certified geriatric specialists; authorizes certified geriatric specialists to supervise activities of others in nursing home facilities according to rules by Board of Nursing, etc. Amends FS. Effective Date: Upon becoming law.

SB 282 (3R) by Senator Posey—

Negotiable Instruments; provides additional circumstance under which person not in possession of lost, destroyed, or stolen negotiable instrument may enforce such instrument. Amends 673.3091. Effective Date: Upon becoming law.

CS/SB 222 (3R) by the Committee on Criminal Justice and Senator Crist—

Service of Process; prohibits finding of contempt for failure to appear in response to subpoena that is not certified; allows Chief Financial Officer, when serving as attorney to receive service of all legal process for certain regulated persons, to send process by any verifiable means to person last designated by regulated person to receive process, instead of requiring process to be sent by registered or certified mail, etc. Amends Ch. 48, 83.13, 624.307. Effective Date: 07/01/2004.

Creates 458.3245, 459.0126. Effective Date: Upon becoming law.

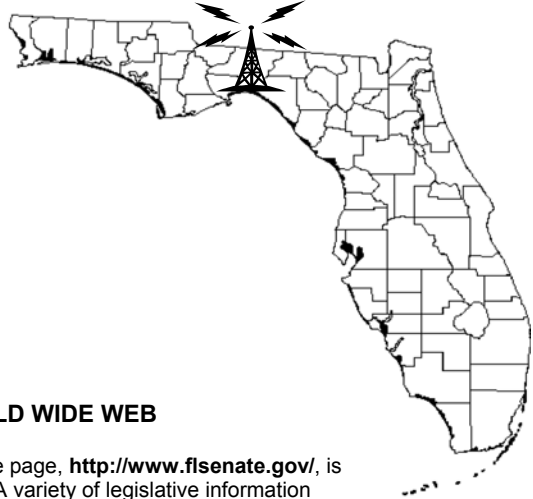
