### BILLS ON THIRD READING

#### **CS/SB's 2730, SB 1596 (3R) by the Committee on Regulated Industries, Senators Joyner and Constantine—**

**Residential Tenancies;** (THIS BILL COMBINES S2730 & S1596) allows landlord to terminate rental agreement & recover liquidated damages or charge tenant early termination fee for breach of agreement, or both, under certain circumstances; requires tenant to indicate acceptance of early termination fee or liquidated-damages provision in rental agreement in order for provision to take effect; provides limit on combined total of damages & fee, etc. Amends 83.43,.595. Effective Date: Upon becoming law.

---

#### **CS/CS/CS/SB 1980 (3R) by the Committees on General Government Appropriations, Governmental Operations, Environmental Preservation and Conservation and the Committee on Environmental Preservation and Conservation (Saunders)—**

**Wildlife Management & Saltwater Fisheries;** increases annual use fee for Sea Turtle specialty license plate; deletes suspension of stone crab endorsements for first violations; prohibits unauthorized possession of blue crab trap gear or removal of said trap contents & provides penalties therefor; clarifies provisions regulating spiny lobsters; requires FWC to adopt & publish rule establishing due process procedures, etc. Amends Chs. 320, 370, 372, 861, 20; reenacts 380.511(1)(c). Effective Date: 07/01/2007.

*Similar to **CS/HB 7173 (HC)** in the Committees on Environmental Preservation and Conservation, Governmental Operations, and General Government Appropriations*

---

#### **CS/CS/SB 1982 (3R) by the Committees on General Government Appropriations, Environmental Preservation and Conservation and the Committee on Environmental Preservation and Conservation (Saunders)—**

**Recreational Licenses & Permits/FWC;** authorizes FWC, tax collectors, & certain subagents to request & collect donations when selling recreational license or permit; revises exemption under which resident need not possess license in order to fish in salt water from land or from structure fixed to land; requires commission to provide to Governor & Legislature report on activities funded from sale of snook permits; corrects reference to spiny lobster, etc. Amends Ch. 372. Effective Date: 10/01/2007.

---

#### **CS/SB's 574, CS/SB 1228 (3R) by the Committee on Education Pre-K - 12 Appropriations, the Committee on Education Pre-K - 12 (Gaetz), Senators Bennett, Gaetz and others—**

**School Districts;** (THIS BILL COMBINES S574 & CS/S1228) provides criteria for designating academically high-performing school districts; provides exceptions for such districts to be exempt from certain statutes & rules; provides for notice concerning property & casualty insurance costs; provides criteria for using district school tax funds; authorizes use of funds for specified purposes, etc. Creates 1003.621; amends 200.065, 1011.71. Effective Date: Upon becoming law.

*Similar to **CS/HB 511 (HC)** in Messages*

**CS/CS/HB 1309 (3R) by the Policy & Budget Council, the Healthcare Council, Representative Galvano and others—**

**Adoption & Child Protection;** redesignates Office of Child Abuse Prevention as Office of Adoption & Child Protection; revises purpose of office; provides for Chief Child Advocate & provides duties therefor; provides for promotion of adoption & support of adoptive families in state plan of office; establishes Child Abuse Prevention & Permanency Advisory Council; provides adoption assistance program for children within child welfare system, etc. Amends Ch. 39, 409.166. Effective Date: 7/1/2007.

*Substituted for CS/CS/SB 1388 (SUB) (Storms) and read the second time on April 30, 2007*

---

**CS/HB 111 (3R) by the Jobs & Entrepreneurship Council, Representative Galvano and others—**

**Nonresident Title Insurance Agents;** provides additional requirements for nonresident title insurance agent licensure; revises unlawful rebate specifications; provides exception to prohibition against dealing in certain premium; revises rate & rate deviation requirements; revises determination of insurability & records retention requirements; revises requirements for estoppel letter; provides liability for title insurance agents recording certificate of release, etc. Amends FS. Effective Date: 10/01/2007.

*Substituted for CS/SB 636 (SUB) (Lawson) and read the second time on April 30, 2007*

---

**CS/SB 760 (3R) by the Committee on Health Regulation and Senator Atwater—**

**Hospitals;** revises provisions designating classes of disease; exempts certain cancer center hospitals from licensure restrictions; revises provisions re licensing standards for adult cardiovascular services; revises criteria for adoption of rules by AHCA; requires certain hospitals to participate in clinical outcome-reporting systems operated by American College of Cardiology & Society for Thoracic Surgeons, etc. Amends 395.003, 408.0361. Effective Date: 07/01/2007.

*Similar to HB 7165 (HC) in Messages*

---

**CS/HB 405 (3R) by the Safety & Security Council, Representative Mealor and others—**

**Vacation & Timeshare Plans;** revises formula for funding reserve accounts for conversions; authorizes seller to offer timeshare interests in timeshare plan located outside of this state without filing public offering statement for such out-of-state plan; revises info. required to be contained in filed public offering statements for certain timeshare plans; revises provisions re advertising & oral statements to include those made by resale service providers, etc. Amends FS. Effective Date: 07/01/2007.

*Substituted for CS/CS/SB 1374 (SUB) (Jones) and read the second time on April 30, 2007*

**CS/CS/CS/SB 1928 (3R) by the Committees on Transportation and Economic Development Appropriations, Governmental Operations, Transportation and the Committee on Transportation (Baker)—**

**Transportation/M.P.O.'s;** requires commission to monitor transportation authorities & conduct periodic reviews of each authority; authorizes metropolitan planning orgs. & certain separate entities to establish per diem & travel reimbursement rates; defines term "metropolitan planning organization" for purposes of FRS Act; providing for creation of transportation concurrency backlog authorities; renames charter county transit system surtax, etc. Amends FS. Effective Date: 07/01/2007.

*Compare to CS/CS/HB 985 (HC) in Messages*

**CS/CS/HB 83 (3R) by the Policy & Budget Council, the Economic Expansion & Infrastructure Council, Representative Grant and others—**

**Venture Capital Investments;** cites act as "Fla. Capital Formation Act"; requires Enterprise Fla., Inc., to facilitate creation of Fla. Opportunity Fund; creates Institute for Commercialization of Public Research; provides that 21st Century Technology, Research, & Scholarship Enhancement Act includes commercialization of products & services developed from research & development conducted at state universities, etc. Amends Ch. 288, 1004.226. Effective Date: 07/01/2007.

*Substituted for CS/CS/CS/CS/SB 2420 (SUB) (Ring) and read the second time on April 30, 2007*

---

**CS/CS/HB 131 (3R) by the Policy & Budget Council, the Economic Expansion & Infrastructure Council and Representative Grant—**

**Pub. Rec. & Meetings/Fla. Opportunity Fund;** provides exemption from public records requirements for certain information held by Fla. Opportunity Fund & for certain information held by Institute for Commercialization of Public Research; creates exemption from public records requirements for certain information held by Fla. Technology, Research, & Scholarship Board; creates exemption from public meetings requirements for portions of meetings of said board, etc. Creates 288.9626; amends 1004.226. Effective Date: Contingent.

*Substituted for CS/CS/SB 2422 (SUB) (Ring) and read the second time on April 30, 2007*

**CS/HB 1301 (3R) by the Economic Expansion & Infrastructure Council, Representative Aubuchon and others—**

**Workforce Services;** revises definitions of work activities to conform to federal law & regulations governing work requirements for participants in temporary cash assistance program; revises certain requirements for & duties of regional workforce boards re work requirements for program participants; clarifies circumstances under which transitional child care is available to former participants in welfare transition program, etc. Amends Ch. 445, 402.305. Effective Date: Upon becoming law.

*Substituted for **CS/SB 1926 (SUB)** (Diaz de la Portilla) and read the second time on April 30, 2007*

---

**SB 1172 (3R) by Senator Joyner and others—**

**Health Insurance Coverage;** includes certain amino-acid-based formulas within requirements concerning optional coverage for formulas; cites specified provisions as "Mary B. Hooks Act"; includes lymph node dissections under provisions prescribing length of hospital stay re mastectomy & outpatient postsurgical followup care which specified health insurers & HMOs must cover; limits application. Amends 627.42395,.64171,.66121, 641.31. Effective Date: 07/01/2007.

---

**SB 720 (3R) by Senator Crist—**

**Adam Arnold Act/DUI;** requires court to sentence driver of vehicle to minimum term of imprisonment if person is DUI & leaves scene of crash that results in death; requires court to order driver of vehicle to make restitution to victim for any damage or loss if driver leaves scene of accident that results in injury or death; requires court to make payment of restitution condition of probation, etc. Amends 316.027,.193, 921.0021. Effective Date: 07/01/2007.

*Identical to **HB 25 (HC)** in the Committees on Transportation, Criminal Justice, and Judiciary*

---

**CS/CS/SB 1864 (3R) by the Committees on Community Affairs, Banking and Insurance, Senator Posey and others—**

**Hurricane Damage Mitigation;** redesignates Fla. Comprehensive Hurricane Damage Mitigation Program as "My Safe Florida Home Program"; revises criteria & requirements for hurricane mitigation inspections; requires DFS to transfer certain appropriated funds to Volunteer Florida Foundation, Inc., for certain purposes; requires DFS to develop no-interest loan program; provides requirements for buildings located in wind-borne debris region, etc. Amends FS. Effective Date: Upon becoming law.

*Compare to **CS/HB 7057 (HC)** in the Committees on Banking and Insurance, and Community Affairs*

---

**SB 274 (3R) by Senator Margolis and others—**

**Cystic Fibrosis Treatment;** requires group health insurance policy to cover services needed to treat cystic fibrosis authorized by physician; requires contract by health maintenance organization to cover services needed to treat cystic fibrosis as authorized by physician; amends provision re out-of-state groups to conform cross-reference to changes made by act; provides that act fulfills important state interest. Creates 627.6614; amends 641.31, 627.6515. Effective Date: 01/01/2008.

*Read the second time and amended on April 30, 2007*

---

**CS/SB 2508 (3R) by the Committee on Higher Education, Senator Rich and others—**

**Social Worker Identification;** defines term "social worker"; prohibits persons from identifying themselves as social workers unless they hold certain credentials; provides exceptions; requires DOH to adopt rules. Amends 39.01, 491.003; creates 491.016. Effective Date: 07/01/2007.

*Read the second time on April 30, 2007*

---

**CS/CS/SB 2856 (3R) by the Committees on Community Affairs, Regulated Industries and Senator Crist—**

**Funeral & Cemetery Industry Regulation;** prohibits certain persons from conducting, maintaining, managing, owning, or operating licensees under specified provisions; provides exception; revises regulation & practice of limited licensees; authorizes use of Internet courses for continuing education; provides for internment or entombment of decedent with remains of decedent's pet; conforms cross-references, etc. Amends Ch. 497, 553.36, 316.515, 627.702; creates 497.609. Effective Date: 07/01/2007.

*Read the second time and amended on April 30, 2007*

*Similar to **CS/HB 1177 (HC)** in Messages*

---

**CS/CS/SB 1592 (3R) by the Committees on Transportation and Economic Development Appropriations, Judiciary and Senator Bennett—**

**Open Government Act;** revises guidelines for construction of statutory language granting rulemaking authority; prescribes limits & guidelines re incorporation of material by reference; prescribes responses that may be made by agency to committee objection to rule or statement of estimated regulatory costs; requires electronic publication of Florida Administrative Code; revises for specified period limit for unencumbered balance in Records Mgmt. TF, etc. Amends FS. Effective Date: 07/01/2007 except as otherwise provided.

*Read the second time and amended on April 30, 2007*

*Similar to **HB 7183 (HC)** in Messages*

**CS/HB 743 (3R) by the Safety & Security Council, Representative Hukill and others—**

**Trusts;** revises criteria for investments in certain investment instruments; provides criteria, requirements, & limitations on trustee's power to invade principal of trust; limits definition of term "land trust" to arrangement in which title to real property is vested in trustee by recorded instrument that confers certain authority as prescribed by state law; clarifies use of income interest of trust, etc. Amends Chs. 731, 736, 660.417, 689.071. Effective Date: 07/01/2007.

*Substituted for CS/CS/SB 2218 (SUB) (Posey) and read the second time on April 30, 2007*

---

**CS/SB 644 (3R) by the Committee on Governmental Operations and Senator Lynn—**

**State Universities/Buildings/Naming;** provides for naming of facilities of state university for living person by university in accordance with rules of Board of Governors of State University System; authorizes university board of trustees to name building in accordance with specified provision. Amends 267.062, 1013.79. Effective Date: 07/01/2007.

*Read the second time on April 30, 2007*

---

**CS/CS/SB 2346 (3R) by the Committees on Community Affairs, Environmental Preservation and Conservation and Senator Bennett—**

**Myakka River;** requires Myakka River Management Coordinating Council to prepare report; provides report requirements; requires public hearings; requires council to submit report to Governor & Legislature. Amends 258.501. Effective Date: 07/01/2007.

*Read the second time on April 30, 2007*

---

**SB 2230 (3R) by Senator Wise—**

**Accessible Parking Spaces;** provides for reservation of accessible parking spaces for persons who require extra space to exit from or enter motor vehicle; requires signage; requires specific markings; provides penalty. Amends 553.5041. Effective Date: 10/01/2007.

*Read the second time on April 30, 2007*

---

**CS/SB 1020 (3R) by the Committee on Finance and Tax, Senator Haridopolos and others—**

**Ad Valorem Taxation;** requires that property appraiser provide instructions to taxing authorities for computing rolled-back rate; provides that certain tax increment finance payments, taxes levied for payment of bonds, & voted tax levies are exempt from limitations on millage rates; amends specified provisions re taxpayer rights, approval of assessment rolls, disclosure of tax impact, & school district taxes, etc. Amends Chs. 192, 193, 194, 200, 218, 1011. Effective Date: 07/01/2007.

---

**CS/SJR 3034 (3R) by the Committee on Finance and Tax, Senator Atwater and others—**

**Ad Valorem Taxation/Tangible Personal Property;** constitutional amendment to authorize, by general law, exemption from ad valorem taxation of up to \$25,000 of assessed value on each tangible personal property tax return & to schedule amendment to take effect on January 1, 2009; to provide that assessed value of new homestead must equal or exceed assessed value of previous homestead, etc. Amends ss. 3, 4, 6, Art. VII; creates new section, Art. XII.

---

**CS/SB 1022 (3R) by the Committee on Finance and Tax, Senator Haridopolos and others—**

**Affordable Housing;** requires appraisers to use income approach when assessing affordable housing property that has low-income tax credit; provides for just valuation of affordable housing property; requires property appraisers to use income approach when assessing such property; specifies kinds of property subject to assessment. Amends 193.017; creates 193.018. Effective Date: 07/01/2007.

---

**CS/CS/SB 560 (3R) by the Committees on Finance and Tax, Community Affairs, Senator Atwater and others—**

**Local Governments;** requires that value of expected future tax benefits for homestead property be compensated for in eminent domain taking; requires that county, municipality, or special district hold certain public hearings before adopting ordinance or resolution increasing impact fee; specified data to be used for tabulating property value & taxation including information concerning ad valorem taxes & millage rates, etc. Amends Ch. 73, 163.31801, 193.011, 195.052, 200.069. Effective Date: 07/01/2007.

## SPECIAL ORDER CALENDAR FOR TUESDAY, MAY 1, 2007

### CS/CS/CS/SB 780 (SO) by the Committees on Transportation and Economic Development Appropriations, Finance and Tax, Community Affairs and Senator Garcia—

**Affordable Housing;** requires certain counties to adopt plan for ensuring affordable workforce housing; authorizes local government to adopt amendments to local comprehensive plan in order to integrate port master plan with such plan; provides that all phase, buildout, & expiration dates for projects that are developments of regional impact & under active construction on specified date are extended for 3 years, etc. Amends Chs. 163, 197, 420, 380.06. Effective Date: 07/01/2007.

*Reported favorably as a committee substitute by the Committee on Community Affairs and reported favorably as a committee substitute by the Committee on Finance and Tax, and reported favorably as a committee substitute by the Committee on Transportation and Economic Development Appropriations*

*Compare to **HB 1375 (HC)** in the Committees on Community Affairs, Finance and Tax, and Transportation and Economic Development Appropriations*

---

### CS/CS/SB 2250 (SO) by the Committees on Governmental Operations, Military Affairs and Domestic Security, Senator Deutch and others—

**Iran/Divestment of Public Funds;** requires SBA to identify all companies doing certain types of business in or with Iran in which public moneys are invested; requires SBA to create & maintain Scrutinized Company List that names all such companies; requires board to divest company of all publicly traded securities of said company under certain conditions; provides exceptions to divestment requirement; exempts SBA from certain statutory or common law obligations, etc. Effective Date: Upon becoming law.

*Reported favorably as a committee substitute by the Committee on Military Affairs and Domestic Security, and reported favorably as a committee substitute by the Committee on Governmental Operations and the Committee on General Government Appropriations reports the committee substitute favorably*

---

### CS/SB 594 (SO) by the Committee on Environmental Preservation and Conservation and Senator Saunders—

**Surface Water Protection Programs;** provides for regulation of peat mines in certain wetlands; provides exemption from water quality standards for permitted stormwater systems within NFWFMD; provides clarification that DEP is authorized to adopt certain criteria to prevent harm to water resources; revises exemption provided to certain mine operators from requirement to notify secretary of DEP when beginning to mine certain substances, etc. Amends Chs. 373, 378, 403. Effective Date: 07/01/2007.

*Reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation, and withdrawn from the Committee on General Government Appropriations*

*Similar to **CS/CS/HB 197 (HC)** in the Committees on Environmental Preservation and Conservation, and General Government Appropriations*

---

### CS/SB 2702 (SO) by the Committee on Banking and Insurance, Senator Aronberg and others—

**Insurance;** provides exemption from required written examination to certain applicants for licensure as claims adjuster; authorizes certain programs to offer correspondence courses to applicants for licensure as health insurance agent; authorizes certain licensed agents to be agent in charge of branch locations under certain circumstances; provides that DFS is responsible for approval of surplus lines agent manual, etc. Amends Ch. 626. Effective Date: 07/01/2007 except as otherwise provided.

*Reported favorably as a committee substitute by the Committee on Banking and Insurance, and withdrawn from the Committee on Regulated Industries and withdrawn from the Committee on General Government Appropriations*

*Compare to **CS/CS/HB 1381 (HC)** in the Committee on Banking and Insurance*

---

### CS/CS/SB 1850 (SO) by the Committees on Governmental Operations, Banking and Insurance and the Committee on Banking and Insurance (Posey)—

**OGSR/Work Papers/DFS or OIR;** revises exemption from public-records law which is provided for work papers held by DFS or OIR of FSC; defines term "work papers"; saves exemption from repeal under OGSR; deletes provisions providing for repeal of exemption. Amends 624.319. Effective Date: 10/01/2007.

*Reported favorably as a committee substitute by the Committee on Banking and Insurance, and reported favorably as a committee substitute by the Committee on Governmental Operations*


