FISCAL POLICY AND CALENDAR COMMITTEE [FPCC] GROUPING

SB 2500 (SO) by the Committee on Fiscal Policy and Calendar Committee (Carlton)—

Special Appropriations; Provides appropriations and reductions in appropriations for the 2007-2008 fiscal year to pay salaries and other expenses, for capital outlay projects such as buildings and other improvements, and for other specified purposes of the various agencies of state government, etc. Effective Date: Upon becoming law.

SB 2502 (SO) by the Committee on Fiscal Policy and Calendar Committee (Carlton)—

Implementing the 2007-2008 Special Appropriations; Provides for the incorporation by reference of certain calculations used by the Legislature for the 2007-2008 fiscal year. Provides for the implementation of specified appropriations. Provides legislative intent with respect to reductions in expenditures made by district school boards, etc. Effective Date: Upon becoming law.

CS/SB 1852 (SO) by the Committee on Health and Human Services Appropriations and Senator Peaden—

Medicaid Providers/Reimbursement; Requires the Agency for Health Care Administration to limit the reimbursement rate for certain specified providers notwithstanding certain provisions and rules to the contrary. Provides that the limitations apply to prepaid health plans and nursing home diversion programs. Provides for application, etc. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Health and Human Services Appropriations

OVERSIGHT AND PROCEDURAL POLICY AND CALENDAR COMMITTEE [OPCC] GROUPING

SB 1676 (SO) by Senator King-

Official Florida Statutes; Adopts the Florida Statutes 2008 and designates the portions thereof that are to constitute the official law of the state. Provides that the Florida Statutes 2008 shall be effective immediately upon publication. Provides that general laws enacted during the June 12-14, 2007, special session and prior thereto and not included in the Florida Statutes 2008 are repealed, etc. Effective Date: 60 days after sine die.

CS/SB 1678 (SO) by the Committee on Rules and Senator King—

Florida Statutes; Deletes provisions that have expired, have become obsolete, have had their effect, have served their purpose, or have been impliedly repealed or superseded. Replaces incorrect cross-references and citations. Corrects grammatical, typographical, and like errors. Removes inconsistencies, redundancies, and unnecessary repetition in the statutes. Improves the clarity of the statutes and facilitates their correct interpretation, etc. Effective Date: 60 days from sine die.

Reported favorably as a committee substitute by the Committee on Rules

SB 1680 (SO) by Senator King-

Florida Statutes; Repeals provisions which have become inoperative by noncurrent repeal or expiration and may be omitted from the 2008 Florida Statutes only through a reviser's bill duly enacted by the Legislature, etc. Effective Date: 60 days after sine die.

SB 1682 (SO) by Senator King-

Florida Statutes; Amends various provisions pursuant to the directive of the Legislature to redesignate the Secretary of Health as the State Surgeon General wherever the term appears in the Florida Statutes, etc. Effective Date: 60 days after sine die.

SR 1538 (SR) by Senator Saunders-

Patient Safety Awareness Week/March 2-8,2008; Recognizes Patient Safety Awareness Week, March 2-8, 2008, coinciding with National Patient Safety Awareness Week and encourages all Floridians to support the goals of increased patient safety, etc.

SENATE BILLS ON SECOND READING

SB 154 (2R) by Senator Fasano-

Pedestrian Safety/Driver Requirements; Requires a driver to stop at intersections with traffic control signals, or crosswalks so indicated with signage, to allow a pedestrian to cross a roadway when the pedestrian is in the crosswalk. Effective Date: 07/01/2008.

Reported favorably by the Committee on Transportation

CS/SB 276 (2R) by the Committee on Judiciary, Senator Rich and others—

Food Donation by Public Food Service Establishment; Designates this act as the "Jack Davis Florida Restaurant Lending a Helping Hand Act." Amends provisions regarding liability for canned or perishable food distributed free of charge. Expands the definition of "perishable food" to include foods that have been prepared at licensed public food service establishments, etc. Effective Date: 07/01/2008.

Reported favorably by the Committee on Regulated Industries and reported favorably as a committee substitute by the Committee on Judiciary

CS/SB 296 (2R) by the Committee on Regulated Industries and Senator Fasano—

Bingo/Electronic Verification of Numbers; Authorizes verification of numbers drawn at bingo games by electronics or other technology in lieu of vocal verification. Revises the definition of "organization" to include chambers of commerce. Exempts chambers of commerce from provisions prohibiting drawings by chance. Authorizes an organization to place signs at a bingo game event disclosing certain required information, etc. Effective Date: 07/01/2008.

Reported favorably as a committee substitute by the Committee on Regulated Industries

SB 458 (2R) by Senator Wise-

Pugilistic Matches/Fraternal Order of Police; Exempts amateur matches that are conducted or sponsored by the Fraternal Order of Police and that are held in conjunction with acharitable event from provisions regulating pugilistic contests and exhibitions, etc. Effective Date: 07/01/2008.

Reported favorably by the Committee on Regulated Industries

CS/CS/SB 1380 (2R) by the Committees on Finance and Tax, Regulated Industries, Senator Jones and others—

Electronic Gaming Machines; Provides that any electronic gaming machine licensee may possess and operate electronic gaming machines at an eligible facility where the licensee is authorized to conduct pari-mutuel wagering activities pursuant to pari-mutuel provisions. Prohibits a person who has not attained 21 years of age from operating or playing an electronic gaming machine or having access to the designated machine area, etc. Effective Date: Upon becoming law.

Reported favorably as a committee substitute by the Committee on Regulated Industries and reported favorably as a committee substitute by the Committee on Finance and Tax

CS/SB 322 (2R) by the Committee on Governmental Operations, Senator Constantine and others—

Political Subdivision/Officer & Employee Conduct; Specifies standards of conduct for officers and employees of entities serving as the chief administrative officer of political subdivisions. Provides for penalties to be imposed against persons other than lobbyists or public officers and employers. Provides for the Commission on Ethics to report to the Governor violations involving persons other than lobbyists or public officers and employees, etc. Effective Date: 07/01/2008.

SB 784 (2R) by Senator Bennett-

Child Welfare Professionals Recognition Day; Designates the second Monday in May as "Child Welfare Professionals Recognition Day" to recognize all professionals who work with abused children and dysfunctional families. Encourages the Department of Children and Family Services, local governments, and other agencies to sponsor events promoting the awareness of the child welfare system, etc. Effective Date: Upon becoming law.

Requires that primary English instructors have 300 inservice hours or the equivalent, that instructors in basic subject areas have 60 inservice hours or the equivalent, etc. Effective Date: 07/01/2008.


