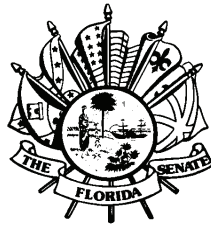

Revises provisions relating to contracting and construction for educational facilities, etc. Effective Date: 07/01/2009.

Requires the submission of fingerprints for a criminal records check. Requires that an applicant for a license bear the cost of fingerprinting and a criminal records check. Prohibits reissuance of a license for a specified period following license revocation. Requires the sponsor of an auctioneer apprentice to review the apprentice's records, etc. Effective Date: 07/01/2009.

**Florida Transportation Revenue Study Commission;** Provides legislative findings with respect to the need to preserve investments in transportation infrastructure and reduce congestion. Creates the Florida Transportation Revenue Study Commission for the purpose of studying the state's transportation needs and developing recommendations. Requires the Center for Urban Transportation Research at the University of South Florida to provide staff support to the commission, etc. Effective Date: Upon becoming law.

**Driver Licenses/Contribution to Stop Heart Disease;** Requires the driver license application form to include language permitting the applicant to make a voluntary contribution to Stop Heart Disease. Effective Date: 10/01/2009.

Prohibits a parent or guardian of a child younger than a specified age from authorizing or permitting the child to engage in certain conduct, etc. Effective Date: 10/01/2009.

**CS/CS/SB 148 (2R) by the Committees on Community Affairs, Environmental Preservation and Conservation and Senator Aronberg—**

**Mangrove Protection;** Expands the penalty previously applicable to violations involving mangrove trimming or alteration to apply to any violation under the Mangrove Trimming and Preservation Act. Revises the definition of "riparian mangrove fringe." Provides that the act does not authorize trimming on uninhabited natural islands or lands that are publicly owned or set aside for conservation or mitigation except under specified circumstances, etc. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation, and reported favorably as a committee substitute by the Committee on Community Affairs and the Committee on General Government Appropriations reports the committee substitute favorably*

**Vessel and Personal Watercraft Safety;** Revises certain requirements for operating personal watercraft. Revises the requirements relating to the boating safety course required for leasing or renting a personal watercraft from a livery. Effective Date: 07/01/2009.

**SB 1286 (2R) by Senator Dean—**

**Pest Control Compact;** Enacts the Pest Control Compact. Requires the Commissioner of Agriculture to administer the compact. Provides for the establishment of the Pest Control Insurance Fund to finance pest-control operations under the compact. Prohibits a pledge of the assets of a state that is a party to the compact. Provides for the compact to enter into force upon its enactment by five or more states, etc. Effective Date: 07/01/2009.

**SB 2656 (2R) by Senator Haridopolos—**

Requires a law enforcement agency that transports persons to a receiving facility to have a memorandum of understanding with the facility. Requires that custody of a person who is transported to a receiving or treatment facility be relinquished to a responsible person at the facility. Specifies that psychiatric examination by certain personnel be conducted face-to-face or by electronic means. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs, and reported favorably as a committee substitute by the Committee on Health Regulation and the Committee on Health and Human Services Appropriations, reports the committee substitute favorably*

**CS/CS/SB 770 (2R) by the Committees on Governmental Oversight and Accountability, Children, Families, and Elder Affairs and Senator Fasano—**

**Area Agencies on Aging;** Revises provisions relating to the Department of Elderly Affairs. Deletes references to the boards of area agencies on aging. Extends the period of designation as a lead agency. Designates area agencies on aging as nongovernmental not-for-profit corporations. Requires that each area agency on aging, rather than the department, develop request for proposals for a community care for the elderly lead agency, etc. Effective Date: Upon becoming law.

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs, and reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability, and the Committee on Health and Human Services Appropriations, reports the committee substitute favorably*

**CS/SB 844 (2R) by the Committee on Higher Education and Senator Oelrich—**

**Postsecondary Distance Learning;** Establishes the Florida Distance Learning Consortium. Requires that the Board of Governors and the State Board of Education jointly oversee the consortium. Authorizes the consortium to enter into contracts for administrative services. Provides duties for the consortium. Defines the term "distance learning course" for purposes of assessing a distance learning course user fee for community college and state university students. Effective Date: Upon becoming law.

**CS/SB 892 (2R) by the Committee on Children, Families, and Elder Affairs, Senator Bennett and others—**

**Mental Health and Substance Abuse Services;** Authorizes the Agency for Health Care Administration to license facilities that provide services as an integrated adult mental health crisis stabilization unit and addictions receiving facility. Provides eligibility criteria for treatment services. Requires the Department of Children and Family Services to adopt rules. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs, and the Committees on Health Regulation and Health and Human Services Appropriations, report the committee substitute favorably*

**SB 902 (2R) by Senator Deutch—**

**Florida Public Health Foundation, Inc.;** Changes the name of said foundation to the Florida Public Health Institute, Inc. Modifies the purpose of the institute. Deletes the duties of the institute to facilitate communication between biomedical researchers and health care providers, to provide an annual report of its finances, and to provide an annual report of its activities to the Governor and the Florida Center for Universal Research to Eradicate Disease, etc. Effective Date: Upon becoming law.

*Reported favorably by the Committees on Health Regulation and Health and Human Services Appropriations*

**CS/SB 948 (2R) by the Committee on Health Regulation and Senator Jones—**

**Emergency Medical Services;** Revises requirements for the field internship experience in paramedic programs. Authorizes the Department of Health to adopt rules. Revises the documented requirements for a driver of an emergency vehicle. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Health Regulation and the Committee on Higher Education reports the committee substitute favorably*

**SB 1050 (2R) by Senator Joyner—**

**Medicaid/Preventable Medical Errors;** Requires the AHCA to identify preventable medical errors that are not reimbursed by Medicaid programs in other states, the Medicare program, and private insurers and recommend to the Governor and the Legislature an expanded list of preventable medical errors for which the Medicaid program may refuse reimbursement, etc. Effective Date: 07/01/2009.

*Reported favorably by the Committees on Health Regulation and Health and Human Services Appropriations*

**SB 1396 (2R) by Senator Aronberg—**

**Administration of Estates;** Provides for nonapplication of certain limitation-of-action provisions to certain paternity determinations. Revises criteria for certain household items, motor vehicles, and tuition programs as exempt property. Revises requirements for a petition for summary administration, etc. Effective Date: 07/01/2009.

*Reported favorably by the Committee on Judiciary and withdrawn from the Committee on Rules*

**CS/CS/SB 1552 (2R) by the Committees on Banking and Insurance, Judiciary and Senator Bennett—**

**Lis Pendens;** Permits property to be sold exempt from claims asserted in an action when the lis pendens has expired or been withdrawn or discharged. Requires a notice of lis pendens to include the date of the action or the case number of the action. Extends the time in which the holder of an unrecorded interest or lien may intervene in a pending action. Provides for the control and discharge of a lis pendens that no longer affects the property. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Judiciary and reported favorably as a committee substitute by the Committee on Banking and Insurance*

**CS/SB 1592 (2R) by the Committee on Health Regulation and Senator Lynn—**

**Nurse Registries/Companion-homemaker Organizations;** Requires nurse registries and organizations that provide companion or homemaker services to provide notice to patients or clients. Specifies the contents of the notice. Requires the notice to be kept for a specified number of years. Provides an exception. Requires the Agency for Health Care Administration to develop a form for the notice. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Health Regulation and the Committee on Health and Human Services Appropriations, reports the committee substitute favorably*

**CS/SB 1604 (2R) by the Committee on Health Regulation and Senator Aronberg—**

**Nursing Services;** Requires that hospitals establish nurse staffing collaborative councils. Requires the council to produce annual hospital nurse staffing plans. Requires the chief nurse executive to communicate with the council to ensure appropriate implementation of the nurse staffing plan. Requires that the council conduct a semiannual review of the nurse staffing plan. Requires the nurse staffing plan to be reviewed with the nurse personnel, etc. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Health Regulation and the Committee on Health and Human Services Appropriations, reports the committee substitute favorably*

**SB 1628 (2R) by Senator Gelber—**

**Long-term Care Services;** Requires the Agency for Health Care Administration, in consultation with the Department of Elderly Affairs, to accept and forward to the Centers for Medicare and Medicaid Services an application for expansion of a pilot project from an entity that provides certain benefits under a federal program. Effective Date: 07/01/2009.

*Reported favorably by the Committees on Health Regulation, Children, Families, and Elder Affairs, and Health and Human Services Appropriations*

**SB 1896 (2R) by the Committee on Health Regulation—**

**Florida Patient Safety Corporation;** Repeals provision relating to the Florida Patient Safety Corporation. Repeals provision relating to a public records exemption for patient safety data or other records held by the Florida Patient Safety Corporation and its subsidiaries, advisory committees, or contractors, with certain exceptions, and relating to a public meetings exemption for portions of meetings held by the corporation or its subsidiaries, etc. Effective Date: Upon becoming law.

*Reported favorably by the Committees on Health Regulation, Governmental Oversight and Accountability, and Health and Human Services Appropriations*

**CS/SB 1914 (2R) by the Committee on Education Pre-K - 12 and Senator Detert—**

**School Districts/Paperwork and Data Reduction;** Deletes provisions that require each district school board to reduce paperwork and data collection and report its findings and potential solutions on reducing burdens associated with such collection. Requires that the Commissioner of Education monitor and review the collection of paperwork, data, and reports by school districts, etc. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Education Pre-K - 12 and the Committee on Education Pre-K - 12 Appropriations reports the committee substitute favorably*

**CS/CS/SB 1958 (2R) by the Committees on Banking and Insurance, Judiciary and Senator Gelber—**

**Trust Administration;** Redefines the term "beneficiary" to include a person having certain beneficial interests. Provides an additional limitation on terms of a trust prevailing over provisions of the Florida Trust Code. Authorizes trust instruments to authorize certain persons to designate one or more persons to represent and bind a beneficiary and receive certain information. Authorizes a trustee to delegate investment functions to a cotrustee, etc. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Judiciary and reported favorably as a committee substitute by the Committee on Banking and Insurance*

**CS/SB 2096 (2R) by the Committee on Higher Education and Senator Oelrich—**

**Nonpublic Postsecondary Educational Institutions;** Revises the criteria for licensure by means of accreditation for an independent postsecondary educational institution. Requires that, in order to maintain its license, an institution file a report with the Commission for Independent Education which includes the results of a site visit performed by an accrediting agency. Requires that each institution request such site visits, etc. Effective Date: 07/01/2009.

*Reported favorably as a committee substitute by the Committee on Higher Education and the Committee on Higher Education Appropriations reports the committee substitute favorably*

**CS/SB 2426 (2R) by the Committee on Education Pre-K - 12 and Senator Detert—**

**Student Records;** Deletes provisions relating to the rights parents have regarding their children's postsecondary student records to conform to changes made by the act. Requires that the State Board of Education comply with federal law with respect to the release of education records. Requires that a public postsecondary educational institution comply with federal law. Provides an aggrieved student with the right to bring an action in court, etc. Effective Date: 07/01/2009.

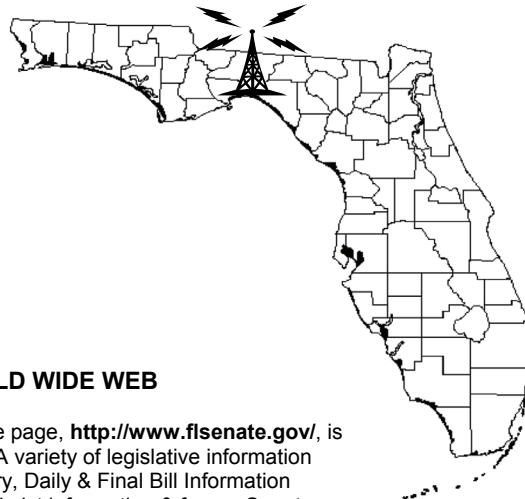

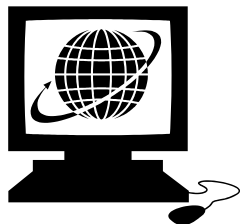
