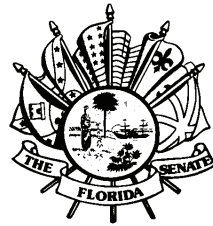

BILLS ON THE CALENDAR

BILLS ON THIRD READING

POLICY AND STEERING COMMITTEE ON SOCIAL RESPONSIBILITY [SPSC] GROUPING

CS/CS/SB 456 (3R) by the Committees on Health Regulation, Children, Families, and Elder Affairs, Senator Gaetz and others—

Mental Illness/Psychiatric Examination; Defines the term "electronic means." Requires a law enforcement agency that transports persons to a receiving facility to have a memorandum of understanding with the facility. Requires that custody of a person who is transported to a receiving or treatment facility be relinquished to a responsible person at the facility. Specifies that psychiatric examination by certain personnel be conducted face-to-face or by electronic means. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/SB 770 (3R) by the Committees on Governmental Oversight and Accountability, Children, Families, and Elder Affairs and Senator Fasano—

Area Agencies on Aging; Revises provisions relating to the Department of Elderly Affairs. Deletes references to the boards of area agencies on aging. Extends the period of designation as a lead agency. Designates area agencies on aging as nongovernmental not-for-profit corporations. Requires that each area agency on aging, rather than the department, develop request for proposals for a community care for the elderly lead agency, etc. Effective Date: Upon becoming law.

Read the second time on April 23, 2009

HB 767 (3R) by Representative Fitzgerald and others—

Mental Health and Substance Abuse Services; Authorizes AHCA to license facilities that provide services as integrated adult mental health crisis stabilization units & addictions receiving facilities; provides eligibility criteria for treatment services; requires DCFS to adopt rules. Effective Date: 07/01/2009.

Substituted for CS/SB 892 (SUB) (Bennett) and read the second time on April 23, 2009

CS/CS/SB 1548 (3R) by the Committees on Criminal and Civil Justice Appropriations, Criminal Justice, Senator Joyner and others—

Theft; Increases the minimum amount of value attributed to certain emergency medical equipment and law enforcement equipment for the theft to reach the threshold for a second-degree felony. Authorizes a law enforcement officer who has probable cause to believe that a defendant has committed retail theft to issue a notice to appear in lieu of arresting the defendant under certain circumstances, etc. Effective Date: 10/01/2009.

Read the second time on April 23, 2009

CS/CS/SB 278 (3R) by the Committees on Education Pre-K - 12 Appropriations, Education Pre-K - 12 and Senator Gaetz—

Charter Schools; Provides that a charter technical career center is subject to certain requirements in a financial emergency. Provides for the development of a financial recovery plan, which may be approved by the Commissioner of Education. Provides for duties of a charter school sponsor and governing board if a charter school or charter technical career center experiences a deteriorating financial condition or is in a financial emergency, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

CS/CS/SB 1616 (3R) by the Committees on Education Pre-K - 12 Appropriations, Education Pre-K - 12 and Senator Oelrich—

Career and Adult Education; Renames the Division of Workforce Education within the DOE as the "Division of Career and Adult Education." Revises the membership of the State Apprenticeship Advisory Council. Provides for a standard high school diploma designation for completed industry certifications. Requires that OPPAGA review and provide a report on workforce education programs for occupations not included on specific occupation lists and on funding options, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

CS/CS/SB 2538 (3R) by the Committees on Education Pre-K - 12 Appropriations, Education Pre-K - 12 and Senator Detert—

Supplemental Educational Services; Requires that each supplemental educational services provider report certain information to the DOE regarding services to public school students in the district by a specified date each year. Requires that the DOE post a uniform survey on its Internet website to be completed online by principals and school districts. Requires that the DOE evaluate each provider based on such information and assign a service designation, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

CS/SB 554 (3R) by the Committee on Higher Education Appropriations and Senator Dean—

Legal Jurisdiction of Campus Police; Redefines the term "mutual aid agreement" to authorize state university police officers to enforce laws within a specified jurisdictional area as agreed upon in a mutual aid agreement. Authorizes university police officers to enforce traffic violations committed within a specified distance from property under the supervision or control of the university, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/SB 762 (3R) by the Committees on Higher Education Appropriations, Higher Education, Senator Pruitt and others—

State University Tuition and Fees; Requires the Education Estimating Conference to develop information relating to the national average of tuition and fees. Revises provisions relating to the use of the student financial aid fee. Revises provisions relating to the establishment of a tuition differential. Provides requirements for a university board of trustees to submit a proposal to the Board of Governors to implement a tuition differential, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

HB 7121 (3R) by the Education Policy Council, Representative Culp and others—

Postsecondary Distance Learning; Establishes Florida Distance Learning Consortium to facilitate collaboration among public postsecondary educational institutions in use of distance learning; provides duties of consortium; defines distance learning course for purposes of assessing distance learning course user fee for community college & state university students. Effective Date: Upon becoming law.

Substituted for CS/SB 844 (SUB) (Oelrich) and read the second time on April 23, 2009

CS/SB 2096 (3R) by the Committee on Higher Education and Senator Oelrich—

Nonpublic Postsecondary Educational Institutions; Revises the criteria for licensure by means of accreditation for an independent postsecondary educational institution. Requires that, in order to maintain its license, an institution file a report with the Commission for Independent Education which includes the results of a site visit performed by an accrediting agency. Requires that each institution request such site visits, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/SB 2682 (3R) by the Committees on Higher Education Appropriations, Higher Education and Senator Pruitt—

Florida College System; Renames the Division of Community Colleges as the Division of Florida Colleges. Defines the terms "Florida college" and "community college." Specifies the counties served by each Florida college. Provides that Florida colleges may offer specified baccalaureate degree programs through agreements with regionally accredited postsecondary educational institutions, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

CS/CS/CS/CS/SB 462 (3R) by the Committees on Health and Human Services Appropriations, Governmental Oversight and Accountability, Judiciary, Health Regulation, Senator Fasano and others—

Prescription Drugs/Electronic Monitoring/DOH; Requires the DOH to establish a comprehensive electronic database system to monitor the prescribing and dispensing of certain controlled substances. Requires specified prescribing and dispensing information to be reported to the electronic database system. Requires the department to establish policies and procedures for the system. Prohibits certain physicians from practicing in a pain-management clinic that has not registered with the DOH, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

SB 902 (3R) by Senator Deutch—

Public Health; Changes the name of the Florida Public Health Foundation, Inc., to the Florida Public Health Institute, Inc. Deletes the duties of the institute to facilitate communication between biomedical researchers and health care providers, to provide an annual report of its finances, and to provide an annual report of its activities to the Governor and the Florida Center for Universal Research to Eradicate Disease, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2009

CS/SB 948 (3R) by the Committee on Health Regulation and Senator Jones—

Emergency Medical Services; Revises requirements for the field internship experience in paramedic programs. Authorizes the Department of Health to adopt rules. Revises the documented requirements for a driver of an emergency vehicle. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

SB 1050 (3R) by Senator Joyner—

Medicaid/Preventable Medical Errors; Requires the AHCA to identify preventable medical errors that are not reimbursed by Medicaid programs in other states, the Medicare program, and private insurers and recommend to the Governor and the Legislature an expanded list of preventable medical errors for which the Medicaid program may refuse reimbursement, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/SB 1144 (3R) by the Committees on Health and Human Services Appropriations, Health Regulation and Senator Peaden—

Prescription Drugs; Revises the definition of the term "manufacturer" for purposes of the Florida Drug and Cosmetic Act. Requires certain manufacturers to disclose the names of affiliated group members to the Department of Health. Revises requirements for a prescription drug manufacturer permit, nonresident prescription drug manufacturer permit, and health care clinic establishment permit. Revises requirements for a pedigree paper, etc. Effective Date: 10/01/2009.

Read the second time and amended on April 23, 2009

POLICY AND STEERING COMMITTEE ON WAYS AND MEANS [WPSC] GROUPING

HB 7077 (3R) by the Committee on Health Care Appropriations (CGHC) and Representative Ambler—

Grants & Donations TF/AHCA & DCFS/Chiles Endowment; Provides additional source of funds for Grants and Donations Trust Fund within AHCA; revises date of reversion of undisbursed balances in Lawton Chiles Endowment Fund; requires that leasehold licensee fee be deposited into Grants and Donations Trust Fund of agency; requires that funds from nursing home facility quality assessments, certain grants & donations, & leasehold licensee fees be deposited into Grant and Donations TF of agency, etc. Effective Date: 07/01/2009.

Substituted for CS/SB 1346 (SUB) (Peaden) and read the second time on April 23, 2009

POLICY AND STEERING COMMITTEE ON SOCIAL RESPONSIBILITY [SPSC] GROUPING

CS/SB 1592 (3R) by the Committee on Health Regulation and Senator Lynn—

Nurse Registries/Companion-homemaker Organizations; Requires nurse registries and organizations that provide companion or homemaker services to provide notice to patients or clients. Specifies the contents of the notice. Requires the notice to be kept for a specified number of years. Provides an exception. Requires the Agency for Health Care Administration to develop a form for the notice. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

SB 1628 (3R) by Senator Gelber—

Long-term Care Services; Requires the Agency for Health Care Administration, in consultation with the Department of Elderly Affairs, to accept and forward to the Centers for Medicare and Medicaid Services an application for expansion of a pilot project from an entity that provides certain benefits under a federal program. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/SB 1868 (3R) by the Committees on Health and Human Services Appropriations, Health Regulation and Senator Peaden—

Prescribed Drugs; Authorizes the use of an institutional formulary system in a Class I institutional pharmacy at which, with certain exceptions, all medicinal drugs are administered from individual prescription containers to the patient and medicinal drugs are not dispensed on the premises. Revises provisions specifying the information required to be included in written prescriptions for medicinal drugs, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

SB 1896 (3R) by the Committee on Health Regulation (Gaetz)—

Florida Patient Safety Corporation; Repeals provision relating to the Florida Patient Safety Corporation. Repeals provision relating to a public records exemption for patient safety data or other records held by the Florida Patient Safety Corporation and its subsidiaries, advisory committees, or contractors, with certain exceptions, and relating to a public meetings exemption for portions of meetings held by the corporation or its subsidiaries, etc. Effective Date: Upon becoming law.

Read the second time on April 23, 2009

CS/CS/CS/SB 1986 (3R) by the Committees on Health and Human Services Appropriations, Criminal Justice, Health Regulation, Senator Gaetz and others—

Health Care; Designates Miami-Dade County as a health care fraud area of concern. Allocates certain funds recovered under the Florida False Claims Act to fund rewards for persons who report and provide information relating to Medicaid fraud. Requires entities regulated or licensed by the AHCA to designate a liaison officer for emergency operations. Revises the requirements of a provider to participate in the Florida 211 network, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

CS/SB 412 (3R) by the Committee on Criminal and Civil Justice Appropriations and Senator Crist—

Service of Process; Increases fees charged by the sheriff in civil cases for service of process. Exempts the state and its agencies from increased fees or additional fees required for alias and pluries. Provides that criminal witness subpoenas and criminal summonses may be served by a special process server appointed by the local sheriff or by a certified process server. Requires the submission of an affidavit before levying a judgment upon real property, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/HB 599 (3R) by the Committee on Governmental Affairs Policy (EDCA), Representative Hukill and others—

Administration of Estates; Revises various provisions relating to administration of estates. Effective Date: 07/01/2009.

Substituted for SB 1396 (SUB) (Aronberg) and read the second time on April 23, 2009

CS/CS/SB 1552 (3R) by the Committees on Banking and Insurance, Judiciary and Senator Bennett—

Lis Pendens; Permits property to be sold exempt from claims asserted in an action when the lis pendens has expired or been withdrawn or discharged. Requires a notice of lis pendens to include the date of the action or the case number of the action. Extends the time in which the holder of an unrecorded interest or lien may intervene in a pending action. Provides for the control and discharge of a lis pendens that no longer affects the property. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/HB 965 (3R) by the Committee on Civil Justice & Courts Policy (CCJP), Representative Grady and others—

Trust Administration; Revises beneficiary definition to exclude specified interests as beneficial interests; provides additional limitation on terms of trust prevailing over Florida Trust Code provisions; revises representation authority for holders of power of appointment; authorizes trust instruments to authorize specified persons to designate one or more persons to represent & bind beneficiary & receive information, etc. Effective Date: 07/01/2009.

Substituted for CS/CS/SB 1958 (SUB) (Gelber) and read the second time on April 23, 2009

POLICY AND STEERING COMMITTEE ON ENERGY, ENVIRONMENT, AND LAND USE [EPSC] GROUPING

CS/SB 110 (3R) by the Committee on Military Affairs and Domestic Security and Senator Bullard—

Community Redevelopment/Blighted Areas; Expands the definition of the term "blighted area" to include land previously used as a military facility. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/SB 148 (3R) by the Committees on Community Affairs, Environmental Preservation and Conservation and Senator Aronberg—

Mangrove Protection; Expands the penalty previously applicable to violations involving mangrove trimming or alteration to apply to any violation under the Mangrove Trimming and Preservation Act. Revises the definition of "riparian mangrove fringe." Provides that the act does not authorize trimming on uninhabited natural islands or lands that are publicly owned or set aside for conservation or mitigation except under specified circumstances, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/SB 306 (3R) by the Committee on Commerce, Senator Rich and others—

Vessel and Personal Watercraft Safety; Revises certain requirements for operating personal watercraft. Revises the requirements relating to the boating safety course required for leasing or renting a personal watercraft from a livery. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/CS/SB 1004 (3R) by the Committees on General Government Appropriations, Judiciary, Environmental Preservation and Conservation and Senator Constantine—

Coral Reefs; Creates the "Florida Coral Reef Protection Act." Requires responsible parties to notify the DEP if their vessel runs aground or damages a coral reef. Authorizes the department to enter into settlement agreements that require responsible parties to pay another government entity or nonprofit organization to fund projects consistent with the conservation or protection of coral reefs, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/SB 1078 (3R) by the Committees on General Government Appropriations, Judiciary and Senator Baker—

Water Management Districts/Limitation of Liability; Applies the limitation of liability of a WMD to the water areas of the district. Provides liability protection to an owner of private land used as an easement or other right by a WMD for the purpose of providing access to lands or water areas that the WMD makes available to the public for outdoor recreational activities. Defines the term "park area, district or other lands, or water areas.", etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

HB 255 (3R) by Representative Bemby and others—

Pest Control; Provides for enactment of Pest Control Compact; requires Commissioner of Agriculture to administer compact; requires that application for assistance be made by commissioner; provides for establishment of Pest Control Insurance Fund to finance pest-control operations under compact; provides for administration of fund by governing board & executive committee, etc. Effective Date: 07/01/2009.

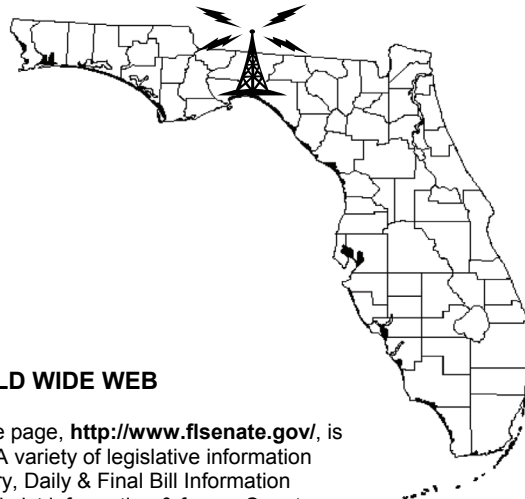
