# CS/CS/SB 762 (3R) by the Committees on Higher Education Appropriations, Higher Education, Senator Pruitt and others—

State University Tuition and Fees; Requires the Education Estimating Conference to develop information relating to the national average of tuition and fees. Revises provisions relating to the use of the student financial aid fee. Revises provisions relating to the establishment of a tuition differential. Provides requirements for a university board of trustees to submit aproposal to the Board of Governors to implement a tuition differential, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

#### SB 902 (3R) by Senator Deutch-

Public Health; Changes the name of the Florida Public Health Foundation, Inc., to the Florida Public Health Institute, Inc. Deletes the duties of the institute to facilitate communication between biomedical researchers and health care providers, to provide an annual report of its finances, and to provide an annual report of its activities to the Governor and the Florida Center for Universal Research to Eradicate Disease, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2009

## SB 1896 (3R) by the Committee on Health Regulation (Gaetz)—

Florida Patient Safety Corporation; Repeals provision relating to the Florida Patient Safety Corporation. Repeals provision relating to a public records exemption for patient safety data or other records held by the Florida Patient Safety Corporation and its subsidiaries, advisory committees, or contractors, with certain exceptions, and relating to a public meetings exemption for portions of meetings held by the corporation or its subsidiaries, etc. Effective Date: Upon becoming law.

Read the second time on April 23, 2009

Identical to **HB 7023 (HC)** in the Committees on Health Regulation, Governmental Oversight and Accountability, and Health and Human Services Appropriations

# CS/CS/SB 148 (3R) by the Committees on Community Affairs, Environmental Preservation and Conservation and Senator Aronberg—

Mangrove Protection; Expands the penalty previously applicable to violations involving mangrove trimming or alteration to apply to any violation under the Mangrove Trimming and Preservation Act. Revises the definition of "riparian mangrove fringe." Provides that the act does not authorize trimming on uninhabited natural islands or lands that are publicly owned or set aside for conservation or mitigation except under specified circumstances, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

# CS/CS/CS/SB 1004 (3R) by the Committees on General Government Appropriations, Judiciary, Environmental Preservation and Conservation and Senator Constantine—

**Coral Reefs;** Creates the "Florida Coral Reef Protection Act." Requires responsible parties to notify the DEP if their vessel runs aground or damages a coral reef. Authorizes the department to enter into settlement agreements that require responsible parties to pay another government entity or nonprofit organization to fund projects consistent with the conservation or protection of coral reefs, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

#### SB 2656 (3R) by Senator Haridopolos—

**Arboriculture;** Creates the "Florida Arborist Licensing Law." Provides powers and duties of the DOACS. Establishes licensure procedures and requirements to practice arboriculture and provide such services. Authorizes DOACS to enforce certain provisions of state law by specified means. Revises a definition to make tropical foliage exempt from regulation under provisions relating to dealers in agricultural products, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

# CS/SB 342 (3R) by the Committee on Transportation and Economic Development Appropriations, Senator King and others—

**St. Johns River License Plate**; Creates the St. Johns River license plate. Establishes an annual use fee for the plate. Provides for the distribution of use fees received from the sale of such plates. Effective Date: 10/01/2009.

Read the second time on April 24, 2009

# CS/SB 642 (3R) by the Committee on Health and Human Services Appropriations, Senator Altman and others—

License Plates; Revises authorized uses of proceeds received from the sale of the United We Stand license plate. Creates a Fraternal Order of Police license plate. Creates an Autism license plate. Creates the Go Green Florida license plate. Creates the Catch Me, Release Me license plate. Creates an Endless Summer license plate. Creates the St. Johns River license plate. Creates a Florida Biodiversity Foundation license plate, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 24, 2009

## CS/SB 650 (3R) by the Committee on General Government Appropriations and Senator Garcia—

Catch Me, Release Me License Plate; Creates the Catch Me, Release Me license plate. Establishes an annual use fee for the plate. Provides for the distribution of use fees received from the sale of the plate. Effective Date: 10/01/2009.

Read the second time on April 24, 2009

### CS/SB's 674, SB 1422 (3R) by the Committee on Regulated Industries, Senators Constantine and Baker—

Construction Contracting; (THIS BILL COMBINES S674 & S1422) Requires that owners of property acting as their own contractor and providing direct, onsite supervision of all work not performed by licensed contractors read and sign a disclosure statement before a permit is issued. Provides that certain individuals or business organizations may not be considered unlicensed for failure to have a required local jurisdiction license. Provides for retroactive application, etc. Effective Date: Upon becoming law.

Read the second time on April 24, 2009

#### CS/CS/SB 714 (3R) by the Committees on General Government Appropriations, Regulated Industries . Senator Jones and others—

Condominiums; Requires that coverage under a unit owner's policy for certain assessments include at least a minimum amount of loss assessment coverage. Provides an exemption for certain condominiums from installing a manual fire alarm system as required in the Life Safety Code if certain conditions are met. Requires that adequate property insurance be based upon the replacement cost of the property to be insured as determined by an independent appraisal, etc. Effective Date: Upon becoming law

Read the second time and amended on April 24, 2009

#### SB 860 (3R) by Senator Altman and others—

**Endless Summer License Plate;** Creates an Endless Summer license plate. Establishes an annual use fee for the plate. Provides for the distribution of use fees received from the sale of such plates. Effective Date: 10/01/2009.

Read the second time on April 24, 2009

#### SB 872 (3R) by Senator Smith—

**Fictitious Names**; Repeals specified provision relating to a conditional waiver by the Department of State of the requirement that an applicant to do business under a fictitious name advertise the intention to register such fictitious name in a newspaper in the county in which the principal place of business will be located. Effective Date: 07/01/2009.

Read the second time on April 24, 2009

## CS/CS/HB 405 (3R) by the Economic Development & Community Affairs Policy Council, the Committee on Insurance, Business, &Financial Affairs Policy (GGPC), Representative Nelson and others—

**Delivery Vehicles**; Authorizes use of golf carts, low-speed vehicles, & utility vehicles by seasonal delivery personnel during certain timeframe; requires specified vehicles to be equipped with safety equipment. Effective Date: 07/01/2009.

Substituted for **CS/CS/CS/SB 1088 (SUB)** (Altman) and read the second time on April 24, 2009

#### SB 1398 (3R) by Senator Fasano—

Fraternal Order of Police/Autism License Plate; Creates a Fraternal Order of Police license plate and an Autism license plate. Establishes an annual use fee for the plates. Provides for the distribution of use fees received from the sale of such plates. Effective Date: 07/01/2009.

Read the second time and amended on April 24, 2009

# CS/CS/SB 1404 (3R) by the Committees on Criminal Justice, Transportation, Senator Altman and others—

Child-restraint Requirements; Provides child-restraint requirements for children ages 4 through 7. Provides exceptions. Redefines the term "motor vehicle" to exclude certain vehicles from such requirements. Provides a grace period and exceptions. Effective Date: 07/01/2009 except as otherwise provided.

## CS/SB 582 (3R) by the Committee on Transportation and Senator Baker—

**Transportation**; Provides legislative findings with respect to the need to preserve investments in transportation infrastructure and reduce congestion. Requires specified scale tolerances to be applied to weight limits for vehicles on highways that are not in the Interstate Highway System. Creates an exemption for certain proposed affordable housing developments from transportation concurrency requirements, etc. Effective Date: Upon becoming law

Read the second time and amended on April 24, 2009

#### SB 2064 (3R) by Senator Altman-

Construction Defects; Limits application of certain notices. Revises requirements and procedures for notice and opportunity to repair certain defects. Specifies that there are no construction lien rights under certain provisions of law for certain testing. Revises requirements for application to certain claims for legal relief. Revises application of notice requirements to certain earlier contracts. Specifies a required notice for certain contracts, etc. Effective Date: 10/01/2009.

Read the second time on April 24, 2009

### CS/SB 2210 (3R) by the Committee on Transportation and Senator Wilson—

Charter County Transit System Surtax; Changes the name of the surtax. Expands eligible counties authorized to levy the surtax. Requires interlocal agreements in certain counties to be updated no less than every 5 years to include certain municipalities. Effective Date: 07/01/2009.

Read the second time and amended on April 24, 2009

Similar to **CS/CS/HB 1205 (HC)** in the Committees on Transportation, Community Affairs, Finance and Tax, and Transportation and Economic Development Appropriations

#### SB 2330 (3R) by Senator Richter-

**Corporations**; Authorizes certain alternative procedures for the election of members of the board of directors. Revises resignation procedures for members of the board of directors. Provides that a resignation may be irrevocable under certain conditions. Deletes a provision providing that there shall be no charge for telephone requests for certain general corporate information. Prohibits a corporation not for profit from making distributions to its members, etc. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 24, 2009

# CS/CS/SB 1894 (3R) by the Committees on Finance and Tax, Judiciary, Senator Bennett and others—

**Surplus Lines Insurers;** Provides for the nonapplication of certain provisions of state law to surplus lines insurance authorized under the Surplus Lines Law. Provides methods of payment for premiums and claims regarding surplus lines contracts issued on or after a specified date. Requires that certain insurers provide a disclosure statement to a claimant under certain circumstances, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 24, 2009

## SB 216 (3R) by Senator Justice and others—

# Campaign Financing/Local Government Expenditures; Defines the terms "local government" and "public funds." Prohibits a local government from expending, and a person or group from accepting, public funds for a political advertisement or electioneering communication concerning an issue, referendum,

electioneering communication concerning an issue, referendum, or amendment that is subject to the vote of the electors. Provides an exception for certain electioneering communications. Clarifies restrictions with respect to local officials. Effective Date: 07/01/2009.

Read the second time on April 24, 2009

#### SB 324 (3R) by Senator Crist—

### Public Libraries/Internet Safety Education Program;

Encourages all public libraries to implement an Internet safety education program for children and adults. Provides minimum requirements for the program. Requires libraries to annually report to the Division of Library and Information Services of the Department of State the number of participants who complete the program. Requires that the division adopt rules to award additional points to grant applicants implementing such a program. Effective Date: 07/01/2009.

Read the second time on April 24, 2009

# CS/CS/SB 2160 (3R) by the Committees on Policy & Steering Committee on Ways and Means, Finance and Tax and Senator Haridopolos—

#### Obsolete or Outdated Agency Plans/Reports/Programs;

Repeals a provision relating to the Florida State Commission on Hispanic Affairs. Revises reporting requirements of the Citizen's Assistance Office. Repeals a provision relating to the Florida Commission on African-American Affairs. Repeals a provision relating to the Florida Legal Resource Center. Revises the recipients of the annual report of trust funds by the Chief Financial Officer, etc. Effective Date: Upon becoming law.

## CS/CS/CS/SB 494 (3R) by the Committees on General Government Appropriations, Community Affairs, Environmental Preservation and Conservation, Senator Bennett and others—

**Water Conservation**; Revises requirements for automatic landscape irrigation systems. Encourages county and municipal governments to adopt and enforce the Model Ordinance for Florida-Friendly Fertilizer Use on Urban Landscapes or an equivalent requirement as a mechanism for protecting local surface water and groundwater quality. Requires the DEP to establish and approve training and testing programs providing urban landscape best-management practices, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 24, 2009

## CS/SB 624 (3R) by the Committee on Community Affairs and Senator Fasano—

Law Enforcement Officers and Correctional Officers; Provides that a law enforcement officer or correctional officer is entitled to specified rights if the officer is subject to suspension in a disciplinary proceeding. Provides that said officers are entitled to review witness statements by other officers & other existing evidence before the officer under investigation is interrogated, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 24, 2009

## HB 73 (3R) by Representative Schenck and others—

Permit Process for Economic Development Projects;
Designates act "Mike McHugh Act"; requires DEP & water
management districts to adopt programs to expedite processing
of permits for certain economic development projects; requires
municipalities & counties to identify certain businesses by
commission resolution; provides timeframe for permit application
approval or denial, etc. Effective Date: 07/01/2009.

Substituted for **CS/SB 852 (SUB)** (Fasano) and read the second time on April 24, 2009

# CS/CS/SB 2536 (3R) by the Committees on Judiciary, Environmental Preservation and Conservation and Senator Constantine—

Fish & Wildlife Conservation Commission; Requires the FWC rather than the DOR to distribute a specified sum from the Invasive Plant Control Trust Fund to eradicate melaleuca. Provides for preservation of sea grasses. Increases the annual use fee for certain specialty license plates. Amends the definition of the term "live-aboard vessel." Prohibits possessing or operating a vessel equipped with certain fuel containers or related equipment, etc. Effective Date: 07/01/2009 except as otherwise provided.

Read the second time and amended on April 24, 2009

## SB 68 (3R) by Senator Aronberg—

Nicole Hornstein Act/Equine Activities; Requires a child younger than a specified age to wear a helmet when riding an equine in certain locations. Provides requirements for helmets. Requires a person renting or leasing an equine for riding by a child younger than a specified age to provide a helmet if the child does not have a helmet. Prohibits a parent or guardian of a child younger than a specified age from authorizing or permitting the child to engage in certain conduct, etc. Effective Date: 10/01/2009.

Read the second time and amended on April 24, 2009

## CS/CS/SB 162 (3R) by the Committees on Governmental Oversight and Accountability, Health Regulation and Senator Ring—

Electronic Health Records; Expands access to a patient's health records in order to facilitate the exchange of data between certain health care facility personnel. Deletes the exemption that allows long-term ombudsman councils to have access to certain nursing home patient records. Creates the "Florida Electronic Health Records Exchange Act." Requires the AHCA to operate an electronic health record technology loan fund, subject to a specific appropriation. Effective Date: Upon becoming law.

Read the second time and amended on April 24, 2009

#### SB 498 (3R) by Senator Baker—

Clinical, Counseling, and Psychotherapy Services; Provides for a waiver of confidentiality and privileged communications when, in the clinical judgment of a person licensed or certified under the laws covering said services, there is a clear and immediate probability of certain harm. Provides immunity from liability for, and prohibiting causes of action against, such person for disclosure of otherwise confidential communications under such circumstances. Effective Date: 07/01/2009.

Read the second time on April 24, 2009

## CS/SB 720 (3R) by the Committee on Health Regulation, Senator Peaden and others—

Physician Practice; Revises provisions regarding board certification of a physician as a specialist. Provides that a supervising physician may not be required to review and cosign a physician assistant's charts or medical records. Deletes certain supervisory physician requirements related to prescribing and dispensing medications noted in appropriate medical records, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 24, 2009

### SB 1848 (3R) by Senator Detert and others—

**Prisoner's Immigration Status/Verification**; Requires the staff of a jail or other detention center or facility to make a reasonable effort to determine the citizenship status of a person charged with specified crimes. Requires facility staff to verify the person's immigration status and notify the United States Department of Homeland Security if the person is not lawfully in the United States. Requires agencies affected by this act to adopt written procedures, etc. Effective Date: 07/01/2009.

## CS/CS/HB 873 (3R) by the Health & Family Services Policy Council, the Committee on Health Care Regulation Policy (HFPC), Representative A. Williams and others—

Inactive Licenses/Certificates of Need/Health Care; Extends period for which certificate of need is valid; provides for renewal of inactive license status for statutory rural hospitals; requires plan approval & commencement of construction under certain circumstances; requires certain proof of enforceable capital expenditures under certain circumstances. Effective Date: Upon becoming law.

Substituted for **CS/SB 1926 (SUB)** (Lawson) and read the second time on April 24, 2009

# CS/CS/SB 2066 (3R) by the Committees on Education Pre-K - 12 Appropriations, Education Pre-K - 12 and Senator Haridopolos—

**Public School Athletic Coaches/Certification**; Provides that completion of a sports safety course shall meet certain certification requirements. Requires the sports safety course to be approved by the Florida High School Athletic Association Board of Directors and to meet specified requirements. Effective Date: 07/01/2009.

Read the second time on April 24, 2009

Similar to **CS/CS/HB 1539 (HC)** in the Committees on Education Pre-K - 12 and Education Pre-K - 12 Appropriations

# CS/CS/SB 2612 (3R) by the Committees on Health Regulation, Children, Families, and Elder Affairs and Senator Wise—

Substance Abuse & Mental Health Services; Establishes priority populations of persons who are eligible for services funded by the DCFS. Deletes a provision that authorizes the DCFS to establish a pilot project to serve certain persons who qualify to receive substance abuse or mental health services in a specified district. Provides that a crisis stabilization unit is exempt from licensure. Authorizes DCFS to issue probationary, regular, and interim licenses, etc. Effective Date: 07/01/2009.

Read the second time on April 24, 2009

#### CS/HB 285 (3R) by the Committee on Health Care Regulation Policy (HFPC), Representative Patronis and others—

**Medicaid Low-Income Pool/Disproportionate Share**; Expands membership of Medicaid Low-Income Pool Council; provides for composition of expanded membership; designates council chair; provides restrictions on specified appointments. Effective Date: 07/01/2009.

Substituted for **CS/CS/SB 556 (SUB)** (Gaetz) and read the second time on April 24, 2009

## CS/CS/HB 991 (3R) by the Full Appropriations Council on Education & Economic Development, the Committee on PreK-12 Policy (EPC), Representative Grady and others—

School Improvement and Accountability; Designates act "Florida's Equal Opportunity in Education Act"; revises provisions relating to powers & duties of district school boards to implement state system of school improvement & education accountability; requires that State Board of Education comply with federal Elementary and Secondary Education Act (ESEA); requires that DOE categorize public schools annually based on school grade & level & rate of change in student performance, etc. Effective Date: 07/01/2009.

Substituted for **CS/SB 1682 (SUB)** (Wise) and read the second time on April 24, 2009

# CS/CS/CS/SB's 2430, SB 1960 (3R) by the Committees on Policy & Steering Committee on Ways and Means, Finance and Tax, Judiciary, Senators Lawson and Gelber—

Pub. Rec./K-12 & Postsecondary Education Records; Provides an exemption from public records requirements for K-12 education records held by an agency, public school, center, institution, or other entity that is part of the state's education system. Provides exceptions to the exemption. Expands the exemption from public records requirements for records of students in public postsecondary educational institutions to include education records and applicant records, etc. Effective Date: Contingent.

Provides that certain actions constitute an immediate and serious danger to the public safety, health & welfare, etc. Effective Date: 07/01/2009.

## CS/CS/CS/SB 1182 (SO) by the Committees on Governmental Oversight and Accountability, Ethics and Elections, Community Affairs, Senator Fasano and others—

State Retirement System; Clarifies when a State Community College System Optional Retirement Program participant is considered a retiree. Prohibits elected officials who retire after a certain date from reenrolling in the FRS. Provides that retirees of a state-administered retirement system may not be reemployed by an employer participating in the FRS for 6 months. Rec./Education Testing/Investigation by DOE**; Provides an exemption from public records requirements for personally identifiable information or allegations of misconduct obtained or reported in connection with an investigation of a testing impropriety conducted by the Department of Education. Provides that the exemption applies until the investigation is concluded or becomes inactive. Provides for future legislative review and repeal of the exemption under the OGSR Act, etc. Effective Date: 07/01/2009.

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12 and the Committee on Governmental Oversight and Accountability, reports the committee substitute favorably and withdrawn from the Committee on Rules

Similar to **CS/HB 895 (HC)** in the Committees on Education Pre-K - 12, Governmental Oversight and Accountability, and Rules

#### SB 1066 (SO) by Senator Aronberg and others—

**Foreign Defamation Judgments/Nonrecognition**; Provides that an out-of-country foreign judgment need not be recognized if the cause of action resulted in a defamation judgment obtained in a jurisdiction outside the United States, unless a court in this state first determines that the defamation law applied in the foreign court's adjudication provided at least as much protection for freedom of speech and press as would be provided in this state, etc. Effective Date: 07/01/2009.

## SB 1862 (SO) by Senator Joyner—

**Community Corrections Assistance;** Adds rehabilitative community reentry programs to the list of programs, services, and facilities that may be funded using community corrections funds. Effective Date: 07/01/2009.

## CS/CS/SB 340 (SO) by the Committees on Judiciary, Criminal Justice and Senator Ring—

Removes residency requirements in statutes relating to computer pornography involving minor children and the transmission of material harmful to a minor be electronic device or equipment, respectively. Requires sexual offenders and predators to provide home telephone numbers and any cellular telephone numbers, etc. Effective Date: 07/01/2009.

## CS/SB 1122 (SO) by the Committee on Health Regulation, Senator Gaetz and others—

Health Insurance/Payment of Benefits/Claims Forms; Requires that an insurer make payment to the designated provider of services whenever an insured, using any health insurance claim form, specifically authorizes payments of benefits directly to any recognized hospital, licensed ambulance provider, physician, dentist, or other person who provided the services in accordance with the provisions of the policy. Requires that claims forms provide an option for such payment, etc. Effective Date: 07/01/2009.

Reported favorably, with one amendment, by the Committee on Banking and Insurance, and reported favorably as a committee substitute by the Committee on Health Regulation and the Committee on General Government Appropriations reports the committee substitute favorably and withdrawn from the Committee on Policy & Steering Committee on Ways and Means

# CS/CS/SB 1468 (SO) by the Committees on Finance and Tax, Community Affairs, Senator Dean and others—

Working Waterfront Property; Identifies property that is eligible for classification as working waterfront property. Requires the assessment of such property based on current use. Provides for the loss of classification upon a change of ownership or use. Provides for the classification of land as working waterfront property on an assessment roll. Provides that certain property does not qualify as commercial waterfront property, etc. Effective Date: 07/01/2009.

OGSR/Surplus State Lands and Documents; Amends a provision relating to an exemption from public records requirements for a written valuation of state-owned lands determined to be surplus and for related documents used to form the valuation or pertaining to the valuation. Reorganizing and clarifying provisions. Saves the exemption from repeal under the OGSR Act. Removes the scheduled repeal of the exemption. Effective Date: 10/01/2009.

Confidential Informants/Rachael's Law; Creates Rachael's Law. Requires a law enforcement agency that uses confidential informants to disclose certain information to persons who are requested to serve as said informants. Provides that a law enforcement agency must provide a person who is requested to serve as a confidential informant the opportunity to consult with legal counsel. Requires training for persons involved in the recruitment and use of confidential informants, etc. Effective Date: 07/01/2009.

## CS/SB 2198 (SO) by the Committee on Judiciary and Senator Haridopolos—

Tobacco Settlement Agreements; Requires trial courts to stay the execution of all judgments in favor of certain former class action members during appellate proceedings upon the posting of a supersedeas bond or other surety by signatories, parents, successors, or affiliates of a signatory to a tobacco settlement agreement applicable to all such judgments. Limits the total cumulative value of all supersedeas bonds or other surety to a certain amount, etc. Effective Date: Upon becoming law.

**First-responder Services**; Prohibits counties and municipalities from imposing a fee or seeking reimbursement for costs relating to certain first-responder services. Provides an exception. Defines the term "first responder." Effective Date: 07/01/2009.

**Health Care**; Designates Miami-Dade County as a health care fraud area of concern. Allocates certain funds recovered under the Florida False Claims Act to fund rewards for persons who report and provide information relating to Medicaid fraud. Provides for certain out-of-state providers to enroll as Medicaid providers. Removes provisions requiring quality-of-care monitors for nursing facilities in agency district offices, etc. Effective Date: 07/01/2009.

Reported favorably as a committee substitute by the Committee on Health Regulation and reported favorably as a committee substitute by the Committee on Judiciary

#### SB 2416 (SO) by Senator Gaetz—

**Solid Waste Disposal/Yard Trash/Class I Landfill;** Authorizes the disposal of yard trash at a Class I landfill if the landfill has a system for collecting landfill gas and arranges for the reuse of the gas. Effective Date: 07/01/2009.

Reported favorably by the Committee on Environmental Preservation and Conservation, and withdrawn from the Committee on Community Affairs

#### SB 2246 (SO) by Senator King and others—

Jacksonville Transportation Authority; Revises a requirement for membership on the governing body of the authority to provide that an appointed member must be a resident and elector of Duval County. Revises scope of the authority to include certain services throughout Duval County. Requires a public hearing prior to designation or relocation of transportation facilities or substantive changes thereto. Provides approval for bond financing by the authority, etc. Effective Date: 07/01/2009.

Insurance; Cites act as the "Safeguard Our Seniors Act." Expands the definition of "affiliated party" to include certain third-party marketers. Includes family members of insurance agents in a prohibition related to the transaction of life insurance. Expands grounds for discretionary refusal, suspension, or revocation of certain licenses. Authorizes the use of video depositions in certain circumstances, etc. Effective Date: 07/01/2009

#### SB 628 (SO) by Senator Lynn and others—

Enterprise Zones/City of Ocala; Authorizes the City of Ocala to apply to the Office of Tourism, Trade, and Economic Development for designation of an enterprise zone. Provides an application deadline. Provides requirements for the area of the enterprise zone. Requires that the office establish the initial effective date of the enterprise zone. Effective Date: Upon becoming law.

Requires that a member of the legislative committee administer the oath or affirmation, etc. Effective Date: 07/01/2009.

## CS/SB 2408 (SO) by the Committee on Judiciary and Senator Joyner—

**Wrongful Incarceration Compensation**; Requires that a petition for compensation include clear and convincing evidence of actual innocence. Requires the petitioner to submit fingerprints for criminal history records checks. Provides that failure to submit fingerprints within the prescribed timeframe does not warrant denial of compensation under the act. Requires the Department of Legal Affairs to request certain records from the clerk of the court and the DOC, etc. Effective Date: 07/01/2009.

## CS/SB 2296 (SO) by the Committee on Health Regulation and Senator Constantine—

**Influenza Vaccine;** Requires child care facilities, family day care homes, and large family child care homes to provide parents with certain information regarding the causes, symptoms, and transmission of the influenza virus. Effective Date: Upon becoming law.

Provides that federal or state authorizations for such actions prevail over certain other regulations, permits, comprehensive plans, and laws, etc. Effective Date: Upon becoming law.

## CS/CS/CS/SB 904 (SO) by the Committees on Policy & Steering Committee on Ways and Means, Judiciary, Children, Families, and Elder Affairs and Senator Deutch—

Parental Responsibility and Time-sharing; Provides for parenting coordination as an alternative dispute resolution process to resolve parenting plan disputes. Revises the elements of the rebuttable presumption that shared parental responsibility is detrimental to a child when a parent is convicted of a crime involving domestic violence. Allows the modification of aparenting plan only upon a showing of substantially changed circumstances, etc. Effective Date: 10/01/2009.

Provides legislative findings and intent relating to young adults leaving foster care, etc. Effective Date: 07/01/2009.

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs, and the Committee on Community Affairs reports the committee substitute favorably and withdrawn from the Committee on Policy & Steering Committee on Ways and Means

# CS/CS/SB 564 (SO) by the Committees on Policy & Steering Committee on Ways and Means, Transportation and Economic Development Appropriations, Senator Haridopolos and others—

Public Campaign Financing; Repeals the "Florida Election Campaign Financing Act." Deletes references to the Election Campaign Financing Trust Fund, which expired, effective November 4, 1996, by operation of s. 19(f), Art. III of the State Constitution. Provides expenditure limits for certain candidates for statewide office. Effective Date: 01/01/2010 except as otherwise provided.


