# BILLS ON THIRD READING

# SB 902 (3R) by Senator Deutch-

**Public Health;** Changes the name of the Florida Public Health Foundation, Inc., to the Florida Public Health Institute, Inc. Deletes the duties of the institute to facilitate communication between biomedical researchers and health care providers, to provide an annual report of its finances, and to provide an annual report of its activities to the Governor and the Florida Center for Universal Research to Eradicate Disease, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 23, 2009

### CS/CS/SB 148 (3R) by the Committees on Community Affairs, Environmental Preservation and Conservation and Senator Aronberg—

**Mangrove Protection;** Expands the penalty previously applicable to violations involving mangrove trimming or alteration to apply to any violation under the Mangrove Trimming and Preservation Act. Revises the definition of "riparian mangrove fringe." Provides that the act does not authorize trimming on uninhabited natural islands or lands that are publicly owned or set aside for conservation or mitigation except under specified circumstances, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

### CS/CS/CS/SB 1004 (3R) by the Committees on General Government Appropriations, Judiciary, Environmental Preservation and Conservation, Senator Constantine and others—

**Coral Reefs;** Creates the "Florida Coral Reef Protection Act." Requires responsible parties to notify the DEP if their vessel runs aground or damages a coral reef. Authorizes the department to enter into settlement agreements that require responsible parties to pay another government entity or nonprofit organization to fund projects consistent with the conservation or protection of coral reefs, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

### SB 2656 (3R) by Senator Haridopolos-

**Arboriculture;** Creates the "Florida Arborist Licensing Law." Provides powers and duties of the DOACS. Establishes licensure procedures and requirements to practice arboriculture and provide such services. Authorizes DOACS to enforce certain provisions of state law by specified means. Revises a definition to make tropical foliage exempt from regulation under provisions relating to dealers in agricultural products, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

### CS/SB 642 (3R) by the Committee on Health and Human Services Appropriations, Senator Altman and others—

License Plates; Revises authorized uses of proceeds received from the sale of the United We Stand license plate. Creates a Fraternal Order of Police license plate. Creates an Autism license plate. Creates the Go Green Florida license plate. Creates the Catch Me, Release Me license plate. Creates an Endless Summer license plate. Creates the St. Johns River license plate. Creates a Florida Biodiversity Foundation license plate, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 24, 2009

### CS/CS/SB 1894 (3R) by the Committees on Finance and Tax, Judiciary, Senator Bennett and others—

**Surplus Lines Insurers;** Provides for the nonapplication of certain provisions of state law to surplus lines insurance authorized under the Surplus Lines Law. Provides methods of payment for premiums and claims regarding surplus lines contracts issued on or after a specified date. Requires that certain insurers provide a disclosure statement to a claimant under certain circumstances, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 24, 2009

# CS/CS/SB 2536 (3R) by the Committees on Judiciary, Environmental Preservation and Conservation and Senator Constantine—

**Fish & Wildlife Conservation Commission;** Requires the FWC rather than the DOR to distribute a specified sum from the Invasive Plant Control Trust Fund to eradicate melaleuca. Provides for preservation of sea grasses. Increases the annual use fee for certain specialty license plates. Amends the definition of the term "live-aboard vessel." Prohibits possessing or operating a vessel equipped with certain fuel containers or related equipment, etc. Effective Date: 07/01/2009 except as otherwise provided.

Read the second time and amended on April 24, 2009

Similar to **CS/CS/HB 1423 (HC)** in the Committees on Environmental Preservation and Conservation, Criminal Justice, Judiciary, and General Government Appropriations

# SB 68 (3R) by Senator Aronberg-

**Nicole Hornstein Act/Equine Activities;** Requires a child younger than a specified age to wear a helmet when riding an equine in certain locations. Provides requirements for helmets. Requires a person renting or leasing an equine for riding by a child younger than a specified age to provide a helmet if the child does not have a helmet. Prohibits a parent or guardian of a child younger than a specified age from authorizing or permitting the child to engage in certain conduct, etc. Effective Date: 10/01/2009.

Read the second time and amended on April 24, 2009

Similar to **CS/HB 169 (HC)** in the Committees on Agriculture, Transportation, Judiciary, and General Government Appropriations

# CS/SB 718 (3R) by the Committee on Health Regulation and Senator King—

**Discretionary Sales Surtaxes**; Deletes a limitation upon the imposition of indigent care and trauma center discretionary sales surtaxes by certain counties. Effective Date: 07/01/2009.

Read the second time on April 27, 2009

# CS/CS/HB 179 (3R) by the Finance & Tax Council, the Committee on Military & Local Affairs Policy (EDCA), Representative Nelson and others—

**Property Appraisers;** Revises property appraisers' authority to inspect property for assessment purposes to include use of image technology in lieu of physical inspection; requires DOR to establish minimum standards for use of image technology; revises required time limitations for filing applications for homestead exemptions; revises procedural requirements for property appraiser approval of such exemptions, etc. Effective Date: 07/01/2009.

Substituted for **CS/SB 800 (SUB)** (Baker) and read the second time on April 27, 2009

# CS/CS/SB 1950 (3R) by the Committees on Policy & Steering Committee on Ways and Means, Banking and Insurance and Senator Richter—

**Property Insurance;** Revises the dates of an insurer's contract year for purposes of calculating the insurer's retention. Requires the State Board of Administration to offer an additional amount of reimbursement coverage to certain insurers that purchased coverage during a certain calendar year. Prohibits a public adjuster from accepting referrals for compensation from a person with whom said adjuster conducts business, etc, Effective Date: 06/01/2009.

Read the second time and amended on April 24, 2009; and further amended on April 27, 2009

# CS/CS/HB 453 (3R) by the Finance & Tax Council, the Committee on PreK-12 Policy (EPC), Representative Weatherford and others—

**Tax Credits/Nonprofit Scholarship-funding Org.**; Provides that credit authorized under Florida Tax Credit Scholarship Program does not apply to credit for Florida alternative minimum tax; expands & renames Corporate Income Tax Credit Scholarship Program to include insurance premium tax credits; revises credits for contributions to nonprofit scholarship-funding organizations, etc. Effective Date: 07/01/2009.

Substituted for **CS/CS/SB 1310 (SUB)** (Gardiner) and read the second time on April 27, 2009

# SB 234 (3R) by Senator Gaetz-

**State University Presidents;** Revises powers and duties of the Board of Governors and university boards of trustees relating to personnel. Provides that a state university president is not subject to the personnel program established by the Board of Governors. Requires that a board of trustees appoint the university president and administer a personnel program for the president. Effective Date: 07/01/2009.

Read the second time on April 27, 2009

# CS/CS/CS/HB 29 (3R) by the Criminal & Civil Justice Policy Council, the Committees on Energy & Utilities Policy (GGPC), Public Safety & Domestic Security Policy (CCJP), Representative Grimsley and others—

**Unlawful Use of Utility Services;** Provides criminal penalties for permitting tenant or occupant to use unlawfully connected utility services; provides that such violation is first-degree misdemeanor; provides for prima facie evidence of intent to violate such prohibition; provides that theft of utility services for purpose of manufacturing controlled substance is first-degree misdemeanor, etc. Effective Date: 10/01/2009.

Substituted for **CS/CS/CS/SB 236 (SUB)** (Dean) and read the second time on April 27, 2009

# CS/CS/CS/SB 448 (3R) by the Committees on Criminal and Civil Justice Appropriations, Agriculture, Criminal Justice and Senator Rich—

Sexual Activities Involving Animals; Provides definitions. Prohibits knowing sexual conduct or sexual contact with an animal. Prohibits specified related activities. Provides penalties. Provides that the act does not apply to certain husbandry, conformation judging, and veterinary practices. Effective Date: 10/01/2009.

Read the second time on April 27, 2009

## CS/HB 123 (3R) by the Full Appropriations Council on General Government &Health Care, Representative Snyder and others—

**Human Smuggling;** Provides that person commits a misdemeanor if he or she transports an individual into this state from another country & knows, or should know, that individual is illegally entering US; provides criminal penalties. Effective Date: 10/01/2009.

Substituted for **CS/SB 502 (SUB)** (Dockery) and read the second time on April 27, 2009

# CS/CS/SB 526 (3R) by the Committees on Criminal and Civil Justice Appropriations, Criminal Justice, Senator Lynn and others—

**Court Costs;** Expands the list of provisions of law for which a court is required to impose an additional court cost for certain pleadings or findings relating to offenses against a minor and certain other offenses. Increases the amount of the court cost. Provides for distribution of a portion of the court costs to the Office of the Statewide Guardian Ad Litem and the Florida Network of Children's Advocacy Centers, Inc. Effective Date: 07/01/2009.

Read the second time and amended on April 27, 2009

# CS/HB 739 (3R) by the Committee on State & Community Colleges & Workforce Policy (EPC), Representative Chestnut and others—

**Community College Student Fees;** Authorizes community college boards of trustees to establish transportation access fee; limits amount of fee; provides timeframe for fee increase & implementation of increase; prohibits inclusion of fee in calculating amount student receives under Florida Bright Futures Scholarship Program awards. Effective Date: 07/01/2009.

Substituted for **CS/CS/SB 622 (SUB)** (Oelrich) and read the second time on April 27, 2009

# CS/CS/CS/SB 1128 (3R) by the Committees on Judiciary, Children, Families, and Elder Affairs, Education Pre-K - 12, Senator Rich and others—

Education/Children in Shelter Care or Foster Care; Provides conditions for the district school superintendent or court appointment of a surrogate parent for educational decisionmaking for a child who has or is suspected of having a disability. Provides requirements for educational placement. Requires DCFS, AHCA, & residential facilities licensed by APD to notify certain school districts following the placement of an exceptional student in a private residential care facility, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 27, 2009

# CS/HB 177 (3R) by the Policy Council, Representative Adams and others—

**Firearms Transactions;** Clarifies that violations of provisions prohibiting keeping any list, record, or registry of privately owned firearms or any list, record, or registry of the owners of those firearms may be committed by entities as well as persons; requires that secondhand dealers & pawnbrokers who electronically submit certain firearm transaction records submit specified information in FCIC coding. Effective Date: 07/01/2009.

Substituted for **CS/SB 1340 (SUB)** (Crist) and read the second time on April 27, 2009

## CS/HB 1269 (3R) by the Health & Family Services Policy Council, Representative Homan and others—

**Breast Cancer Detection and Screening;** Establishes breast cancer early detection & treatment referral program within DOH; provides purposes of program; requires department to provide information regarding breast cancer & referrals for screening & treatment for certain populations; requires State Surgeon General to submit report to Legislature. Effective Date: 07/01/2009.

Substituted for **CS/SB 1880 (SUB)** (Peaden) and read the second time on April 27, 2009

# CS/CS/HB 1209 (3R) by the Government Accountability Act Council, the Committee on State & Community Colleges & Workforce Policy (EPC) and Representative Grimsley—

**Nursing Programs;** Revises provisions for approval of nursing programs by Board of Nursing; requires institutions wishing to conduct certain nursing programs to submit program application & pay program review fee to DOH; specifies that program application is deemed approved if board does not act within specified timeframes; provides standards for approval of nursing programs, etc. Effective Date: 07/01/2009.

Substituted for **CS/CS/SB 2284 (SUB)** (Haridopolos) and read the second time on April 27, 2009

# CS/CS/CS/SB 2404 (3R) by the Committees on Health and Human Services Appropriations, Governmental Oversight and Accountability, Children, Families, and Elder Affairs and Senator Storms—

Adult Protective Services; Revises terminology. Defines the term "activities of daily living" and revises the term "vulnerable adult." Requires that the central abuse hotline, which is maintained by the DCFS, immediately transfer reports relating to vulnerable adults to the appropriate county sheriff's office. Authorizes the DCFS to file a petition to determine incapacity. Prohibits the DCFS from acting as guardian or providing legal counsel to the guardian, etc. Effective Date: 07/01/2009.

Read the second time on April 27, 2009

# HB 7117 (3R) by the Education Policy Council and Representative Culp—

**Student Records;** Deletes provisions relating to rights parents have regarding children's postsecondary student records to conform to changes made by act; deletes certain provisions governing release of K-12 student records & reports to specified parties; requires that State Board of Education comply with federal law with respect to release of education records; requires that public postsecondary educational institutions comply with federal law. Effective Date: 07/01/2009.

Substituted for **CS/SB 2426 (SUB)** (Detert) and read the second time on April 27, 2009

# HB 381 (3R) by Representative N. Thompson and others—

**Care of Children**; Creates "Zahid Jones, Jr., Give Grandparents & Other Relatives a Voice Act"; requires that case record of child under supervision or in custody of DCFS be maintained in complete & accurate manner; expands list of persons or entities that have access to child abuse records; renames "children's zones" as "children's initiatives"; revises provisions relating to strategic community plan; provides for reappropriation of funds, etc. Effective Date: 07/01/2009.

Substituted for CS/CS/CS/CS/SB 1276 (SUB) (Storms) and read the second time on April 27, 2009

**Excise Tax on Documents;** Imposes tax on consideration for short sale transfers of real property; excludes specified unpaid indebtedness from such consideration; defines term "short sale"; authorizes DOR to adopt rules establishing arm's length criteria for short sale purposes. Effective Date: 07/01/2009.

Substituted for **CS/CS/SB 728 (SUB)** (Bennett) and read the second time. and motion to retain on Special Order Calendar having been made (Villalobos) and adopted on April 27, 2009

### CS/CS/SB 2482 (SO) by the Committees on Education Pre-K - 12 Appropriations, Education Pre-K - 12 and Senator Wise—

**School Improvement and Accountability;** Redefines the term "secondary school" to no longer include an elementary school serving students through grade 6 only. Revises provisions relating to accelerated high school graduation. Revises the credits for certain courses required under the 3-year standard college preparatory program beginning with students who enter grade 9 in the 2009-2010 school year, etc. Effective Date: 07/01/2009.

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12 and reported favorably as a committee substitute by the Committee on Education Pre-K -12 Appropriations

Compare to **HB 7087 (HC)** in the Committees on Education Pre-K - 12 and Education Pre-K -12 Appropriations

# SB 2058 (SO) by Senator Alexander-

**Charter County Transit System Surtax**; Renames said surtax. Expands the eligibility to levy the surtax to all charter counties. Effective Date: 07/01/2009.

Reported favorably by the Committees on Transportation, Community Affairs, Finance and Tax, and Transportation and Economic Development Appropriations

# CS/CS/SB 2614 (SO) by the Committees on Health and Human Services Appropriations, Health Regulation and Senator Gaetz—

**Health Care;** Repeals provisions relating to a comprehensive nutrition program, healthy lifestyles promotion, and the Healthy Communities, Healthy People Act. Requires certain state agencies to purchase drugs through the statewide purchasing contract administered by the DOH. Amends provisions relating to the Comprehensive Statewide Tobacco Education and Use Prevention Program, etc. Effective Date: 07/01/2009.

Read the second time, amended, and with pending amendment #4 (barcode 402490) by Senator Lawson on April 27, 2009

Similar to **CS/HB 1471 (HC)** in the Committees on Health Regulation and Health and Human Services Appropriations

# CS/CS/CS/CS/SB 1540 (SO) by the Committees on Education Pre-K - 12 Appropriations, Judiciary, Criminal Justice, Education Pre-K - 12, Senator Wise and others—

**Zero-tolerance Policies/Schools;** Requires that a district school board having a policy authorizing corporal punishment as a form of discipline review its policy on said punishment at specified intervals. Provides that zero-tolerance policies do not require the reporting of petty acts of misconduct and misdemeanors to a law enforcement agency. Prohibits a student from exposing below-waist underwear in a specified manner while on the grounds of a public school, etc. Effective Date: 07/01/2009.

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12 and reported favorably as a committee substitute by the Committee on Criminal Justice and the Committee on Education Pre-K - 12 reports the committee substitute favorably and reported favorably as a committee substitute by the Committee on Judiciary and reported favorably as a committee substitute by the Committee on Education Pre-K - 12 Appropriations

# CS/CS/SB 2572 (SO) by the Committees on Transportation and Economic Development Appropriations, Agriculture, Senator Dean and others—

**Rural Agricultural Industrial Centers;** Authorizes landowners within a rural agricultural industrial center to apply for an amendment to the local government comprehensive plan for certain purposes. Clarifies that any land area that is not designated as a rural area of critical economic concern does not hold any of the rights or benefits derived from such designation, etc. Effective Date: 07/01/2009.

Reported favorably as a committee substitute by the Committee on Agriculture and the Committees on Community Affairs and Commerce report the committee substitute favorably and reported favorably as a committee substitute by the Committee on Transportation and Economic Development Appropriations

Similar to **CS/HB 7053 (HC)** in the Committees on Agriculture, Community Affairs, Commerce and Transportation and Economic Development Appropriations

# CS/CS/CS/SB 478 (SO) by the Committees on Criminal Justice, Commerce, Community Affairs, Senator Baker and others—

**Secondhand Dealers/Secondary Metals Recyclers;** Excludes cardio and strength-training or conditioning equipment designed primarily for indoor use from the definition of secondhand goods. Provides that the procedures governing hold notices issued when a law enforcement officer has reasonable cause to believe that certain regulated metals in the possession of a secondary metals recycler have been stolen are of statewide application, etc. Effective Date: 10/01/2009.

Reported favorably as a committee substitute by the Committee on Community Affairs and reported favorably as a committee substitute by the Committee on Commerce and reported favorably as a committee substitute by the Committee on Criminal Justice

Compare to CS/CS/HB 339 (HC) in Messages

# CS/SB 580 (SO) by the Committee on Judiciary, Senator Haridopolos and others—

**Impact Fees/Challenges;** Requires that the government prove certain elements by a preponderance of the evidence in an action involving the challenge of an impact fee. Prohibits a court from using a deferential standard. Effective Date: 07/01/2009.

Reported favorably, with one amendment, by the Committee on Community Affairs and reported favorably as a committee substitute by the Committee on Judiciary and the Committees on Finance and Tax, and Transportation and Economic Development Appropriations, report the committee substitute favorably


