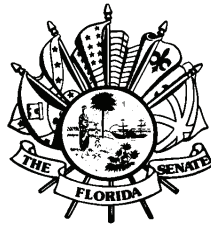

BILLS ON THE CALENDAR

BILLS ON THIRD READING

CS/CS/SB 148 (3R) by the Committees on Community Affairs, Environmental Preservation and Conservation and Senator Aronberg—

Mangrove Protection; Expands the penalty previously applicable to violations involving mangrove trimming or alteration to apply to any violation under the Mangrove Trimming and Preservation Act. Revises the definition of "riparian mangrove fringe." Provides that the act does not authorize trimming on uninhabited natural islands or lands that are publicly owned or set aside for conservation or mitigation except under specified circumstances, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

CS/CS/CS/SB 1004 (3R) by the Committees on General Government Appropriations, Judiciary, Environmental Preservation and Conservation, Senator Constantine and others—

Coral Reefs; Creates the "Florida Coral Reef Protection Act." Requires responsible parties to notify the DEP if their vessel runs aground or damages a coral reef. Authorizes the department to enter into settlement agreements that require responsible parties to pay another government entity or nonprofit organization to fund projects consistent with the conservation or protection of coral reefs, etc. Effective Date: 07/01/2009.

Read the second time on April 23, 2009

SB 2656 (3R) by Senator Haridopolos—

Arboriculture; Creates the "Florida Arborist Licensing Law." Provides powers and duties of the DOACS. Establishes licensure procedures and requirements to practice arboriculture and provide such services. Authorizes DOACS to enforce certain provisions of state law by specified means. Revises a definition to make tropical foliage exempt from regulation under provisions relating to dealers in agricultural products, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 23, 2009

*Compare to **CS/CS/HB 1241 (HC)** in the Committees on Agriculture, Governmental Oversight and Accountability, and General Government Appropriations*

CS/SB 642 (3R) by the Committee on Health and Human Services Appropriations, Senator Altman and others—

License Plates; Revises authorized uses of proceeds received from the sale of the United We Stand license plate. Creates a Fraternal Order of Police license plate. Creates an Autism license plate. Creates the Go Green Florida license plate. Creates the Catch Me, Release Me license plate. Creates an Endless Summer license plate. Creates the St. Johns River license plate. Creates a Florida Biodiversity Foundation license plate, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 24, 2009

CS/CS/SB 1894 (3R) by the Committees on Finance and Tax, Judiciary, Senator Bennett and others—

Surplus Lines Insurers; Provides for the nonapplication of certain provisions of state law to surplus lines insurance authorized under the Surplus Lines Law. Provides methods of payment for premiums and claims regarding surplus lines contracts issued on or after a specified date. Requires that certain insurers provide a disclosure statement to a claimant under certain circumstances, etc. Effective Date: Upon becoming law.

Read the second time and amended on April 24, 2009

*Similar to **CS/HB 853 (HC)** in the Committees on Banking and Insurance, Finance and Tax, General Government Appropriations, and Policy & Steering Committee on Ways and Means*

CS/CS/SB 2536 (3R) by the Committees on Judiciary, Environmental Preservation and Conservation and Senator Constantine—

Fish & Wildlife Conservation Commission; Requires the FWC rather than the DOR to distribute a specified sum from the Invasive Plant Control Trust Fund to eradicate melaleuca. Provides for preservation of sea grasses. Increases the annual use fee for certain specialty license plates. Amends the definition of the term "live-aboard vessel." Prohibits possessing or operating a vessel equipped with certain fuel containers or related equipment, etc. Effective Date: 07/01/2009 except as otherwise provided.

Read the second time and amended on April 24, 2009

*Similar to **CS/CS/HB 1423 (HC)** in the Committees on Environmental Preservation and Conservation, Criminal Justice, Judiciary, and General Government Appropriations*

SB 2058 (3R) by Senator Alexander—

Charter County Transit System Surtax; Renames said surtax. Expands the eligibility to levy the surtax to all charter counties. Effective Date: 07/01/2009.

Read the second time on April 28, 2009

CS/CS/SB 2614 (3R) by the Committees on Health and Human Services Appropriations, Health Regulation and Senator Gaetz—

Health Care; Repeals provisions relating to a comprehensive nutrition program, healthy lifestyles promotion, and the Healthy Communities, Healthy People Act. Requires the DOH to include in its environmental health program the testing of the air in enclosed ice rinks. Requires certain state agencies to purchase drugs through the statewide purchasing contract administered by the DOH. Revises requirements to be designated as a teaching nursing home, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 27, 2009; and further amended on April 28, 2009

Similar to CS/HB 1471 (HC) in the Committees on Health Regulation and Health and Human Services Appropriations

CS/CS/CS/CS/SB 1540 (3R) by the Committees on Education Pre-K - 12 Appropriations, Judiciary, Criminal Justice, Education Pre-K - 12, Senator Wise and others—

Zero-tolerance Policies/Schools; Requires that a district school board having a policy authorizing corporal punishment as a form of discipline review its policy on said punishment at specified intervals. Provides that zero-tolerance policies do not require the reporting of petty acts of misconduct and misdemeanors to a law enforcement agency. Encourages school districts to use alternatives to expulsion or referral to law enforcement agencies, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 28, 2009

CS/HB 7053 (3R) by the Policy Council, the Committee on Agriculture & Natural Resources Policy (GGPC) and Representative T. Williams—

Rural Agricultural Industrial Centers; Authorizes landowners within rural agricultural industrial center to apply for amendment to local government comprehensive plan for specified purposes; provides amendment requirements; requires local government to transmit application to state land planning agency for review within specified period after receiving such application, etc. Effective Date: 07/01/2009.

Substituted for CS/CS/SB 2572 (SUB) (Dean) and read the second time on April 28, 2009

CS/CS/HB 339 (3R) by the Economic Development & Community Affairs Policy Council, the Committee on Agriculture & Natural Resources Policy (GGPC), Representative Patterson and others—

Secondhand Dealers and Secondary Metals Recyclers; Excludes certain exercise equipment from definition of "secondhand goods"; preempts certain local government ordinances relating to hold notices for secondary metals recyclers; creates part III of ch. 538, F.S.; provides definitions & exceptions; provides for recordkeeping; provides electronic access to transaction files by law enforcement agencies; provides a method of relinquishment of abandoned property, etc. Effective Date: 10/01/2009.

Substituted for CS/CS/CS/SB 478 (SUB) (Baker) and read the second time on April 28, 2009

CS/CS/HB 227 (3R) by the Economic Development & Community Affairs Policy Council, the Committee on Military & Local Affairs Policy (EDCA), Representative Aubuchon and others—

Impact Fees; Requires government to prove specified elements of impact fee by preponderance of evidence; prohibits courts from using deferential standard in court actions; prohibits specified local governments from increasing impact fees or imposing new impact fees; provides nonapplication to impact fees pledged to retire debt or certain impact fee increases; provides for future repeal. Effective Date: 07/01/2009.

Substituted for CS/SB 580 (SUB) (Haridopolos), read the second time and amended on April 28, 2009

CS/CS/SB 712 (3R) by the Committees on Policy & Steering Committee on Ways and Means, Community Affairs and Senator Pruitt—

Special Districts/Commodities/Contractual Services; Authorizes special districts to purchase commodities and contractual services from purchasing agreements of other special districts, municipalities, or counties. Provides that the boundaries of a special district are deemed to include an annexed area under certain circumstances. Effective Date: 07/01/2009.

Read the second time and amended on April 28, 2009

HB 701 (3R) by Representative Hudson and others—

Notices of Proposed Property Taxes; Revises form of notice of proposed property taxes to include additional information relating to past & proposed millage rates & ad valorem taxes & assessment reductions & exemptions; defines terms; conforms cross-references. Effective Date: 01/01/2010.

Substituted for CS/CS/SB 752 (SUB) (Richter), read the second time and amended on April 28, 2009

CS/CS/HB 333 (3R) by the Economic Development & Community Affairs Policy Council, the Committee on Roads, Bridges, & Ports Policy (EDCA) and Representative Workman—

Off-Highway Vehicles; Revises definitions of terms "ATV," "all-terrain vehicle," & "off-highway vehicle" & defines term "ROV" for purposes of provisions relating to sale & use of motorized off-highway vehicles. Effective Date: 07/01/2009.

Substituted for CS/CS/SB 798 (SUB) (Baker) and read the second time on April 28, 2009

CS/SB 210 (3R) by the Committee on Transportation, Senator Baker and others—

Commercial Vehicles/Weight Limits/School Zones; Increases the maximum weight limits on certain vehicles to compensate for weight increases that result from the installation of idle-reduction technologies. Revises the authorized locations for the placement of certain warning signs at school zones. Effective Date: 07/01/2009.

Read the second time and amended on April 28, 2009

CS/CS/SB 810 (3R) by the Committees on Policy & Steering Committee on Ways and Means, Commerce, Senator Garcia and others—

Unemployment Compensation; Raises the amount of an employee's wages subject to an employer's contribution to the trust fund, with a reversion to current law after January 1, 2015. Revises the rate and recoupment period for computing the employer contribution to the trust fund, with a reversion to current law for recoupment after January 1, 2015. Provides for retroactive application, etc. Effective Date: Upon becoming law except as otherwise provided.

Read the second time and amended on April 28, 2009

CS/CS/HB 675 (3R) by the General Government Policy Council, the Health & Family Services Policy Council, Representative Workman and others—

Medicare Supplement Policies; Cites act as "Alonzo Mourning Access to Care Act"; requires insurers issuing Medicare supplement policies in state to offer opportunity to enroll in Medicare supplement policy to specified individuals having disability or end-stage renal disease; permits insurers offering Medicare supplement policies to effect one-time rate schedule change, etc. Effective Date: 10/01/2009.

Substituted for CS/CS/CS/SB 1022 (SUB) (Altman) and read the second time on April 28, 2009

CS/CS/HB 845 (3R) by the General Government Policy Council, the Committee on Insurance, Business, & Financial Affairs Policy (GGPC), Representative Drake and others—

Self-Insurance Funds; Requires application for workers' compensation coverage issued by group self-insurance fund to notify applicants that policyholders must make additional contributions to fund if fund is unable to pay its obligations; authorizes specified electric cooperatives to operate self-insurance fund for specified purposes; provides requirements; subjects such funds to specified assessments, etc. Effective Date: 07/01/2009.

Substituted for CS/CS/CS/SB 1138 (SUB) (Gaetz) and read the second time on April 28, 2009

HB 379 (3R) by Representative Wood—

Florida Uniform Principal and Income Act; Provides requirements for determination of income from certain compensation plans, annuities, & retirement plans or accounts; provides trustee requirements with respect to payment allocations; provides criteria for payment of certain funds to spouse; provides applicability. Effective Date: 07/01/2009.

Substituted for SB 1222 (SUB) (Richter) and read the second time on April 28, 2009

CS/CS/SB 2072 (3R) by the Committees on General Government Appropriations, Judiciary, Senator Richter and others—

Workers' Compensation; Repeals specified provision relating to the prohibition against a fee, consideration, or gratuity for an attorney or other person for certain services. Requires that a judge of compensation claims enter an order determining the portion of settlement proceeds to be allocated to child support arrearages. Deletes provisions authorizing said judge to approve alternative attorney's fees under certain circumstances, etc. Effective Date: Upon becoming law.

Read the second time on April 28, 2009

CS/HB 7141 (3R) by the Full Appropriations Council on General Government & Health Care, the Criminal & Civil Justice Policy Council and Representative Adams—

Seaport Security; Revises provisions relating to seaport security; authorizes FDLE to exempt all or part of port from certain security requirements; provides criteria for eligibility to enter secure or restricted areas; establishes statewide access eligibility reporting system within FDLE; requires all access eligibility to be submitted to FDLE & retained within system; provides procedure for obtaining access to secure & restricted areas, etc. Effective Date: 07/01/2009.

Substituted for CS/CS/CS/SB 2684 (SUB) (Aronberg) and read the second time on April 28, 2009

CS/CS/SB 2226 (3R) by the Committees on Judiciary, Banking and Insurance, the Committee on Banking and Insurance (Richter) and others—

Mortgage Brokering and Lending; Authorizes the Financial Services Commission to adopt rules relating to compliance with the S.A.F.E. Mortgage Licensing Act of 2008. Provides exemptions from part I, II, and III of ch. 494, F.S., relating to the licensing and regulation of loan originators, mortgage brokers, and mortgage lenders. Exempts certain attorneys from the definition of "foreclosure-rescue consultant," etc. Effective Date: 07/01/2009 except as otherwise provided.

Read the second time and amended on April 28, 2009

CS/HB 515 (3R) by the General Government Policy Council, Representative Evers and others—

Oil and Gas Production Taxes; Provides tiered tax rate structure for oil production tax on tertiary oil; revises definitions. Effective Date: 07/01/2009.

Substituted for CS/SB 978 (SUB) (Pruitt) and read the second time on April 28, 2009

CS/CS/SB 168 (3R) by the Committees on Higher Education, Criminal Justice, Senator Joyner and others—

Florida Statewide Task Force on Human Trafficking; Creates within the Department of Children and Family Services the Florida Statewide Task Force on Human Trafficking. Requires that the task force prepare a final report by a specified date. Provides duties of the Florida State University Center for the Advancement of Human Rights, etc. Effective Date: Upon becoming law.

Read the second time on April 28, 2009

CS/HB 135 (3R) by the Committee on Insurance, Business, & Financial Affairs Policy (GGPC), Representative McKeel and others—

Pub. Rec./Insured Dependents/Agency Group Plan; Provides exemption from public records requirements for personal identifying information of certain insured dependents; provides for retroactive application of exemption; provides for future legislative review & repeal of exemption; provides statement of public necessity. Effective Date: 07/01/2009.

Substituted for CS/SB 270 (SUB) (Dockery) and read the second time on April 28, 2009

CS/HB 1409 (3R) by the Committee on Health Care Services Policy (HFPC) and Representative Sands—

Placement of Children; Authorizes Governor to execute new Interstate Compact for the Placement of Children; specifies provisions of compact; provides for present compact to remain in effect until Governor enters into new compact; provides rulemaking authority to DCFS. Effective Date: Upon becoming law.

Substituted for CS/SB 2240 (SUB) (Rich) and read the second time on April 28, 2009

HB 7025 (3R) by the Committee on Governmental Affairs Policy (EDCA) and Representative Schenck—

OGSR/Archival Materials; Removes scheduled repeal under Open Government Sunset Review Act of exemption from public records requirements for nonpublic manuscripts or other archival materials donated to & held by official archive of municipality or county contingent upon special terms & conditions that limit right to inspect or copy such manuscripts or materials; clarifies exemption, etc. Effective Date: 10/01/2009.

Substituted for CS/SB 1834 (SUB) (Haridopolos) and read the second time on April 28, 2009

CS/SB 1580 (3R) by the Committee on Finance and Tax, Senator Ring and others—

Ad Valorem Taxation; Authorizes tax collectors to accept partial payment of taxes under certain circumstances. Imposes a processing fee on a partial tax payment. Provides a deadline for payment of the remaining balance. Authorizes a tax collector to treat certain underpayment as full payment. Provides for a provision exempting property owned by an education institution from ad valorem taxation to apply retroactively to January 1, 2005, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 28, 2009

CS/CS/HB 57 (3R) by the Criminal & Civil Justice Policy Council, the Committee on Public Safety & Domestic Security Policy (CCJP), Representative Reed and others—

Law Enforcement Explorers; Defines "law enforcement explorer"; provides for reclassification of certain offenses against law enforcement explorers. Effective Date: 10/01/2009.

Substituted for CS/SB 508 (SUB) (Hill) and read the second time on April 28, 2009

CS/CS/SB 440 (3R) by the Committees on Governmental Oversight and Accountability, Health Regulation and Senator Fasano—

Pub. Rec./DOH Prescription Drug Monitoring Program; Exempts from public records requirements information and records reported to the DOH under the electronic prescription drug monitoring program for monitoring the prescribing and dispensing of controlled substances listed in Schedules II-IV. Authorizes certain persons and entities access to patient-identifying, practitioner-identifying, or pharmacist-identifying information. Provides guidelines for the use of such information, etc. Effective Date: Contingent.

Read the second time and amended on April 28, 2009

HB 7037 (3R) by the Committee on Governmental Affairs Policy (EDCA), Representative McBurney and others—

OGSR/ID & Location Info./Fed. Attorneys & Judges; Removes scheduled repeal under Open Government Sunset Review Act of exemptions from public records requirements for identification & location information of current or former U.S. attorneys, assistant U.S. attorneys, current or former judges of U.S. Courts of Appeal, federal district judges, & federal magistrates, & spouses & children thereof; defines "identification and location information", etc. Effective Date: 10/01/2009.

Substituted for CS/SB 1342 (SUB) (Constantine) and read the second time on April 28, 2009

CS/SB 258 (3R) by the Committee on Judiciary and Senator Wise—

Name Change/Petition/Criminal History Check; Requires that a person filing a petition for change of name have fingerprints submitted for a state and national criminal history records check before the court hearing on the petition. Provides an exception to such requirement. Provides procedures for the taking and submission of fingerprints. Requires submission of the results of a criminal history records check to the clerk of court. Provides for use of the results by the clerk of the court, etc. Effective Date: 10/01/2009.

Read the second time and amended on April 28, 2009

HB 7017 (3R) by the Committee on Governmental Affairs Policy (EDCA) and Representative Plakon—

OGSR/Building Plans and Blueprints; Removes scheduled repeal under Open Government Sunset Review Act of exemption from public records requirements for building plans, blueprints, schematic drawings, & diagrams held by agency which depict internal layout or structural elements of certain facilities, complexes, & developments; reorganizes exemption & makes editorial changes. Effective Date: 10/01/2009.

Substituted for SB 754 (SUB) (Aronberg) and read the second time on April 28, 2009

CS/CS/SB 732 (3R) by the Committees on Policy & Steering Committee on Ways and Means, Governmental Oversight and Accountability and Senator Smith—

Financial Instruments; Requires that the CFO and local governments deposit surplus funds in financial deposit instruments insured by the FDIC rather than in certificates of deposit. Revises the dates of an insurer's contract year for purposes of calculating the insurer's retention. Deletes a provision relating to concurrent deposits by a unit of local government and customers of other federally insured financial institutions, etc. Effective Date: 07/01/2009.

Read the second time and amended on April 28, 2009

Identical to CS/CS/CS/HB 569 (HC) in the Committees on Banking and Insurance, Governmental Oversight and Accountability, General Government Appropriations, and Policy & Steering Committee on Ways and Means

HB 7021 (3R) by the Committee on Governmental Affairs Policy (EDCA) and Representative Schenck—

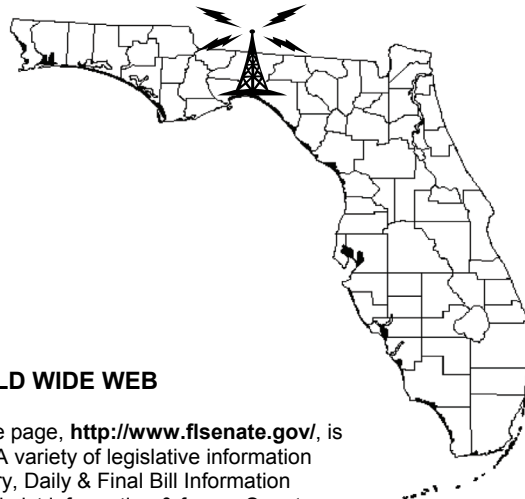

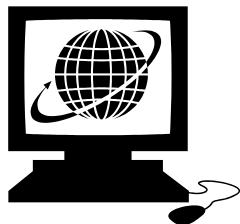
