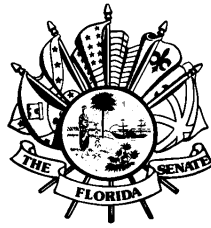

BILLS ON THIRD READING

POLICY AND STEERING COMMITTEE ON WAYS AND MEANS [WPSC] GROUPING

SB 1280 (3R) by Senator Villalobos—

Official Florida Statutes; Adopts the Florida Statutes 2009 and designates the portions thereof that are to constitute to official law of the state. Provides that the Florida Statutes 2009 shall be effective immediately upon publication. Provides that general laws enacted during the 2008 regular session and prior thereto and not included in the Florida Statutes 2009 are repealed, etc. Effective Date: 60 days after sine die.

Read the second time on March 3, 2009

CS/SB 1282 (3R) by the Committee on Rules and Senator Villalobos—

Florida Statutes; Amends and repeals provisions to delete provisions which have become inoperative by noncurrent repeal or expiration and may be omitted from the 2009 Florida Statutes only through a reviser's bill duly enacted by the Legislature. Repeals provisions to confirm the October 2, 2008, repeal of exemptions in accordance with the Open Government Sunset Review Act, etc. Effective Date: 60 days after sine die.

Read the second time on March 3, 2009

SB 1284 (3R) by Senator Villalobos—

Florida Statutes; Amends, deletes, and reenacts provisions that have expired, have become obsolete, have had their effect, have served their purpose, or have been impliedly repealed or superseded. Replaces incorrect cross-references and citations. Corrects grammatical, typographical, and like errors. Removes inconsistencies, redundancies, and unnecessary repetition in the statutes, etc. Effective Date: 60 days after sine die.

Operating Trust Fund/State Courts System; Re-creates the Operating Trust Fund within the state courts system without modification. Abrogates provisions relating to the termination of the trust fund, to conform. Effective Date: 07/01/2009.

SB 1108 (2R) by Senator Crist—

Administrative Trust Fund/DOC; Re-creates the Administrative Trust Fund within the Department of Corrections without modification. Abrogates provisions relating to the termination of the trust fund, to conform. Effective Date: 07/01/2009.

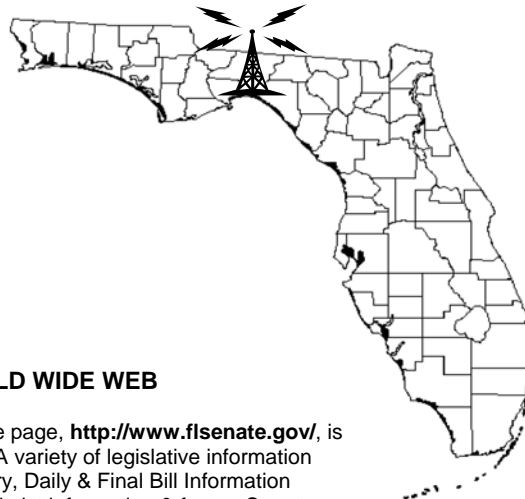
