## BILLS ON THE CALENDAR

### BILLS ON THIRD READING

#### **CS/CS/SB 818, 1st Eng. (3R) by the Committees on Criminal Justice, Health Regulation, Senator Fasano and others—**

**Controlled Substances;** Authorizes certain health care practitioners to complete a continuing education course relating to the prescription drug monitoring program. Creates a felony of the third degree for any person to register or attempt to register a pain-management clinic through misrepresentation or fraud. Authorizes the DOH to revoke the certificate of registration of a pain-management clinic based upon a finding by a probable cause panel of a board that the clinic does not meet certain requirements, etc. Effective Date: 10/01/2011

*Read the second time on April 27, 2011 and amended on April 28, 2011*

*Compare to CS/CS/HB 7095, 2nd Eng.(HC) in the Committees on Health Regulation; Criminal Justice; and Budget*

---

#### **CS/SB 844, 1st Eng. (3R) by the Committee on Budget, Senator Benacquisto and others—**

**Violations/Probation/Community Control/Widman Act;** Creates the "Officer Andrew Widman Act." Authorizes a judge, after making a certain finding, to issue a warrant for the arrest of a probationer or offender who has violated the terms of probation or community control. Authorizes the court to commit or release the probationer or offender under certain circumstances. Authorizing the court, in determining whether to require or set the amount of bail, to consider the likelihood that the person will be imprisoned for the violation of probation or community control, etc. Effective Date: 10/01/2011

*Read the second time and amended on April 28, 2011*

---

#### **CS/CS/SB 1346, 1st Eng. (3R) by the Committees on Children, Families, and Elder Affairs, Commerce and Tourism, and Commerce and Tourism—**

**Obsolete References and Programs;** Removes an obsolete reference to the Department of Commerce and the Department of Labor and Employment Security. Updates a reference to the Department of Commerce to refer instead to the Office of Tourism, Trade, and Economic Development. Repeals provisions relating to agreements of the Department of Labor and Employment Security with county tax collectors. Repeals provisions relating to child abuse prevention training in the district school system, etc. Effective Date: 07/01/2011

*Read the second time and amended on April 28, 2011*

---

#### **CS/CS/SB 1196 (3R) by the Committees on Commerce and Tourism, Regulated Industries and Senator Bogdanoff—**

**Construction Liens;** Specifies that a lessor's interest in property is not subject to a construction lien for improvements made by a lessee if certain documents containing specific information and meeting certain criteria are recorded in the official records of the county before the recording of a notice of commencement. Authorizes certain contractors and lienors to demand that a lessor serve verified copies of a lease prohibiting liability for improvements made by a lessee, etc. Effective Date: 10/01/2011

*Read the second time on April 27, 2011*

**CS/HJR 7111, 2nd Eng. (3R) by the Committees on Judiciary Committee, Civil Justice Subcommittee, Representative Eisnagle and others—**

**Supreme Court;** Proposes a revision of Article V of the State Constitution, relating to the judiciary, consisting of amendments to ss. 2, 3, 4, 7, 11, 12, & 14, Art. V, & creation of s. 21, Art. V, of State Constitution to divide current Supreme Court into two divisions, one hearing civil cases & other hearing criminal cases; provides for administration of divisions; defines jurisdiction of divisions; provides for transition from present Supreme Court; revises provisions relating to repeal of court rules; limits readoption of repealed court rule, etc.

**CS/CS/CS/SB 88 (SO) by the Committees on Governmental Oversight and Accountability, Judiciary, Community Affairs, Senator Gaetz and others—**

**Public Employee Compensation;** Revises provisions relating to the prohibition against the payment of extra compensation. Prohibits provisions in contracts that provide for severance pay. Allows for severance pay under specified circumstances. Deletes a provision that allows a municipality to pay extra compensation. Repeals provisions relating to a prohibition against severance pay for officers or employees of water management districts, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability*

**CS/CS/SB 178 (SO) by the Committees on Commerce and Tourism, Banking and Insurance and Senator Oelrich—**

**Commercial Insurance Rates;** Exempts certain liability and property insurance lines from specific rate standards and filing requirements. Revises certain reporting and recordkeeping requirements for such exempt insurers and certain rating organizations regarding rate changes. Requires such entities to pay certain examination costs. Deletes a provision that permits the Office of Insurance Regulation of the Financial Services Commission to require such insurers to provide certain information regarding rates at the insurer's expense, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Commerce and Tourism; and the Committee on Budget reports the committee substitute favorably*

*Similar to **CS/CS/HB 99(HC)** in the Committees on Banking and Insurance; Commerce and Tourism; and Budget*

**CS/CS/SB 274 (SO) by the Committees on Budget, Transportation and Senator Lynn—**

**Road and Bridge Designations;** Designates Senator Javier D. Souto Way in Miami-Dade County. Designates Nona and Papa Road in St. Johns County. Designates Walter Francis Spence Parkway in Okaloosa County. Designates Corporal Michael J. Roberts Parkway in Hillsborough County. Designates the Florida Highway Patrol Trooper Sgt. Nicholas G. Sottile Memorial in Highlands County, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Committee on Budget; and the Committee on Rules reports the committee substitute favorably*

*Compare to **CS/HB 7213, 2nd Eng.(HC)** in the Committees on Transportation; Budget; and Rules*

**CS/CS/SB 296 (SO) by the Committees on Community Affairs, Commerce and Tourism and Senator Wise—**

**Household Moving Services;** Provides for the biennial renewal of mover and moving broker registrations. Prohibits a mover or moving broker from conducting business without being registered with the department. Preempts local ordinances and regulations except in certain counties. Restricts the levy or collection of local registration fees and taxes of movers and moving brokers. Provides for local registration and bonding, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Commerce and Tourism; reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Budget reports the committee substitute favorably*

*Similar to **CS/HB 901(HC)** in the Committees on Commerce and Tourism; Community Affairs; and Budget*

**SB 306 (SO) by Senator Rich—**

**Relief/Brown/North Broward Hospital District;** Compensates Denise Gordon Brown and David Brown, parents of Darian Brown, for injuries and damages sustained as a result of the negligence of Broward General Medical Center. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

*Recommended favorably by the Special Master on Claim Bills; and reported favorably by the Committee on Rules*

**SB 322 (SO) by Senator Flores—**

**Relief/Edwards & Roden/Lee County;** Compensates Aaron Edwards, a minor, and his parents, Mitzi Roden and Mark Edwards. Compensates them for damages sustained as a result of the medical negligence by employees of Lee Memorial Health System of Lee County. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

*Recommended favorably, with one amendment, by the Special Master on Claim Bills; and reported favorably by the Committee on Rules*

**CS/SB 378 (SO) by the Committee on Rules Subcommittee on Ethics and Elections and Senator Gaetz—**

**Federal Write-in Absentee Ballot;** Authorizes absent uniformed services voters and overseas voters to use the federal write-in absentee ballot to vote in any federal and certain state or local elections, under certain circumstances. Prescribes requirements for designating candidate choices. Provides for the disposition of valid votes involving joint candidacies. Allows for abbreviations, misspellings, and other minor variations in the name of an office, candidate, or political party. Authorizes the submission of multiple ballots under certain circumstances, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Rules Subcommittee on Ethics and Elections; and the Committees on Rules; and Budget reports the committee substitute favorably*

*Identical to **CS/HB 227(HC)** in the Committees on Rules Subcommittee on Ethics and Elections; Rules; and Budget*

---

**CS/SB 380 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Wise—**

**Training/Certification/Child Welfare Personnel;** Provides required criteria for the approval of credentialing entities that develop and administer certification programs for persons who provide child welfare services. Revises the use of the Child Welfare Training Trust Fund within the Department of Children and Family Services. Requires persons who provide child welfare services to be certified by a third-party credentialing entity. Allows entities to contract for training. Requires persons to master core competencies. Authorizes approval of third-party credentialing entities, etc. Effective Date: 10/01/2011

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and the Committees on Governmental Oversight and Accountability; and Budget reports the committee substitute favorably*

**CS/CS/SB 396 (SO) by the Committees on Regulated Industries, Community Affairs and Senator Bennett—**

**Building Construction and Inspection;** Exempts certain rule proceedings relating to the Florida Building Code. Requires that state agencies, local governments, and the court system adopt a sustainable building rating system for new and renovated buildings. Revises the continuing education requirements for licensed home inspectors. Removes certain application requirements for a person who performs home inspection services and who qualifies for licensure on or before a specified date, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Regulated Industries; and the Committee on Budget reports the committee substitute favorably*

**CS/CS/SB 416 (SO) by the Committees on Judiciary, Criminal Justice and Senator Bogdanoff—**

**Public Records;** Provides an exemption from public records requirements for photographs and video and audio recordings that depict or record the killing of a person. Authorizes access to such photographs or video or audio recordings by specified members of the immediate family of the deceased subject of the photographs or video or audio recordings. Provides for access to such records by local governmental entities or state or federal agencies in furtherance of official duties. Provides for future legislative review and repeal of the exemption, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably*

*Similar to **CS/HB 411(HC)** in the Committees on Criminal Justice; Judiciary; and Rules*

---

**SB 420 (SO) by the Committee on Health Regulation—**

**OFSR/Florida Center for Brain Tumor Research;** Provides that personal identifying information pertaining to a donor to the central repository for brain tumor biopsies or the brain tumor registry of the Florida Center for Brain Tumor Research is confidential and exempt from public records requirements. Provides an exception under certain conditions for information disclosed to a person engaged in bona fide research. Provides for future legislative review and repeal of the exemption under the Open Government Sunset Review Act, etc. Effective Date: 07/01/2011

*Reported favorably by the Committees on Health Regulation; and Governmental Oversight and Accountability*

*Similar to **HB 7079(HC)** in the Committees on Health Regulation; and Governmental Oversight and Accountability*

---

**CS/SB 438 (SO) by the Committee on Criminal Justice and Senator Hill—**

**Injunctions for Protection Against Violence;** Subject to available funding, directs the Florida Association of Court Clerks and Comptrollers to develop an automated process by which a petitioner for an injunction for protection may request notification of service of the injunction or notice of other court actions related to the injunction. Requires that notice be given to the petitioner within a specified time. Provides for the content of the notice. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committees on Judiciary; and Budget reports the committee substitute favorably*

*Similar to **CS/CS/HB 563(HC)** in the Committees on Criminal Justice; Judiciary; and Budget*

## **SB 502 (SO) by Senator Oelrich—**

**State Symbols;** Designates the Barking Tree Frog as the official state amphibian. Effective Date: 07/01/2011

*Reported favorably by the Committees on Environmental Preservation and Conservation; Governmental Oversight and Accountability; and Rules*

## **CS/SB 504 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Bogdanoff—**

**Child Visitation;** Requires probable cause of sexual abuse in order to create a presumption of detriment. Provides that persons meeting specified criteria may not visit or have contact with a child without a hearing and court order. Revises requirements for a hearing seeking to rebut a presumption of detriment. Revises provisions relating to hearings on whether to prohibit or restrict visitation or other contact with the person who is alleged to have influenced a child's testimony, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and the Committees on Judiciary; and Budget reports the committee substitute favorably*

---

## **CS/CS/SB 512 (SO) by the Committees on Budget, Environmental Preservation and Conservation and Senator Negron—**

**Vessels;** Revises penalty provisions for the violation of navigation rules. Provides that a violation resulting in serious bodily injury or death is a second-degree misdemeanor. Provides that a violation that does not constitute reckless operation of a vessel is a noncriminal violation. Provides an additional exemption from the requirement that certain persons possess a boating safety identification card while operating a motor vessel of a specified horsepower. Provides for increased penalties for certain noncriminal violations of navigation rules, etc. Effective Date: 10/01/2011

*Reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation; reported favorably as a committee substitute by the Committee on Budget; and the Committee on Rules reports the committee substitute favorably*

---

## **SB 514 (SO) by Senator Garcia and others—**

**Vehicle Crashes Involving Death;** Cites this act as the "Ashley Nicole Valdes Act." Requires a defendant who was arrested for leaving the scene of a crash involving death be held in custody until brought before a judge for admittance to bail in certain circumstances. Reenacts provision relating to the Criminal Punishment Code, to incorporate the amendments made to provision in a reference thereto. Effective Date: 10/01/2011

*Reported favorably by the Committees on Criminal Justice; Judiciary; and Budget*

*Identical to **HB 347(HC)** in the Committees on Criminal Justice; Judiciary; and Budget*

---

## **SB 568 (SO) by the Committee on Judiciary—**

**OGSR/Court Records/Court Monitors/Guardianship;** Amends provisions relating to public record exemptions for court records relating to court monitors in guardianship proceedings. Consolidates provisions. Provides that orders appointing nonemergency court monitors are exempt rather than confidential and exempt. Provides that only court orders finding no probable cause are confidential and exempt. Saves the exemptions from repeal under the Open Government Sunset Review Act. Removes the scheduled repeal of the exemption. Effective Date: 10/01/2011

*Reported favorably by the Committees on Judiciary; and Governmental Oversight and Accountability*

*Identical to **HB 7085(HC)** in the Committees on Judiciary; and Governmental Oversight and Accountability*

---

## **SB 570 (SO) by the Committee on Judiciary—**

**OGSR/Interference With Custody;** Amends a provision relating to a public records exemption for information submitted to a sheriff or state attorney for the purpose of obtaining immunity from prosecution for the offense of interference with custody. Saves the exemption from repeal under the Open Government Sunset Review Act. Deletes a provision providing for the repeal of the exemption. Effective Date: 10/01/2011

*Reported favorably by the Committees on Judiciary; and Governmental Oversight and Accountability*

*Identical to **HB 7083(HC)** in the Committees on Judiciary; and Governmental Oversight and Accountability*

---

## **CS/SB 572 (SO) by the Committees on Governmental Oversight and Accountability, and Judiciary—**

**OGSR/Statewide Public Guardianship Office;** Amends a provision which provides an exemption from public records requirements for information that identifies certain donors or prospective donors to the direct-support organization for the Statewide Public Guardianship Office. Removes superfluous and duplicative language. Repeals a provision which provides for repeal of the exemption. Effective Date: 10/01/2011

*Reported favorably by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability*

*Identical to **HB 7081(HC)** in the Committees on Judiciary; and Governmental Oversight and Accountability*

## **CS/CS/SB 594 (SO) by the Committees on Community Affairs, Judiciary and Senator Hays—**

**Sovereign Immunity;** Requires that a claim in a wrongful death case be presented to the Department of Financial Services (DFS) within 2 years after the claim accrues. Provides that failure of the DFS or the appropriate agency to make final disposition of a claim for wrongful death within 90 days after it is filed is deemed to be a final denial of the claim. Tolls the statute of limitations for the period of time taken by the DFS or other agency to deny a medical malpractice or wrongful death claim. Specifies applicability to workers' compensation claims, etc. Effective Date: July 1, 2011

*Reported favorably as a committee substitute by the Committee on Judiciary; and the Committees on Governmental Oversight and Accountability; and Community Affairs reports the committee substitute favorably*

*Similar to **CS/CS/HB 277(HC)** in the Committees on Judiciary; Governmental Oversight and Accountability; and Community Affairs*

---

## **CS/SB 600 (SO) by the Committees on Governmental Oversight and Accountability, and Criminal Justice—**

## **CS/SB 34 (2R) by the Committee on Rules and Senator Dean—**

**Relief/Angela Isham/City of Ft. Lauderdale;** Compensates Angela Isham, individually, and as co-personal representative of the Estate of David Isham, deceased, for the death of Mr. Isham, which was due to the negligence of employees of the City of Ft. Lauderdale. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

## **CS/SB 46 (2R) by the Committee on Rules and Senator Haridopolos—**

**Relief/William Dillon/State of Florida;** Compensates William Dillon, who was wrongfully incarcerated for 27 years and exonerated by a court after DNA testing. Directs the Chief Financial Officer to draw a warrant for the purchase of an annuity. Provides for a waiver of certain tuition and fees. Provides conditions for payment. Provides that the act does not waive certain defenses or increase the state's liability, etc. Effective Date: upon becoming a law

Authorizes a financial emergency review board for a local government entity or district school board to consult with other governmental entities for the consolidation of all administrative direction and support services, etc. Effective Date: 07/01/2011

**SB 118 (2R) by Senator Bullard and others—**

**Bicycle Safety;** Revises safety standard requirements for bicycle helmets that must be worn by certain riders and passengers. Provides for enforcement of requirements for bicycle lighting equipment. Provides penalties for violations. Provides for dismissal of the charge following a first offense under certain circumstances. Effective Date: 10/01/2011

**CS/CS/SJR 140 (2R) by the Committees on Budget, Judiciary and Senator Ring—**

**CS/SB 324 (2R) by the Committee on Rules and Senator Flores—**

**Relief/James D. Feurtado, III/Miami-Dade County;** Compensates James D. Feurtado, III, for injuries sustained as a result of the negligence of an employee of Miami-Dade County. Provides a limitation on the payment of fees and costs, etc. Effective Date: upon becoming a law

*Recommended favorably by the Special Master on Claim Bills; and reported favorably as a committee substitute by the Committee on Rules*

**SB 418 (2R) by Senator Flores and others—**

**State Lotteries;** Requires each retailer of lottery tickets to provide assistance to any individual who is blind or visually impaired and has requested assistance in filling out his or her lottery ticket. Provides that a retailer or an employee of the retailer is not liable under certain circumstances, etc. Effective Date: 07/01/2011

**CS/CS/SB 450 (2R) by the Committees on Judiciary, Military Affairs, Space, and Domestic Security, Senator Bennett and others—**

Provides immunity from civil liability for providers of temporary housing and aid to emergency first responders and their immediate family members following a declared emergency. Provides definitions. Provides nonapplicability. Authorizes specified registration with a county emergency management agency as a provider of housing and aid for emergency first responders. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Military Affairs, Space, and Domestic Security; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably*

**SB 464 (2R) by Senator Latvala—**

**Assault or Battery of a Law Enforcement Officer;** Requires the Department of Law Enforcement to issue a blue alert if a law enforcement officer has been killed, suffered serious bodily injury, or been assaulted and the suspect has fled the scene, or if a law enforcement officer is missing while in the line of duty. Requires that the blue alert be disseminated on the emergency alert system through television, radio, and highway signs. Provides that emergency traffic information may take precedence over blue alert information. Effective Date: 10/01/2011

*Reported favorably by the Committees on Criminal Justice; Transportation; and Budget*

**CS/SB 480 (2R) by the Committee on Community Affairs and Senator Wise—**

**Florida Endowment for Vocational Rehabilitation;** Removes a provision that requires the State Board of Administration to invest and reinvest moneys in the endowment fund for the Florida Endowment for Vocational Rehabilitation. Requires that a specified percent of the remainder of all civil penalties received by a county court and after distribution pursuant to ch. 318, F.S., be remitted to the Department of Revenue on a monthly basis, etc. Effective Date: upon becoming a law

**State Memorials;** Establishes the Florida Veterans' Hall of Fame on the Plaza Level of the Capitol Building. Provides for the Department of Veterans' Affairs to administer the Florida Veterans' Hall of Fame. Authorizes the department to establish a nomination and selection process and an induction ceremony, etc. Effective Date: 07/01/2011

**CS/CS/SB 632 (2R) by the Committees on Community Affairs, Higher Education and Senator Oelrich—**

**Postsecondary Education;** Revises provisions relating to the disposal of personal property lost or abandoned on a university or Florida College System institution campus and the disposition of proceeds from the sale of such property. Repeals a provision relating to an exemption for students who earn 9 or more credits from one or more of the articulated acceleration mechanisms from any requirement of a public postsecondary educational institution which mandates enrollment during a summer term, etc. Effective Date: 07/01/2011

**CS/SB 734 (2R) by the Committee on Communications, Energy, and Public Utilities and Senator Wise—**

**Assault or Battery on Utility Workers;** Defines the term "utility worker." Provides for reclassification of certain offenses against utility workers, etc. Effective Date: 07/01/2011

*Reported favorably as a committee substitute by the Committee on Communications, Energy, and Public Utilities; the Committees on Criminal Justice; and Budget Subcommittee on Criminal and Civil Justice Appropriations reports the committee substitute favorably; and withdrawn from the Committee on Budget*

**CS/SB 746 (2R) by the Committee on Criminal Justice and Senator Altman—**

**Open House Parties;** Provides that a person who violates the open house party statute a second or subsequent time commits a misdemeanor of the first degree. Provides that a person commits a misdemeanor of the first degree if the violation of the open house party statute causes or contributes to causing serious bodily injury or death to the minor, or causes or contributes to causing serious bodily injury or death to another person as a result of the minor's consumption of alcohol or drugs at the open house party. Provides criminal penalties. Effective Date: 07/01/2011

**SB 874 (2R) by Senator Hays and others—**

Provides for retroactive effect of the exemption. Provides for future legislative review and repeal of the exemption. Provides a statement of public necessity. Effective Date: upon becoming a law

**CS/SB 880 (2R) by the Committee on Budget and Senator Garcia—**

**Value Adjustment Boards;** Requires a petitioner challenging the assessed value of property before the value adjustment board to pay a specified percentage of the taxes by a certain date. Requires a petitioner challenging the denial of a classification or exemption, or the assessment on specified grounds, before the value adjustment board to pay the amount of tax which the taxpayer admits in good faith to be owing by a certain date. **Driver's Licenses and Identification Cards;** Requires that the application form for an original, renewal, or replacement driver's license or identification card include an option to make a voluntary contribution to Disabled American Veterans, Department of Florida. Provides that such contributions are not income of a revenue nature. Effective Date: 07/01/2011

Authorizes an institution to delegate to an external agent the management and investment of an institutional fund, etc. Effective Date: 07/01/2012

**Public Retirement Plans;** Provides for the calculation of local government retirement benefits after a certain date. Requires the Department of Management Services to provide a fact sheet on each local plan. Provides that a local government employer is eligible for participation in the Florida Retirement System if it has no unfunded actuarial liabilities. Revises provisions relating to benefits paid by a municipality that has its own pension plan, etc. Effective Date: 07/01/2011

Establishes criteria for qualification. Authorizes a teaching agency to be affiliated with an academic research university in the state that meets certain criteria. Authorizes a teaching agency to be affiliated with an academic health center, etc. Effective Date: 07/01/2011

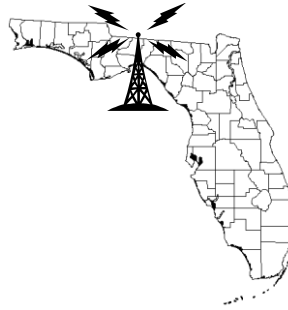
