BILLS ON THE CALENDAR

BILLS ON THIRD READING

CS/CS/SB 818, 1st Eng. (3R) by the Committees on Criminal Justice, Health Regulation, Senator Fasano and others—

Controlled Substances; Authorizes certain health care practitioners to complete a continuing education course relating to the prescription drug monitoring program. Creates a felony of the third degree for any person to register or attempt to register a pain-management clinic through misrepresentation or fraud. Authorizes the DOH to revoke the certificate of registration of a pain-management clinic based upon a finding by a probable cause panel of a board that the clinic does not meet certain requirements, etc. Effective Date: 10/01/2011

Read the second time on April 27, 2011 and amended on April 28, 2011

Compare to CS/CS/HB 7095, 2nd Eng.(HC) in the Committees on Health Regulation; Criminal Justice; and Budget

CS/HJR 7111, 2nd Eng. (3R) by the Committees on Judiciary Committee, Civil Justice Subcommittee, Representative Eisnaugle and others—

Supreme Court; Proposes a revision of Article V of the State Constitution, relating to the judiciary, consisting of amendments to ss. 2, 3, 4, 7, 11, 12, & 14, Art. V, & creation of s. 21, Art. V, of State Constitution to divide current Supreme Court into two divisions, one hearing civil cases & other hearing criminal cases; provides for administration of divisions; defines jurisdiction of divisions; provides for transition from present Supreme Court; revises provisions relating to repeal of court rules; limits readoption of repealed court rule, etc.

Substituted for **SJR 2084(SUB)** (Bogdanoff) and read the second time on April 28, 2011

CS/CS/HB 99 (3R) by the Committees on Economic Affairs Committee, Insurance and Banking Subcommittee and Representative Drake—

Commercial Insurance Rates; Exempts additional categories or kinds of insurance & types of commercial lines risks from certain filing requirements; deletes requirement that rate change notice include total premium written for exempt class; removes requirement that specified types of records & information be retained; requires retention of certain actuarial data; requires specified insurers & rating organizations to incur examination expenses; removes requirement that rating organization maintain certain statistics, etc. Effective Date: 10/01/2011

Substituted for CS/CS/SB 178(SUB) (Oelrich) and read the second time on April 29, 2011

CS/CS/SB 396, 1st Eng. (3R) by the Committees on Regulated Industries, Community Affairs and Senator Bennett—

Building Construction and Inspection; Provides that the issuance of a statement of estimated regulatory costs does not apply to updates of or modifications to the Florida Building Code or the Florida Fire Prevention Code. Prohibits the Florida Building Commission from adopting rules that limit any exceptions or exemptions provided for modifications or repairs of existing structures within the limits of an existing foundation under certain circumstances. Requires that state agencies, local governments, and the court system adopt a sustainable building rating system or national model green building code for new and renovated buildings, etc. Effective Date: 07/01/2011

Read the second time and amended on April 29, 2011

CS/HB 1329 (3R) by the Committee on K-20 Innovation Subcommittee, Representative Bileca and others—

McKay Scholarships/Students with Disabilities; Makes scholarships available to students with disabilities who have 504 accommodation plan issued under federal law; allows parent to request & receive scholarship for student to enroll in & attend private school if student has 504 accommodation plan; provides that students with certain temporary 504 accommodation plans are ineligible for scholarship; provides that parent may choose to enroll student in public school in adjacent district under certain conditions; provides for scholarship amounts. Effective Date: 07/01/2011

Substituted for **CS/SB 1656(SUB)** (Wise) and read the second time on April 29, 2011

CS/SB 1754 (3R) by the Committee on Banking and Insurance, Senator Garcia and others—

Health Insurance; Prohibits a person from being compelled to purchase health insurance except under specified conditions. Specifies that the act does not prohibit the collection of certain debts. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Banking and Insurance; and the Committees on Health Regulation; and Rules reports the committee substitute favorably

Identical to CS/HB 1193(HC) in Messages

LOCAL BILLS CALENDAR FOR MONDAY, MAY 2, 2011

SB 1980 (LB) by Senator Latvala-

Lealman Special Fire Control District/Pinellas Co.; Reduces the maximum ad valorem millage rate that may be levied by the district. Provides requirements for the annexation of the unincorporated territory of the district by a municipality. Requires the approval of an annexation by a referendum of the electors within the district. Provides for future expiration of the requirements for annexation, etc. Effective Date: upon becoming a law

HB 229 (LB) by Representative Young-

City of Tampa, Hillsborough County; Revises General Employees' Pension Plan for city; revises definitions of terms "Salaries or Wages," "Employee," & "Military Service Time"; revises application of term "Actuarial Equivalent"; defines term "Limitation Year"; provides that all employee contributions to pension fund after certain date are mandatory & that city shall pay such contributions to fund on behalf of employee; provides certain beneficiaries option to roll over certain death benefits; provides for refund of employee contributions, etc. Effective Date: 10/01/2011

CS/HB 231 (LB) by the Committee on Community and Military Affairs Subcommittee, Representative Young and others—

City Pension Fund/City of Tampa/Hillsborough Co.;

Authorizes City of Tampa to enter into supplemental contract with certain firefighters & police officers to comply with ch. 2009-97, Laws of Florida; revises manner in which elective trustees are elected; increases maximum length of time prior to term commencement in which to conduct trustee elections; allows board to retain services of more than one nationally recognized professional investment counselor; increases investment cap on foreign securities, etc. Effective Date: 10/01/2011

HB 233 (LB) by Representative Young—

City of Tampa, Hillsborough County; Authorizes Division of Alcoholic Beverages & Tobacco of DBPR to issue alcoholic beverage license to City of Tampa to use within Curtis Hixon Waterfront Park & Kiley Garden Park; provides that license may be used only for special events; provides for payment of license fee; prohibits sales for consumption off premises; authorizes transfer & provides for subsequent reversion of license under certain circumstances. Effective Date: upon becoming a law

HB 529 (LB) by Representative Caldwell-

Lee County Sheriff's Office; Provides that certain retirement health insurance benefits shall not be available to specified employees. Effective Date: upon becoming a law

CS/HB 555 (LB) by the Committee on Community and Military Affairs Subcommittee and Representative Mayfield—

Indian River Mosquito Control District; Revises powers of board of commissioners relating to employment of certain persons; specifies provisions of law governing election of commissioners & removes obsolete provisions for staggering of initial terms; requires district to pay for surety bonds required of commissioners before they assume office; requires commissioners to elect secretary/treasurer for board; revises per diem & travel expense provisions for commissioners & employees, etc. Effective Date: 07/01/2011

HB 657 (LB) by Representative Harrell—

Martin County; Limits issuance of special alcoholic beverage licenses to restaurants that serve certain number of patrons, occupy certain amount of floor space, & are located within legal boundaries of community redevelopment areas of county. Effective Date: upon becoming a law

HB 659 (LB) by Representative Harrell—

Martin County; Revises membership of County Health Care Review Board. Effective Date: upon becoming a law

HB 699 (LB) by Representative Taylor—

Southeast Volusia Hospital District/Volusia County; Expands representation of district's governing body. Effective Date: upon becoming a law

HB 741 (LB) by Representative Berman—

Lake Worth Drainage District, Palm Beach County; Authorizes district to develop & operate water supply facilities & enter into interlocal agreements with local governments & public & private utilities for such purpose; provides for issuance of notes & bonds; prohibits district from engaging in retail water sales. Effective Date: upon becoming a law

CS/HB 745 (LB) by the Committee on Community and Military Affairs Subcommittee and Representative Wood—

Polk County Historical Commission, Polk County; Revises number of commissioners; provides for membership, meetings, rules of procedure, & staff; provides powers & duties; provides for funding & dedicated accounts for county historical museum & genealogical library; deletes provisions relating to Polk County Historical Association; requires board of county commissioners to provide repository for museum & library materials. Effective Date: upon becoming a law

HB 861 (LB) by Representative Jenne—

North Springs Improvement District, Broward County; Extends & enlarges boundaries of district. Effective Date: upon becoming a law

HB 865 (LB) by Representative Jenne-

Town of Southwest Ranches, Broward County; Amends town's charter to remove inapplicable provisions & make ministerial changes; provides further description of town's rural residential character; eliminates previously repealed language; provides additional language relating to filling council vacancies; clarifies that only town council is required to vote by roll call; clarifies that roll call vote is required by town council on all land use & quasi-judicial items. Effective Date: upon becoming a law

HB 867 (LB) by Representative Jenne—

Broward County; Revises dates on which municipal candidates must file qualification papers & fees for certain elections. Effective Date: upon becoming a law

CS/HB 869 (LB) by the Committee on Community and Military Affairs Subcommittee, Representative Boyd and others—

Manatee County Port Authority; Provides for conveyance of title to submerged lands adjacent to port authority's boundaries from Board of Trustees of Internal Improvement Trust Fund; defines territorial boundaries of submerged lands. Effective Date: upon becoming a law

HB 985 (LB) by Representative Burgin—

Hillsborough County; Defers future repeal of ch. 2004-414, Laws of Florida, which relates to projects for which payment & performance bonds may be waived for construction of public building, for prosecution & completion of public work, or for repairs on public building or public work when cost of project is at or below certain threshold & contract for construction, completion, or repair is awarded pursuant to economic development program established to encourage local small businesses to participate in county procurement programs. Effective Date: upon becoming a law

HB 1009 (LB) by Representative McBurney-

City of Jacksonville, Duval County; Adds special zone in downtown Jacksonville; provides exception from certain requirements for restaurant liquor licenses in zone. Effective Date: upon becoming a law

HB 1045 (LB) by Representative Clemens—

Loxahatchee Groves Water Control Dist./Palm Beach; Provides for dedication of width of roads to public; provides dedication requirements; provides for prima facie evidence of public road easements; exempts certain property of electric company; assigns traffic control jurisdiction on all public roads within district to Town of Loxahatchee Groves. Effective Date: upon becoming a law

CS/HB 1063 (LB) by the Committee on Community and Military Affairs Subcommittee and Representative Goodson—

Canaveral Port District, Brevard County; Increases amount for which Canaveral Port Authority may encumber personal properties & facilities; increases amount for which contracts for construction, improvement, repair, or building may be entered into or goods, supplies, or materials may be purchased by district or authority. Effective Date: upon becoming a law

CS/HB 1293 (LB) by the Committee on Community and Military Affairs Subcommittee and Representative Tobia—

Brevard County; Authorizes Division of Alcoholic Beverages & Tobacco of Department of Business & Professional Regulation to issue an alcoholic beverage license to Brevard Art Museum, Inc., for use within museum's buildings; requires payment of license fee; provides for sale of beverages for consumption at museum; provides for transfer of license. Effective Date: upon becoming a law

HB 1307 (LB) by Representative Metz—

City of Mount Dora, Lake County; Authorizes Division of Alcoholic Beverages & Tobacco of DBPR to issue temporary permits to nonprofit civic organization to sell alcoholic beverages for consumption on premises at outdoor events on public right-of-way in downtown Mount Dora, subject to certain statutory requirements; provides that such events require street-closure permit from city; provides that permits authorized by act are in addition to certain other authorized temporary permits; requires division to adopt rules. Effective Date: upon becoming a law

HB 1311 (LB) by Representative Coley—

Walton County; Provides that certain rigid coastal armoring structures constructed during specified time may remain without need to obtain DEP permit; provides conditions. Effective Date: upon becoming a law

CS/HB 1317 (LB) by the Committee on Community and Military Affairs Subcommittee and Representative Adkins—

Nassau County; Creates targeted job creation zone pilot project; authorizes county to designate specified areas as targeted job creation zones & to implement specified exceptions, strategies, & incentives; provides for alternative process for adoption & review of specified local government comprehensive plan amendments; provides for repeal of pilot project. Effective Date: 07/01/2011

CS/HB 1345 (LB) by the Committee on Community and Military Affairs Subcommittee and Representative Kreegel—

Charlotte County Airport Authority/Charlotte Co.; Revises various provisions of Charlotte County Airport Authority Act; revises definitions; expands purpose of authority; revises provisions relating to members, officers, compensation, & meetings; revises powers of authority; revises requirements for expenditure of funds. Effective Date: upon becoming a law

HB 1351 (LB) by Representative Jenne-

South Broward Drainage District, Broward County; Revises & provides definitions; conforms terminology; updates obsolete provisions; revises inconsistent provisions; revises method of deciding elections in event of a tie; clarifies language regarding imposition of district assessments & taxes; clarifies type of property subject to district rules, criteria, & regulations; authorizes board to take action required of district by another governmental agency; requires district to take water control elevations into consideration for all projects within district, etc. Effective Date: upon becoming a law

CS/HB 1489 (LB) by the Committee on Economic Affairs Committee and Representative Albritton—

Sebring Airport Authority, Highlands County; Revises powers of authority; provides that authority may establish, operate, & maintain foreign-trade zone status under alternative site framework in DeSoto, Glades, Hardee, Hendry, Highlands, & Okeechobee Counties & Cities of Belle Glade, Pahokee, & South Bay; expands power to purchase commodities or contractual services. Effective Date: upon becoming a law

HB 4191 (LB) by Representative Hager—

Palm Beach County; Deletes obsolete provisions relating to establishment of advisory committee to advise Board of County Commissioners on improvements, operations, maintenance, & enhancement of South Lake Worth Inlet & adjacent property & to assist in development, coordination, & public review of Inlet Management Plan. Effective Date: upon becoming a law

HB 4197 (LB) by Representative Gaetz—

Okaloosa County; Repeals provisions relating to establishment & duties of Personnel Standards & Review Board for Okaloosa County Sheriff's Department. Effective Date: upon becoming a law

HB 4203 (LB) by Representative Gaetz—

Okaloosa County; Repeals act relating to exception for certain restaurants in county to limitation under general law on number of alcoholic beverage licenses allowed to be issued in county, to provide for issuance of such licenses to restaurants in county in excess of such limitation in accordance with criteria & conditions specified in general law. Effective Date: upon becoming a law

HB 4205 (LB) by Representative Holder—

Pinecraft Lighting District, Sarasota County; Abolishes district; repeals all special acts relating to district; transfers assets & liabilities of district to Sarasota County. Effective Date: upon becoming a law

SPECIAL ORDER CALENDAR FOR MONDAY, MAY 2, 2011

CS/SB 106 (SO) by the Committee on Governmental Oversight and Accountability and Senator Ring—

Public Records; Creates an exemption from public records requirements for information that identifies a donor or prospective donor of a donation made for the benefit of a publicly owned performing arts center if the donor desires to remain anonymous. Creates such exemption for information identifying a donor or prospective donor to the direct-support organization of the Legislative Research Center and Museum at the Historic Capitol. Provides for future legislative review and repeal of the exemptions under the Open Government Sunset Review Act, etc. Effective Date: 10/01/2011

Reported favorably by the Committee on Community Affairs; reported favorably, with one amendment, by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability

CS/CS/SB 204 (SO) by the Committees on Health Regulation, Criminal Justice, Senator Wise and others—

Controlled Substances; Defines the term "homologue" for purposes of the Florida Comprehensive Drug Abuse Prevention and Control Act. Includes certain hallucinogenic substances on the list of controlled substances in Schedule I. Provides that it is a misdemeanor of the first degree to be in possession of not more than a specified amount of certain hallucinogenic substances. Reenacts provisions relating to prohibited acts and penalties regarding controlled substances and the offense severity chart of the Criminal Punishment Code, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Health Regulation; the Committee on Judiciary reports the committee substitute favorably; and withdrawn from the Committee on Budget

Identical to CS/CS/HB 39(HC) in the Committees on Criminal Justice; Health Regulation; Judiciary; and Budget

CS/SB 224 (SO) by the Committee on Governmental Oversight and Accountability and Senator Dean—

Local Government Accountability; Amends provisions relating to the Legislative Auditing Committee to clarify when the Department of Community Affairs may institute procedures for declaring that a special district is inactive. Specifies the level of detail required for each fund in the sheriff's proposed budget. Revises the schedule for submitting a local governmental entity's audit and annual financial reports to the Department of Financial Services. Revises provisions relating to the guidelines for district school boards to maintain an ending fund balance for the general fund, etc. Effective Date: 10/01/2011

Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Budget reports the committee substitute favorably

CS/CS/SB 236 (SO) by the Committees on Budget Subcommittee on General Government Appropriations, Environmental Preservation and Conservation, Senator Hays and others—

State Parks; Provides for the parents of certain deceased veterans and the spouse and parents of law enforcement officers and firefighters who die in the line of duty to receive annual entrance passes to state parks at no charge. Designates the Jack Mashburn Marina at St. Andrews State Park in Bay County. Exempts parks within the state park system which have freeroaming animal populations from certain liability provisions. Provides for certain municipalities to use the proceeds of the surcharge for land acquisition or beach renourishment or restoration, etc. Effective Date: 07/01/2011

Reported favorably by the Committee on Military Affairs, Space, and Domestic Security; reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation; and reported favorably as a committee substitute by the Committee on Budget Subcommittee on General Government Appropriations

Similar to CS/CS/HB 95(HC) in the Committees on Military Affairs, Space, and Domestic Security; Environmental Preservation and Conservation; Budget Subcommittee on General Government Appropriations; and Budget

SB 474 (SO) by Senator Evers-

Sales Representative Contracts; Repeals a provision relating to sales representative contracts, commissions, requirements, termination of agreements, and civil remedies. Effective Date: 07/01/2011

Reported favorably by the Committees on Commerce and Tourism; Judiciary; and Rules

Identical to HB 4023(HC) in the Committees on Commerce and Tourism; Judiciary; and Rules

CS/SB 524 (SO) by the Committee on Transportation, Senator Latvala and others—

Seaports; Deletes provisions relating to statewide minimum standards for seaport security. Deletes provisions authorizing the Department of Law Enforcement to exempt all or part of a seaport from specified requirements in certain circumstances. Prohibits a seaport from charging any fee for administration or production of access control credentials that require or are associated with a fingerprint-based background check, in addition to the fee for the federal TWIC, etc. Effective Date: upon becoming a law

Reported favorably by the Committee on Military Affairs, Space, and Domestic Security; reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Committee on Budget Subcommittee on Criminal and Civil Justice Appropriations; and withdrawn from the Committee on Budget

Similar to CS/CS/CS/CS/HB 283(HC) in the Committees on Military Affairs, Space, and Domestic Security; Transportation; Budget Subcommittee on General Government Appropriations; and Budget

SB 534 (SO) by Senator Wise—

Firesafety; Revises the rulemaking authority and responsibilities of the State Fire Marshal relating to educational and ancillary plants. Revises requirements and procedures for inspections of buildings and equipment. Abolishes special state firesafety inspector classifications and certifications. Provides criteria, procedures, and requirements for special state firesafety inspectors to be certified as firesafety inspectors. Revises firesafety inspection requirements for educational institution boards to conform to certain codes, etc. Effective Date: 07/01/2011

Reported favorably by the Committees on Banking and Insurance; Education Pre-K - 12; Community Affairs; and Higher Education; and withdrawn from the Committee on Budget

Identical to **HB 331(HC)** in the Committees on Banking and Insurance; Education Pre-K - 12; Community Affairs; Higher Education; and Budget

CS/CS/SB 556 (SO) by the Committees on Budget, Criminal Justice, Senator Oelrich and others—

Temporary Assistance for Needy Families Program; Requires the Department of Children and Family Services to perform a drug test on individuals who apply for benefits funded by the Temporary Assistance for Needy Families Program. Makes individuals responsible for bearing the cost of drug testing. Requires certain notice. Provides procedures for testing and retesting. Provides for notice of local substance abuse programs. Provides conditions for an individual to reapply for temporary assistance for needy families benefits, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Committee on Budget Subcommittee on Health and Human Services Appropriations reports the committee substitute favorably, with one amendment; and reported favorably as a committee substitute by the Committee on Budget

Similar to CS/CS/CS/CS/HB 353, 1st Eng.(HC) in the Committees on Criminal Justice; Budget Subcommittee on Health and Human Services Appropriations; and Budget

CS/SB 580 (SO) by the Committee on Community Affairs and Senator Oelrich—

Residential Building Permits; Prohibits local enforcement agencies and building code officials or entities from requiring certain inspections of buildings, structures, or real property as a condition of issuance of certain residential building permits. Provides certain exceptions to the application of the act. Provides for expiration of the act following an amendment to the Florida Building Code by the Florida Building Commission which incorporates the provisions of the act. Effective Date: 07/01/2012

Reported favorably as a committee substitute by the Committee on Community Affairs; and the Committees on Regulated Industries; and Budget reports the committee substitute favorably

Similar to CS/HB 407(HC) in the Committees on Community Affairs; Regulated Industries; and Budget

CS/SJR 592 (SO) by the Committee on Budget, Senator Bennett and others—
