Controlled Substances; Authorizes certain health care practitioners to complete a continuing education course relating to the prescription drug monitoring program. Creates a felony of the third degree for any person to register or attempt to register a pain-management clinic through misrepresentation or fraud. Authorizes the DOH to revoke the certificate of registration of a pain-management clinic based upon a finding by a probable cause panel of a board that the clinic does not meet certain requirements, etc. Effective Date: 10/01/2011

Education Accountability; Revises numerous provisions relating to K-12 public education system; revises provisions relating to virtual instruction courses, school board member acceptance of gifts, Opportunity Scholarship Program, McKay Scholarships, Voluntary Prekindergarten Education Program, special education services, requirements for middle grades promotion & high school graduation, digital curriculum, career & professional academies, use of restraint & seclusion on students with disabilities, assistive technology, statewide assessments, college readiness, school improvement, etc. Effective Date: 07/01/2011

Substituted for **CS/CS/SB 1696(SUB)** (Wise), read the second time, and amended on May 2, 2011

SB 788 (3R) by Senator Diaz de la Portilla-

Public School Educational Instruction; Requires district school boards to designate one month of the school year to celebrate the Founding Fathers of the United States of America and the principles inherent in the country's founding documents. Specifies the focus of instruction during the designated month. Provides that instruction may be integrated into the existing school curriculum. Effective Date: 07/01/2011

Read the second time on May 3, 2011

CS/CS/HB 965, 1st Eng. (3R) by the Committees on Appropriations Committee, Finance and Tax Committee, Representative Horner and others—

Florida Tax Credit Scholarship Program; Revises provisions relating to amount of tax credit allowed for contribution made to eligible nonprofit scholarship-funding organization; revises provisions relating to carryforward of unused amount of tax credit & rescindment of all or part of tax credit under Florida Tax Credit Scholarship Program. Effective Date: 07/01/2011

Substituted for **CS/SB 1388(SUB)** (Flores) and read the second time on May 3, 2011

CS/CS/CS/CS/CS/HJR 381, 2nd Eng. (3R) by the Committees on Economic Affairs Committee, Appropriations Committee, Finance and Tax Committee, Community and Military Affairs Subcommittee, Representatives Dorworth, Costello, Crisafulli, Bovo and others—

Property Assessment/Homestead Exemption; Proposes amendments to State Constitution to allow Legislature by general law to prohibit increases in assessed value of homestead & specified nonhomestead property if just value of property decreases, reduce limitation on annual assessment increases applicable to nonhomestead real property, provide additional homestead exemption for owners of homestead property who have not owned homestead property for specified time before purchase of current homestead property, & application & limitations with respect thereto, etc.

Ad Valorem Taxation; Reduces amount by which any change in value of nonhomestead residential property resulting from annual reassessment may exceed assessed value of property for prior year; reduces amount by which any change in value of certain residential & nonresidential real property resulting from annual reassessment may exceed assessed value of property for prior year; provides first-time Florida homesteader with additional homestead exemption; provides for calculation of exemption; provides for applicability period of exemption, etc. Effective Date: upon becoming a law

Substituted for **CS/SB 1722(SUB)** (Fasano) and read the second time on May 3, 2011

CS/SB 2040, 1st Eng. (3R) by the Committees on Judiciary, and Judiciary—

Enforcement of Immigration Laws; Requires one-stop career center staff to verify the employment eligibility of workers referred to employers using a federal program for electronic verification of employment eligibility. Requires notice to employers on the exception to use of electronic verification. Prohibits an agency from providing federal, state, or local public benefits to certain aliens. Requires an agency to verify the eligibility of applicants for public benefits using the federal Systematic Alien Verification for Entitlements Program, etc. Effective Date: 07/01/2011

Read the second time and amended on May 3, 2011

CS/CS/HB 7197 (3R) by the Committees on Education Committee, Appropriations Committee, K-20 Innovation Subcommittee, Representative Stargel and others—

Digital Learning; Creates Digital Learning Now Act; requires school districts to establish virtual instruction options; authorizes establishment of virtual charter schools & provides requirements; authorizes blended learning courses; provides additional requirements for Florida Virtual School; requires full-time & part-time school district virtual instruction program options; provides funding & accountability requirements; requires online learning course for high school graduation; redefines FTE student for purposes of virtual instruction. Effective Date: 07/01/2011

Substituted for **CS/SB 1620(SUB)** (Flores) and read the second time on May 3, 2011

CS/CS/SB 632 (SO) by the Committees on Community Affairs, Higher Education and Senator Oelrich—

Postsecondary Education; Revises provisions relating to the disposal of personal property lost or abandoned on a university or Florida College System institution campus and the disposition of proceeds from the sale of such property. Repeals a provision relating to an exemption for students who earn 9 or more credits from one or more of the articulated acceleration mechanisms from any requirement of a public postsecondary educational institution which mandates enrollment during a summer term, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Higher Education; reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Budget reports the committee substitute favorably

CS/CS/SB 1180 (SO) by the Committees on Budget, Transportation and Senator Latvala—

Transportation; Provides that the Florida Statewide Passenger Rail Commission has the primary and exclusive authority to monitor certain designated functions related to passenger rail systems. Removes from the Florida Transportation Commission the responsibility and duty to monitor the efficiency, productivity, and management of all publicly funded passenger rail systems in the state, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably, with twelve amendments, by the Committee on Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and reported favorably as a committee substitute by the Committee on Budget

Similar to **CS/CS/CS/HB 1363, 1st Eng.(HC)** in the Committees on Transportation; Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and Budget

CS/CS/SB 1194 (SO) by the Committees on Children, Families, and Elder Affairs, Higher Education and Senator Oelrich—

Postsecondary Education; Deletes provisions relating to the use of test scores for assessment of college-level communication and computation skills. Requires the establishment of the Articulation Coordinating Committee and provides its responsibilities. Deletes provisions that exclude students with intellectual disabilities from eligibility for substitute requirements for admission to or graduation from a public postsecondary educational institution. Abrogates the repeal of provisions which created the 21st Century World Class Scholars Program, etc. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Higher Education; reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and the Committees on Budget Subcommittee on Higher Education Appropriations; and Budget reports the committee substitute favorably

CS/CS/SB 2086 (SO) by the Committees on Rules, Rules Subcommittee on Ethics and Elections, and Rules Subcommittee on Ethics and Elections—

Elections; Expands the list of responsibilities of the Secretary of State when acting in his or her capacity as chief election officer. Replaces a requirement for the Department of State to print copies of a pamphlet containing the Election Code with a requirement that the pamphlet be made available. Requires that third-party voter registration organizations register with the Division of Elections. Requires such organizations to provide the division with certain information, etc. Effective Date: upon becoming a law, except as otherwise provided

Reported favorably as a committee substitute by the Committee on Rules Subcommittee on Ethics and Elections; reported favorably as a committee substitute by the Committee on Rules; and the Committee on Budget reports the committee substitute favorably, with one amendment

Similar to **CS/CS/HB 1355, 1st Eng.(HC)** in the Committees on Rules Subcommittee on Ethics and Elections; Rules; and Budget

SB 1770 (SO) by Senator Hays and others-

Parental Notice of Abortion; Revises notice requirements relating to the termination of pregnancy of a minor. Provides exceptions to the notice requirements. Revises procedure for judicial waiver of notice. Provides for the minor to petition for a hearing within a specified time. Provides that in a hearing relating to waiving the requirement for parental notice, the court consider certain additional factors, including whether the minor's decision to terminate her pregnancy was due to undue influence. Provides a procedure for appeal if judicial waiver of notice is not granted, etc. Effective Date: upon becoming a law

Reported favorably by the Committee on Health Regulation; reported favorably, with one amendment, by the Committee on Judiciary; and withdrawn from the Committee on Budget

Similar to **HB 1247, 1st Eng.(HC)** in the Committees on Health Regulation; Judiciary; and Budget

CS/SB 1744 (SO) by the Committee on Health Regulation and Senator Storms—

Abortions; Requires that an ultrasound be performed on a woman obtaining an abortion. Requires that the ultrasound be reviewed with the patient before the woman gives informed consent for the abortion procedure. Requires that the woman certify in writing that she declined to review the ultrasound and did so of her own free will and without undue influence. Provides an exemption from the requirement to view the ultrasound for women who are the victims of rape, incest, domestic violence, or human trafficking or for women who have a serious medical condition, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Health Regulation; and withdrawn from the Committees on Budget; and Rules

Compare to **CS/HB 1127(HC)** in the Committees on Health Regulation; Budget; and Rules

CS/CS/SB 556 (SO) by the Committees on Budget, Criminal Justice, Senator Oelrich and others—

Temporary Assistance for Needy Families Program; Requires the Department of Children and Family Services to perform a drug test on individuals who apply for benefits funded by the Temporary Assistance for Needy Families Program. Makes individuals responsible for bearing the cost of drug testing. Requires certain notice. Provides procedures for testing and retesting. Provides for notice of local substance abuse programs. Provides conditions for an individual to reapply for temporary assistance for needy families benefits, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Committee on Budget Subcommittee on Health and Human Services Appropriations reports the committee substitute favorably, with one amendment; and reported favorably as a committee substitute by the Committee on Budget

Similar to **CS/CS/CS/CS/HB 353, 1st Eng.(HC)** in the Committees on Criminal Justice; Budget Subcommittee on Health and Human Services Appropriations; and Budget

SB 1398 (SO) by Senator Bogdanoff-

Judiciary; Repeals provisions relating to regular terms of the Supreme Court, compensation of the marshal, census commissions for the judicial circuits, and terms of the circuit courts. Repeals provisions relating to terms of the First Judicial Circuit through the Twentieth Judicial Circuit. Repeals provisions relating to requiring a judge to attend the first day of each term of the circuit court. Repeals provisions relating to requiring a judge to state a reason for nonattendance. Repeals provisions relating to guardians of incapacitated world war veterans, etc. Effective Date: 07/01/2011

Reported favorably, with one amendment, by the Committee on Judiciary; and withdrawn from the Committee on Rules

CS/CS/CS/SB 1972 (SO) by the Committees on Budget, Budget Subcommittee on Health and Human Services Appropriations, Health Regulation, Senator Negron and others—

Health and Human Services; Exempts hospital districts from the requirement to provide funding to a community redevelopment agency. Provides for medical assistance for children in out-of-home care and adopted children. Revises provisions relating to conditions for Medicaid eligibility. Establishes the Medicaid managed care program as the statewide, integrated managed care program for medical assistance and long-term care services. Requires all Medicaid recipients to be enrolled in Medicaid managed care. Establishes regions for separate procurement of plans, etc. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Health Regulation; reported favorably as a committee substitute by the Committee on Budget Subcommittee on Health and Human Services Appropriations; and reported favorably as a committee substitute by the Committee on Budget

Compare to **CS/HB 7107, 2nd Eng.(HC)** in the Committees on Health Regulation; Budget Subcommittee on Health and Human Services Appropriations; and Budget

CS/HB 7109, 2nd Eng. (SO) by the Committees on Appropriations Committee, Health and Human Services Committee and Representative Schenck—

Medicaid; Requires APD to establish transition plan for current Medicaid recipients to iBudget system by specified date; requires AHCA to develop transition plan for current Medicaid recipients to managed care plans, set reimbursements rates for hospitals that provide Medicaid services, contract on prepaid or fixed-sum basis with certain dental health plans, develop opt-out process for recipients with access to employer-sponsored coverage, maintain Medicaid Encounter Data System, establish designated payment for specified Medicare Advantage Special Needs members, etc. Effective Date: 07/01/2011

Withdrawn from the Committees on Health Regulation; Budget Subcommittee on Health and Human Services Appropriations; and Budget

CS/CS/SB 1122 (SO) by the Committees on Environmental Preservation and Conservation, Community Affairs and Senator Bennett—

Growth Management; Redesignates the "Local Government Comprehensive Planning and Land Development Regulation Act" as the "Community Planning Act." Revises and provides duties of local governments and municipalities relating to comprehensive plans. Revises provisions relating to the Century Commission for a Sustainable Florida. Revises the findings and intent to include the necessity for a specific strategic plan addressing the state's growth management system, etc. Effective Date: upon becoming a law, except as otherwise provided

Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Environmental Preservation and Conservation; and withdrawn from the Committee on Budget

Similar to **CS/HB 7129, 2nd Eng.(HC)** in the Committees on Community Affairs; Environmental Preservation and Conservation; and Budget

SB 996 (SO) by Senator Simmons-

Communications Among Branches of State Government; Cites this act as the "Communication of Judicial Opinions Act." Requires the clerks of the State Supreme Court and district courts of appeal to transmit certain judicial opinions to the Governor, the President of the Senate, and the Speaker of the House of Representatives within a specified time. Effective Date: 07/01/2011

Reported favorably by the Committees on Judiciary; Governmental Oversight and Accountability; and Budget

CS/CS/SB 830 (SO) by the Committees on Rules, Community Affairs, Senator Thrasher and others—

Labor and Employment; Prohibits a state agency from deducting from employee wages funds for political activity. Prohibits a county, municipality, or other local governmental entity from deducting from employee wages funds for political activity. Prohibits labor organizations from collecting dues, assessments, fines, or penalties for the purposes of political activity without written authorization. Requires that the labor organization provide notice of such contributions and expenditures, etc. Effective Date: July 1, 2011

Reported favorably as a committee substitute by the Committee on Community Affairs; the Committee on Budget reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

Compare to **CS/HB 1021(HC)** in the Committees on Community Affairs; Budget; and Rules

CS/SB 2170 (SO) by the Committees on Rules, and Judiciary—

Judicial Nominating Commissions; Provides for termination of the terms of all current members of judicial nominating commissions. Provides for staggered terms of newly appointed members. Effective Date: upon becoming a law

Reported favorably by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules

Compare to **HB 7101(HC)** in the Committees on Judiciary; and Rules

CS/CS/SB 666 (SO) by the Committees on Governmental Oversight and Accountability, Regulated Industries and Senator Ring—

Governmental Reorganization; Transfers and reassigns certain functions and responsibilities, including records, personnel, property, and unexpended balances of appropriations and other resources, from the Division of Pari-mutuel Wagering of the Department of Business and Professional Regulation to the Department of Gaming Control. Requires the department to issue advisory opinions under certain circumstances. Provides for the Department of Gaming Control or the Department of Legal Affairs, to prosecute a fair association for illegal gambling activities, etc. Effective Date: 10/01/2011

Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Budget reports the committee substitute favorably

CS/SB 1176 (SO) by the Committee on Judiciary and Senator Ring—

High School Athletic Trainers; Revises membership requirements for the Board of Athletic Training. Revises requirements for licensure by examination for athletic trainers. Requires certification requirements for license renewal. Revises continuing education requirements for licensure renewal. Encourages school districts to employ or contract with certified athletic trainers at certain high schools in this state. Requires athletic trainers to be certified by the Board of Certification of the National Athletic Trainers' Association, etc. Effective Date: 07/01/2011

Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Budget reports the committee substitute favorably

Compare to **CS/CS/HB 831(HC)** in the Committees on Education Pre-K - 12; Judiciary; and Budget

CS/CS/SB 1382 (SO) by the Committees on Budget, Governmental Oversight and Accountability and Senator Bennett—

Rulemaking; Requires that an agency include in its notice of intended rulemaking a statement as to whether the proposed rule will require legislative ratification. Reduces the time before an agency files a rule for adoption within which the agency must notify the person who submitted a lower cost alternative and the Administrative Procedures Committee. Excludes rules adopting federal standards and emergency rulemaking from certain provisions, etc. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Budget

Compare to CS/CS/CS/HB 993(HC) in the

Committees on Governmental Oversight and Accountability; and Budget

SB 1792 (SO) by Senator Diaz de la Portilla-

Growth Policy; Repeals provisions relating to the Urban Infill and Redevelopment Assistance Grant Program, to terminate the program. Conforms cross-references to changes made by the act. Effective Date: 07/01/2011

Reported favorably by the Committees on Community Affairs; Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and Budget

Identical to **HB 4001(HC)** in the Committees on Community Affairs; Budget Subcommittee on Transportation, Tourism, and Economic Development Appropriations; and Budget

CS/CS/SB 488 (SO) by the Committees on Judiciary, Criminal Justice, Senator Fasano and others—

Sexual Offenses; Cites this act as the "Walk in Their Shoes Act." Revises offenses that are considered "child molestation" for purposes of admitting evidence of other crimes, wrongs, or acts in a criminal case involving child molestation. Requires certain property or material that is used in a criminal proceeding to remain in the care, custody, and control of the law enforcement agency, the state attorney, or the court. Requires a law enforcement officer to provide or arrange for transportation of a victim of sexual battery to an appropriate facility for medical treatment or forensic examination, etc. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Judiciary; and withdrawn from the Committee on Budget

Similar to CS/CS/CS/HB 251, 1st Eng.(HC) in the Committees on Criminal Justice; Judiciary; and Budget

CS/SB 1902 (SO) by the Committee on Children, Families, and Elder Affairs, Senator Rich and others—

Independent Living; Requires the court to retain jurisdiction over a child until the child is 21 years of age if the child elects to receive Foundations First Program services. Provides purpose and legislative intent with respect to the provision of services for older children who are in licensed care. Creates the College Bound Program for young adults who have completed high school and have been admitted to an eligible postsecondary institution. Requires the DCFS to contract with a national nonprofit organization to administer the Road-to-Independence Program, etc. Effective Date: 10/01/2011

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and withdrawn from the Committee on Budget

CS/SB 1246 (SO) by the Committee on Agriculture, Senator Norman and others—

Farms; Prohibits a person from entering onto a farm and making any audio record, photograph, or video record at the farm without the owner's written consent. Provides exceptions. Provides definitions. Provides penalties. Effective Date: 07/01/2011

Reported favorably as a committee substitute by the Committee on Agriculture; and withdrawn from the Committees on Criminal Justice; and Budget

CS/CS/SB 476 (SO) by the Committees on Judiciary, Regulated Industries and Senator Evers—

Public Lodging Establishments; Prohibits local governments from regulating vacation rentals based solely on their classification or use. Provides that public lodging establishments formerly classified as resort condominiums and resort dwellings are classified as vacation rentals. Provides additional penalties for the offense of unlawfully distributing handbills in a public lodging establishment, etc. Effective Date: upon becoming a law

Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Judiciary; and withdrawn from the Committee on Budget

Provides that a nurse registry is exempt from certain license penalties and fines otherwise imposed by the AHCA on a nurse registry under certain circumstances, etc. Effective Date: 07/01/2011

Requires an abortion clinic to provide conspicuous notice on any form or medium of advertisement that the abortion clinic is prohibited from performing abortions in the third trimester or after viability. Prohibits a termination of pregnancy from being performed in a location other than a validly licensed hospital, abortion clinic, or physician's office, etc. Effective Date: 10/01/2011

Increases the mandatory minimum term of imprisonment for such a battery while possessing a semiautomatic firearm and its high-capacity detachable box magazine or a machine gun. Provides purpose and legislative intent with respect to the provision of services for older children who are in licensed care. Creates the College Bound Program for young adults who have completed high school and have been admitted to an eligible postsecondary institution. Requires the DCFS to contract with a national nonprofit organization to administer the Road-to-Independence Program, etc. Effective Date: 10/01/2011

SB 2056 (2R1) by the Committee on Rules Subcommittee on Ethics and Elections—

OGSR/Commission on Ethics; Amends provisions which provide exemptions from public records and public meeting requirements for records and meetings related to audits and investigations conducted by the Commission on Ethics of alleged violations of certain lobbyist registration and reporting requirements. Saves the exemptions from repeal under the Open Government Sunset Review Act. Removes the scheduled repeal of the exemptions. Effective Date: 07/01/2011

Reported favorably by the Committee on Rules Subcommittee on Ethics and Elections; and withdrawn from the Committees on Rules; and Governmental Oversight and Accountability

CS/SB 2062 (2R1) by the Committees on Judiciary, and Children, Families, and Elder Affairs—

Persons with Developmental Disabilities; Prohibits monitoring requirements that mandate pornographic materials be available in residential facilities that serve clients of the Agency for Persons with Disabilities. Requires the court to order a person involuntarily admitted to residential services to be released to the agency for appropriate residential services. Forbids the court from ordering that such person be released directly to a residential service provider. Authorizing the agency to transfer a person from one residential setting to another, etc. Effective Date: 07/01/2011
