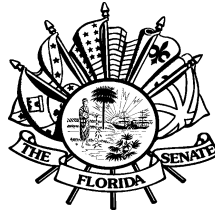

CS/CS/SB 764 (3R) by the Committees on Rules, Judiciary and Senator Detert—

Hearsay; Providing that certain statements are an exception to the hearsay rule and thus admissible, etc. Effective Date: Upon becoming a law

Read the second time on April 23, 2014, and read the third time on April 24, 2014

CS/CS/HB 561, 2nd Eng. (3R) by the Committees on Judiciary Committee, Civil Justice Subcommittee and Representative Fresen—

Attorneys for Dependent Children with Special Needs; Requires appointment of attorney to represent dependent child who meets one or more specified criteria; requires that, if one is available, attorney who is willing to represent child without additional compensation be appointed; requires appointment in writing; requires that appointment continue in effect until attorney is allowed to withdraw or is discharged by court or until case is dismissed; requires that attorney not acting in pro bono capacity be adequately compensated for services & have access to funding for certain costs; provides for financial oversight by Justice Administrative Commission; provides limit on attorney fees; requires DCF to develop procedures to identify dependent children who qualify for an attorney. Effective Date: 07/01/2014

CS/HB 337 (3R) by the Committee on K-12 Subcommittee and Representative Fresen—

Florida Teachers Classroom Supply Assistance Program; Revises procedures for distributing program funds to classroom teachers. Effective Date: 07/01/2014

Substituted for SB 886(SUB) (Montford) and read the second time on April 29, 2014

CS/HB 485 (3R) by the Committee on Criminal Justice Subcommittee, Representative Raburn and others—

Sexual Offenses Against Students by Authority Figures; Designates act the "Stop Harassing Underage Teens Act"; provides for reclassification of specified sexual offenses committed against students by authority figure of school; provides for severity ranking of offenses. Effective Date: 10/01/2014

Substituted for CS/SB 698(SUB) (Stargel) and read the second time on April 29, 2014

CS/HB 7077, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Health Quality Subcommittee, Representative Patronis and others—

Nonresident Sterile Compounding Permits; Expands penalties to apply to injury to nonhuman animal; deletes requirement that Board of Pharmacy refer regulatory issues affecting nonresident pharmacy to state where pharmacy is located; provides that pharmacy is subject to certain health care fraud provisions; requires registered nonresident pharmacies & outsourcing facilities to obtain permit in order to ship, mail, deliver, or dispense compounded sterile products into this state; authorizes board to deny, revoke, or suspend permit, or impose fine or reprimand for certain actions; provides dates by which certain nonresident pharmacies must obtain permit; authorizes board to adopt rules; authorizes department to inspect nonresident pharmacies & nonresident sterile compounding permittees; requires such pharmacies & permittees to pay for costs of such inspections. Effective Date: 10/01/2014

HB 531 (3R) by Representative Richardson—

Public Health Trusts; Authorizes public health trusts to lease certain real property. Effective Date: 07/01/2014

CS/CS/HB 629, 1st Eng. (3R) by the Committees on Regulatory Affairs Committee, Business and Professional Regulation Subcommittee, Representative Boyd and others—

Charities; Revises provisions related to the solicitation of funds. Effective Date: 07/01/2014

CS/CS/HB 271, 1st Eng. (3R) by the Committees on Regulatory Affairs Committee, Government Operations Appropriations Subcommittee, Representative Cummings and others—

Workers' Compensation; Revises powers of DFS relating to compliance with & enforcement of workers' compensation coverage requirements; provides for stop-work order information to be available on Division of Workers' Compensation's website; revises requirements for release of stop-work orders; revises penalties; revises rate formulas related to determination of compensation for disability & death; revises provisions relating to assessment rate of Special Disability Trust Fund; reduces assessment rate limitation. Effective Date: 07/01/2014

CS/CS/SB 312 (3R) by the Committees on Appropriations, Community Affairs, Senator Simpson and others—

Agriculture; Authorizing a property appraiser to grant an agricultural classification after the application deadline upon a showing of extenuating circumstances; expanding the exemption for certain farm equipment from the sales and use tax imposed under ch. 212, F.S., to include irrigation equipment, replacement parts and accessories for irrigation equipment, and repairs of irrigation equipment; authorizing agricultural landowners to establish baseline wetland and surface water conditions before implementing certain best management practice implementation agreements, etc. Effective Date: 07/01/2014

Read the second time on April 29, 2014

CS/CS/HB 979 (3R) by the Committees on Appropriations Committee, Economic Development and Tourism Subcommittee, Representative Peters and others—

Homelessness; Revises legislative findings; requires DEO to provide training & technical assistance to certain designated lead agencies of homeless assistance continuums of care; requires that provision of such training & assistance be delegated to certain nonprofit entities; requires department to establish award levels for "Challenge Grants"; specifies criteria to determine award levels; requires department, after consultation with Council on Homelessness, to specify grant award level in notice of solicitation of grant applications; revises qualifications for grant; specifies authorized uses of grant funds; requires lead agency that receives grant to submit report to department; provides for contingent effect. Effective Date: 07/01/2014

Education; Providing a directive to the Division of Law Revision and Information; including large family child care homes in local zoning regulation requirements; providing requirements for nonpublic schools delivering certain voluntary prekindergarten education programs and school readiness programs; revising provisions for licensure, registration, and operation of family day care homes; requiring a child care facility operating as a provider of certain voluntary prekindergarten education programs or child care programs to comply with minimum standards, etc. Effective Date: 07/01/2014

Discretionary Sales Surtaxes; Authorizing a county as defined in s. 125.011(1), F.S., to levy a surtax up to a specified amount for the benefit of a Florida College System institution and a state university in the county pursuant to an ordinance conditioned to take effect upon approval in a county referendum; establishing an oversight board with specified duties, responsibilities, and requirements relating to the expenditure of surtax proceeds; requiring that the board of trustees of each institution receiving surtax proceeds prepare an annual plan for submission to the oversight board for approval; providing that state funding may not be reduced because an institution receives surtax funds, etc. Effective Date: Upon becoming a law

Legislature; Fixing the date for convening the regular session of the Legislature in the year 2016, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Military and Veterans Affairs, Space, and Domestic Security; and reported favorably as a committee substitute by the Committee on Community Affairs

**CS/SB 744 (SO) by the Committee on Children,

Motor Vehicle Insurance and Driver Education for Children in Care; Authorizing the court to consider the best interest of a child in removing specified disabilities of nonage for certain minors; directing the Department of Children and Families to establish a statewide pilot program to pay specified costs of driver education, licensure and costs incidental to licensure, and motor vehicle insurance for a child in licensed out-of-home care who meets certain qualifications; requiring the department to contract with a qualified not-for-profit entity to operate and develop procedures for the pilot program; providing for preferential enrollment in driver education for specified children in care, etc. Effective Date: 07/01/2014

Health Care Clinic Act; Redefining the term “clinic”; exempting certain federally certified clinics from licensure under the act; providing that a clinic is subject to penalties if it engages physicians whose licenses have been suspended or revoked, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Health Policy; reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Appropriations reports the committee substitute favorably

Public Records/Florida State Boxing Commission; Providing an exemption from public records requirements for the information in the reports required to be submitted to the Florida State Boxing Commission by a promoter or obtained by the commission through audit of a promoter’s records; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: On the same date that SB 810 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes law

**CS/SB 810 (SO) by the Committee on Regulated
Industries and Senator Galvano—**

Pugilistic Exhibitions; Revising the duties and responsibilities of the executive director of the Florida State Boxing Commission; deleting a provision requiring the electronic recording of commission proceedings; clarifying the commission’s exclusive jurisdiction over approval of amateur and professional boxing, kickboxing, and mixed martial arts matches; providing for immediate license suspension and other disciplinary action if a participant fails or refuses to provide a urine sample or tests positive for specified prohibited substances; authorizing the commission and the Department of Business and Professional Regulation to audit specified records retained by a promoter, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Regulated Industries; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

SB 914 (SO) by Senator Latvala—

State Contracting; Revising the criteria for evaluating a proposal to include consideration of prior relevant experience of the vendor; revising the criteria for evaluating a response to an agency's invitation to negotiate to include consideration of prior relevant experience of the vendor, etc. Effective Date: 07/01/2014

Reported favorably by the Committee on Governmental Oversight and Accountability; recommended favorably by Appropriations Subcommittee on General Government; and reported favorably by the Committee on Appropriations

*Identical to **HB 953(HC)** in the Committees on Governmental Oversight and Accountability; Appropriations Subcommittee on General Government; and Appropriations*

CS/CS/CS/SB 948 (SO) by the Committees on Appropriations, Banking and Insurance, Governmental Oversight and Accountability and Senator Ring—

Foreign Investments; Revising the percentage of investments that the State Board of Administration may invest in foreign securities; revising and providing definitions with respect to requirements that the board divest securities in which public moneys are invested in certain companies doing specified types of business in or with Sudan or Iran; requiring a domestic insurer to provide a list of investments that it has in companies on the State Board of Administration's lists of scrutinized companies with activities in Sudan or in Iran's petroleum energy sector, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; reported favorably as a committee substitute by the Committee on Banking and Insurance; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/CS/SB 1044 (SO) by the Committees on Appropriations, Agriculture, Communications, Energy, and Public Utilities and Senator Simpson—

Building Construction Policies; Requiring the Department of Agriculture and Consumer Services to include in its annual report recommendations for energy efficiency; authorizing an employer to present certain documents electronically or physically in order to show proof and certify to the permit issuer that it has secured compensation for its employees; authorizing an agency or local government to require rooftop equipment to be installed in compliance with the Florida Building Code if the equipment is being replaced or removed during reroofing and is not in compliance with the Florida Building Code's roof-mounted mechanical units requirements, etc. Effective Date: Except as otherwise provided in this act, this act shall take effect July 1, 2014

CS/CS/SB 1048 (SO) by the Committees on Community Affairs, Transportation and Senator Latvala—

Department of Transportation; Authorizing the department to seek certain investors for certain leases; limiting the number of referenda that certain authorities may be subject to; specifying that a referendum applies to future bond issuances; amending provisions relating to outdoor advertising signs; providing that an outdoor advertising license is not required solely to erect or construct outdoor signs or structures; exempting from permitting certain signs placed by tourist-oriented businesses, certain farm signs placed during harvest seasons, certain acknowledgment signs on publicly funded school premises, and certain displays on specific sports facilities, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Transportation

CS/CS/CS/SB 1254 (SO) by the Committees on Appropriations, Rules, Health Policy and Senator Grimsley—

Health Care Services; Exempting a home health agency that is not Medicare or Medicaid certified and does not provide skilled nursing care from having to provide documentation of accreditation; revising the report requirements for home health agencies; limiting services at PPEC centers; amending provisions relating to home medical equipment providers; requiring that the emergency management plan include criteria relating to the maintenance of patient equipment and supply lists, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Health Policy; reported favorably as a committee substitute by the Committee on Rules; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1114 (SO) by the Committees on Appropriations, Governmental Oversight and Accountability, and Community Affairs (Simpson)—

Retirement; Revising the definition of "vested" or "vesting" to provide that a member initially enrolled in the Florida Retirement System after a certain date is vested in the pension plan after completing 10 years of creditable service; providing for compulsory membership in the Florida Retirement System Investment Plan for certain members of the Elected Officers' Class initially enrolled after a certain date; authorizing renewed membership in the retirement system for retirees who are reemployed in a position eligible for the Elected Officers' Class under certain circumstances, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/CS/HB 851, 2nd Eng. (SO) by the Committees on Appropriations Committee, Education Appropriations Subcommittee, Higher Education and Workforce Subcommittee, Representative Nunez and others—

Postsecondary Education Tuition and Fees; Amending provisions relating to the determination of resident status for tuition purposes; revising certain residency requirements for a dependent child; prohibiting denial of classification as a resident for tuition purposes based on certain immigration status; classifying persons who receive certain tuition exemptions or waivers as residents for tuition purposes; revising provisions relating to the tuition waiver for a recipient of a Purple Heart or another combat decoration superior in precedence, etc. Effective Date: 07/01/2014

Withdrawn from the Committees on Education; Judiciary; Appropriations Subcommittee on Education; and Appropriations

CS/SB 1148 (SO) by the Committees on Appropriations, and Education (Legg)—

Postsecondary Education; Requiring the State Board of Education to review baccalaureate degree programs currently offered by Florida College System institutions, rather than proposed baccalaureate degree programs; revising the purpose of the Florida College System with regard to baccalaureate degrees; revising a Florida College System institution's primary responsibilities and secondary role as they relate to providing upper-level instruction and awarding baccalaureate degrees; increasing the annual maximum number of scholarships that may be awarded in the Rosewood Family Scholarship Program, etc. Effective Date: Upon becoming a law and shall apply retroactively to March 31, 2014

Recommended favorably as a committee substitute by Appropriations Subcommittee on Education; and reported favorably as a committee substitute by the Committee on Appropriations

SB 1172 (SO) by Senator Sobel—

Conveyance of Property Taken by Eminent Domain; Authorizing a condemning authority to convey, without restriction, lands condemned for specific noise mitigation or noise compatibility programs at certain large hub airports to a person or private entity, etc. Effective Date: 07/01/2014

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

CS/CS/SB 1208 (SO) by the Committees on Health Policy, Criminal Justice and Senator Latvala—

Fraudulent Controlled Substance Prescriptions; Revising provisions prohibiting possession of incomplete prescription forms; providing enhanced criminal penalties for violations involving incomplete prescription forms, etc. Effective Date: 10/01/2014

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Health Policy; and the Committee on Appropriations reports the committee substitute favorably

Similar to CS/HB 517(HC) in the Committees on Criminal Justice; Health Policy; and Appropriations

CS/SB 1292 (SO) by the Committee on Education and Senator Legg—

Postsecondary Education; Establishing the Florida Center for Library Automation; repealing provisions relating to licensing electronic library resources and the Florida Virtual Campus; creating the Complete Florida Plus Program, rather than the Complete Florida Degree Program, within the Innovation Institute of the University of West Florida; establishing the Complete Florida Degree Initiative; providing that the University of West Florida is the successor in interest to the Florida Virtual Campus, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Education; Appropriations Subcommittee on Education recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

CS/CS/SB 1328 (SO) by the Committees on Appropriations, Governmental Oversight and Accountability and Senator Latvala—

Inspectors General; Revising provisions relating to the duties, appointment, and removal of agency inspectors general, etc. Effective Date: 07/01/2014
