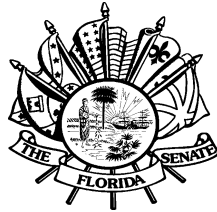

### SB 462 (3R) by Senator Lee—

**Family Law;** Providing that a collaborative law process commences when the parties enter into a collaborative law participation agreement; prohibiting a tribunal from ordering a party to participate in a collaborative law process over the party's objection; providing for confidentiality of communications made during the collaborative law process, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2015
