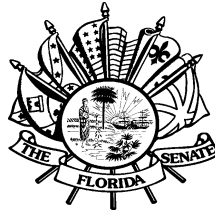

HB 7001, 1st Eng. (3R) by the Committee on Criminal Justice Subcommittee, Representatives Trujillo and Moskowitz—

Intercepting and Recording Oral Communications; Provides that it is lawful to intercept & record certain oral communications. Effective Date: 07/01/2015

*Substituted for **CS/SB 542(SUB)** (Benacquisto), read the second time, and amended on April 14, 2015*

CS/SB 172, 1st Eng. (3R) by the Committee on Governmental Oversight and Accountability, Senators Bradley, Ring and others—

Local Government Pension Reform; Requiring that firefighter and police officer pension plans meet the requirements of ch. 175 and ch. 185, F.S., respectively, in order to receive certain insurance premium tax revenues; revising the method of creating and maintaining firefighters' and police officers' retirement trust funds; providing that the use of premium tax revenues may deviate from the requirements of ch. 175 and ch. 185, F.S., under certain circumstances, etc. Effective Date: 07/01/2015

Read the second time and amended on April 14, 2015

CS/CS/SB 778, 1st Eng. (3R) by the Committees on Governmental Oversight and Accountability, Community Affairs and Senator Hays—

Local Government Construction Preferences; Prohibiting local ordinances and regulations from restricting competition for the award of a contract for construction services based upon certain conditions; requiring a state college, county, municipality, school district, or other political subdivision of the state to make specified disclosures in competitive solicitation documents, etc. Effective Date: 07/01/2015

Read the second time and amended on April 14, 2015

CS/CS/CS/SB 554, 1st Eng. (3R) by the Committees on Rules, Judiciary, Commerce and Tourism and Senator Simmons—

Limited Liability Companies; Specifying that persons who are not members of a limited liability company are not deemed to have notice of a provision of the company's articles of organization which limits a person's authority to transfer real property held in the company's name unless such limitation appears in an affidavit, certificate, or other instrument that is recorded in a specified manner; removing the prohibition that an operating agreement may not vary the power of a person to dissociate, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2015

CS/SB 378, 1st Eng. (3R) by the Committee on Criminal Justice, Senators Garcia, Gibson and others—

Juvenile Justice; Authorizing a law enforcement officer to issue a warning to a juvenile who admits having committed a misdemeanor or to inform the child's parent or guardian of the child's infraction; allowing a law enforcement officer who does not exercise one of these options to issue a civil citation or require participation in a similar diversion program; requiring a law enforcement officer to provide written documentation in certain circumstances, etc. Effective Date: 10/01/2015

Read the second time and amended on April 14, 2015

SB 520 (3R) by Senator Grimsley—

Long-term Care Insurance; Providing additional forms for the mandatory offer of nonforfeiture benefits in long-term care insurance policies, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

CS/CS/SB 1446 (3R) by the Committees on Rules, Governmental Oversight and Accountability and Senator Richter—

Public Records/Department of Agriculture and Consumer Services; Providing an exemption from public records requirements for criminal or civil intelligence or investigative information, or any other information, held by the Department of Agriculture and Consumer Services as part of an investigation with another state or federal regulatory, administrative, or criminal justice agency; providing exceptions to the public records exemption; providing for future legislative review and repeal of the exemption under the Open Government Sunset Review Act; providing a statement of public necessity, etc. Effective Date: Upon becoming a law if SB 1444 or similar legislation is adopted in the same legislative session or an extension thereof and becomes law

Read the second time on April 14, 2015

CS/CS/SB 7040 (3R) by the Committees on Rules, Governmental Oversight and Accountability, and Transportation (Brandes)—

Public Records/E-mail Addresses/Department of Highway Safety and Motor Vehicles; Providing an exemption from public records requirements for e-mail addresses collected by the Department of Highway Safety and Motor Vehicles; providing for future review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

CS/SB 604, 1st Eng. (3R) by the Committee on Commerce and Tourism, Senator Flores and others—

Consumer Protection; Citing this act as the "True Origin of Digital Goods Act"; requiring owners and operators of specified websites and online services to disclose certain information; providing for injunctive relief, etc. Effective Date: 07/01/2015

Read the second time and amended on April 14, 2015

CS/SB 960 (3R) by the Committee on Fiscal Policy, Senator Lee and others—

Florida Bright Futures Scholarship Program; Providing that the initial award period and the renewal period for students who are unable to accept an initial award immediately after completion of high school due to a full-time religious or service obligation begin upon the completion of the religious or service obligation; requiring a student, as a prerequisite for the Florida Academic Scholars award, the Florida Medallion Scholars award, or the Florida Gold Seal Vocational Scholars award, to identify a social or civic issue or a professional area of interest and develop a plan for his or her personal involvement in addressing the issue or learning about the area, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

Similar to CS/CS/HB 747(HC) in the Committees on Higher Education; Appropriations Subcommittee on Education; and Fiscal Policy

CS/CS/CS/SB 248, 1st Eng. (3R) by the Committees on Rules, Governmental Oversight and Accountability, Criminal Justice, Senator Smith and others—

Public Records/Body Camera Recording Made by a Law Enforcement Officer; Providing that a body camera recording is confidential and exempt from public records requirements under certain circumstances; providing exceptions; requiring a law enforcement agency to retain body camera recordings for at least a specified period; providing for retroactive application; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2015

Read the second time and amended on April 14, 2015

CS/SB 1146, 1st Eng. (3R) by the Committee on Health Policy and Senator Simmons—

Agency Relationships with Governmental Health Care Contractors; Extending sovereign immunity to employees or agents of a health care provider that executes a contract with a governmental contractor; clarifying that a receipt of specified notice must be acknowledged by a patient or the patient's representative at the initial visit, etc. Effective Date: 07/01/2015

Read the second time and amended on April 14, 2015

SB 728, 1st Eng. (3R) by Senator Benacquisto—

Health Insurance Coverage for Opioids; Providing that a health insurance policy that covers opioid analgesic drug products may impose a prior authorization requirement for an abuse-deterrent opioid analgesic drug product only if the insurer imposes the same requirement for each opioid analgesic drug product without an abuse-deterrence labeling claim; prohibiting such health insurance policy from requiring use of an opioid analgesic drug product without an abuse-deterrence labeling claim before providing coverage for an abuse-deterrent opioid analgesic drug product, etc. Effective Date: 01/01/2016

CS/CS/SB 606 (3R) by the Committees on Appropriations, Health Policy, Senator Gaetz and others—

Dental Care; Establishing a joint local and state dental care access account initiative, subject to the availability of funding; requiring the Department of Health to implement an electronic benefit transfer system; authorizing the department to transfer state funds remaining in a closed account at a specified time and to return unspent funds from local sources; requiring the Department of Economic Opportunity to rank shortage areas and medically underserved areas, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

CS/CS/SB 760 (3R) by the Committees on Fiscal Policy, Health Policy, Senator Bradley and others—

Child Protection; Providing requirements for the representation of Children's Medical Services on multiagency teams investigating certain child deaths or other critical incidents; requiring the Statewide Medical Director for Child Protection and the medical directors to hold certain qualifications; providing that a physician who holds an expert witness certificate may provide expert testimony in criminal child abuse and neglect cases, etc. Effective Date: 07/01/2015

*Similar to **CS/CS/HB 1055, 1st Eng.(HC)** in the Committees on Children, Families, and Elder Affairs; Health Policy; and Fiscal Policy*

SB 7028 (3R) by the Committee on Military and Veterans Affairs, Space, and Domestic Security (Altman)—

Educational Opportunities for Veterans; Revising criteria for eligibility for out-of-state fee waivers at state universities, Florida College System institutions, and specified career centers; removing a provision regarding the applicability of waivers to required credit hours for a student's degree or certificate program, etc. Effective Date: Upon becoming a law

Read the second time on April 14, 2015

CS/CS/SB 806 (3R) by the Committees on Rules, Banking and Insurance and Senator Richter—

Regulation of Financial Institutions; Requiring that mailed semiannual assessments be received by the Office of Financial Regulation by a specified date; requiring that electronically transmitted semiannual assessments be transmitted to the office by specified dates; revising the individuals for whom certain information must be provided to the office on an application for authority to organize a banking corporation or trust company, etc. Effective Date: 10/01/2015

Read the second time on April 14, 2015

CS/CS/SB 1024 (3R) by the Committees on Fiscal Policy, Transportation and Senator Simmons—

Central Florida Expressway Authority; Requiring the chairs of the boards of specified county commissions each to appoint one member from their respective counties who is a commission member or chair or a county mayor to serve on the governing body of the authority; specifying that the Central Florida Expressway Authority is a party to a certain lease-purchase agreement between the department and the Orlando-Orange County Expressway Authority; removing the requirement that title in fee simple absolute to the former Orlando-Orange County Expressway System be transferred to the state upon the completion of the faithful performance and termination of a specified lease-purchase agreement, etc. Effective Date: 07/01/2015

CS/SB 7018, 1st Eng. (3R) by the Committees on Appropriations, and Children, Families, and Elder Affairs (Sobel)—

State Ombudsman Program; Revising legislative intent with respect to citizen ombudsmen; deleting references to ombudsman councils and transferring their responsibilities to representatives of the State Long-Term Care Ombudsman Program; revising the duties and authority of the state ombudsman; requiring the state ombudsman to designate and direct program districts; providing conditions under which a representative of the program could be found to have a conflict of interest, etc. Effective Date: 07/01/2015

Read the second time and amended on April 14, 2015

CS/CS/SB 998, 1st Eng. (3R) by the Committees on Commerce and Tourism, Regulated Industries and Senator Margolis—

Alcoholic Beverages; Defining the term "powdered alcohol"; prohibiting the sale, offer for sale, purchase, use, offer for use, or possession of powdered alcohol; exempting sparkling wine and champagne from a specified volume restriction; requiring the calculation of a specified excise tax to be based on the advertised volume per drink, etc. Effective Date: 07/01/2015

Read the second time and amended on April 14, 2015

CS/CS/SB 1216, 1st Eng. (3R) by the Committees on Fiscal Policy, Community Affairs and Senator Simpson—

Community Development; Declaring that there is a compelling state interest in enabling property owners to voluntarily finance certain improvements to property damaged by sinkhole activity with local government assistance; subdividing the state into specified geographic regions for the purpose of regional comprehensive planning, etc. Effective Date: Upon becoming a law

Read the second time and amended on April 14, 2015

CS/CS/SB 716 (3R) by the Committees on Governmental Oversight and Accountability, Regulated Industries, Senator Hays and others—

Public Records/Animal Medical Records; Providing an exemption from public records requirements for certain animal medical records held by a state college of veterinary medicine that is accredited by the American Veterinary Medical Association Council on Education; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

CS/SB 534 (3R) by the Committee on Criminal Justice, Senator Latvala and others—

Human Trafficking; Requiring the Department of Transportation and certain employers to display human trafficking public awareness signs at specified locations; providing civil penalties for violations, etc. Effective Date: 01/01/2016

Read the second time on April 14, 2015

*Compare to **CS/CS/HB 369(HC)** in the Committees on Transportation; Criminal Justice; and Appropriations*

CS/CS/SB 656 (3R) by the Committees on Regulated Industries, Judiciary and Senator Latvala—

Unlawful Detention by a Transient Occupant; Defining the term "transient occupant"; providing factors that establish a transient occupancy; providing for removal of a transient occupant by a law enforcement officer; providing a cause of action for wrongful removal; limiting actions for wrongful removal; providing a civil action for removal of a transient occupant, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

*Similar to **CS/CS/HB 305(HC)** in the Committees on Judiciary; Regulated Industries; and Rules*

SB 672 (3R) by Senator Dean—

Service of Process; Authorizing a criminal witness subpoena commanding a witness to appear for a deposition to be posted at the witness's residence by an authorized person if one attempt to serve the subpoena has failed, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

CS/SB 1208 (3R) by the Committee on Health Policy and Senator Bean—

Dietetics and Nutrition; Authorizing certain registered or certified individuals to use specified titles and designations; requiring the Board of Medicine to waive the examination requirement for specified applicants; providing that a licensed dietitian/nutritionist treating a patient who is under the active care of a licensed physician or licensed chiropractor is not precluded from ordering a therapeutic diet if otherwise authorized to order such a diet, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

*Similar to **CS/HB 951(HC)** in the Committees on Health Policy; and Fiscal Policy*

CS/CS/CS/SB 1094, 1st Eng. (3R) by the Committees on Rules, Community Affairs, Banking and Insurance and Senator Brandes—

Peril of Flood; Specifying requirements for the coastal management element required for a local government comprehensive plan; requiring a surveyor and mapper to complete an elevation certificate in accordance with a checklist developed by the Division of Emergency Management and to submit a copy of the elevation certificate to the division within a certain time after its completion; deleting a provision that prohibits supplemental flood insurance from including excess coverage over any other insurance covering the peril of flood, etc. Effective Date: 07/01/2015

Read the second time and amended on April 14, 2015

SB 982 (3R) by Senator Thompson and others—

Florida Civil Rights Act; Prohibiting discrimination on the basis of pregnancy in public lodging and food service establishments and in places of public accommodation; prohibiting employment discrimination on the basis of pregnancy; prohibiting discrimination on the basis of pregnancy by labor organizations, joint labor-management committees, employment agencies, and in occupational licensing, certification, and membership organizations, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

CS/SB 7068, 1st Eng. (3R) by the Committees on Children, Families, and Elder Affairs, and Appropriations (Lee)—

Mental Health and Substance Abuse Services; Revising the definition of "mental illness" to exclude dementia and traumatic brain injuries; requiring the Agency for Health Care Administration and the Department of Children and Families to develop a plan to obtain federal approval for increasing the availability of federal Medicaid funding for behavioral health care; requiring that, by a specified date, the department, in consultation with the Agency for Health Care Administration, modify certain licensure rules and procedures, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2015

CS/CS/SB 608 (3R) by the Committees on Fiscal Policy, Regulated Industries and Senator Stargel—

Real Estate Brokers and Appraisers; Requiring the Florida Real Estate Commission to adopt certain rules pertaining to broker registration on a temporary, emergency basis; revising the supervision requirements for registered trainee appraisers; requiring an appraisal management company to prepare and retain an order file in certain circumstances; providing that duly authorized agents and employees of the department may inspect an appraisal management company at all reasonable hours, etc. Effective Date: 07/01/2015

SB 462 (SO) by Senator Lee—

Family Law; Providing that a collaborative law process commences when the parties enter into a collaborative law participation agreement; prohibiting a tribunal from ordering a party to participate in a collaborative law process over the party's objection; providing for confidentiality of communications made during the collaborative law process, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2015

Read the second time on March 18, 2015

CS/SB 1298 (SO) by the Committee on Appropriations and Senator Simmons—

Insurance for Short-term Rental and Transportation Network Companies; Establishing insurance requirements for short-term rental network companies during certain timeframes; prohibiting the personal insurance policy of a participating lessor of a short-term rental property from providing specified coverage during certain timeframes except under specified circumstances; requiring a transportation network company driver or such company on the driver's behalf, or a combination thereof, to maintain primary automobile liability insurance issued by specified insurers with certain coverages in specified amounts during certain timeframes, etc. Effective Date: 07/01/2015

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 842 (SO) by the Committee on Banking and Insurance and Senator Benacquisto—

Citizens Property Insurance Corporation Eligibility for Coverage; Deleting a provision prohibiting certain improvements to major structures from being eligible for coverage by the Citizens Property Insurance Corporation; prohibiting coverage for major structures rebuilt, repaired, restored, or remodeled to increase the total square footage of finished area by a specified amount, etc. Effective Date: 07/01/2015

Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Community Affairs reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/HB 715(HC) in the Committees on Banking and Insurance; Community Affairs; and Fiscal Policy

CS/CS/SB 596 (SO) by the Committees on Commerce and Tourism, Regulated Industries and Senator Hays—

Craft Distilleries; Defining the term "branded product"; revising the current limitation on the number of containers that may be sold to consumers by craft distilleries; applying such limitation to individual containers for each branded product; prohibiting a craft distillery from shipping or arranging to ship any of its distilled spirits to consumers; requiring the Department of Transportation to install directional signs at specified locations in accordance with Florida's Highway Guide Sign Program upon the request of a craft distillery licensed in this state, etc. Effective Date: 07/01/2015

Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Commerce and Tourism; and the Committee on Fiscal Policy reports the committee substitute favorably

CS/SB 340 (SO) by the Committee on Appropriations, Senator Grimsley and others—

Crisis Stabilization Services; Requiring the Department of Children and Families to develop standards and protocols for the collection, storage, transmittal, and analysis of utilization data from public receiving facilities; requiring a managing entity to require public receiving facilities in its provider network to submit certain data within specified timeframes, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Children, Families, and Elder Affairs; recommended favorably by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations
