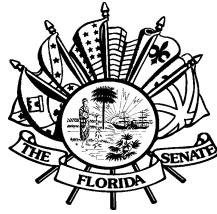

BILLS ON THIRD READING

CS/CS/SB 1446 (3R) by the Committees on Rules, Governmental Oversight and Accountability and Senator Richter—

Public Records/Department of Agriculture and Consumer Services; Providing an exemption from public records requirements for criminal or civil intelligence or investigative information, or any other information, held by the Department of Agriculture and Consumer Services as part of an investigation with another state or federal regulatory, administrative, or criminal justice agency; providing exceptions to the public records exemption; providing for future legislative review and repeal of the exemption under the Open Government Sunset Review Act; providing a statement of public necessity, etc. Effective Date: Upon becoming a law if SB 1444 or similar legislation is adopted in the same legislative session or an extension thereof and becomes law

Read the second time on April 14, 2015

CS/SB 960 (3R) by the Committee on Fiscal Policy, Senator Lee and others—

Florida Bright Futures Scholarship Program; Providing that the initial award period and the renewal period for students who are unable to accept an initial award immediately after completion of high school due to a full-time religious or service obligation begin upon the completion of the religious or service obligation; requiring a student, as a prerequisite for the Florida Academic Scholars award, the Florida Medallion Scholars award, or the Florida Gold Seal Vocational Scholars award, to identify a social or civic issue or a professional area of interest and develop a plan for his or her personal involvement in addressing the issue or learning about the area, etc. Effective Date: 07/01/2015

Read the second time on April 14, 2015

Similar to CS/CS/HB 747(HC) in the Committees on Higher Education; Appropriations Subcommittee on Education; and Fiscal Policy

CS/SB 7068, 1st Eng. (3R) by the Committees on Children, Families, and Elder Affairs, and Appropriations (Lee)—

Mental Health and Substance Abuse Services; Revising the definition of "mental illness" to exclude dementia and traumatic brain injuries; requiring the Agency for Health Care Administration and the Department of Children and Families to develop a plan to obtain federal approval for increasing the availability of federal Medicaid funding for behavioral health care; requiring that, by a specified date, the department, in consultation with the Agency for Health Care Administration, modify certain licensure rules and procedures, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2015

Read the second time and amended on April 14, 2015. Read the third time on April 23, 2015, with pending amendment #1 (902964) by Garcia.

CS/CS/SB 382, 1st Eng. (3R) by the Committees on Appropriations, Health Policy, Senator Sobel and others—

Assisted Living Facilities; Providing that Medicaid managed care plans are responsible for enrolled mental health residents; providing that managing entities under contract with the Department of Children and Families are responsible for mental health residents who are not enrolled with a Medicaid managed care plan; requiring the Agency for Health Care Administration to impose a fine if a facility is not in compliance with certain background screening requirements; directing the agency to create an assisted living facility consumer information website, etc. Effective Date: 07/01/2015

Read the second time and amended on April 22, 2015

Similar to CS/CS/HB 1001(HC) in the Committees on Health Policy; Appropriations Subcommittee on Health and Human Services; and Appropriations

HB 441 (3R) by Representative Rodrigues, R. and others—

Home Health Agencies; Revises information that home health agency is required to submit to AHCA for license renewal; removes requirement that home health agency submit quarterly reports. Effective Date: 07/01/2015

Substituted for CS/SB 816(SUB) (Grimsley), read the second time, and amended on April 23, 2015

CS/CS/CS/HB 87 (3R) by the Committees on Judiciary Committee, Business and Professions Subcommittee, Civil Justice Subcommittee, Representative Passidomo and others—

Construction Defect Claims; Revises definition of term "completion of building or improvement"; provides additional requirements for notice of claim; revises requirements for response; revises provisions relating to production of certain records. Effective Date: 10/01/2015

Substituted for CS/SB 418(SUB) (Richter) and read the second time on April 22, 2015

CS/CS/SB 1296 (3R) by the Committees on Appropriations, Military and Veterans Affairs, Space, and Domestic Security and Senator Bean—

Military and Veterans Affairs; Creating the Military and Overseas Voting Assistance Task Force within the Department of State; providing legislative intent for the State Board of Education and the Board of Governors of the State University System to work collaboratively to align existing degree programs at state universities and Florida College System institutions, train faculty, incorporate outreach services into existing disability services, facilitate statewide meetings for personnel, and provide sufficient courses and priority registration to veterans, etc. Effective Date: 07/01/2015

Read the second time on April 23, 2015

CS/SB 7078, 1st Eng. (3R) by the Committees on Fiscal Policy, and Children, Families, and Elder Affairs (Sobel)—

Child Welfare; Authorizing critical incident rapid response teams to review cases of child deaths occurring during an open investigation; requiring case staffing when medical neglect is substantiated; requiring an epidemiological child abuse death assessment and prevention system; providing intent for the operation of and interaction between the state and local death review committees, etc. Effective Date: 07/01/2015

Read the second time and amended on April 23, 2015

CS/SB 7052 (3R) by the Committees on Finance and Tax, and Military and Veterans Affairs, Space, and Domestic Security (Altman)—

Ad Valorem Tax Exemption for Deployed Servicemembers; Expanding the military operations that qualify a servicemember deployed in support of such an operation in the previous calendar year for an additional ad valorem tax exemption; providing an extended deadline and specifying procedures for filing an application for such tax exemption for a qualifying deployment during the 2014 calendar year, etc. Effective Date: Upon becoming a law, and first applies to ad valorem tax rolls for 2015

Read the second time on April 23, 2015

CS/CS/HB 1069 (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee, Representative Perry and others—

Defendants in Specialized Courts; Requires trial court to transfer certain criminal cases involving participants in specified programs to another jurisdiction having such program under certain conditions. Effective Date: 07/01/2015

Substituted for CS/SB 1170(SUB) (Bradley) and read the second time on April 23, 2015

CS/CS/SB 908 (3R) by the Committees on Criminal Justice, Transportation, Senator Altman and others—

Traffic Safety; Revising provisions relating to the passing of a vehicle; prohibiting passing and turning in front of a vulnerable user in an unsafe manner; providing penalties; providing fines and penalties for specified infractions contributing to bodily injury of a vulnerable user; requiring a hearing for specified offenses, etc. Effective Date: 10/01/2015

Read the second time on April 23, 2015

CS/SB 916 (3R) by the Committee on Banking and Insurance and Senator Montford—

Commercial Insurer Rate Filing Procedures; Restricting to certain property rate filings a requirement that the chief executive officer or chief financial officer and chief actuary of a property insurer certify the information contained in a rate filing; exempting commercial nonresidential multiperil insurance from annual base rate filing, etc. Effective Date: 07/01/2015

Read the second time on April 23, 2015

CS/SB 946 (3R) by the Committee on Environmental Preservation and Conservation, Senator Bullard and others—

Legal Holidays and Special Observances; Designating the second Monday in October of each year as "Sir Lancelot Jones Day" in Miami-Dade and Monroe Counties; encouraging public officials, schools, private organizations, and citizens in Miami-Dade and Monroe Counties to commemorate the occasion, etc. Effective Date: Upon becoming a law

Read the second time on April 23, 2015

CS/SB 574 (3R) by the Committee on Governmental Oversight and Accountability and Senator Montford—

Electronic Auction Services; Revising the powers and duties of the district school board to authorize the adoption of rules regarding procurement practices; authorizing a district school board's use of electronic auction services in conjunction with bid pooling for school buses and related purchases, etc. Effective Date: 07/01/2015

Read the second time on April 23, 2015

HB 633, 1st Eng. (3R) by Representative Sullivan and others—

Informed Patient Consent; Revises conditions for voluntary & informed consent to termination of pregnancy. Effective Date: 07/01/2015

Substituted for CS/SB 724(SUB) (Flores) and read the second time on April 23, 2015

CS/HB 189 (3R) by the Committee on Finance and Tax Committee and Representative Cummings—

Insurance Guaranty Associations; Revises definition of term "asset" to include Florida Insurance Guaranty Association assessments for purposes of determining financial condition of insurer; transfers provision relating to obligation of Florida Life and Health Insurance Guaranty Association to pay valid claims. Effective Date: 07/01/2015

Substituted for CS/CS/SB 600(SUB) (Richter) and read the second time on April 23, 2015

CS/HB 279, 1st Eng. (3R) by the Committee on Health Innovation Subcommittee, Representative Pigman and others—

Pharmacy; Authorizes registered intern under supervision of pharmacist to administer specified vaccines to adult; revises which vaccines may be administered by pharmacist or registered intern under supervision of pharmacist; requires registered intern seeking to administer vaccines to be certified to administer such vaccines & to complete minimum amount of coursework. Effective Date: 07/01/2015

Substituted for CS/SB 792(SUB) (Bean) and read the second time on April 23, 2015

CS/CS/HB 791, 1st Eng. (3R) by the Committees on Finance and Tax Committee, Civil Justice Subcommittee, Representative Moraitis and others—

Residential Properties; Authorizing the use of a copy, facsimile transmission, or other reliable reproduction of an original proxy vote for certain purposes; authorizing condominium associations to conduct votes of the membership by online voting under certain conditions; authorizing the electronic transmission of notices of certain meetings of a cooperative association irrespective of whether authorized by the association's bylaws, etc. Effective Date: 07/01/2015

Substituted for CS/CS/CS/SB 748(SUB) (Ring) and read the second time on April 23, 2015

CS/CS/CS/HB 157 (3R) by the Committees on Judiciary Committee, Justice Appropriations Subcommittee, Criminal Justice Subcommittee, Representative Passidomo and others—

Fraud; Defines "business entity"; provides for restitution for certain out-of-pocket costs of victims; requires business entities to provide copies of business records of fraudulent transactions involving identity theft to victims & law enforcement agencies in certain circumstances; provides exception; includes counties & other political subdivisions in provisions prohibiting false marking of goods or packaging with location of origin; prohibits fraudulent issuance of indicia of membership interest in limited liability company; specifies that electronic statements are included in provisions prohibiting certain false representations; prohibits sale of counterfeit security company signs or decals; increases criminal penalties for fraudulently obtaining goods or services from health care provider; expands specified identity theft offenses to include all persons rather than being limited to natural persons; prohibits knowingly providing false information that becomes part of public record to facilitate or further commission of certain offenses. Effective Date: 10/01/2015

Substituted for CS/CS/CS/SB 390(SUB) (Richter) and read the second time on April 23, 2015

CS/HB 7109 (3R) by the Committees on Regulatory Affairs Committee, Energy and Utilities Subcommittee, Representatives La Rosa, Peters and others—

Florida Public Service Commission; Limits terms of office of PSC commissioners appointed after certain date; requires specified PSC meetings & workshops to be recorded or streamed live; requires specified persons to register as lobbyist if communicating with PSC Nominating Council; revises provisions regarding ex parte communications; requires PSC commissioners to take ethics training; specifies amount of money that may be charged by public utilities for deposits; revises provisions regarding notification of specified customer rates; specifies uses of certain funds received for demand-side renewable energy systems; authorizes the PSC to issue orders to grant issuance of nuclear asset-recovery bonds; creates provisions regarding financing of such bonds. Effective Date: 07/01/2015

Substituted for CS/CS/CS/SB 288(SUB) (Latvala), read the second time, and amended on April 23, 2015

CS/CS/HB 1133, 1st Eng. (3R) by the Committees on Regulatory Affairs Committee, Insurance and Banking Subcommittee and Representative Fant—

Division of Insurance Agent and Agency Services; Revises definition of "general lines" agent; revises & creates licensure & examination requirements for general lines agent, personal lines agent, all-lines adjuster, life agent & health agent; revises prelicensure education requirements for insurance agents; revises qualifications for a customer representative's license; requires agents to maintain certain records for specified periods; defines "surrender"; authorizes certain notices of insolvency to be delivered by e-mail. Effective Date: 07/01/2015

Substituted for CS/CS/SB 1222(SUB) (Richter) and read the second time on April 23, 2015

CS/CS/HB 335, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Health Quality Subcommittee, Representatives Plasencia, Campbell and others—

Psychiatric Nurses; Requires psychiatric nurses to hold national advanced practice certification as psychiatric mental health advanced practice nurse; authorizes such nurses to approve release of individuals from receiving facility after involuntary examination under certain circumstances. Effective Date: 07/01/2015

*Substituted for **CS/SB 476(SUB)** (Grimsley) and read the second time on April 23, 2015*

CS/HB 471 (3R) by the Committee on Highway and Waterway Safety Subcommittee, Representatives DuBose, Moraitis and others—

Disabled Parking; Revises provisions that allow counties & municipalities to charge fees for vehicles displaying disabled parking permit at certain timed parking facilities; excludes vehicles displaying "DV" license plate issued to certain disabled veterans from payment of such fees. Effective Date: 07/01/2015

*Substituted for **SB 788(SUB)** (Sobel) and read the second time on April 23, 2015*

CS/HB 7021, 1st Eng. (3R) by the Committees on State Affairs Committee, Agriculture and Natural Resources Subcommittee, Representatives Sullivan, Trumbull and others—

Fish and Wildlife Conservation Commission; Authorizing citizen support organizations to receive funds from the commission if the organization provides services by contract under certain circumstances; revising the time period for which tarpon tags are valid; removing criteria for issuance of restricted species endorsements on saltwater products licenses; removing provisions authorizing the commission to limit the number of participants engaged in the taking of alligators or their eggs; providing penalties for the feeding of wildlife and freshwater fish, etc. Effective Date: Upon becoming a law

*Substituted for **CS/CS/SB 680(SUB)** (Dean) and read the second time on April 23, 2015*

CS/HB 133 (3R) by the Committee on Civil Justice Subcommittee, Representative Plasencia and others—

Sexual Offenses; Designates act as "43 Days Initiative Act"; revises time limitations for criminal prosecution of specified sexual battery offenses if victim is 16 years of age or older; provides applicability. Effective Date: 07/01/2015

*Substituted for **CS/SB 1270(SUB)** (Soto), read the second time, and amended on April 23, 2015*

CS/CS/CS/HB 889, 1st Eng. (3R) by the Committees on Judiciary Committee, Health Quality Subcommittee, Civil Justice Subcommittee and Representative Wood—

Health Care Representatives; Providing an exception for a patient who has designated a surrogate to make health care decisions and receive health information without a determination of incapacity being required; revising provisions relating to the designation of health care surrogates; providing for the designation of health care surrogates for minors; specifying that a principal's wishes are controlling while he or she has decisionmaking capacity, etc. Effective Date: 10/01/2015

*Substituted for **CS/CS/SB 1224(SUB)** (Joyner) and read the second time on April 23, 2015*

CS/CS/CS/HB 371 (3R) by the Committees on State Affairs Committee, Appropriations Committee, Government Operations Subcommittee, Representative Raulerson and others—

Agency Inspectors General; Provides additional hiring requirements, employment qualifications, & terms of employment for inspectors general & staff; establishes duty of specified persons & entities with respect to inspector general's duties; requires contracts & other specified documents to contain certain statement regarding inspector general's duties; authorizes Chief Inspector General to retain legal counsel & issue & enforce subpoenas. Effective Date: 07/01/2015

*Substituted for **CS/CS/SB 1304(SUB)** (Latvala) and read the second time on April 23, 2015*

CS/CS/HB 1127, 1st Eng. (3R) by the Committees on Appropriations Committee, Insurance and Banking Subcommittee and Representative Sullivan—

Insurance Fraud; Repeals provisions relating to operation or reporting of unlicensed health care clinics; revises provisions related to certain health care clinic charges or reimbursement claims; revises & provides criminal penalties for unlawful charges, operating or failing to report unlicensed clinic, filing false or misleading information related to clinic license application, & other violations; repeals provisions relating to establishment of motor vehicle insurance fraud DSO. Effective Date: 10/01/2015

*Substituted for **CS/CS/SB 1306(SUB)** (Bradley) and read the second time on April 23, 2015*

CS/HB 749 (3R) by the Committee on Insurance and Banking Subcommittee, Representative Van Zant and others—

Continuing Care Communities; Revises requirements for continuing care contracts; revises authority of OIR to waive requirements for accredited facilities; provides that continuing care & continuing care at-home contracts are preferred claims subject to any secured claim in event of liquidation or receivership proceedings against provider; requires agent of provider to provide copy of examination report & corrective action plan under certain conditions; requires residents' council to provide forum for certain purposes; requires residents' council to adopt its own bylaws & governance documents; revises provisions relating to quarterly meetings between residents & governing body of provider; revises powers of residents' council; revises continuing care facility reporting requirements. Effective Date: 10/01/2015

HB 115 (3R) by Representative Gaetz—

Sentencing; Redefines "victim" for purposes of restitution provisions to include governmental entities & political subdivisions; requires sentencing judge to order restitution & specified number of community service work hours for violations of provisions relating to bribery & misuse of public office & offenses by public officers & employees. Effective Date: 10/01/2015

*Substituted for **SB 732(SUB)** (Abruzzo) and read the second time on April 23, 2015*

CS/HB 27 (3R) by the Committee on Highway and Waterway Safety Subcommittee, Representatives Gaetz, Workman and others—

Driver Licenses & Identification Cards; Provides for DHSMV to accept military identification card to meet certain requirements for issuance of driver license or identification card; authorizes word "Veteran" to be exhibited on driver license or identification card of veteran. Effective Date: 07/01/2015

*Substituted for **CS/SB 240(SUB)** (Brandes) and read the second time on April 23, 2015*

CS/CS/HB 21 (3R) by the Committees on Health and Human Services Committee, Children, Families and Seniors Subcommittee, Representatives Hager, Harrell and others—

Substance Abuse Services; Requires DCF to create voluntary certification program for recovery residences; requires DCF to approve credentialing entities to develop & administer certification program; requires background screening of recovery residence employees; provides for denial, suspension, or revocation of certification; directs DCF to approve at least one credentialing entity by specified date to develop & administer certification program; requires DCF to publish list on its website. Effective Date: 07/01/2015

*Substituted for **CS/CS/SB 326(SUB)** (Clemens) and read the second time on April 23, 2015*

HB 553 (3R) by Representative Perry—

Public Libraries; Revises composition & duties of State Library Council; revises powers & duties of DOS' Division of Library & Information Services; requires division to coordinate with DOE's Division of Blind Services to provide certain services; authorizes division to issue electronic information; revises provisions regarding delivery & distribution of publications; requires specified entities in state government to designate state publications liaison; revises duties of division with respect to management of State Publications Program; removes provision requiring division to provide centralized microfilming program for state agencies. Effective Date: 07/01/2015

*Substituted for **SB 434(SUB)** (Detert) and read the second time on April 23, 2015*

CS/CS/HB 779, 1st Eng. (3R) by the Committees on Judiciary Committee, Civil Justice Subcommittee, Representative Jones, M. and others—

Rental Agreements; Provides that purchaser taking title to tenant-occupied residential property following foreclosure sale takes title to property subject to rights of tenant; specifies rights of tenant; authorizes tenant to remain in possession of property for 30-days following receipt of written notice; prescribing form for 30-day notice of termination; establishing requirements for delivery of notice; authorizes purchaser to apply for writ of possession if tenant refuses to vacate property; provides exceptions; provides for construction. Effective Date: Upon becoming a law

*Substituted for **CS/CS/SB 524(SUB)** (Soto) and read the second time on April 23, 2015*

CS/CS/HB 197 (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee, Representative Metz and others—

Tracking Devices or Tracking Applications; Prohibits installation of tracking device or tracking application without person's consent; creates presumption that consent is revoked upon initiation of specified proceedings; provides exceptions; provides that violations of prohibition on installation of tracking devices & tracking applications by private investigative, private security, & repossession services are grounds for disciplinary action, to which penalties apply. Effective Date: 10/01/2015

*Substituted for **CS/CS/SB 282(SUB)** (Hukill) and read the second time on April 23, 2015*

HB 193 (3R) by Representative Broxson and others—

Crime Stoppers Trust Fund; Authorizes county that is awarded grant from trust fund to use such funds for purchase & distribution of promotional items. Effective Date: 07/01/2015

*Substituted for **SB 164(SUB)** (Evers) and read the second time on April 23, 2015*

CS/HB 71 (3R) by the Committee on Judiciary Committee, Representative Smith and others—

Service Animals; Requires public accommodation to permit use of service animal by individual with disability; provides conditions for public accommodation to exclude or remove service animal; revises penalties for certain persons or entities who interfere with use of service animal; provides penalty for knowing & willful misrepresentation with respect to use or training of service animal. Effective Date: 07/01/2015
