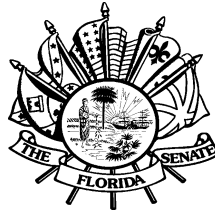

BILLS ON THE CALENDAR

Senate Bills Filed

SB 2-A by Bean

Health Insurance Affordability Exchange; Creating the Florida Health Insurance Affordability Exchange Program or FHIX in the Agency for Health Care Administration; providing patient rights and responsibilities; providing for the development of a long-term reorganization plan and the formation of the FHIX Workgroup; limiting eligible persons in the Medically Needy program to those under the age of 21 and pregnant women, and specifying an effective date; providing an expiration date for the program, etc. Effective Date: Upon becoming a law.

SB 2500-A by Lee

Appropriations; Providing moneys for the annual period beginning July 1, 2015, and ending June 30, 2016, to pay salaries, and other expenses, capital outlay-buildings, and other improvements, and for other specified purposes of the various agencies of state government, etc. Effective Date: Except as otherwise provided herein, this act shall take effect July 1, 2015, or upon becoming law, whichever occurs later; however, if this act becomes law after July 1, 2015, then it shall operate retroactively to July 1, 2015.

SB 2502-A by Lee

Implementing the General Appropriations Act; Incorporating by reference certain calculations of the Florida Education Finance Program; providing that funds for instructional materials must be released and expended as required in specified proviso language, notwithstanding other provisions of law; revising the basis for allocating fixed capital outlay funds for existing satisfactory facilities, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2015; or, if this act fails to become a law until after that date, it shall take effect upon becoming a law and operate retroactively to July 1, 2015.

SB 2504-A by Lee

State Employees; Providing for the resolution of collective bargaining issues at impasse between the state and certified bargaining units of state employees, etc. Effective Date: 07/01/2015.

SB 2506-A by Lee

Florida Business Information Portal; Establishing the Florida Business Information Portal within the Department of Business and Professional Regulation; requiring the department, in collaboration with specified state agencies, to implement the portal by a specified date; requiring designated state agencies to cooperate with the department in the development, implementation, and updates of the portal; authorizing the Department of Business and Professional Regulation to contract for services to develop the portal, etc. Effective Date: 07/01/2015.

Medicaid; Deleting provisions that authorized the agency to receive funds from certain state entities, local governments, and other political subdivisions for a specific purpose; providing that the Agency for Health Care Administration is authorized to receive intergovernmental transfers of funds from governmental entities for specified purposes; creating the Florida Health Insurance Affordability Exchange Program or FHIX in the Agency for Health Care Administration; providing for the development of a long-term reorganization plan and the formation of the FHIX Workgroup, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2015.

Allocation of Funds for Community-based Care Lead Agencies; Revising the equity allocation model for funding community-based care lead agencies, etc. Effective Date: 07/01/2015.

Employer Contributions to Fund Retiree Benefits; Revising the employer contribution rates for the retiree health insurance subsidy; revising the required employer retirement contribution rates for members of each membership class and subclass of the Florida Retirement System; providing findings of an important state interest, etc. Effective Date: 07/01/2015.

SB 2514-A by Lee

Department of Transportation; Revising the distribution of revenues from additional fees imposed on certain motor vehicle registration transactions; providing for the use of moneys from such distribution by the department; creating the Florida Shared-Use Nonmotorized Trail Network; requiring funding to be allocated to the Florida Shared-Use Nonmotorized Trail Network in the program and resource plan of the department; authorizing memoranda of agreement and contracts for maintaining the network; authorizing the department to adopt rules, etc. Effective Date: 07/01/2015.

Implementation of the Water and Land Conservation Constitutional Amendment; Terminating certain trust funds within the Department of Environmental Protection, the Department of Agriculture and Consumer Services, and the Fish and Wildlife Conservation Commission; providing for the disposition of balances in the trust funds; requiring the Department of Environmental Protection to pay all outstanding debts or obligations of the terminated trust funds; requiring the Chief Financial Officer to close out and remove the terminated trust funds from the various state accounting systems, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming law, this act shall take effect July 1, 2015.

Land Acquisition Trust Fund/Agency for Persons with Disabilities; Creating the Land Acquisition Trust Fund within the Agency for Persons with Disabilities; providing for the purpose of the trust fund and sources of funds; requiring that title to lands or related property interests acquired be vested in the Board of Trustees of the Internal Improvement Trust Fund; requiring the agency or its designee to manage the lands or property interests acquired in accordance with the purposes set forth in s. 28, Art. X of the State Constitution; providing for future review and termination or re-creation of the trust fund, etc. Effective Date: 07/01/2015.
