SB 1098 (SO) by Senator Lee-

Sales Tax Refund for Eligible Job Training Organizations;

Providing that eligible job training organizations are entitled to receive a refund of a specified percentage of certain sales taxes remitted to the Department of Revenue; requiring such organizations to use the refund only for specified purposes; requiring that refunds be granted on a first-come, first-served basis, etc. Effective Date: 07/01/2019

Prescription Drug Formulary Consumer Protection; Requiring insurers issuing individual or group health insurance policies to provide certain notices to current and prospective insureds within a certain timeframe before the effective date of any change to a prescription drug formulary during a policy year; specifying requirements for a notice of medical necessity that an insured's treating physician may submit to the insurer within a certain timeframe; requiring small employer carriers to comply with certain requirements for any change to a prescription drug formulary under the health benefit plan, etc. Effective Date: 01/01/2020

CS/SB 1306 (SO) by the Committee on Appropriations, Senator Book and others—

Women's Suffrage Centennial Commission; Creating the commission adjunct to the Department of State; prescribing duties of the commission in order to ensure a suitable statewide observance of the centennial of women's suffrage; requiring the Division of Historical Resources of the department to provide administrative and staff support, etc. Effective Date: 07/01/2019

SB 1338 (SO) by Senator Rodriguez—

Guardianship; Applying provisions relating to the determination of venue in proceedings for the appointment of a guardian to minors; requiring that a court dismiss a petition for determination of incapacity if all members of the examining committee conclude that the person is not incapacitated, unless a certain motion is filed within a specified period, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Judiciary; reported favorably by the Committee on Children, Families, and Elder Affairs; and reported favorably by the Committee on Rules

CS/CS/SB 1400 (SO) by the Committees on Judiciary, Community Affairs and Senator Albritton—

Private Property Rights; Deleting a provision that authorizes electric utilities to perform certain right-of-way tree maintenance only if a property owner has received local government approval; prohibiting certain local government ordinances or regulations from requiring a permit, application, notice, fee, or fine for certain activities regarding trees on residential property; establishing a property owner bill of rights; requiring each county property appraiser office to provide information regarding the property owner bill of rights on the appraiser's website, etc. Effective Date: 07/01/2019

Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably

SB 1422 (SO) by Senator Gruters—

Health Plans; Revising eligibility requirements for multiple-employer welfare arrangements; revising applicability of requirements relating to preexisting conditions; providing disclosure requirements for short-term individual, group, blanket, and franchise health insurance policies; revising requirements for, and applicability relating to, association and small employer policies, etc. Effective Date: 07/01/2019

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Commerce and Tourism; and reported favorably by the Committee on Rules

CS/CS/SB 1460 (SO) by the Committees on Appropriations, Health Policy, Senator Book and others—

Stroke Centers; Revising the criteria for hospitals to be included on the state list of stroke centers by the Agency for Health Care Administration; revising provisions relating to the statewide stroke registry to conform to changes made by the act; revising provisions prohibiting the advertisement of a hospital as a state-listed stroke center, unless certain conditions are met, to conform to changes made by the act, etc. Effective Date: 07/01/2019

Reported favorably as a committee substitute by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 1476 (SO) by the Committee on Banking and Insurance and Senator Flores—
