**Motor Vehicle Racing;** Authorizes law enforcement officer to arrest person without warrant upon probable cause that person committed criminal racing violation. Effective Date: 07/01/2019

**Early Childhood Music Education Incentive Pilot Program;** Extending the scheduled expiration of the pilot program, etc. Effective Date: 07/01/2019

#### **CS/SB 236 (3R) by the Committee on Criminal Justice and Senator Book—**

**Public Records and Public Meetings;** Providing an exception to the expiration of certain public records and public meetings exemptions under specified circumstances; prohibiting the disclosure of the personal identifying information of an alleged victim of sexual harassment or sexual misconduct, or information that could assist an individual in determining the identity of such alleged victim, in any portion of a proceeding conducted by the Commission on Ethics, a commission on ethics and public trust, or a county or a municipality that has established a local investigatory process which is open to the public; providing for future legislative review and repeal; providing statements of public necessity, etc. Effective Date: Upon becoming a law

#### **CS/SB 262, 1st Eng. (3R) by the Committee on Judiciary, Senator Albritton and others—**

**Child Welfare;** Providing for the name of a child's guardian ad litem or attorney ad litem to be entered on court orders in dependency proceedings; requiring cooperation between certain parties and the court to achieve permanency for a child as soon as possible; requiring the court during an adjudicatory hearing to advise parents in plain language of certain requirements to achieve permanency with their child, etc. Effective Date: 10/01/2019

#### **SJR 362 (3R) by Senator Brandes—**

**Abolishing the Constitution Revision Commission;** Proposing amendments to the State Constitution to abolish the Constitution Revision Commission, etc.

#### **CS/SB 442 (3R) by the Committee on Military and Veterans Affairs and Space, Senator Lee and others—**

**Postsecondary Education for Certain Military Personnel;** Requiring the Board of Governors and State Board of Education, in consultation with the Department of Veterans' Affairs, to create a uniform system for the award of postsecondary credit to certain servicemembers and veterans of the United States Armed Forces; requiring specified postsecondary institutions to waive the transcript fee for active duty members of the Armed Forces of the United States, certain veterans, and their spouses and dependents, etc. Effective Date: 07/01/2019

*Read the second time on April 25, 2019*

**SB 742 (3R) by Senator Braynon—**

**Designation of Eligible Telecommunications Carriers;** Including certain commercial mobile radio service providers within the definition of the term "eligible telecommunications carrier"; authorizing the Public Service Commission to designate any commercial mobile radio service provider as an eligible telecommunications carrier for the limited purpose of providing Lifeline service; deleting a provision requiring carriers to allow subscribers to demonstrate continued eligibility for Lifeline service under certain conditions, etc. Effective Date: Upon becoming a law

**CS/SB 828 (3R) by the Committee on Criminal Justice, Senator Rader and others—**

**Lewd or Lascivious Exhibition;** Prohibiting certain lewd or lascivious acts in the presence of county correctional personnel; providing criminal penalties, etc. Effective Date: 07/01/2019

*Read the second time on April 25, 2019*

---

**CS/CS/CS/SB 168, 1st Eng. (3R) by the Committees on Rules, Infrastructure and Security, Judiciary, Senator Gruters and others—**

**Federal Immigration Enforcement;** Prohibiting sanctuary policies; requiring state entities, local governmental entities, and law enforcement agencies to use best efforts to support the enforcement of federal immigration law; authorizing a law enforcement agency to transport an alien unlawfully present in the United States under certain circumstances; prohibiting discrimination on specified grounds, etc. Effective Date: Section 908.107, Florida Statutes, as created by this act, shall take effect October 1, 2019, and, except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

**SB 1098, 1st Eng. (3R) by Senator Lee—**

**Sales Tax Refund for Eligible Job Training Organizations;** Providing that eligible job training organizations are entitled to receive a refund of a specified percentage of certain sales taxes remitted to the Department of Revenue; requiring such organizations to use the refund only for specified purposes; requiring that refunds be granted on a first-come, first-served basis, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect upon becoming a law

**CS/CS/CS/SB 1180, 1st Eng. (3R) by the Committees on Rules, Health Policy, Banking and Insurance, Senator Mayfield and others—**

**Prescription Drug Formulary Consumer Protection;** Requiring insurers issuing individual or group health insurance policies to provide certain notices to current and prospective insureds, and the insureds' treating physicians, within a certain timeframe before the effective date of any change to a prescription drug formulary during a policy year; requiring small employer carriers to comply with certain requirements for any change to a prescription drug formulary under the health benefit plan; requiring health maintenance organizations to provide certain notices to current and prospective subscribers, and the subscribers' treating physicians, within a certain timeframe before the effective date of any change to a prescription drug formulary during a contract year, etc. Effective Date: 01/01/2020

**CS/CS/SB 1278 (3R) by the Committees on Appropriations, Environment and Natural Resources and Senator Mayfield—**

**Biosolids Management;** Requiring the Department of Environmental Protection, subject to appropriation, to establish a real-time water quality monitoring program; defining the term "biosolids"; prohibiting the land application of biosolids on certain sites, etc. Effective Date: 07/01/2019

---

**CS/SB 1306 (3R) by the Committee on Appropriations, Senator Book and others—**

**Women's Suffrage Centennial Commission;** Creating the commission adjunct to the Department of State; prescribing duties of the commission in order to ensure a suitable statewide observance of the centennial of women's suffrage; requiring the Division of Historical Resources of the department to provide administrative and staff support, etc. Effective Date: 07/01/2019

---

**SB 1338 (3R) by Senator Rodriguez—**

**Guardianship;** Applying provisions relating to the determination of venue in proceedings for the appointment of a guardian to minors; requiring that a court dismiss a petition for determination of incapacity if all members of the examining committee conclude that the person is not incapacitated, unless a certain motion is filed within a specified period, etc. Effective Date: Upon becoming a law

**CS/SB 1476 (3R) by the Committee on Banking and Insurance and Senator Flores—**

**Citizens Property Insurance Corporation;** Specifying a limit on annual rate increases, except for certain coverage, in policies issued by the corporation to insureds located in certain counties, etc. Effective Date: 07/01/2019

**CS/SB 1656, 1st Eng. (3R) by the Committee on Criminal Justice, Senator Lee and others—**

**Criminal Statutes;** Specifying that the reenactment or amendment of a criminal statute operates prospectively and does not affect or abate specified circumstances; providing that a reference to any other chapter, part, section, or subdivision of the Florida Statutes in a criminal statute or a reference within a criminal statute constitutes a general reference under the doctrine of incorporation by reference, etc. Effective Date: Upon becoming a law

**CS/SB 332 (SO) by the Committee on Criminal Justice, Senator Pizzo and others—**

**Incarcerated Women;** Citing this act as the "Dignity for Incarcerated Women Act"; requiring correctional facilities to provide incarcerated women with certain health care products, subject to certain requirements; providing requirements for male correctional facility employees in certain circumstances; requiring documentation of certain incidents involving male correctional facility employees, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably*

*Similar to **CS/HB 49(HC)** in the Committees on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice; and Appropriations*

**CS/SB 532 (SO) by the Committee on Community Affairs, Senator Lee and others—**

**Wetland Mitigation;** Authorizing a local government to allow permittee-responsible mitigation on lands purchased and owned by a local government for conservation purposes under certain circumstances; requiring such mitigation to meet specified requirements, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Community Affairs; Appropriations Subcommittee on Agriculture, Environment, and General Government recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably*

*Similar to **CS/HB 521(HC)** in the Committees on Community Affairs; Appropriations Subcommittee on Agriculture, Environment, and General Government; and Appropriations*

**CS/CS/SB 620 (SO) by the Committees on Rules, Military and Veterans Affairs and Space and Senator Broxson—**

**Military Affairs;** Prohibiting a landlord from requiring a prospective tenant who is a servicemember to deposit or advance more than a certain amount of funds; providing an additional circumstance under which a servicemember may terminate a rental agreement; directing the Department of Highway Safety and Motor Vehicles to develop a Blue Angels license plate; prohibiting certain construction or activities that are incompatible with the mission of a military installation on certain land under a rural-lands-protection easement, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Military and Veterans Affairs and Space; the Committee on Innovation, Industry, and Technology reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules*

**CS/SB 7066 (SO) by the Committees on Rules, and Ethics and Elections (Baxley)—**

**Election Administration;** Requiring the Secretary of State to provide signature matching training to certain persons; revising the voter threshold necessary to require the reporting of certain precinct-level results by ballot; authorizing certain individuals to serve as witnesses during the ballot duplication process; revising requirements for vote-by-mail ballot instructions; providing a penalty for certain supervisors who willfully violate the Florida Election Code, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

*Reported favorably as a committee substitute by the Committee on Rules*

**SB 342 (SO) by Senator Lee—**

**Public Records/Voters and Voter Registration;** Providing an exemption from public records requirements for information concerning preregistered voter registration applicants who are minors; providing for future legislative review and repeal; providing for retroactive application; providing a statement of public necessity, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Ethics and Elections; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules*

*Similar to **CS/HB 281, 1st Eng.(HC)** in the Committees on Ethics and Elections; Governmental Oversight and Accountability; and Rules*

**SJR 690 (SO) by Senator Rodriguez—**

**Single Subject Limitation for Taxation and Budget Reform Commission;** Proposing an amendment to the State Constitution to require that any proposals to revise the State Constitution, or any part thereof, filed by the Taxation and Budget Reform Commission be limited to a single subject, etc.

*Reported favorably by the Committee on Judiciary; reported favorably by the Committee on Ethics and Elections; and reported favorably by the Committee on Rules*

## **SB 702 (SO) by Senator Lee and others—**

**Qualified Blind Trusts;** Repealing provisions relating to qualified blind trusts, etc. Effective Date: 01/01/2020

*Reported favorably by the Committee on Ethics and Elections; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules*

---

## **SB 746 (SO) by Senator Wright—**

**Public Records/Judicial Assistants;** Providing an exemption from public records requirements for certain identifying and location information of current and former judicial assistants and their spouses and children; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Judiciary; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules*

---

## **CS/SB 1526 (SO) by the Committee on Appropriations and Senator Harrell—**

**Telehealth;** Establishing standards of practice for telehealth providers; providing that a nonphysician telehealth provider using telehealth and acting within his or her relevant scope of practice is not deemed to be practicing medicine without a license; prohibiting a contract between a certain health insurer and a telehealth provider from requiring the telehealth provider to be reimbursed at lesser amount than if the service were provided in person; prohibiting a contract between a certain health maintenance organization and a telehealth provider from requiring the telehealth provider to be reimbursed at lesser amount than if the service were provided in-person, etc. Effective Date: Except as otherwise provided, this act shall take effect July 1, 2019

*Reported favorably by the Committee on Health Policy; recommended favorably, with one amendment, by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations*

*Compare to **CS/CS/HB 23(HC)** in the Committees on Health Policy; and Rules*

## **CS/CS/CS/SB 796 (SO) by the Committees on Appropriations, Infrastructure and Security, Innovation, Industry, and Technology, Senator Gruters and others—**

**Public Utility Storm Protection Plans;** Requiring public utilities to individually submit to the Public Service Commission, for review and approval, a transmission and distribution storm protection plan; requiring the commission to conduct an annual proceeding to allow utilities to justify and recover certain costs through a storm protection cost recovery clause; authorizing utilities to recover depreciation on certain capital costs through the recovery clause, etc. Effective Date: Upon becoming a law

*Reported favorably as a committee substitute by the Committee on Innovation, Industry, and Technology; reported favorably as a committee substitute by the Committee on Infrastructure and Security; and reported favorably as a committee substitute by the Committee on Appropriations*

---

## **CS/SM 804 (SO) by the Committee on Judiciary, Senator Torres and others—**

**Humanitarian Assistance/Government of Venezuela;** Requesting Congress to take appropriate actions to assist in the delivery of humanitarian assistance, to continue and intensify financial sanctions against the regime of Nicolás Maduro and the Government of Venezuela, and to instruct appropriate federal agencies to hold Nicolás Maduro and officials of the Government of Venezuela accountable for violations of law and abuses of internationally recognized human rights, etc.

*Reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably*

*Similar to **CS/CS/HM 205(HC)** in the Committees on Judiciary; and Rules*

## **CS/CS/SB 838 (SO) by the Committees on Rules, Children, Families, and Elder Affairs and Senator Powell—**

**Public Records/Mental Health Treatment and Services;** Providing an exemption from public records requirements for petitions for voluntary and involuntary admission for mental health treatment, court orders, related records, and personal identifying information regarding persons seeking mental health treatment and services; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules*

---

## **CS/SB 860 (SO) by the Committee on Appropriations, Senator Stargel and others—**

**Alzheimer's Disease;** Increasing membership of the Alzheimer's Disease Advisory Committee; revising representation requirements of the committee; requiring the Department of Elderly Affairs to review and update the Alzheimer's disease state plan every 3 years in collaboration with certain parties; providing that certain clinics shall not receive decreased funding for a specified reason, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Children, Families, and Elder Affairs; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations*

*Similar to **CS/CS/HB 449(HC)** in the Committees on Children, Families, and Elder Affairs; Appropriations Subcommittee on Health and Human Services; and Appropriations*

---

**CS/CS/SB 1528 (SO) by the Committees on Appropriations, Health Policy, Senator Bean and others—**

**Prescription Drug Importation Programs;** Requiring the Agency for Health Care Administration to establish the Canadian Prescription Drug Importation Program; requiring the agency to contract with a vendor to facilitate wholesale prescription drug importation under the program; providing eligibility criteria for prescription drugs, Canadian suppliers, and importers under the program; authorizing a Canadian supplier to export drugs into this state under the program under certain circumstances, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations*

*Similar to **CS/HB 19(HC)** in the Committees on Health Policy; Appropriations Subcommittee on Health and Human Services; and Appropriations*

---

**CS/CS/SB 874 (SO) by the Committees on Appropriations, Banking and Insurance and Senator Rouson—**

**Consumer Finance Loans;** Creating the Access to Responsible Credit Pilot Program within the Office of Financial Regulation; providing requirements for program licensees, program loans, interest rates, program loan refinancing, receipts, disclosures and statements provided by program licensees to borrowers, origination fees, insufficient funds fees, and delinquency charges; authorizing the office to examine each program licensee, branch office, and access partner, etc. Effective Date: 01/01/2020

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Appropriations; and the Committee on Rules reports the committee substitute favorably*

---

**CS/CS/SB 974 (SO) by the Committees on Appropriations, Infrastructure and Security and Senator Perry—**

**Motor Vehicles;** Authorizing any motor vehicle to be equipped with certain lamps or devices under certain circumstances; authorizing certain vehicles to display red and white warning signals under certain circumstances; authorizing an insurance company to provide an independent entity with a certain release statement authorizing it to release a vehicle to the lienholder, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

*Reported favorably as a committee substitute by the Committee on Infrastructure and Security; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations*

*Similar to **CS/HB 1057, 1st Eng.(HC)** in the Committees on Infrastructure and Security; Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and Appropriations*

---

**CS/CS/CS/SB 1000 (SO) by the Committees on Appropriations, Community Affairs, Innovation, Industry, and Technology and Senator Hutson—**

**Communications Services;** Specifying limitations and prohibitions on municipalities and counties relating to registrations and renewals of communications service providers; prohibiting certain municipalities and counties from electing to impose permit fees; revising items over which municipalities and counties may not exercise regulatory control, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Innovation, Industry, and Technology; reported favorably as a committee substitute by the Committee on Community Affairs; the Committee on Finance and Tax reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations*

---
