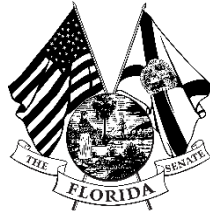

FIRST PUBLICATION ON SECOND READING

SB 172 (2R1) by Senator Bradley—

Florida Drug and Cosmetic Act; Preempting the regulation of over-the-counter proprietary drugs or cosmetics to the state, etc. Effective Date: 07/01/2020

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Innovation, Industry, and Technology; and reported favorably by the Committee on Rules

CS/SB 356 (2R1) by the Committee on Innovation, Industry, and Technology, Senator Hutson and others—

Keep Our Graduates Working Act; Creating the "Keep Our Graduates Working Act of 2020"; prohibiting a state authority from suspending or revoking a person's professional license, certificate, registration, or permit solely on the basis of a delinquency or default in the payment of his or her student loan, etc. Effective Date: 07/01/2020

Reported favorably by the Committee on Education; reported favorably as a committee substitute by the Committee on Innovation, Industry, and Technology; and the Committee on Rules reports the committee substitute favorably

SM 420 (2R1) by Senator Diaz and others—

VA MISSION Act of 2018; Urging Congress and the department to ensure that the VA MISSION Act of 2018 is implemented in a manner consistent with the legislative intent and purpose of the act, etc.

Reported favorably by the Committee on Military and Veterans Affairs and Space; and reported favorably by the Committee on Rules

SR 546 (2R1) by Senator Rodriguez—

Oppression of the Nicaraguan People/President Daniel Ortega; Condemning the oppression of the Nicaraguan people under President Daniel Ortega, etc.

Reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

SB 594 (2R1) by Senator Benacquisto—

Florida Statutes; Adopting the Florida Statutes 2020 and designating the portions thereof that are to constitute the official law of the state, etc. Effective Date: On the 60th day after adjournment sine die of the session of the Legislature in which enacted

Reported favorably by the Committee on Rules

SB 596 (2R1) by Senator Benacquisto—

Florida Statutes; Deleting provisions that have expired, have become obsolete, have had their effect, have served their purpose, or have been impliedly repealed or superseded; replacing incorrect cross-references and citations; correcting grammatical, typographical, and like errors; removing inconsistencies, redundancies, and unnecessary repetition in the statutes, etc. Effective Date: On the 60th day after adjournment sine die of the session of the Legislature in which enacted

Reported favorably by the Committee on Rules

SB 598 (2R1) by Senator Benacquisto—

Florida Statutes; Deleting provisions which have become inoperative by nonconcurrent repeal or expiration and, pursuant to s. 11.242(5)(b) and (i), F.S., may be omitted from the 2020 Florida Statutes only through a reviser's bill duly enacted by the Legislature, etc. Effective Date: On the 60th day after adjournment sine die of the session of the Legislature in which enacted

Reported favorably by the Committee on Rules

SB 600 (2R1) by Senator Benacquisto—

Florida Statutes; Amending and repealing provisions to conform to the directive of the Legislature in section 9 of chapter 2012-116, Laws of Florida, codified as section 11.242(5)(j), Florida Statutes, to prepare a reviser's bill to omit all statutes and laws, or parts thereof, which grant duplicative, redundant, or unused rulemaking authority, etc. Effective Date: On the 60th day after adjournment sine die of the session of the Legislature in which enacted
