**Florida Drug and Cosmetic Act;** Preempting the regulation of over-the-counter proprietary drugs or cosmetics to the state, etc. Effective Date: 07/01/2020

#### **CS/SB 356 (SO) by the Committee on Innovation, Industry, and Technology, Senator Hutson and others—**

**Keep Our Graduates Working Act;** Creating the "Keep Our Graduates Working Act of 2020"; prohibiting a state authority from suspending or revoking a person's professional license, certificate, registration, or permit solely on the basis of a delinquency or default in the payment of his or her student loan, etc. Effective Date: 07/01/2020

*Reported favorably by the Committee on Education; reported favorably as a committee substitute by the Committee on Innovation, Industry, and Technology; and the Committee on Rules reports the committee substitute favorably*

#### **SB 400 (SO) by Senator Gibson—**

**Elder Abuse Fatality Review Teams;** Authorizing the establishment of elder abuse fatality review teams in each judicial circuit, to be housed, for administrative purposes only, in the Department of Elderly Affairs; authorizing elder abuse fatality review teams in existence on a certain date to continue to exist; requiring each review team to annually submit to the department by a certain date a summary report containing specified information; providing immunity from monetary liability for review team members under certain conditions, etc. Effective Date: 07/01/2020

*Reported favorably by the Committee on Children, Families, and Elder Affairs; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Appropriations*

#### **CS/CS/SB 404 (SO) by the Committees on Rules, Health Policy, Senator Stargel and others—**

**Abortion;** Reclassifying the criminal offense for a specified violation; prohibiting physicians from performing or inducing the termination of the pregnancy of a minor unless specified requirements are satisfied; requiring a physician to obtain written consent from a minor's parent or legal guardian before performing or inducing a termination of the pregnancy of a minor; providing exceptions to such consent requirement; providing criminal penalties for physicians, etc. Effective Date: 07/01/2020

*Reported favorably as a committee substitute by the Committee on Health Policy; the Committee on Judiciary reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules*

#### **CS/CS/SB 406 (SO) by the Committees on Rules, Health Policy and Senator Stargel—**

**Public Records/Minor's Petition to Waive Consent/Abortion;** Providing a public records exemption for information that could identify a minor which is contained in a record held by the court relating to the minor's petition to waive consent requirements to obtain an abortion; providing for future legislative review and repeal under the Open Government Sunset Review Act; providing a statement of public necessity, etc. Effective Date: On the same date that SB 404 or similar legislation takes effect if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

## SENATE BILLS ON SECOND READING

### **CS/CS/CS/SB 140 (2R) by the Committees on Rules, Banking and Insurance, Community Affairs, Senator Hutson and others—**

**Fireworks;** Defining the term “designated holiday”; providing an exemption for the use of fireworks solely and exclusively during a designated holiday, etc. Effective Date: Upon becoming a law

*Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Banking and Insurance; and reported favorably as a committee substitute by the Committee on Rules*

### **CS/CS/SB 346 (2R) by the Committees on Appropriations, Criminal Justice, Senator Bradley and others—**

**Criminal Justice;** Prohibiting the imprisonment for longer than a certain time for persons who possess, purchase, or possess with the intent to purchase less than a specified amount of a controlled substance; authorizing a court to impose a sentence other than the mandatory minimum term of imprisonment and mandatory fine for a person convicted of trafficking if the court makes certain findings on the record; requiring that a custodial interrogation conducted at a place of detention in connection with certain offenses be electronically recorded in its entirety; revising the circumstances under which a wrongfully incarcerated person is eligible for compensation, etc. Effective Date: 07/01/2020

*Reported favorably as a committee substitute by the Committee on Criminal Justice; recommended favorably as a committee substitute by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Appropriations*

### **CS/SB 372 (2R) by the Committee on Education, Senator Lee and others—**

**Postsecondary Education for Certain Military Personnel;** Requiring the Board of Governors and the State Board of Education, in consultation with the Department of Veterans' Affairs, to create a process for the uniform award of postsecondary credit or career education clock hours to certain servicemembers and veterans of the United States Armed Forces; requiring certain postsecondary institutions to award uniform postsecondary credit or career education clock hours for specified courses taken and occupations held by individuals during their service in the military, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Military and Veterans Affairs and Space; reported favorably as a committee substitute by the Committee on Education; and the Committee on Appropriations reports the committee substitute favorably*

### **CS/SB 426 (2R) by the Committee on Appropriations, Senator Montford and others—**
