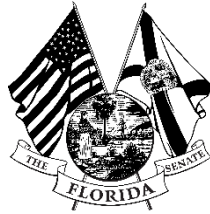

CS/CS/SB 220 (3R) by the Committees on Appropriations, Governmental Oversight and Accountability, Senator Cruz and others—

Abandoned Cemeteries; Creating the Task Force on Abandoned African-American Cemeteries; requiring the Department of State to partner with specified entities to undertake an investigation of the former Zion Cemetery site; requiring the department to contract with the University of South Florida and the Florida Agricultural and Mechanical University for the identification and location of eligible next of kin; requiring the department to create, place, and maintain memorials at certain sites, subject to legislative appropriation, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

CS/CS/SB 156, 1st Eng. (3R) by the Committees on Appropriations, Education, Senator Perry and others—

Early Childhood Music Education Incentive Pilot Program; Extending the scheduled expiration of the pilot program; requiring the University of Florida's College of Education to collaborate with Florida International University's school of music for evaluation of the pilot program; requiring that the evaluation be shared with the Florida Center for Partnerships in Arts-Integrated Teaching, etc. Effective Date: 07/01/2020

Read the second time and amended on March 6, 2020

SB 1092, 1st Eng. (3R) by Senator Bean and others—

Fire Prevention and Control; Creating the Firefighter Cancer Decontamination Equipment Grant Program within the Division of State Fire Marshal of the Department of Financial Services for certain purposes; requiring the division to administer the program and annually award grants, and distribute equipment and training, to qualifying fire departments in a certain manner; requiring the State Fire Marshal to adopt rules and procedures, etc. Effective Date: 07/01/2020

Read the second time and amended on March 6, 2020

CS/SB 1276 (3R) by the Committee on Appropriations and Senator Albritton—

Department of Citrus; Establishing the Friends of Florida Citrus Program within the Department of Citrus; creating the Friends of Florida Citrus Advisory Council adjunct to the department; authorizing the Department of Citrus to loan department employees to or share department employees with specified state and federal entities, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

CS/CS/SB 1392 (3R) by the Committees on Appropriations, Judiciary and Senator Simmons—

Courts; Revising provisions governing the payment of subsistence and travel reimbursement for Supreme Court justices who designate an official headquarters other than the headquarters of the Supreme Court; authorizing district court of appeal judges who meet certain criteria to have an appropriate facility in their county of residence designated as their official headquarters; specifying eligibility for subsistence and travel reimbursement, subject to the availability of funds; providing that a county is not required to provide space for a judge in a county courthouse, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2020

CS/CS/CS/SB 140, 1st Eng. (3R) by the Committees on Rules, Banking and Insurance, Community Affairs, Senator Hutson and others—

Fireworks; Defining the term "designated holiday"; providing an exemption for the use of fireworks solely and exclusively during a designated holiday; prohibiting homeowners' associations from promulgating certain rules or regulations, etc. Effective Date: Upon becoming a law

Read the second time and amended on March 6, 2020

CS/CS/SB 646 (3R) by the Committees on Innovation, Industry, and Technology, Education and Senator Mayfield—

Intercollegiate Athlete Compensation and Rights; Authorizing certain intercollegiate athletes to earn compensation for the use of their names, images, or likenesses; prohibiting a postsecondary educational institution and other entities, institutions, and their employees from compensating intercollegiate athletes or prospective intercollegiate athletes for the use of their names, images, or likenesses; prohibiting the revocation or reduction of certain aid as a result of intercollegiate athletes earning certain compensation or obtaining specified representation; providing requirements for certain athlete agents, etc. Effective Date: 07/01/2021

Read the second time on March 6, 2020

CS/CS/SB 826 (3R) by the Committees on Infrastructure and Security, Environment and Natural Resources and Senator Mayfield—

Marina Evacuations; Prohibiting vessels under a specified weight from remaining in certain marinas that have been deemed unsuitable for refuge during a hurricane after the issuance of a hurricane watch; requiring a marina owner, operator, employee, or agent to remove specified vessels under certain circumstances; providing that such owner, operator, employee, or agent may charge the vessel owner a reasonable fee for such removal and may not be held liable for any damages as a result of such removal, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

CS/SB 884 (3R) by the Committee on Appropriations, Senator Hooper and others—

Law Enforcement and Correctional Officers; Specifying that an allegation or complaint of misconduct against a law enforcement officer or a correctional officer may originate from any source; authorizing law enforcement and correctional agencies to request a separate agency to conduct an investigation of a complaint under certain circumstances, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

CS/SB 1298 (3R) by the Committee on Appropriations and Senator Simmons—

Office of the Judges of Compensation Claims; Specifying the salaries of full-time judges of compensation claims and the Deputy Chief Judge of Compensation Claims, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

CS/SB 218 (3R) by the Committee on Health Policy and Senator Harrell—

Licensure Requirements for Osteopathic Physicians; Revising licensure requirements for persons seeking licensure or certification as an osteopathic physician, etc. Effective Date: Upon becoming a law

Read the second time on March 6, 2020

CS/SB 292 (3R) by the Committee on Banking and Insurance and Senator Broxson—

Insurance Claims Data; Defining the terms “loss run statement” and “provide”; requiring surplus lines and authorized insurers, respectively, to provide insureds either a loss run statement or certain information within a certain timeframe after receipt of the insured’s written request; requiring insurers to provide notice to the agent of record after providing a loss run statement; prohibiting insurers from charging a fee to prepare and provide one loss run statement annually, etc. Effective Date: 01/01/2021

Read the second time on March 6, 2020

CS/SB 128 (3R) by the Committee on Governmental Oversight and Accountability and Senator Wright—

Public Records/Judicial Assistants; Providing an exemption from public records requirements for certain identifying and location information of current and former judicial assistants and their spouses and children; providing for retroactive application of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

SB 374, 1st Eng. (3R) by Senator Rouson—

Housing Discrimination; Providing that discriminatory restrictions are unlawful, unenforceable, and declared null and void; removing housing discrimination as a cause of action for certain relief and damages stemming from violations of the Florida Civil Rights Act of 1992; revising the conditions under which an aggrieved person may commence a civil action in any appropriate court against a specified respondent to enforce specified rights; authorizing, rather than requiring, a civil action to commence within a specified period after an alleged discriminatory housing practice, etc. Effective Date: Upon becoming a law

Read the second time and amended on March 6, 2020

CS/CS/CS/SB 1066 (3R) by the Committees on Appropriations, Finance and Tax, Community Affairs and Senator Gruters—

Impact Fees; Prohibiting new or increased impact fees from applying to certain applications; providing a calculation on which contributions to mitigate impacts not otherwise funded by impact fees must be based; prohibiting such contributions from being collected before the issuance of building permits; providing that impact fee credits are assignable and transferable under certain conditions, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

CS/CS/SB 1606 (3R) by the Committees on Infrastructure and Security, Banking and Insurance and Senator Perry—

Insurance Administration; Revising a certain electronic signature requirement for a motor vehicle salvage certificate of title; authorizing the payment of certain workers' compensation benefits to be transmitted to the employee's account with a licensed money transmitter; revising criteria for assessing a residential condominium unit owner's loss assessment coverage; specifying sales practice requirements, prohibited sales practices, and authorized sales practices relating to travel insurance, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2020

CS/SB 82, 1st Eng. (3R) by the Committee on Appropriations and Senator Bean—

Individuals with Disabilities; Requiring persons and entities under contract with the Agency for Persons with Disabilities to use the agency data management systems to bill for services; revising criteria used by the agency to develop a client's iBudget; requiring the Agency for Health Care Administration to seek federal approval to provide consumer-directed options; providing an exemption from a certificate-of-need requirement for certain intermediate care facilities, etc. Effective Date: 07/01/2021

Read the second time and amended on March 6, 2020

CS/CS/SB 364, 1st Eng. (3R) by the Committees on Rules, Community Affairs, Senator Rader and others—

Independent Living Task Force; Establishing the Independent Living Task Force within the Florida Housing Finance Corporation; defining the term "disability"; requiring the task force to submit a report to the Governor and the Legislature by a specified date, etc. Effective Date: Upon becoming a law

Read the second time and amended on March 6, 2020

CS/CS/CS/SB 1794, 1st Eng. (3R) by the Committees on Rules, Judiciary, Ethics and Elections and Senator Hutson—

Constitutional Amendments; Increasing the signature threshold at which the Secretary of State must transmit initiative petitions to the Attorney General for review; providing that a citizen may challenge in circuit court a petition circulator's registration with the Secretary of State; authorizing the Division of Elections or a supervisor of elections to provide petition forms in a certain electronic format; requiring that ballots containing constitutional amendments proposed by initiative include certain disclosures and statements, in a specified order, etc. Effective Date: Upon becoming a law

Read the second time and amended on March 6, 2020

CS/CS/CS/SB 1876, 1st Eng. (3R) by the Committees on Rules, Innovation, Industry, and Technology, Agriculture, Senator Montford and others—

State Hemp Program; Revising the definition of the term "food" to include hemp extract for purposes of the Florida Food Safety Act; providing that a person operating a minor food outlet that sells hemp extract is not exempt from certain food permit requirements; providing that hemp extract that does not meet certain requirements will be considered adulterated or misbranded; prohibiting the sale of certain hemp extract products to individuals under a specified age, etc. Effective Date: Upon becoming a law

Read the second time and amended on March 6, 2020

SB 2506 (3R) by the Committee on Appropriations (Bradley)—

Correctional Medical Authority; Transferring the State of Florida Correctional Medical Authority from the Executive Office of the Governor to the Department of Health by a type two transfer, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

SB 7046 (3R) by the Committee on Governmental Oversight and Accountability (Hooper)—

State Group Insurance Program; Authorizing persons eligible to participate in the program to elect membership with certain health maintenance organization plans; requiring at least one health maintenance organization plan be made available to each enrollee residing in the state; prohibiting specified fraudulent acts in connection with the program, including the submission of fraudulent insurance claims, making false statements in claims, and the acceptance of certain payments; requiring the Division of State Group Insurance to establish an anti-fraud unit for certain purposes by a specified date, etc. Effective Date: 07/01/2020

Read the second time on March 6, 2020

SB 7052, 1st Eng. (3R) by the Committee on Innovation, Industry, and Technology (Simpson)—

Office of Public Counsel; Providing term limits for the Public Counsel; providing an exception for time served before a specified date; providing for the appointment and removal of the Public Counsel; requiring the Committee on Public Counsel Oversight to receive applications, conduct interviews, and appoint a Public Counsel by a specified date every 4 years, etc. Effective Date: 07/01/2020

Read the second time and amended on March 6, 2020

CS/SB 1018, 1st Eng. (3R) by the Committee on Criminal Justice and Senator Stewart—

Exposure of Sexual Organs; Increasing criminal penalties for exposure of sexual organs for a second or subsequent offense; providing an exception to the unlawful exposure of sexual organs; authorizing warrantless arrests when a law enforcement officer has probable cause to believe that a person has violated s. 800.03, F.S., etc. Effective Date: 10/01/2020

Read the second time and amended on March 6, 2020

CS/SB 1326, 1st Eng. (3R) by the Committee on Appropriations and Senator Simpson—

Child Welfare; Requiring the Department of Children and Families to establish performance metrics; requiring sheriffs providing certain services to adopt the child welfare practice model; requiring the department to establish an Office of Quality; adding responsibilities to the department of contracts regarding care for children in the child welfare system; requiring the Florida Institute for Child Welfare and the Florida State University College of Social Work to design and implement a specified curriculum, etc. Effective Date: 07/01/2020

Read the second time and amended on March 6, 2020

CS/CS/CS/SB 664, 1st Eng. (3R) by the Committees on Rules, Commerce and Tourism, Judiciary, Senator Lee and others—

Verification of Employment Eligibility; Requiring written agreements for the procurement of specified contractual services to include a statement regarding the requirement that a contractor or subcontractor register with and use E-Verify; requiring public employers and certain contractors and subcontractors to register with and use E-Verify by a specified date; prohibiting the approval of certain economic development incentive applications after a specified date; requiring employers to register with and use an electronic employment verification system to verify the employment eligibility of new employees by a certain date, etc. Effective Date: 07/01/2020

Read the second time and amended on March 6, 2020

CS/CS/HB 915, 2nd Eng. (3R) by the Committees on State Affairs Committee, Transportation and Infrastructure Subcommittee, Representative Avila and others—

Commercial Service Airports; Directing the Auditor General to conduct specified audits of certain airports; requiring certain members of the governing body of a large-hub commercial service airport to comply with certain financial disclosure requirements; requiring the governing body of a municipality, county, or special district that operates a commercial service airport to establish and maintain a website; requiring the governing body to post or provide links to certain information on the website; requiring commercial service airports to comply with certain contracting requirements; requiring governing body members and employees of a commercial service airport to comply with certain ethics requirements; requiring the department to review such information and submit an annual report to the Governor and Legislature; prohibiting the expenditure of certain funds unless specified conditions are met, etc. Effective Date: 10/01/2020

SB 1116 (SO) by Senator Brandes and others—

Trust Funds/State-Operated Institutions Inmate Welfare Trust Fund/Department of Corrections; Creating the State-Operated Institutions Inmate Welfare Trust Fund within the Department of Corrections; providing the purpose of the trust fund; providing for future review and termination or re-creation of the trust fund, etc. Effective Date: 07/01/2020

Reported favorably by the Committee on Criminal Justice; recommended favorably by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably by the Committee on Appropriations

CS/CS/SB 1118 (SO) by the Committees on Appropriations, Criminal Justice, Senator Brandes and others—

Inmate Welfare Trust Funds; Requiring that certain amounts in inmate trust fund accounts be deposited into the trust fund; requiring that specified proceeds and funds be deposited into the State-Operated Institutions Inmate Welfare Trust Fund; providing that the trust fund is a trust held by the Department of Corrections for the benefit and welfare of certain inmates; requiring that funds of the trust fund be used exclusively for specified purposes at correctional facilities operated by the department; requiring that certain prisoner earnings are deposited into the trust fund, etc. Effective Date: On the same date that SB 1116 or similar legislation takes effect if such legislation is enacted in the same legislative session or an extension thereof and becomes a law

Reported favorably as a committee substitute by the Committee on Criminal Justice; recommended favorably as a committee substitute by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1120 (SO) by the Committees on Appropriations, Children, Families, and Elder Affairs and Senator Harrell—

Substance Abuse Services; Specifying that certified recovery residence administrators and certain persons associated with certified recovery residences are subject to certain background screenings; requiring, rather than authorizing, the exemption from disqualification from employment for certain substance abuse service provider personnel; deleting a provision relating to background screenings for certain persons associated with applicant recovery residences; providing criminal penalties for violations relating to recovery residence patient referrals, etc. Effective Date: 07/01/2020

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 1170 (SO) by the Committee on Governmental Oversight and Accountability, Senator Baxley and others—

Public Records and Meetings/Division of State Technology; Revising a provision to reflect the abolishment of the Agency for State Technology; providing an exemption from public records requirements for portions of records held by a state agency which contain network schematics, hardware and software configurations, or encryption; providing an exemption from public meetings requirements for portions of meetings which would reveal certain records; providing for future legislative review and repeal under the Open Government Sunset Review Act of the exemptions; providing statements of public necessity, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Innovation, Industry, and Technology; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Rules reports the committee substitute favorably

SB 1244 (SO) by Senator Albritton—

State Workforce Development Boards; Defining the terms “for cause” and “state board”; replacing CareerSource Florida, Inc., with the state board or the Department of Economic Opportunity in provisions relating to the implementation of the federal Workforce Innovation and Opportunity Act; revising provisions relating to the operation of CareerSource Florida, Inc.; authorizing a chief elected official for a local workforce development board to remove certain persons from the board for cause; revising authority relating to the Workforce Training Institute, etc. Effective Date: 07/01/2020

Reported favorably by the Committee on Commerce and Tourism; reported favorably by the Committee on Innovation, Industry, and Technology; and reported favorably by the Committee on Rules

SB 1292 (SO) by Senator Perry—

Public Records/Nonjudicial Arrest Record of a Minor; Providing an exemption from public records requirements for a nonjudicial record of the arrest of a minor who has successfully completed a diversion program; providing for future legislative review and repeal of the exemption under the Open Government Sunset Review Act; providing a statement of public necessity, etc. Effective Date: On the same date that SB 700 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably by the Committee on Criminal Justice; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules

CS/SB 1344 (SO) by the Committee on Appropriations and Senator Harrell—

Intermediate Care Facilities; Requiring certain facilities that have been granted a certificate-of-need exemption to demonstrate and maintain compliance with specified criteria; providing an exemption from a certificate-of-need requirement for certain intermediate care facilities; limiting the number of such exemptions the Agency for Health Care Administration may grant, etc. Effective Date: 07/01/2020

Reported favorably by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 1312 (SO) by the Committee on Appropriations, Senator Montford and others—

Voting Systems; Defining the term “automatic tabulating equipment” for purposes of the Florida Election Code; revising procedures governing the canvassing of returns to specify usage of a voting system’s automatic tabulating equipment; clarifying the circumstances under which ballots must be processed through automatic tabulating equipment in a recount; specifying the manner by which a manual recount may be conducted, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect January 1, 2021

Reported favorably by the Committee on Ethics and Elections; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Appropriations

SB 1376 (SO) by Senator Broxson and others—

Credit For Reinsurance; Adding conditions under which a ceding insurer must be allowed credit for reinsurance; specifying requirements for assuming insurers and reinsurance agreements; authorizing a ceding insurer or its representative that is subject to rehabilitation, liquidation, or conservation to seek a certain court order; authorizing the Office of Insurance Regulation to revoke or suspend an assuming insurer’s eligibility under certain conditions, etc. Effective Date: 07/01/2020

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

CS/CS/CS/SB 1464 (SO) by the Committees on Rules, Banking and Insurance, Infrastructure and Security and Senator Flores—

Underground Facility Damage Prevention and Safety; Revising and providing noncriminal violations relating to the transportation of certain hazardous materials; requiring certain persons to transmit an incident report to the State Fire Marshal; providing that certain incident reports must be investigated by the State Fire Marshal or his or her agents; requiring Sunshine State One-Call of Florida, Inc., to review certain reports and complaints, etc. Effective Date: 07/01/2020

Reported favorably as a committee substitute by the Committee on Infrastructure and Security; reported favorably as a committee substitute by the Committee on Banking and Insurance; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 1508 (SO) by the Committees on Infrastructure and Security, Criminal Justice and Senator Taddeo—

Police Vehicles; Prohibiting a person from knowingly selling, exchanging, or transferring a police vehicle without removing any police markings from the vehicle; requiring law enforcement agencies to provide an official letter of notification that the police markings have been removed; exempting sales, exchanges, or transfers of police vehicles to members of the public for the purposes of collection or display from specified requirements, etc. Effective Date: 07/01/2020
