Child Care Facilities; Citing this act at the "Child Safety Alarm Act"; requiring that, by a specified date, vehicles used by child care facilities and large family child care homes to transport children be equipped with a reliable alarm system that prompts the driver to inspect the vehicle for children before exiting the vehicle; requiring the Department of Children and Families to adopt by rule minimum safety standards for such systems and to maintain a list of approved alarm manufacturers and alarm systems, etc. Effective Date: 10/01/2020

SB 294 (2R) by Senator Wright and others—

Crimes Against Veterans; Citing this act as the "Florida Veterans Protection Act"; providing an enhanced sentence for any person who commits aggravated white collar crimes against a certain number of veterans by obtaining or attempting to obtain a specified amount of money; providing criminal penalties, etc. Effective Date: 10/01/2020

Reported favorably by the Committee on Military and Veterans Affairs and Space; reported favorably by the Committee on Criminal Justice; and reported favorably by the Committee on Rules

CS/CS/SB 346 (2R) by the Committees on Appropriations, Criminal Justice, Senator Bradley and others—

Criminal Justice; Prohibiting the imprisonment for longer than a certain time for persons who possess, purchase, or possess with the intent to purchase less than a specified amount of a controlled substance; authorizing a court to impose a sentence other than the mandatory minimum term of imprisonment and mandatory fine for a person convicted of trafficking if the court makes certain findings on the record; requiring that a custodial interrogation conducted at a place of detention in connection with certain offenses be electronically recorded in its entirety; revising the circumstances under which a wrongfully incarcerated person is eligible for compensation, etc. Effective Date: 07/01/2020

Postsecondary Education for Certain Military Personnel; Requiring the Board of Governors and the State Board of Education, in consultation with the Department of Veterans' Affairs, to create a process for the uniform award of postsecondary credit or career education clock hours to certain servicemembers and veterans of the United States Armed Forces; requiring certain postsecondary institutions to award uniform postsecondary credit or career education clock hours for specified courses taken and occupations held by individuals during their service in the military, etc. Effective Date: Upon becoming a law

Regional Rural Development Grants; Specifying that the concept of building the professional capacity of a regional economic development organization includes the hiring of professional staff to perform specified services; providing that matching grants may be used to provide technical assistance to local governments and economic development organizations and to existing and prospective businesses; increasing the amount of funds the Department of Economic Opportunity may expend each fiscal year from the Rural Community Development Revolving Loan Fund for certain purposes; revising the maximum percentage of total infrastructure project costs for which the department may award grants, etc. Effective Date: 07/01/2020
