CS/CS/HB 431, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Professions and Public Health Subcommittee, Representative Rommel and others—

Practice of Physician Assistants; Provides physician assistant reimbursement & direct billing requirements; authorizes licensed physician assistants to procure medicinal drugs & medical devices under certain circumstances; authorizes physician assistants to authenticate documents for specified reasons; revises accreditation requirements; revises physician assistant licensure requirements; deletes various provisions relating to physician assistants. Effective Date: 07/01/2021

Substituted for **CS/CS/SB 894(SUB)** (Diaz), read the second time, and amended on April 26, 2021

CS/CS/CS/HB 53, 1st Eng. (3R) by the Committees on State Affairs Committee, Public Integrity and Elections Committee, Government Operations Subcommittee, Representative DiCeglie and others—

Public Works; Revises prohibition relating to solicitation for construction services paid for with state appropriated funds; prohibits state or political subdivision that contracts for public works project from taking specified action against certain persons that are engaged in public works project or have submitted bid for such project; requires OEDR to include an analysis of certain expenditures in its annual assessment; requires counties, municipalities, & special districts that provide wastewater services & stormwater management to develop needs analysis. Effective Date: 07/01/2021

Substituted for **CS/CS/CS/SB 1076(SUB)** (Brodeur), read the second time, and amended on April 26, 2021

HB 997, 1st Eng. (3R) by Representative Garrison—

Pub. Rec. and Meetings/Postsecondary Education Executive Search; Provides exemption from public records requirements for personal identifying information of applicant for president of state university or FCS institution; provides exemption from public meeting requirements for meeting held for specified purposes relating to postsecondary executive search; provides for future legislative review & repeal; provides statement of public necessity. Effective Date: 07/01/2021

Substituted for **CS/SB 220(SUB)** (Brandes) and read the second time on April 26, 2021

HB 245 (3R) by Representative Chaney and others—

Massage Therapy; Revises definition & purpose of massage therapy. Effective Date: 07/01/2021

Substituted for **CS/SB 352(SUB)** (Rodriguez) and read the second time on April 26, 2021

CS/CS/HB 259 (3R) by the Committees on Judiciary Committee, Education and Employment Committee, Representatives Williamson, Byrd and others—

Safety of Religious Institutions; Authorizes, for specified purposes, concealed weapons or firearms licensee to carry firearm on certain property of church, synagogue, or other religious institution. Effective Date: Upon becoming a law

Read the second time on April 26, 2021

HB 735 (3R) by Representative Harding and others—

Preemption of Local Occupational Licensing; Preempts licensing of occupations to state; prohibits local governments from imposing or modifying licensing requirements; specifies certain local licensing may not be enforced; specifies certain specialty contractors are not required to register with Construction Industry Licensing Board; prohibits local governments from requiring certain specialty contractors to obtain license; specifies job scopes for which local government may not require license; authorizes counties & municipalities to issue journeyman licenses. Effective Date: 07/01/2021

Substituted for **CS/SB 268(SUB)** (Perry) and read the second time on April 26, 2021

CS/HB 921 (3R) by the Committee on Criminal Justice and Public Safety Subcommittee, Representative Snyder and others—

Electronic Threats; Prohibits person from sending, posting, or transmitting, or from procuring sending, posting, or transmission of written or electronic record when person makes threat to kill or to do bodily harm to another person or to conduct mass shooting or an act of terrorism. Effective Date: 10/01/2021

Substituted for **SB 1850(SUB)** (Perry), read the second time, and amended on April 26, 2021

CS/HB 1261, 2nd Eng. (3R) by the Committee on Education and Employment Committee, Representative Toledo and others—

Higher Education; Prohibits certain educational institutions from being civilly liable for certain actions; requires state university to waive certain tuition & fees for certain students who meet specified criteria; revises eligibility criteria for specified grant program. Effective Date: 07/01/2021

Substituted for **CS/SB 7070(SUB)** (Gruters), read the second time, and amended on April 26, 2021

CS/CS/SB 1448 (SO) by the Committees on Appropriations, Governmental Oversight and Accountability and Senator Jones—

Information Technology Procurement; Requiring the Department of Management Services, through the Florida Digital Service, to establish certain project management and oversight standards for state agency compliance; requiring the department to perform project oversight on information technology projects that have total project costs of a certain amount or more; authorizing the department to execute certain contracts if the Secretary of Management Services and the state chief information officer certify certain information in writing, etc. Effective Date: 07/01/2021

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to CS/CS/HB 1137(HC) in the Committee on Appropriations

CS/CS/SB 1592 (SO) by the Committees on Appropriations, Finance and Tax, Senator Burgess and others—

Broadband Internet Infrastructure; Creating the "Florida Broadband Deployment Act of 2021"; requiring municipal electric utilities to provide a specified promotional rate to broadband providers for wireline attachments made in unserved or underserved areas within the utility's service area; requiring municipal electric utilities to provide certain information regarding connections made available to broadband providers to the Office of Broadband within the Department of Economic Opportunity; requiring the local technology planning teams within the office to provide support to rural communities regarding broadband service availability; requiring wireline attachments to comply with certain safety and engineering standards, etc. Effective Date: 07/01/2021

Reported favorably by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Finance and Tax; and reported favorably as a committee substitute by the Committee on Appropriations

Compare to CS/CS/HB 1239, 2nd Eng.(HC) in the Committee on Appropriations

SB 1624 (SO) by Senator Albritton-

Special District Accountability; Requiring certain independent special districts to contract with an independent entity to conduct performance audits; requiring the Office of Program Policy Analysis and Government Accountability to conduct performance audits of certain classifications of independent special districts; requiring the performance audits to be reported by a time certain; requiring that certain data be included in financial audits of special districts, etc. Effective Date: 10/01/2021

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Appropriations

Similar to CS/CS/CS/HB 1103(HC) in the Committee on Appropriations

CS/CS/SB 1900 (SO) by the Committees on Appropriations, Governmental Oversight and Accountability and Senator Boyd—

Cybersecurity; Requiring certain audit plans of an inspector general to include certain information; providing that the Department of Management Services, acting through the Florida Digital Service, is the lead entity for the purpose of certain responsibilities; requiring the department, through the Florida Digital Service, to track the implementation by state agencies of certain plans; creating the Florida Cybersecurity Advisory Council within the Department of Management Services; requiring the council to provide certain assistance to the Florida Digital Service; providing for the membership of the council, etc. Effective Date: 07/01/2021

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; recommended favorably as a committee substitute by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to **CS/CS/HB 1297(HC)** in the Committee on Appropriations

CS/HB 9 (SO) by the Committee on Judiciary Committee, Representative Zika and others—

Protecting Consumers Against Pandemic-related Fraud; Defines "personal protective equipment"; prohibits dissemination of false or misleading information relating to personal protective equipment with specified intent; prohibits dissemination of false or misleading vaccine information with specified intent; authorizes state attorney or statewide prosecutor to prosecute violation; authorizes AG to seek civil remedies. Effective Date: Upon becoming a law

Reported favorably by the Committee on Rules

CS/SB 1294 (SO) by the Committee on Rules and Senator Brodeur—

Cottage Food Operations; Citing this act as the "Home Sweet Home Act"; revising the definition of the term "cottage food operation"; increasing the annual gross sales limitation for exempting cottage food operations from certain food and building permitting requirements; authorizing the sale, offer for sale, acceptance of payment, and delivery of cottage food products by mail; preempting the regulation of cottage food operations to the state; prohibiting local governments from prohibiting cottage food operations or regulating cottage food products by cottage food operations, etc. Effective Date: 07/01/2021

Reported favorably by the Committee on Regulated Industries; reported favorably by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/HB 663(HC) in the Committee on Rules

CS/SB 7068 (SO) by the Committees on Appropriations, and Finance and Tax (Rodriguez)—

Taxation; Adding exceptions to the definition of the term "change of ownership" for purposes of a certain homestead assessment limitation; specifying that portions of property not used for certain purposes are not exempt from ad valorem taxation; providing that improvements to real property are deemed owned by certain educational institutions for purposes of the educational exemption from ad valorem taxation if certain criteria are met; providing that modifications of certain original documents for certain purposes on which documentary stamp taxes were previously paid are not renewals and are not subject to the documentary stamp tax; extending the expiration date of the sales tax exemption for data center property; creating the Strong Families Tax Credit; defining terms, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect July 1, 2021

Reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/CS/SB 1186 (SO) by the Committees on Appropriations, Finance and Tax, Community Affairs and Senator Brandes—

Property Assessments for Elevated Properties; Specifying that changes to elevate certain homestead and nonhomestead residential property, respectively, do not increase the assessed value of the property; requiring property owners to provide certification for such property; prohibiting certain areas from being included in square footage calculation, etc. Effective Date: On the effective date of the amendment to the State Constitution proposed by SJR 1182 or a similar joint resolution having substantially the same specific intent and purpose, if such amendment to the State Constitution is approved at the general election held in November 2022 or at an earlier special election specifically authorized by law for that purpose

LOCAL BILLS CALENDAR FOR THURSDAY, APRIL 29, 2021

CS/HB 385 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee, Representative Hage and others—

Alcoholic Beverage Licenses, Lake and Sumter Counties; Revises criteria for special alcoholic beverage licenses for certain entities operating within Lake & Sumter Counties; revises boundaries. Effective Date: Upon becoming a law

HB 751 (LB) by Representative Clemons—

City of Gainesville, Alachua County; Authorizes issuance of special license to mobile food dispensing vehicles to sell alcoholic beverages for consumption of alcoholic beverages within specified area; provides requirements; prohibits licensee from selling alcoholic beverages by package for consumption outside specified area; provides for issuance of an unlimited number of licenses within specified area; provides that operator is not exempt from meeting requirements to hold a license. Effective Date: Upon becoming a law

CS/HB 787 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Stevenson—

St. Augustine-St. Johns County Airport Authority, St. Johns County; Renames authority; authorizes authority to conduct airport operations under specified name. Effective Date: Upon becoming a law

CS/HB 915 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee, Representative Willhite and others—

Port of Palm Beach District, Palm Beach County; Deletes provisions requiring certain persons to execute and deliver a bond within a specified time period after assuming office; revises annual salary of commissioners & revises the term "port manager" to "port director". Effective Date: Upon becoming a law

HB 979 (LB) by Representative Willhite-

Village of Wellington, Palm Beach County; Provides exception to general law; prohibits sale & use of fireworks located within Equestrian Preserve of Village of Wellington except under specified circumstances. Effective Date: Upon becoming a law

CS/HB 1035 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee, Representatives Roth and Snyder—

Loxahatchee River Environmental Control District, Martin and Palm Beach Counties; Codifies, amends, repeals, & reenacts special acts relating to district. Effective Date: Upon becoming a law

CS/HB 1185 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Roth—

Indian Trail Improvement District, Palm Beach County; Authorizes district to study feasibility of elector-initiated conversion of district to municipality; provides procedure for such study; provides for transition date & permits continuation of district. Effective Date: Upon becoming a law

HB 1213 (LB) by Representative Harding—

Homosassa Special Water District, Citrus County; Revises requirements to fill vacancy on Board of Commissioners; increases threshold cost of work for which district must use competitive bid process; authorizes District to procure contractual services without receiving competitive sealed bids under certain circumstances. Effective Date: Upon becoming a law

HB 1251 (LB) by Representative Toledo and others—

Water Street Tampa Improvement District, Hillsborough County; Revises district boundaries; requires referendum. Effective Date: Upon approval by a majority vote of the owners of land within the area described in section 1

CS/HB 1495 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Daley—

Coral Springs Improvement District, Broward County; Provides exception to general law; revises number of board members; requires members of Board of Supervisors of the Coral Springs Improvement District to be elected by qualified electors of district; provides for staggered terms of office for board; provides requirements for elections of board members & for candidates seeking election; provides duties of Supervisor of Elections of Broward County; provides for referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of the Coral Springs Improvement District voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force

CS/HB 1499 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Daley—

Pine Tree Water Control District, Broward County; Requires members of board of supervisors be elected through general election; provides for staggered terms; provides requirements for elections of board members & candidates seeking election; requires Supervisor of Elections of Broward County to appoint certain persons, prepare & furnish ballots, designate polling places, & canvass returns; provides for declaration & certification of election results; provides requirements for referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of the Pine Tree Water Control District voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force, except this section and section 2 shall take effect upon becoming a law

CS/CS/HB 1501 (LB) by the Committees on Public Integrity and Elections Committee, Local Administration and Veterans Affairs Subcommittee and Representative Daley—

Sunshine Drainage District, Broward County; Revises number of members of board of supervisors; provides for members of board of supervisors to be elected by qualified electors of district; provides for staggered terms; requires nonpartisan elections; provides requirements for candidates & election duties of the supervisor of elections; provides requirements for referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of the Sunshine Drainage District voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force, except this section and section 2 shall take effect upon becoming a law

CS/CS/HB 1503 (LB) by the Committees on Public Integrity and Elections Committee, Local Administration and Veterans Affairs Subcommittee and Representative Daley—

North Springs Improvement District, Broward County; Revises number of board members; requires members to be residents of district; provides designated seats for supervisors; provides for repeal unless reviewed & saved from repeal by Legislature; provides exception to general law; requires board of supervisors be elected by qualified electors of district; provides requirements for referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of the North Springs Improvement District voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force, except that section 1 shall take effect on November 5, 2030, if approved by a majority vote of the qualified electors of the North Springs Improvement District voting in a referendum and this section and section 3 shall take effect upon becoming a law

CS/HB 1587 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Gregory—

East Manatee Fire Rescue District, Manatee County; Provides for merger of Myakka City Fire Control District into East Manatee Fire Rescue District; revises boundaries. Effective Date: 10/01/2021

HB 1589 (LB) by Representative Mooney—

City of Key West, Monroe County; Revises provisions relating to election of Utility Board members, membership of board, & terms of service; provides for forfeiture of office; revises exemption from competitive procurement time period for original contract; provides sale, transfer, or other disposition of ownership interest in certain utilities effective only under specified circumstances. Effective Date: Upon becoming a law

HB 1591 (LB) by Representative Plakon and others—

South Seminole and North Orange County Wastewater Transmission Authority; Designates regional sewage treatment plant as Orlando Iron Bridge Wastewater Treatment Facility; revises boundaries; revises provisions relating to selection of governing board members & officers; authorizes authority to contract with entity for certain purposes. Effective Date: Upon becoming a law

HB 1593 (LB) by Representative Smith, D.—

Seminole County; Provides exception to general law; provides exception for specified cemeteries in unincorporated areas of Seminole County. Effective Date: Upon becoming a law

HB 1631 (LB) by Representative Gregory—
