CS/HB 403 (3R) by the Committee on Commerce Committee, Representative Giallombardo and others—

Home-based Businesses; Specifies conditions under which business is considered home-based business; authorizes home-based business to operate in residential zone; prohibits local government from certain actions relating to licensure & regulation of home-based business; authorizes specified business owners to challenge certain local government actions; authorizes prevailing party to recover specified attorney fees & costs. Effective Date: 07/01/2021

*Substituted for **CS/CS/SB 266(SUB)** (Perry), read the second time, and amended on April 28, 2021*

CS/HB 663 (3R) by the Committee on Regulatory Reform Subcommittee, Representatives Salzman, Botana and others—

Cottage Food Operations; Increases annual gross sales limitation for exempting cottage food operations from food & building permitting requirements; authorizes sale, offer for sale, & delivery of cottage food products by mail; preempts regulation of cottage food operations to state; prohibits local governments from prohibiting or regulating cottage food operations. Effective Date: 07/01/2021

*Substituted for **CS/SB 1294(SUB)** (Brodeur), read the second time, and amended on April 28, 2021*

CS/CS/CS/HB 969 (3R) by the Committees on Commerce Committee, Civil Justice and Property Rights Subcommittee, Regulatory Reform Subcommittee, Representative McFarland and others—

Consumer Data Privacy; Requires collectors to provide notice to consumers about data collection & selling practices; provides consumers right to request data be disclosed, deleted, or corrected & to opt-in or opt-out of sale or sharing of such data; provides nondiscrimination measures, methods for requesting data & opting-in or opting-out of sale or sharing of such data, private cause of action, enforcement, & jurisdiction. Effective Date: 07/01/2022

*Substituted for **CS/CS/SB 1734(SUB)** (Bradley), read the second time, and amended on April 28, 2021*

CS/CS/HB 971 (3R) by the Committees on Commerce Committee, Government Operations Subcommittee, Representative McFarland and others—

Pub.Rec./Consumer Data Privacy; Provides exemption from public records requirements for information relating to investigations by DLA & law enforcement agencies of certain data privacy violations; provides for future legislative review & repeal of exemption; provides statement of public necessity. Effective Date: On the same date that CS/CS/CS/HB 969 or similar legislation takes effect

CS/SB 506 (SO) by the Committee on Governmental Oversight and Accountability and Senator Garcia—

Transparency in Government Spending; Requiring nongovernmental entities that have received a specified amount of state funds to submit an annual report detailing certain compensation data to the Department of Management Services; requiring such reports to be verified under penalty of perjury; requiring the department to post the information received through such reports on a specified website; requiring a nongovernmental entity to post the reported compensation information on its website; prohibiting a governmental entity from expending, transferring, or distributing funds to a nongovernmental entity if compliance with reporting requirements is not met, etc. Effective Date: 07/01/2021

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; the Committee on Appropriations reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/SB 1140 (SO) by the Committee on Rules, Senator Rodrigues and others—

Unlawful Use of DNA; Citing this act as the "Protecting DNA Privacy Act"; prohibiting DNA analysis and disclosure of DNA analysis results without express consent; prohibiting the collection or retention of a DNA sample of another person without express consent for specified purposes; prohibiting specified DNA analysis and disclosure of DNA analysis results without express consent, etc. Effective Date: 10/01/2021

Reported favorably by the Committee on Health Policy; reported favorably by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/HB 833, 1st Eng.(HC) in the Committee on Rules

CS/CS/SB 1570 (SO) by the Committees on Appropriations, Governmental Oversight and Accountability and Senator Rodriguez—

Quasi-public Entities; Requiring the Governor to specify affiliated departments for certain quasi-public entities by a certain date; requiring a quasi-public entity to maintain a website that includes certain information; prohibiting a quasi-public entity from using public funds to retain a lobbyist; requiring the Auditor General to compile a list of quasi-public entities and submit the list to the Governor, the Legislature, and the Legislative Auditing Committee by a specified date, etc. Effective Date: 07/01/2021

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to CS/CS/HB 1083, 1st Eng.(HC) in the Committee on Appropriations

CS/SB 1864 (SO) by the Committee on Appropriations, Senator Perry and others—

Educator Conduct; Requiring the Department of Education to maintain a disqualification list of certain persons; providing that certain provisions relating to conduct and prohibition from employment apply to educational support employees; prohibiting certain employees and personnel from employment under certain circumstances; prohibiting certain individuals from employment at a charter school; revising acts that warrant a disciplinary action by the Education Practices Commission, etc. Effective Date: 07/01/2021

Reported favorably by the Committee on Education; recommended favorably by Appropriations Subcommittee on Education; and reported favorably as a committee substitute by the Committee on Appropriations

Identical to CS/CS/HB 131(HC) in the Committee on Appropriations

HB 7051, 1st Eng. (SO) by the Committee on Judiciary Committee, Representatives Byrd, Driskell and others—

Law Enforcement and Correctional Officer Practices; Requires application for employment or appointment as law enforcement or correctional officer to contain specified disclosures; requires background investigation of applicant to include specified information; requires employing agencies to maintain employment information for minimum period; requires establishment of standards for officer training & policies concerning use of force; requires law enforcement agencies to establish policies for specified use of force investigations; requires investigation to include an independent report; requires report to be submitted to state attorney; requires law enforcement agencies to submit specified data to FDLE; prohibits child younger than certain age from being arrested, charged, or adjudicated delinquent for delinquent act or violation of law. Effective Date: 07/01/2021

Reported favorably by the Committee on Rules

CS/SB 222 (SO) by the Committee on Governmental Oversight and Accountability, Senator Cruz and others—

Abandoned Cemeteries; Creating the Task Force on Abandoned African-American Cemeteries; requiring the Department of State to partner with specified entities to undertake an investigation of the former Zion Cemetery site; requiring the department to contract with the University of South Florida and Florida Agricultural and Mechanical University for the identification and location of eligible next of kin; directing the Division of Historical Resources of the department to ensure the listing of certain cemeteries in the Florida Master Site File; requiring the division to seek placement of historical markers at certain abandoned cemeteries, subject to certain limitations, etc. Effective Date: 07/01/2021

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and withdrawn from the Committees on Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and Appropriations

CS/CS/SB 402 (SO) by the Committees on Appropriations, Judiciary and Senator Rodrigues—

Legal Notices; Revising construction as to the satisfaction of publication requirements for legal notices; requiring the Florida Press Association to seek to ensure equitable access for minority populations to legal notices posted on the statewide legal notice website; authorizing a governmental agency to choose between print publication or Internet-only publication of specified governmental agency notices with specified newspapers if certain conditions are met; authorizing a newspaper to charge for Internet-only publication of governmental agency notices, subject to specified limitations, etc. Effective Date: 01/01/2022

Reported favorably as a committee substitute by the Committee on Judiciary; recommended favorably as a committee substitute by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 7068 (SO) by the Committees on Appropriations, and Finance and Tax (Rodriguez)—

Taxation; Adding exceptions to the definition of the term "change of ownership" for purposes of a certain homestead assessment limitation; specifying that portions of property not used for certain purposes are not exempt from ad valorem taxation; providing that improvements to real property are deemed owned by certain educational institutions for purposes of the educational exemption from ad valorem taxation if certain criteria are met; providing that modifications of certain original documents for certain purposes on which documentary stamp taxes were previously paid are not renewals and are not subject to the documentary stamp tax; extending the expiration date of the sales tax exemption for data center property; creating the Strong Families Tax Credit; defining terms, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect July 1, 2021

CS/CS/CS/SB 1186 (SO) by the Committees on Appropriations, Finance and Tax, Community Affairs and Senator Brandes—

Property Assessments for Elevated Properties; Specifying that changes to elevate certain homestead and nonhomestead residential property, respectively, do not increase the assessed value of the property; requiring property owners to provide certification for such property; prohibiting certain areas from being included in square footage calculation, etc. Effective Date: On the effective date of the amendment to the State Constitution proposed by SJR 1182 or a similar joint resolution having substantially the same specific intent and purpose, if such amendment to the State Constitution is approved at the general election held in November 2022 or at an earlier special election specifically authorized by law for that purpose

Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Finance and Tax; and reported favorably as a committee substitute by the Committee on Appropriations

CS/HB 385 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee, Representative Hage and others—

Alcoholic Beverage Licenses, Lake and Sumter Counties; Revises criteria for special alcoholic beverage licenses for certain entities operating within Lake & Sumter Counties; revises boundaries. Effective Date: Upon becoming a law

HB 751 (LB) by Representative Clemons—

City of Gainesville, Alachua County; Authorizes issuance of special license to mobile food dispensing vehicles to sell alcoholic beverages for consumption of alcoholic beverages within specified area; provides requirements; prohibits licensee from selling alcoholic beverages by package for consumption outside specified area; provides for issuance of an unlimited number of licenses within specified area; provides that operator is not exempt from meeting requirements to hold a license. Effective Date: Upon becoming a law

CS/HB 787 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Stevenson—

St. Augustine-St. Johns County Airport Authority, St. Johns County; Renames authority; authorizes authority to conduct airport operations under specified name. Effective Date: Upon becoming a law

CS/HB 915 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee, Representative Willhite and others—

Port of Palm Beach District, Palm Beach County; Deletes provisions requiring certain persons to execute and deliver a bond within a specified time period after assuming office; revises annual salary of commissioners & revises the term "port manager" to "port director". Effective Date: Upon becoming a law

HB 979 (LB) by Representative Willhite—

Village of Wellington, Palm Beach County; Provides exception to general law; prohibits sale & use of fireworks located within Equestrian Preserve of Village of Wellington except under specified circumstances. Effective Date: Upon becoming a law

CS/HB 1035 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee, Representatives Roth and Snyder—

Loxahatchee River Environmental Control District, Martin and Palm Beach Counties; Codifies, amends, repeals, & reenacts special acts relating to district. Effective Date: Upon becoming a law

CS/HB 1185 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Roth—

Indian Trail Improvement District, Palm Beach County; Authorizes district to study feasibility of elector-initiated conversion of district to municipality; provides procedure for such study; provides for transition date & permits continuation of district. Effective Date: Upon becoming a law

HB 1213 (LB) by Representative Harding—

Homosassa Special Water District, Citrus County; Revises requirements to fill vacancy on Board of Commissioners; increases threshold cost of work for which district must use competitive bid process; authorizes District to procure contractual services without receiving competitive sealed bids under certain circumstances. Effective Date: Upon becoming a law

HB 1251 (LB) by Representative Toledo and others—

Water Street Tampa Improvement District, Hillsborough County; Revises district boundaries; requires referendum. Effective Date: Upon approval by a majority vote of the owners of land within the area described in section 1

CS/HB 1495 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Daley—

Coral Springs Improvement District, Broward County; Provides exception to general law; revises number of board members; requires members of Board of Supervisors of the Coral Springs Improvement District to be elected by qualified electors of district; provides for staggered terms of office for board; provides requirements for elections of board members & for candidates seeking election; provides duties of Supervisor of Elections of Broward County; provides for referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of the Coral Springs Improvement District voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force

CS/HB 1499 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Daley—

Pine Tree Water Control District, Broward County; Requires members of board of supervisors be elected through general election; provides for staggered terms; provides requirements for elections of board members & candidates seeking election; requires Supervisor of Elections of Broward County to appoint certain persons, prepare & furnish ballots, designate polling places, & canvass returns; provides for declaration & certification of election results; provides requirements for referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of the Pine Tree Water Control District voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force, except this section and section 2 shall take effect upon becoming a law

CS/CS/HB 1501 (LB) by the Committees on Public Integrity and Elections Committee, Local Administration and Veterans Affairs Subcommittee and Representative Daley—

Sunshine Drainage District, Broward County; Revises number of members of board of supervisors; provides for members of board of supervisors to be elected by qualified electors of district; provides for staggered terms; requires nonpartisan elections; provides requirements for candidates & election duties of the supervisor of elections; provides requirements for referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of the Sunshine Drainage District voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force, except this section and section 2 shall take effect upon becoming a law

CS/CS/HB 1503 (LB) by the Committees on Public Integrity and Elections Committee, Local Administration and Veterans Affairs Subcommittee and Representative Daley—

North Springs Improvement District, Broward County; Revises number of board members; requires members to be residents of district; provides designated seats for supervisors; provides for repeal unless reviewed & saved from repeal by Legislature; provides exception to general law; requires board of supervisors be elected by qualified electors of district; provides requirements for referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of the North Springs Improvement District voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force, except that section 1 shall take effect on November 5, 2030, if approved by a majority vote of the qualified electors of the North Springs Improvement District voting in a referendum and this section and section 3 shall take effect upon becoming a law

CS/HB 1587 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Gregory—

East Manatee Fire Rescue District, Manatee County; Provides for merger of Myakka City Fire Control District into East Manatee Fire Rescue District; revises boundaries. Effective Date: 10/01/2021

HB 1589 (LB) by Representative Mooney—

City of Key West, Monroe County; Revises provisions relating to election of Utility Board members, membership of board, & terms of service; provides for forfeiture of office; revises exemption from competitive procurement time period for original contract; provides sale, transfer, or other disposition of ownership interest in certain utilities effective only under specified circumstances. Effective Date: Upon becoming a law

HB 1591 (LB) by Representative Plakon and others—

South Seminole and North Orange County Wastewater Transmission Authority; Designates regional sewage treatment plant as Orlando Iron Bridge Wastewater Treatment Facility; revises boundaries; revises provisions relating to selection of governing board members & officers; authorizes authority to contract with entity for certain purposes. Effective Date: Upon becoming a law

HB 1593 (LB) by Representative Smith, D.—

Seminole County; Provides exception to general law; provides exception for specified cemeteries in unincorporated areas of Seminole County. Effective Date: Upon becoming a law

HB 1631 (LB) by Representative Gregory—

Trailer Estates Park and Recreation District, Manatee County; Revises boundaries; revises powers & duties for trustees; provides for qualification of electors, annual election, & removal of trustees & appointment to fill vacancies; provides for assessment & collection of assessment; establishes fiscal year & provides for annual financial statements; authorizes trustees to issue bonds and other obligations; authorizing trustees to acquire & dispose of real & personal property & to adopt & enforce rules & regulations; provides for abolishment of district & conditions precedent to file suit against district or trustee; provides liability; requires referendum. Effective Date: Upon becoming a law

CS/HB 1633, 1st Eng. (LB) by the Committee on State Affairs Committee and Representative Drake—

Okaloosa Gas District, Okaloosa, Santa Rosa, and Walton Counties; Revises territorial limits & area of service of district to include all of Santa Rosa County & all of Walton County; provides exception; revises membership of the Board of Directors to include one member appointed by each of the Board of County Commissioners of Santa Rosa and Walton Counties; revises director's fee for each meeting attended by a member. Effective Date: Upon becoming a law

HB 1635 (LB) by Representative Ingoglia—

Hernando County School District, Hernando County; Repeals resolution of School Board of Hernando County providing for appointed superintendent of schools; provides for an elected superintendent of schools & referendum. Effective Date: Upon becoming a law

HB 1637 (LB) by Representative Melo—

Immokalee Water and Sewage District, Collier County; Provides appointed members shall serve until successor is appointed. Effective Date: Upon becoming a law

CS/HB 1645, 1st Eng. (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Drake—

City of Freeport, Walton County; Provides exceptions to general law; provides requirements for specialty center designation; authorizes sale of alcoholic beverages for consumption on premises of specialty center under certain conditions; provides that applicant for alcoholic beverage license to be located in specialty center may not be denied licensure under certain conditions. Effective Date: Upon becoming a law

HB 1647 (LB) by Representative Plasencia and others—

City of Orlando, Orange County; Creates special zones in City of Orlando; provides boundaries, exception to general law, & requirements for special alcoholic beverage licenses for restaurants in described areas. Effective Date: Upon becoming a law

100th Anniversary of Hardee County; Commemorating the 100th anniversary of the creation of Hardee County, etc.

SR 2070 (SR) by Senator Albritton—
