Insurance; Redefining the term "covered policy" under the Florida Hurricane Catastrophe Fund in relation to certain collateral protection insurance policies; authorizing any association, trust, or pool created for the purpose of forming a risk management mechanism or providing self-insurance for a public entity to use communications media technology to establish a quorum and conduct public business; authorizing insurers to file certain insurance rating plans based on certain windstorm mitigation construction standards, if certain requirements are met, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2022

SB 474 (SO) by Senator Perry—

Recreational Off-highway Vehicles; Revising the definition of the term "ROV" to increase the weight limit of a specified vehicle, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Agriculture; reported favorably by the Committee on Transportation; and reported favorably by the Committee on Rules

CS/CS/SB 494 (SO) by the Committees on Appropriations, Environment and Natural Resources and Senator Hutson—

Fish and Wildlife Conservation Commission; Requiring land management agencies to consider, in consultation with the commission, as part of certain state land management plans, the feasibility of using portions of such lands as gopher tortoise recipient sites; revising the notices a person must be given for failure to submit to certain tests for alcohol, chemical substances, or controlled substances; authorizing individuals, when participating in certain athletic team practices or competitions, to operate a human-powered vessel within the marked channel of the Florida Intracoastal Waterway under certain circumstances; revising the vessel conditions that an officer of the Fish and Wildlife Conservation Commission or a law enforcement agency may use to determine that a vessel is at risk of becoming derelict, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2022

CS/SB 498 (SO) by the Committee on Banking and Insurance, Senator Baxley and others—

Coverage for Hearing Aids for Children; Requiring certain individual health insurance policies to provide coverage for hearing aids for certain children 18 years of age or younger under certain circumstances; requiring certain individual health maintenance organization contracts to provide coverage for hearing aids for certain children 18 years of age or younger under certain circumstances; specifying certain coverage requirements; providing an exception, etc. Effective Date: 01/01/2023

Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Health Policy reports the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

CS/SB 520 (SO) by the Committee on Governmental Oversight and Accountability, Senator Brandes and others—

Public Records and Public Meetings; Providing an exemption from public records requirements for any personal identifying information of an applicant for president of a state university or a Florida College System institution held by a state university or a Florida College System institution; providing an exemption from public meetings requirements for any portion of a meeting held for the purpose of identifying or vetting applicants for president of a state university or a Florida College System institution, including any portion of a meeting which would disclose certain personal identifying information of such applicants; providing for future legislative review and repeal of the exemptions; providing a statement of public necessity, etc. Effective Date: Upon becoming a law

CS/SB 544 (SO) by the Committee on Appropriations, Senator Boyd and others—

Drug-related Overdose Prevention; Revising the purpose of specified provisions relating to the prescribing, ordering, and dispensing of emergency opioid antagonists to certain persons by authorized health care practitioners; providing certain authorized persons immunity from civil or criminal liability for administering emergency opioid antagonists under certain circumstances; revising requirements for a certain health awareness campaign; requiring hospital emergency departments and urgent care centers to report incidents involving a suspected or actual overdose to the Department of Health under certain circumstances, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 566 (SO) by the Committee on Health Policy and Senator Gruters—

Mental Health Professional Licensure; Revising licensure requirements for clinical social workers, marriage and family therapists, and mental health counselors, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Health Policy; the Committee on Children, Families, and Elder Affairs reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

SB 638 (SO) by Senator Perry—

Early Childhood Music Education Incentive Pilot Program; Extending the expiration date of the Early Childhood Music Education Incentive Pilot Program, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Education; and reported favorably by the Committee on Appropriations

SB 704 (SO) by Senator Harrell—

Substance Abuse Service Providers; Requiring service provider applicants to include the names and locations of certain recovery residences in their license application; requiring service providers to record specified information in the Department of Children and Families' Provider Licensure and Designations System after a specified date; providing civil penalties; prohibiting certified recovery residence administrators from actively managing more than a specified number of residents; requiring service providers to return an individual's personal effects upon the individual's discharge, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Children, Families, and Elder Affairs; reported favorably by the Committee on Community Affairs; and reported favorably by the Committee on Rules

CS/SB 754 (SO) by the Committee on Transportation, Senator Gainer and others—

Mobile Home Registration Periods; Revising the registration and registration renewal periods for a mobile home owned by a natural person; requiring the Department of Highway Safety and Motor Vehicles, beginning on a specified date, to give customers the option to renew their registrations on their dates of birth in certain years; specifying permissible renewal periods for such renewals, etc. Effective Date: 09/01/2023

Reported favorably as a committee substitute by the Committee on Transportation; the Committee on Community Affairs reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

SM 826 (SO) by Senator Wright and others—

Florida National Guard; Urging Congress to impel the United States National Guard Bureau to examine the resource allocations of the Florida National Guard and allow an increase in its force structure, etc.

Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; and reported favorably by the Committee on Rules

CS/SB 838 (SO) by the Committee on Appropriations, Senator Wright and others—

Fire Investigators; Revising the definition of the term "firefighter" to include full-time, Florida-certified fire investigators for the purpose of expanding eligibility for certain cancer treatment benefits to such investigators; providing a declaration of important state interest, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Appropriations

SB 7024 (SO) by the Committee on Governmental Oversight and Accountability (Brandes)—

OGSR/Alleged Victim or Victim of Sexual Harassment; Revising an exemption from public records requirements for personal identifying information of the alleged victim in an allegation of sexual harassment or the victim of sexual harassment if such information identifies that person as an alleged victim or as a victim of sexual harassment; authorizing the alleged victim or the victim to waive confidentiality in writing; extending the date for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 10/01/2022

SB 7026 (SO) by the Committee on Governmental Oversight and Accountability (Brandes)—

OGSR/Dependent Eligibility Verification Services; Designating the Department of Management Services, rather than the Division of State Group Insurance, as the entity that contracts for dependent eligibility verification services for the state group insurance program; authorizing the department or the contractor providing dependent eligibility verification services to require certain information from subscribers; revising the types of information that the department or a contractor providing eligibility verification services may require from subscribers in order to establish dependent eligibility for the state group insurance program, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Rules

CS/SB 282 (SO) by the Committee on Appropriations, Senator Rouson and others—

Mental Health and Substance Use Disorders; Providing that the use of peer specialists is an essential element of a coordinated system of care in recovery from a substance use disorder or mental illness; revising background screening requirements for certain peer specialists; requiring the Department of Children and Families to designate a managing entity with an existing certified recovery peer specialist training program to provide training for peer specialists and to give preference to trainers who are certified peer specialists; requiring peer specialists and certain persons to meet the requirements of a background screening as a condition of employment and continued employment, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Children, Families, and Elder Affairs; recommended favorably by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

SB 288 (SO) by Senator Garcia—

Electronic Dissemination of Commercial Recordings and Audiovisual Works; Revising the definition of the term "electronic dissemination", etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Commerce and Tourism; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

SB 350 (SO) by Senator Bean—

Procedures for Petitions for Utility Rate Relief; Increasing the maximum annual sales, expressed in gigawatt hours, which natural gas or public electric utilities may have to be eligible to request that the Public Service Commission use certain procedures for the utility's petition for rate relief, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Regulated Industries; recommended favorably by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably by the Committee on Appropriations

SB 352 (SO) by Senator Hooper-

Construction Liens; Revising the threshold for determining whether certain direct contracts to repair or replace an existing heating or airconditioning system are exempt from specified notice of commencement and applicability of lien requirements for authorities issuing building permits, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Regulated Industries; and reported favorably by the Committee on Rules

SB 360 (SO) by Senator Harrell-

Traveling Across County Lines to Commit a Burglary; Deleting a requirement that travel across county lines be for a specified purpose in order to reclassify a burglary offense, etc. Effective Date: 10/01/2022

Reported favorably by the Committee on Criminal Justice; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

SB 406 (SO) by Senator Berman—

Secured Transactions; Providing that a description of certain accounts and entitlements by a certain type of collateral is insufficient for the purpose of security agreements; providing retroactive application, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Finance and Tax; and reported favorably by the Committee on Appropriations

SB 434 (SO) by Senator Hooper and others—

Florida Tourism Marketing; Delaying the scheduled repeal of provisions governing the Florida Tourism Industry Marketing Corporation and the Division of Tourism Marketing of Enterprise Florida, Inc., respectively, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Commerce and Tourism; and reported favorably by the Committee on Appropriations

CS/SB 444 (SO) by the Committee on Children, Families, and Elder Affairs, Senator Perry and others—

Lewd or Lascivious Molestation; Specifying what constitutes the crime of lewd or lascivious molestation upon a person 16 years of age or older, etc. Effective Date: 10/01/2022
