### BILLS ON THIRD READING

#### **CS/CS/HB 1557, 1st Eng. (3R) by the Committees on Judiciary Committee, Education and Employment Committee, Representative Harding and others—**

**Parental Rights in Education;** Requires district school boards to adopt procedures that comport with certain provisions of law for notifying student's parent of specified information; requires such procedures to reinforce fundamental right of parents to make decisions regarding upbringing & control of their children; prohibits school district from adopting procedures or student support forms that prohibit school district personnel from notifying parent about specified information or that encourage student to withhold from parent such information; prohibits school district personnel from discouraging or prohibiting parental notification & involvement in critical decisions affecting student's mental, emotional, or physical well-being; prohibits classroom discussion about sexual orientation or gender identity in certain grade levels; requires school districts to notify parents of healthcare services; authorizes parent to bring action against school district to obtain declaratory judgment; provides for additional award of injunctive relief, damages, & reasonable attorney fees & court costs to certain parents. Effective Date: 07/01/2022

### SPECIAL ORDER CALENDAR FOR TUESDAY, MARCH 8, 2022

#### **CS/SB 342 (SO) by the Committee on Criminal Justice, Senator Perry and others—**

**Juvenile Diversion Program Expunction;** Requiring the Department of Law Enforcement to expunge the nonjudicial arrest record of certain minors who successfully complete a diversion program for specified felony offenses, rather than only for misdemeanor offenses; authorizing a minor who successfully completes a diversion program and is granted an expunction for any offense, rather than only for a first-time misdemeanor offense, to lawfully deny or fail to acknowledge certain information, etc. Effective Date: 07/01/2022

*Reported favorably as a committee substitute by the Committee on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably*

#### **CS/SB 344 (SO) by the Committee on Criminal Justice and Senator Perry—**

**Public Records/Nonjudicial Record of the Arrest of a Minor;** Providing an exemption from public records requirements for a nonjudicial record of the arrest of a minor who has successfully completed a diversion program; providing for retroactive application; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: On the same date that SB 342 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

*Reported favorably as a committee substitute by the Committee on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably*

**CS/SB 528 (SO) by the Committee on Judiciary and Senator Polsky—**

**Value of Motor Vehicles Exempt from Legal Process;** Authorizing certain natural persons to exempt a specified amount of interest in a single motor vehicle from certain legal processes, etc. Effective Date: 07/01/2022

*Reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably*

*Identical to CS/HB 265(HC) in the Committee on Rules*

---

**SB 730 (SO) by Senator Harrell and others—**

**Step-therapy Protocols;** Revising the circumstances under which step-therapy protocols may not be required; requiring health insurers to publish on their websites and provide to their insureds specified information; requiring health maintenance organizations to publish on their websites and provide to their subscribers specified information; providing requirements for procedures for requests and appeals of denials of protocol exemptions, etc. Effective Date: 07/01/2022

*Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Health Policy; and reported favorably by the Committee on Rules*

*Similar to HB 459(HC) in the Committee on Rules*

---

**SB 890 (SO) by Senator Burgess and others—**

**Telecommunicator Cardiopulmonary Resuscitation;** Requiring certain 911 public safety telecommunicators to receive ongoing telecommunicator cardiopulmonary resuscitation training; authorizing public safety agencies and certain other agencies to enter into reciprocal agreements to provide telecommunicator cardiopulmonary resuscitation under certain circumstances; providing requirements for certain employees who answer emergency medical service calls, etc. Effective Date: 07/01/2022

*Reported favorably by the Committee on Health Policy; recommended favorably by Appropriations Subcommittee on Health and Human Services; and reported favorably by the Committee on Appropriations*

*Similar to HB 593(HC) in the Committee on Appropriations*

---

**CS/SB 1066 (SO) by the Committee on Banking and Insurance, Senator Burgess and others—**

**Workers' Compensation Benefits for First Responders;** Providing that the time for specified notice in certain cases of compensable posttraumatic stress disorder is measured from the time of the qualifying event or the diagnosis of the disorder, rather than the manifestation of the disorder, whichever is later, etc. Effective Date: 07/01/2022

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Community Affairs reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

*Compare to CS/HB 689, 1st Eng.(HC) in the Committee on Appropriations*

**SB 1518 (SO) by Senator Berman and others—**

**Lactation Space;** Requiring at least one lactation space to be provided in each county courthouse; providing requirements for the lactation space; authorizing the use of state or private funds to provide lactation space in appellate courthouses, etc. Effective Date: 07/01/2022

*Reported favorably by the Committee on Governmental Oversight and Accountability; recommended favorably by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably by the Committee on Appropriations*

---

**CS/CS/SB 398 (SO) by the Committees on Appropriations, Transportation and Senator Hooper—**

**Transportation Projects;** Revising the requirement for the annual commitment of State Transportation Trust Fund revenues for public transportation projects by the Department of Transportation; providing that the department's program for innovative transportation projects may include progressive design-build contracts; revising the department's authority relating to design-build contracts; revising a dollar limit of proposed budget estimates of construction contracts for which an applying contractor may submit certain financial statements, etc. Effective Date: 07/01/2022

*Reported favorably as a committee substitute by the Committee on Transportation; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations*

---

**CS/CS/SB 1702 (SO) by the Committees on Rules, Regulated Industries, Senator Bradley and others—**

**Building Safety;** Defining the term "milestone inspection"; specifying that the purpose of a milestone inspection is not to determine compliance with the Florida Building Code or the firesafety code; requiring certain associations to periodically have a study conducted relating to required reserves after a specified date; requiring associations to provide for the maintenance, repair, and replacement of condominium property; authorizing boards to adopt a special assessment or borrow money for certain reasons without unit owner approval; revising certification and education requirements for directors of association boards, etc. Effective Date: 07/01/2022

**Cybersecurity**; Requiring the Department of Management Services, acting through the Florida Digital Service, to develop and publish guidelines and processes for reporting cybersecurity incidents; requiring state agencies to report ransomware incidents and certain cybersecurity incidents to certain entities within specified timeframes; requiring the Cybersecurity Operations Center to provide certain notifications to the Legislature within a specified timeframe; requiring state agency heads to annually provide cybersecurity awareness training to certain persons, etc. Effective Date: 07/01/2022

#### **CS/CS/SB 1694 (SO) by the Committees on Appropriations, Military and Veterans Affairs, Space, and Domestic Security and Senator Hutson—**

**Public Records and Public Meetings/Cybersecurity**; Providing an exemption from public records requirements for certain cybersecurity insurance information, critical infrastructure information, and certain cybersecurity-related information held by an agency; providing an exemption from public meetings requirements for portions of a meeting that would reveal certain cybersecurity-related information held by an agency; providing for future legislative review and repeal of the exemptions; providing a statement of public necessity, etc. Effective Date: On the same date that SB 1670 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes law

#### **CS/SB 1940 (SO) by the Committee on Environment and Natural Resources, Senator Brodeur and others—**

**Statewide Flooding and Sea Level Rise Resilience**; Establishing the Statewide Office of Resilience within the Executive Office of the Governor; providing for the appointment of a Chief Resilience Officer; requiring the Department of Transportation to develop a resilience action plan for the State Highway System; revising the projects the Department of Environmental Protection may fund within the Resilient Florida Grant Program; extending the dates by which the department must complete a comprehensive statewide flood vulnerability and sea-level rise data set and assessment; requiring the Florida Flood Hub for Applied Research and Innovation to provide tidal and storm surge flooding data to counties and municipalities for vulnerability assessments, etc. Effective Date: 07/01/2022

*Reported favorably as a committee substitute by the Committee on Environment and Natural Resources; Appropriations Subcommittee on Agriculture, Environment, and General Government recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably*

**CS/HB 3 (SO) by the Committee on Appropriations Committee, Representatives Leek, Brannan and others—**

**Law Enforcement Officer, Benefits, Recruitment, and Training;** Revises salary minimums for county sheriffs; provides for adoption benefits for law enforcements officers; creates Florida Law Enforcement Recruitment Bonus Payment Program; provides exemption from certain law enforcement officer training requirements for military veterans; provides requirements for skills training for law enforcement officers relating to officer health & safety; makes children of law enforcement officers eligible for Family Empowerment Scholarships; encourages school districts to establish public safety telecommunication training programs & offer law enforcement explorer programs; requires Board of Governors & State Board of Education to create process that enables eligible law enforcement officers or former officers to earn credit for college-level training & education acquired while serving an officer; creates Florida Law Enforcement Academy Scholarship Program; provides for reimbursement for out-of-state & special operations forces law enforcement equivalency training. Effective Date: 07/01/2022

**CS/HB 7, 2nd Eng. (SO) by the Committee on Education and Employment Committee and Representative Avila—**

**Individual Freedom;** Provides that subjecting individuals to specified concepts under certain circumstances constitutes discrimination based on race, color, sex, or national origin; revising requirements for required instruction on the history of African Americans; requiring the department to prepare and offer certain standards and curriculum; authorizing the department to seek input from a specified organization for certain purposes; prohibits instructional materials reviewers from recommending instructional materials that contain any matter that contradicts certain principles; requires DOE to review school district professional development systems for compliance with certain provisions of law. Effective Date: 07/01/2022

**HB 539 (SO) by Representative Trumbull—**

**Nursing Home Financial Reporting;** Requires nursing homes & their home offices to annually file with AHCA their audited actual experience for purposes of financial reporting. Effective Date: 07/01/2022

**CS/CS/HB 861 (SO) by the Committees on Health and Human Services Committee, Professions and Public Health Subcommittee and Representative Massullo—**

**Medical Specialty Designations;** Provides that using term designating certain medical specialty is grounds for disciplinary action; provides enforcement authority; authorizes DOH to adopt rules. Effective Date: 07/01/2022

**OGSR/Dependent Eligibility Information/DMS;** Revises provision which provides exemption from public records requirements for information held by DMS for verification of dependent eligibility; extends legislative review & repeal of public records exemption to future date; provides statement of public necessity. Effective Date: On the same date that SB 7026 or similar legislation takes effect

**CS/HB 1467, 1st Eng. (SO) by the Committee on Appropriations Committee, Representative Garrison and others—**

**K-12 Education;** Establishing term limits for school board members; deleting a requirement that district school boards maintain a specified list on their websites; requiring certain meetings relating to instructional materials to be noticed and open to the public; revising requirements for the department relating to the development of training programs for the selection of materials used in schools and library media centers; revising district school board requirements for the selection and adoption of certain materials, etc. Effective Date: 07/01/2022

**CS/HB 7049 (SO) by the Committees on State Affairs Committee, Judiciary Committee, Representatives Grall, Fine and others—**

**Legal Notices;** Revises requirements for newspapers publishing legal notices; removes option for publication on newspaper's website; provides for publication of legal notices on publicly accessible websites; authorizes governmental agency to publish legal notices on publicly accessible website; authorizes governmental agency with certain percentage of its population located within county meeting population threshold to use publicly accessible website; requires governmental agency to provide specified notice to residents & property owners relating to alternative methods of receiving notices; provides requirement for public bid advertisements made by governmental agencies on publicly accessible websites. Effective Date: 01/01/2023

**CS/CS/SB 358 (SO) by the Committees on Appropriations, Health Policy and Senator Rodriguez—**

**Mental Health Professionals;** Creating the Professional Counselors Licensure Compact; providing for recognition of the privilege to practice licensed professional counseling in member states; providing for the recognition of the practice of professional counseling through telehealth in member states; providing for the development of the data system, reporting procedures, and the exchange of specified information between member states; specifying that the compact, commission rules, and commission actions are binding on member states, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect upon enactment of the Professional Counselors Licensure Compact into law by 10 states

**Public Records and Meetings/Professional Counselors Licensure Compact;** Providing an exemption from public records requirements for certain information held by the Department of Health or the Board of Clinical Social Work, Marriage and Family Therapy, and Mental Health Counseling pursuant to the Professional Counselors Licensure Compact; providing an exemption from public meetings requirements for certain meetings or portions of certain meetings of the Counseling Compact Commission or its executive committee; providing for future legislative review and repeal of the exemptions; providing statements of public necessity, etc. Effective Date: On the same date that SB 358 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

**Managed Care Plan Performance;** Requiring managed care plans to collect and report specified measures beginning with a certain data reporting period; requiring plans to stratify reported measures by specified categories beginning with a certain data reporting period; requiring a plan's performance to be published on its website in a specified manner; requiring the Agency for Health Care Administration to use the measures to monitor plan performance, etc. Effective Date: 07/01/2022

**LOCAL BILLS CALENDAR FOR THURSDAY, MARCH 10, 2022**

**CS/HB 455 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Trabulsy—**

**Rupert J Smith Law Library, St. Lucie County;** Provides for appointment of an additional member to board of trustees. Effective Date: Upon becoming a law

---

**HB 457 (LB) by Representative Trabulsy—**

**St. Lucie County;** Provides for transfer of real property from Board of Trustees of the Internal Improvement Fund to District Board of Trustees of Indian River State College; provides requirements for the use, sale or disposition, & conveyance of property. Effective Date: Upon becoming a law or on June 1, 2022, whichever occurs earlier

---

**HB 471 (LB) by Representative Roth—**

**Town of Lake Clarke Shores, Palm Beach County;** Provides for municipal annexation of specified territory; provides boundaries, & that specified territory be considered enclave of Town of Lake Clarke Shores. Effective Date: Upon becoming a law

---

**HB 497 (LB) by Representative Persons-Mulicka and others—**

**Lee County School District, Lee County;** Repeals Lee County School Board resolution which provides for appointed superintendent of schools; provides for elected superintendent of schools & referendum. Effective Date: Upon its approval by a majority vote of the qualified electors of Lee County voting in a referendum conducted in accordance with the provisions of law relating to elections currently in force

---

**HB 535 (LB) by Representative Fine—**

**Barefoot Bay Recreation District, Brevard County;** Authorizes amendment to district charter, subject to approval by vote of electors of district, to increase length of terms & stagger election cycle for members of Board of Trustees of the Barefoot Bay Recreation District. Effective Date: Upon becoming a law

---

**CS/HB 651 (LB) by the Committee on Local Administration and Veterans Affairs Subcommittee and Representative Williamson—**

**Navarre Beach Fire Rescue District, Santa Rosa County;** Creates independent special district to provide fire control, fire prevention, emergency medical, rescue response, & public safety services; provides district boundaries; provides for governing board & for the election, organization, and operation of such board; authorizes district to levy non-ad valorem assessments; provides for amendment only by special act; provides severability & referendum. Effective Date: Upon its approval by a majority vote of those qualified electors residing within the district voting in a referendum no later than December 31, 2022

---

**HB 895 (LB) by Representative McFarland—**

**Lakewood Ranch Stewardship District, Manatee and Sarasota Counties;** Revises boundaries of district; requires referendum. Effective Date: Upon this act becoming a law



---

**HB 927 (LB) by Representative Hage—**

**Downtown Crystal River Entertainment District, Citrus County;** Designates boundaries of entertainment district within downtown area of city; authorizes DBPR to issue special licenses or modify existing licenses for bona fide licensees operating validly licensed premises within such entertainment district for sale of alcoholic beverages for consumption off premises; provides special licenses or modifications of existing licenses are in addition to other authorized temporary permits; requires bona fide licensees to comply with all other statutory requirements. Effective Date: Upon becoming a law

---

**HB 929 (LB) by Representative Silvers—**

**City of West Palm Beach, Palm Beach County;** Revises definition of "salary"; provides definition does not include certain persons in a collective bargaining agreement; provides for retroactive restoration of benefit accrual rate to 3 percent for all years of member's service within specified time period; provides eligible members receive lump-sum payment for accumulated leave payable upon retirement. Effective Date: Upon becoming a law

---

**HB 993 (LB) by Representative Tuck—**

**Sebring Airport Authority, Highlands County;** Revises powers of Authority; authorizes Authority to issue bonds secured by & payable from any legally available source, to issue bonds on unsecured basis, to pledge all legally available funds for repayment of debt, & to enter into public-private partnerships to effectuate purposes of act; revises bidding threshold; provides all debt obligations issued by authority are tax exempt to extent allowed by law. Effective Date: Upon becoming a law

---
