#### SB 156 (SO) by Senator Broxson—

**Loss Run Statements;** Specifying the entities that must receive requests for loss run statements; specifying that insurers must provide loss run statements under certain circumstances; revising the required claims history in loss run statements; providing applicability; limiting loss run statement requests with respect to group health insurance policies to group policyholders, etc. Effective Date: Upon becoming a law

#### SB 222 (SO) by Senator Gruters—

**Swimming Pool Specialty Contracting Services;** Authorizing certain persons under the supervision of specified licensed contractors to perform certain specialty contracting services for commercial or residential swimming pools, interactive water features, hot tubs, and spas; providing that such supervision does not require a direct contract between those persons, etc. Effective Date: 07/01/2022

#### SM 302 (SO) by Senator Burgess and others—

**Recognizing Veteran Suicide;** Urging Congress to recognize the epidemic of suicide among veterans and to fully fund suicide prevention efforts of the United States Department of Veterans Affairs, etc.

#### SB 312 (SO) by Senator Diaz—

**Telehealth;** Revising the definition of the term “telehealth”; narrowing the prohibition on prescribing controlled substances through telehealth to include only specified controlled substances, etc. Effective Date: 07/01/2022

*Reported favorably by the Committee on Health Policy; reported favorably by the Committee on Banking and Insurance; and reported favorably by the Committee on Rules*

#### CS/SB 254 (SO) by the Committee on Rules, Senator Brodeur and others—

**Religious Institutions;** Defining the term “religious institution”; providing that an emergency order may not directly or indirectly prohibit religious services or activities; providing an exception under certain circumstances, etc. Effective Date: 07/01/2022

*Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; and reported favorably as a committee substitute by the Committee on Rules*

#### SB 546 (SO) by Senator Gruters—

**Consumer Finance Loans;** Authorizing an applicant for a license to make and collect loans under the Florida Consumer Finance Act to provide certain documents in lieu of evidence of liquid assets; prohibiting a person licensed to make and collect consumer finance loans from charging prepayment penalties for loans; authorizing a licensee or an applicant for a license to make and collect consumer finance loans to provide a surety bond, certificate of deposit, or letter of credit in lieu of evidence of liquid assets; modifying grounds for denial of license or disciplinary action for certain violations of the Florida Consumer Finance Act, etc. Effective Date: 10/01/2022

*Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Commerce and Tourism; and reported favorably by the Committee on Rules*

**CS/SB 620 (SO) by the Committee on Appropriations and Senator Hutson—**

**Local Government;** Authorizing certain businesses to claim business damages from a county or municipality if the county or municipality enacts or amends certain ordinances or charter provisions; limiting the amount of business damages that may be recovered; authorizing businesses to recover costs and fees in a specified manner and if certain requirements are met; requiring courts to consider certain factors and follow specified guidance when assessing costs; specifying requirements for the courts in determining and awarding attorney fees, etc. Effective Date: Upon becoming a law

**CS/SB 336 (SO) by the Committee on Judiciary and Senator Berman—**

**Uniform Commercial Code;** Providing that certain restrictions on the effectiveness of terms in specified agreements and the effectiveness of certain rules of law, statutes, or regulations related to the discharge of account debtors and certain restrictions on the assignment of promissory notes, health-care-insurance receivables, and certain general intangibles, respectively, do not apply to a security interest in an ownership interest in a general partnership, a limited partnership, or a limited liability company, etc. Effective Date: 01/01/2023

**CS/CS/SB 280 (SO) by the Committees on Rules, Community Affairs and Senator Hutson—**

**Local Ordinances;** Authorizing courts to assess and award reasonable attorney fees and costs and damages in certain civil actions filed against local governments; requiring a board of county commissioners to prepare or cause to be prepared a business impact estimate before the enactment of a proposed ordinance; requiring a governing body of a municipality to prepare or cause to be prepared a business impact estimate before the enactment of a proposed ordinance, etc. Effective Date: 10/01/2022

**CS/SB 430 (SO) by the Committee on Military and Veterans Affairs, Space, and Domestic Security and Senator Wright—**

**Interstate Compact on Educational Opportunity for Military Children;** Requiring the President of the Senate and the Speaker of the House of Representatives to each appoint one member to the State Council on Interstate Educational Opportunity for Military Children, rather than appoint one member jointly; extending the scheduled repeal of the compact and related provisions, etc. Effective Date: Upon becoming a law

**SB 542 (SO) by Senator Rodriguez—**

**Evidentiary Standards for Actions Arising During an Emergency;** Defining the term “engaged individual”; prohibiting certain actions taken by a business during a public health emergency from being used as evidence in certain civil causes of action, etc. Effective Date: 07/01/2022

**Trade;** Urging Congress to expeditiously renew trade promotion authority for the executive branch, urging the executive branch to negotiate a comprehensive and mutually beneficial free trade agreement between the United States and the United Kingdom, and urging Congress to ratify such agreement, etc.

**Construction Liens;** Revising the threshold for determining whether certain direct contracts to repair or replace an existing heating or air-conditioning system are exempt from specified notice of commencement and applicability of lien requirements for authorities issuing building permits, etc. Effective Date: 07/01/2022
