# BILLS ON THE CALENDAR

## BILLS ON THIRD READING

### **SB 1438, 1st Eng. (3R) by Senator Yarborough and others—**

**Protection of Children;** Prohibiting a governmental entity from issuing a permit or otherwise authorizing a person to conduct a performance in violation of specified provisions; providing criminal penalties; authorizing the Division of Hotels and Restaurants of the Department of Business and Professional Regulation to fine, suspend, or revoke the license of any public lodging establishment or public food service establishment if the establishment admits a child to an adult live performance; specifying that the Division of Alcoholic Beverages and Tobacco of the Department of Business and Professional Regulation is given full power and authority to revoke or suspend the license of any person issued under the Beverage Law when it is determined or found by the division upon sufficient cause appearing that he or she is maintaining a licensed premises that admits a child to an adult live performance; prohibiting a person from knowingly admitting a child to an adult live performance, etc. Effective Date: Upon becoming a law

## SENATE BILLS ON SECOND READING

### **CS/SB 50 (2R) by the Committee on Governmental Oversight and Accountability and Senator Wright—**

**Public Records/Judicial Assistants;** Adding current judicial assistants and their spouses and children to the list of specified agency personnel and family members to whom an exemption from public records requirements for identification and location information applies; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2023

*Reported favorably by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Rules reports the committee substitute favorably*

### **CS/CS/CS/SB 52 (2R) by the Committee on Fiscal Policy, the Appropriations Committee on Education, the Committee on Education Pre-K -12, Senator Burgess and others—**

**Student Use of Social Media Platforms;** Requiring members of the instructional staff of public schools to provide instruction on the social, emotional, and physical effects of social media to students in specified grades; requiring that district school board codes of student conduct include a prohibition against students using wireless communications devices during instructional time and authorization for teachers to withhold a student's device, with an exception for use at the direction of the teacher; requiring each school district to prohibit and prevent students from accessing social media platforms through the use of Internet access provided by the school district, etc. Effective Date: 07/01/2023

### **CS/SB 108 (2R) by the Committee on Transportation and Senator Rodriguez—**

**Trees and Vegetation Within the Rights-of-way of Certain Roads and Rail Corridors;** Providing that the prohibition against the removal, cutting, marring, defacing, or destruction of trees or other vegetation in certain rights-of-way does not apply if the Department of Transportation suspends such prohibition pursuant to a declared state of emergency; requiring the department to publish informational guidelines regarding the removal of debris from certain emergencies, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Transportation; the Committee on Community Affairs reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

### **CS/CS/SB 154 (2R) by the Committees on Fiscal Policy, Regulated Industries, Senator Bradley and others—**

**Condominium and Cooperative Associations;** Revising the circumstances under which community association managers or management firms must comply with a specified provision; revising the definition of the terms "milestone inspection" and "substantial structural deterioration"; authorizing local enforcement agencies to make certain determinations relating to milestone inspections after a building reaches a specified age; authorizing municipal governing bodies to adopt certain ordinances relating to association repairs; revising requirements relating to the purchase of flood insurance as a condition for maintaining certain policies issued by the Citizens Property Insurance Corporation, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect upon becoming a law

### **CS/CS/SB 192 (2R) by the Committees on Environment and Natural Resources, Community Affairs, Senator Avila and others—**

**Everglades Protection Area;** Requiring that comprehensive plans and plan amendments that apply to certain lands within or near the Everglades Protection Area follow the state coordinated review process; requiring the Department of Environmental Protection, in consultation with specified entities, to make certain determinations for such plans and amendments, to provide written determinations to the local government and specified entities within a specified timeframe, and to coordinate with the local government and specified entities on certain planning strategies and mitigation measures; authorizing site-specific text changes for small-scale future land use map amendments; requiring local governments whose boundaries include any portion of the Everglades Protection Area to transmit copies of adopted small-scale development amendments to the state land planning agency within a specified timeframe, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Environment and Natural Resources; and the Committee on Rules reports the committee substitute favorably*

**CS/SB 232 (2R) by the Committee on Criminal Justice and Senator Garcia—**

**Exploitation of Vulnerable Persons;** Specifying conditions under which a person commits exploitation of a person 65 years of age or older; providing criminal penalties for violations of the act; specifying that not knowing the age of a victim is not a defense to such crime; authorizing persons who are in imminent danger of exploitation to petition for an injunction for protection; providing time limitations for commencing prosecution for violations of the act, etc. Effective Date: 10/01/2023

*Reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/CS/SB 258 (2R) by the Committees on Fiscal Policy, Governmental Oversight and Accountability and Senator Burgess—**

**Prohibited Applications on Government-issued Devices;** Requiring public employers to take certain actions relating to prohibited applications; prohibiting employees and officers of public employers from downloading or accessing prohibited applications on government-issued devices; providing exceptions; providing a deadline by which specified employees must remove, delete, or uninstall a prohibited application; requiring the Department of Management Services to compile a specified list and establish procedures for a specified waiver, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

**CS/CS/SB 264 (2R) by the Committees on Rules, Judiciary, Senator Collins and others—**

**Interests of Foreign Countries;** Prohibiting governmental entities from knowingly entering into certain contracts; authorizing the Attorney General to bring a civil action; providing penalties; requiring government entities to require an affidavit from applicants before providing any economic incentive; prohibiting foreign principals from purchasing agricultural land, or interest in such land, and certain real property in the state, respectively; authorizing foreign principals to continue to own or hold such land or property under certain circumstances, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules*

**CS/CS/SB 284 (2R) by the Committees on Finance and Tax, Governmental Oversight and Accountability and Senator Brodeur—**

**Energy;** Revising the selection criteria for purchasing or leasing vehicles for state agencies, state universities, community colleges, and local governments under a state purchasing plan; specifying that, if available, a state agency must use certain fuels in vehicles with internal combustion engines; requiring the Department of Management Services, before a specified date, to make recommendations to state agencies, state universities, community colleges, and local governments relating to the procurement and integration of electric and natural gas fuel vehicles and other vehicles powered by renewable energy, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; reported favorably as a committee substitute by the Committee on Finance and Tax; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/SB 404 (2R) by the Committee on Rules and Senator Perry—**

**Public Records/Recordings Which Depict or Record the Killing of a Minor/Autopsy Reports of Minors;** Expanding an existing exemption from public records requirements for certain photographs or video or audio recordings held by an agency to include photographs and video and audio recordings held by an agency which depict or record the killing of a minor, with exceptions; providing criminal penalties; providing for retroactive application; creating the "Rex and Brody Act"; creating an exemption from public records requirements for autopsy reports of minors whose deaths were related to acts of domestic violence; providing for future legislative review and repeal of the exemption; providing statements of public necessity, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Children, Families, and Elder Affairs; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Rules*

**CS/SB 478 (2R) by the Appropriations Committee on Education and Senator Perry—**

**Early Childhood Music Education Incentive Program;** Renaming the Early Childhood Music Education Incentive Pilot Program as the Early Childhood Music Education Incentive Program; revising criteria for a school district's eligibility to participate in the program; deleting an obsolete provision requiring the University of Florida's College of Education to conduct a specified evaluation, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Education Pre-K -12; reported favorably as a committee substitute by the Appropriations Committee on Education; and the Committee on Appropriations reports the committee substitute favorably*

**CS/SB 664 (2R) by the Committee on Children, Families, and Elder Affairs and Senator Burgess—**

**Contracts Entered into by the Department of Children and Families;** Revising requirements for contracts between the department and lead agencies, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*
