#### **CS/CS/CS/SB 280 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice and Senator Brodeur—**

**Controlled Substances;** Revising the elements that constitute the capital offense of murder in the first degree; revising the elements that constitute the offense of murder in the third degree and constitute a felony of the second degree; providing criminal penalties for adults who unlawfully distribute specified substances or mixtures and an injury or overdose of the user results; providing enhanced criminal penalties for repeat offenders, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

#### **CS/SB 366 (SO) by the Committee on Military and Veterans Affairs, Space, and Domestic Security, Senator Burgess and others—**

**Dental Services for Indigent Veterans;** Establishing the Veterans Dental Care Grant Program within the Department of Veterans' Affairs; requiring the department to contract with a direct-support organization to administer the program; requiring the department to use a specified standard for determining indigency, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Military and Veterans Affairs, Space, and Domestic Security; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably*

#### **CS/SB 398 (SO) by the Committee on Judiciary and Senator Rodriguez—**

**Limitation of Actions Involving Real Estate Appraisers and Appraisal Management Companies;** Defining terms; specifying statutes of limitations periods for certain actions involving real estate appraisers and appraisal management companies, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably*

*Identical to **CS/CS/HB 213(HC)** in the Committee on Rules*

#### **CS/CS/SB 452 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Health and Human Services, Senator Harrell and others—**

**Home Health Aides for Medically Fragile Children;** Requiring home health agencies to ensure that any delegation of tasks to home health aides for medically fragile children meets specified requirements; establishing the home health aides for medically fragile children program for specified purposes; requiring the Agency for Health Care Administration, in consultation with the Board of Nursing, to approve training programs for home health aides for medically fragile children; authorizing home health aides for medically fragile children to administer certain medications under certain circumstances, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

**CS/SB 496 (SO) by the Committee on Criminal Justice and Senator Burgess—**

**Electronic Monitoring of Persons Charged with or Convicted of Offenses Involving Schools or Students;** Requiring a court to consider electronic monitoring and location restrictions as conditions of pretrial release for persons charged with certain offenses against schools or students; requiring a court to consider electronic monitoring and location restrictions as conditions of probation or community control for persons charged with certain offenses against schools or students, etc. Effective Date: 10/01/2023

*Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

*Identical to **CS/HB 329(HC)** in the Committee on Rules*

**CS/CS/SB 504 (SO) by the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice, Senator Rodriguez and others—**

**Expunction of Criminal History Records;** Revising an eligibility criterion under which a person is eligible to petition a court to expunge a criminal history record if an indictment, information, or other charging document was dismissed by a court; expanding an exception to an eligibility requirement for expunction of a criminal history record to allow a prior expunction of a criminal history record granted for an offense committed when the person was a minor, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Fiscal Policy reports the committee substitute favorably*

**SB 514 (SO) by Senator Hooper and others—**

**Private Instructional Personnel;** Revising the definition of the term "private instructional personnel" to include registered behavioral technicians employed by certain providers, etc. Effective Date: 07/01/2023

*Reported favorably by the Committee on Education Pre-K -12; reported favorably by the Committee on Health Policy; and reported favorably by the Committee on Rules*

*Identical to **HB 795(HC)** in the Committee on Rules*

---

**SB 568 (SO) by Senator Rodriguez and others—**

**Assault or Battery on Hospital Personnel;** Providing enhanced criminal penalties for persons who knowingly commit assault or battery upon hospital personnel, etc. Effective Date: 10/01/2023

*Reported favorably by the Committee on Criminal Justice; reported favorably by the Committee on Health Policy; and reported favorably by the Committee on Rules*

*Similar to **HB 825(HC)** in the Committee on Rules*

---

**CS/CS/CS/SB 1250 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Transportation, Tourism, and Economic Development, the Committee on Transportation and Senator DiCeglie—**

**Department of Transportation;** Increasing the maximum amount of debt service coverage that must be transferred from the State Transportation Trust Fund to the Right-of-Way Acquisition and Bridge Construction Trust Fund; authorizing the department to provide up to 100 percent of project costs for certain eligible projects in rural areas of opportunity; authorizing installation of an automated license plate recognition system within the right-of-way of any road on the State Highway System for a specified purpose; prohibiting use of an automated license plate recognition system to issue a notice of violation or a traffic citation, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2023

**CS/CS/SB 620 (SO) by the Committees on Governmental Oversight and Accountability, Ethics and Elections, Senator DiCeglie and others—**

**Ethics Requirements for Officers and Employees of Special Tax Districts;** Specifying that certain conduct by certain public officers and employees is deemed a conflict of interest; requiring certain ethics training for elected local officers of independent special districts, beginning on a specified date, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Ethics and Elections; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Rules reports the committee substitute favorably*

**CS/SB 704 (SO) by the Committee on Fiscal Policy and Senator Boyd—**

**Opioid Abatement;** Revising the types of delivery systems a pharmacist may order or use to dispense an emergency opioid antagonist; establishing the Statewide Council on Opioid Abatement within the Department of Children and Families, etc. Effective Date: 07/01/2023

*Reported favorably by the Committee on Health Policy; reported favorably by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

**CS/CS/CS/SB 712 (SO) by the Committees on Rules, Commerce and Tourism, Transportation, Senator Avila and others—**

**Motor Vehicle Sales;** Prohibiting an applicant or a licensee from certain actions in the allocation or distribution of motor vehicles to franchised motor vehicle dealers; prohibiting applicants and licensees from engaging in certain activities; revising provisions prohibiting specified entities from owning, operating, or controlling a motor vehicle dealership in this state; requiring the Department of Highway Safety and Motor Vehicles to conduct an inquiry relating to certain written complaints, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Rules*

Similar to **CS/CS/HB 637(HC)** in the Committee on Rules

**CS/SB 858 (SO) by the Committee on Health Policy, Senator Torres and others—**

**Benefits, Training, and Employment for Veterans and their Spouses;** Requiring the Economic Development Programs Evaluation to include a periodic analysis of the Veterans Employment and Training Services Program; revising the duties of the Department of Veterans' Affairs and Florida Is For Veterans, Inc., respectively, to include the provision of certain assistance to veterans' spouses; requiring the Department of Health to waive certain fees for veterans and their spouses under certain circumstances; establishing the Office of Veteran Licensure Services within the Division of Medical Quality Assurance, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Health Policy; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/SB 1320 (SO) by the Committee on Education Pre-K -12, Senator Yarborough and others—**

**Child Protection in Public Schools;** Defining the term "sex"; prohibiting an employee, contractor, or student of a public school from being required to refer to a person using personal titles or pronouns that do not correspond with that person's sex; prohibiting classroom instruction by school personnel on sexual orientation or gender identity until grade 9; providing that such prohibition applies to charter schools; providing that materials used to teach reproductive health or any disease as part of certain courses must be approved by the Department of Education; requiring district school boards to adopt and publish a specified process relating to student access to certain materials, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Education Pre-K -12; and the Committee on Fiscal Policy reports the committee substitute favorably*

Similar to **CS/CS/HB 1069(HC)** in the Committee on Fiscal Policy

---

**CS/SB 958 (SO) by the Committee on Education Postsecondary and Senator Perry—**

**Postsecondary Educational Institutions;** Requiring the Board of Governors of the State University System to establish a Committee on Public Policy Events; requiring offices to report to specified state university offices; prohibiting public institutions of higher education from requiring the completion of a political loyalty test or for persons to meet certain qualifications; designating the Florida Student Association as the nonprofit advocacy organization for students of the State University System; requiring the board of directors to adopt certain bylaws, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Education Postsecondary; the Appropriations Committee on Education reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

Similar to **CS/CS/HB 931(HC)** in the Committee on Fiscal Policy

---

**CS/SB 988 (SO) by the Committee on Health Policy, Senator Burton and others—**

**Medicaid Coverage of Continuous Glucose Monitors;** Requiring the Agency for Health Care Administration, subject to the availability of funds and certain limitations and directions, to provide coverage for continuous glucose monitors for certain Medicaid recipients; providing requirements for Medicaid recipients to continue receiving coverage for their continuous glucose monitors; requiring the agency to include the rate impact of the act in certain rates that become effective on a specified date, etc. Effective Date: 10/01/2023

*Reported favorably as a committee substitute by the Committee on Health Policy; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

Identical to **CS/HB 967(HC)** in the Committee on Fiscal Policy

---

**CS/SB 998 (SO) by the Committee on Criminal Justice, Senator Burgess and others—**

**Chiefs of Police;** Providing rights of chiefs of police; requiring an aggrieved chief of police to provide his or her employing agency with a certain written notice within a specified timeframe; requiring an employing agency to cure an alleged violation within a specified timeframe, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Criminal Justice; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

Compare to **CS/CS/HB 935(HC)** in the Committee on Rules

---

**CS/SB 1056 (SO) by the Appropriations Committee on Agriculture, Environment, and General Government and Senator Gruters—**

**Dosage Form Animal Health Products;** Defining the term “dosage formula animal product”; providing an exception from guaranteed analysis requirements for products sold solely as dosage form animal products; providing labeling requirements for dosage form animal products, etc. Effective Date: 10/01/2023

*Reported favorably by the Committee on Agriculture; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and the Committee on Fiscal Policy reports the committee substitute favorably*

*Identical to **CS/HB 959(HC)** in the Committee on Fiscal Policy*

---

**CS/SB 1082 (SO) by the Committee on Rules and Senator DiCeglie—**

**Vessels;** Authorizing counties and municipalities to establish slow speed, minimum wake boating-restricted areas within a specified distance from certain sewage pumpout facilities at public or private nonresidential marinas within certain portions of the Florida Intracoastal Waterway; removing a provision authorizing local governments to require permitting for certain floating vessel platforms; revising conditions under which local governments may require one-time registrations of floating vessel platforms, etc. Effective Date: 07/01/2023

*Reported favorably by the Committee on Environment and Natural Resources; reported favorably by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules*

*Similar to **CS/CS/HB 847(HC)** in the Committee on Rules*

---

**CS/CS/SB 1098 (SO) by the Committees on Children, Families, and Elder Affairs, Judiciary and Senator Burton—**

**Withholding or Withdrawal of Life-prolonging Procedures;** Authorizing a court to delegate the right to consent to the withholding or withdrawal of life-prolonging procedures of incapacitated persons in certain circumstances; requiring that initial and annual guardianship plans, respectively, state whether any power under the ward’s preexisting order not to resuscitate or advance directive is revoked, modified, suspended, or transferred to the guardian; authorizing a guardian to petition a court for approval to consent to withhold or withdraw life-prolonging procedures under certain circumstances, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and the Committee on Rules reports the committee substitute favorably*

*Similar to **CS/CS/HB 1119(HC)** in the Committee on Rules*

---

**CS/CS/SB 1114 (SO) by the Committees on Fiscal Policy, Regulated Industries and Senator Rodriguez—**

**Homeowners’ Associations;** Citing this act as the “Homeowners’ Associations Bill of Rights”; requiring that notices for board meetings specifically identify agenda items; requiring an association to maintain designated addresses as official records; providing civil penalties for certain actions by officers, directors, or managers of an association; revising the circumstances under which a director or an officer must be removed from office after being charged by information or indictment; restricting certain attorney fees and fines; specifying the types of violations for which an association may levy fines, etc. Effective Date: 10/01/2023

*Reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

*Similar to **CS/CS/HB 919, 1st Eng.(HC)** in the Committee on Fiscal Policy*

---

**CS/SB 1236 (SO) by the Committee on Education Pre-K -12 and Senator Wright—**

**K-12 Education;** Deleting a specified reduction calculation for certain school district funding for school districts that fail to meet certain class size requirements; providing that certain dependent children of active duty military personnel must be enrolled in certain programs; authorizing certain students of military personnel to enroll in any school within this state under certain circumstances, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Education Pre-K -12; the Appropriations Committee on Education reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

*Identical to **CS/CS/HB 633(HC)** in the Committee on Fiscal Policy*

---

**CS/CS/SB 1262 (SO) by the Appropriations Committee on Agriculture, Environment, and General Government, the Committee on Regulated Industries and Senator Martin—**

**Issuance of Special Beverage Licenses;** Revising requirements relating to the issuance of special food service licenses and certain club licenses, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and the Committee on Fiscal Policy reports the committee substitute favorably*

---

**SB 7056 (SO) by the Appropriations Committee on Health and Human Services (Harrell)—**

**Child Protective Investigative Services;** Repealing provisions relating to sheriffs of certain counties providing child protective investigative services; requiring certain sheriffs to transfer the functions of providing child protective investigative services to the Department of Children and Families; providing that certain sheriffs remain the custodians of certain files and documents; authorizing the department and certain sheriffs to enter into an agreement to allow certain employees to remain in office space owned or leased by the sheriff for a specified time, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect January 1, 2024

*Similar to **HB 7061(HC)** in the Committee on Fiscal Policy*

---

**CS/CS/SB 1308 (SO) by the Committees on Rules, Commerce and Tourism, Senator Yarborough and others—**

**Telephone Solicitation;** Prohibiting certain telephonic sales calls; providing conditions under which civil actions may be brought for text message solicitations, etc. Effective Date: Upon becoming a law

*Reported favorably as a committee substitute by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Rules*

*Similar to **CS/CS/HB 761, 1st Eng.(HC)** in the Committee on Rules*

---

**CS/SB 1674 (SO) by the Committee on Fiscal Policy, Senator Grall and others—**

**Facility Requirements Based on Sex;** Creating the “Safety in Private Spaces Act”; requiring certain entities that maintain water closets or changing facilities to meet specified requirements; authorizing persons to enter a restroom or changing facility designated for the opposite sex only under certain circumstances; providing that specified persons who enter certain restrooms or changing facilities and refuse to depart when asked to do so commit the criminal offense of trespass, etc. Effective Date: 07/01/2023

*Reported favorably by the Committee on Rules; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

*Compare to **CS/HB 1521(HC)** in the Committee on Fiscal Policy*

---

**CS/SB 1412 (SO) by the Committee on Children, Families, and Elder Affairs, Senator Bradley and others—**

**Mental Health;** Authorizing the Department of Children and Families to issue a conditional designation for up to a certain number of days to allow the implementation of certain corrective measures by receiving facilities, treatment facilities, and receiving systems; requiring the sheriff to administer or to permit the department to administer the appropriate psychotropic medication to forensic clients before admission to a state mental health treatment facility; revising what an expert is required to specifically report on for recommended treatment for a defendant to attain competence to proceed, if the expert finds that a defendant is incompetent to proceed; revising the circumstances under which every defendant who is charged with a felony and who is adjudicated incompetent to proceed may be involuntarily committed for treatment upon specified findings by the court, etc. Effective Date: 07/01/2023

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/CS/SB 1430 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Education and Senator Avila—**

**Education;** Requiring school districts to annually review and confirm that specified information is accurate and up to date; creating the Year-round School Pilot Program for a period of 4 school years beginning with a specified school year; requiring the Commission for Independent Education to annually prepare an accountability report by a specified date; providing requirements for searches of students’ personal belongings; requiring dual enrollment courses to be age and developmentally appropriate; authorizing students to use a combination of volunteer service hours and paid work hours to meet certain program eligibility requirements, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2023
