Education; Defines "sex" for Florida Early Learning-20 Education Code; provides requirements relating to titles & pronouns; revises provisions relating to instruction & materials for specified instruction relating to reproductive health; provides additional requirements for instruction regarding human sexuality; provides district school boards are responsible for materials used in classroom libraries; revises provisions relating to objections of certain materials & process related to such objections; revises school principal, school district & district school board duties & responsibilities relating to certain materials & processes. Effective Date: 07/01/2023

Facility Requirements Based on Sex; Provides requirements for exclusive use of restrooms & changing facilities by gender; prohibits willfully entering restroom or changing facility designated for opposite sex & refusing to depart when asked to do so; provides requirements for exclusive use of domestic violence centers by gender; provides requirements for correctional institutions; requires entities that receive state licenses to submit compliance documentation; authorizes AG to bring enforcement actions provides exception for individuals born with certain genetically or biochemically verifiable disorder of sex development. Provider Accountability; Revising the rights of residents of nursing home facilities; providing additional disqualifying offenses for purposes of background screening of employees of certain health care providers; creating a cause of action for ex parte injunctive relief against continued unlicensed activity relating to health care provider facilities; authorizing the Agency for Health Care Administration to petition the court for such injunctive relief; providing for ex parte temporary injunctive relief under certain circumstances, etc. Effective Date: 07/01/2023

Department of Health; Prohibiting certain research in this state relating to enhanced potential pandemic pathogens; prohibiting medical marijuana treatment centers from producing marijuana products that are attractive to children or manufactured in specified manners; requiring local registrars to electronically file all live birth, death, and fetal death records in their respective jurisdictions in the department's electronic registration system; revising the types of health care practitioners who may make certain determinations of death; extending the timeframe for the confidentiality of certain birth records; requiring that hearing aids provided to persons younger than 18 years of age be prescription hearing aids and not over-the-counter hearing aids, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2023

Florida Kidcare Program Eligibility; Increasing the income eligibility threshold for coverage under the Medikids program component; increasing the income eligibility threshold for coverage under the Florida Kidcare program; requiring an applicant seeking coverage under the program to provide certain documentation if eligibility cannot be verified using reliable data sources; requiring that premiums for certain enrollees under the Florida Kidcare program be based on a tiered system of uniform premiums, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect upon becoming a law

Education of Dependents of Deceased or Disabled Servicemembers, Prisoners of War, and Persons Missing in Action; Revises eligibility requirements for educational benefits provided by state to spouse or dependent child of deceased or disabled servicemember; revises eligibility requirements for educational benefits provided by state to dependent child of prisoner of war, person missing in action, or deceased or disabled servicemember who participated in certain military operations. Effective Date: 07/01/2023

Reported favorably by the Committee on Fiscal Policy

CS/SB 430 (SO) by the Committee on Governmental Oversight and Accountability and Senator Powell—

Abandoned and Historic Cemeteries; Creating the Historic Cemeteries Program within the Division of Historical Resources of the Department of State; designating the State Historic Preservation Officer as the program's director and requiring him or her to hire employees, subject to legislative appropriation; creating the Historic Cemeteries Program Advisory Council within the division; revising the definition of the term "conservation easement" to include a right or interest in real property which is appropriate to retaining the structural integrity or physical appearance of certain cemeteries, etc. Effective Date: 07/01/2023

CS/CS/SB 490 (SO) by the Committees on Appropriations, Commerce and Tourism, Senator Jones and others—

Deceased Individuals; Citing this act as "Curtis' Law"; requiring law enforcement agencies to provide certain information during the investigation of the death of a minor; providing an exception, etc. Effective Date: 07/01/2023

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; the Committee on Criminal Justice reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to CS/CS/HB 233, 1st Eng.(HC) in the Committee on Appropriations

CS/SB 996 (SO) by the Committee on Transportation and Senator Berman—

Driver License, Identification Card, and Motor Vehicle Registration Applications; Requiring that the motor vehicle registration form and registration renewal form and the driver license or identification card application form, respectively, include an option to make a voluntary contribution to Best Buddies International, etc. Effective Date: 10/01/2023

Reported favorably as a committee substitute by the Committee on Transportation; the Appropriations Committee on Transportation, Tourism, and Economic Development reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Identical to CS/HB 965(HC) in the Committee on Fiscal Policy

SB 1424 (SO) by Senator Calatayud—

Student Outcomes; Revising the responsibilities of the Just Read, Florida! Office; providing that a charter school application must include certain reading instructional strategies; providing that district school board instructional materials must include certain reading instructional strategies; revising requirements for an individualized progress monitoring plan; requiring a school district to evaluate the students at the end of each grading period for a mathematics deficiency; revising training requirements for reading coaches, classroom teachers, and school administrators to include certain instructional strategies, etc. Effective Date: 07/01/2023

Reported favorably by the Committee on Education Pre-K -12; reported favorably by the Appropriations Committee on Education; and reported favorably by the Committee on Fiscal Policy

Real Property Fraud; Requiring the clerk of the circuit court to create, maintain, and operate an opt-in recording notification service; requiring such clerk to ensure that registration for such service is possible through an electronic registration portal; clarifying that an action may be brought under ch. 65, F.S., to quiet title after a fraudulent attempted conveyance; requiring the court to quiet title and award certain title and rights under certain circumstances; requiring a real estate licensee to send a fraud prevention notice under specified circumstances, etc. Effective Date: 07/01/2023

Reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably

SB 1564 (SO) by Senator Stewart—

Year-round School Pilot Program; Creating the Year-round School Pilot Program for a period of 4 school years beginning with a specified school year; providing an application process for school districts seeking to participate in the program; requiring the Commissioner of Education to select a certain number of school districts to participate in the program; providing requirements for participating school districts, etc. Effective Date: 07/01/2023

Reported favorably by the Committee on Education Pre-K -12; reported favorably by the Appropriations Committee on Education; and reported favorably by the Committee on Fiscal Policy

Commercial Financing Transaction Brokers and Providers; Designating the "Florida Commercial Financing Disclosure Law"; requiring providers that consummate commercial financing transactions to provide specified written disclosures; authorizing providers to provide specified required disclosures when consummating a commercial financing facility based on an example of a transaction; prohibiting brokers from taking specified actions, etc. Effective Date: 07/01/2023

Ratification of Rules of the Department of Environmental Protection; Ratifying specified rules relating to standards for onsite sewage treatment and disposal systems and for domestic wastewater facility planning for facilities expansion, collection/transmission systems, and an operation and maintenance manual for the sole and exclusive purpose of satisfying any condition on effectiveness pursuant to s. 120.541(3), F.S., which requires ratification of any rule exceeding the specified thresholds for likely adverse impact or increase in regulatory costs, etc. Effective Date: Upon becoming a law

OGSR/Security or Firesafety System Plans; Amending a provision which provides an exemption from public records requirements for certain security or firesafety system plans; revising legislative intent; amending a provision which provides an exemption from public meeting requirements for the portion of a meeting that would reveal a security or firesafety system plan or portion thereof; removing the scheduled repeal of the exemption, etc. Effective Date: 10/01/2023

SB 7046 (SO) by the Committee on Regulated Industries (Gruters)—

Licensing Fee Relief; Requiring the Department of Business and Professional Regulation to waive a portion of the initial license application fee and the renewal fee for certain licenses; providing a maximum waiver; providing for expiration; providing an appropriation; providing for the disposition of any unexpended balance etc. Effective Date: 07/01/2023

Reported favorably by the Committee on Appropriations

CS/SB 7048 (SO) by the Committees on Rules, and Military and Veterans Affairs, Space, and Domestic Security (Wright)—

Space Florida; Requiring the Secretary of Economic Opportunity to serve as the manager for the state with respect to contracts with Space Florida; requiring the Office of Economic and Demographic Research and the Office of Program Policy Analysis and Government Accountability to provide to the Governor and the Legislature an analysis of Space Florida; requiring the Department of Economic Opportunity to annually submit a proposed operating budget by a specified date; revising membership of the board of directors of Space Florida; providing that open meeting and public records laws apply to Space Florida and its board of directors, etc. Effective Date: 07/01/2023

Reported favorably as a committee substitute by the Committee on Rules

CS/SB 7062 (SO) by the Committees on Appropriations, and Finance and Tax (Ingoglia)—

Taxation; Requiring that a referendum to reenact an expiring tourist impact tax be held at a general election; specifying that certain permanently and totally disabled veterans or their surviving spouses are entitled to, rather than may receive, a prorated refund of ad valorem taxes paid under certain circumstances; revising requirements for applying for property tax refunds due to catastrophic events; providing a sales tax exemption for the purchase of certain equipment necessary for the storage of electrical energy; exempting from sales and use tax the retail sale of certain clothing, wallets, bags, school supplies, learning aids and jigsaw puzzles, and personal computers and personal computer-related accessories during specified timeframes; exempting from sales and use tax specified disaster preparedness supplies during a specified timeframe, etc. Effective Date: Except as otherwise provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2023

Telehealth Practice Standards; Revising the definition of the term "telehealth", etc. Effective Date: 07/01/2023

CS/SB 622 (SO) by the Committee on Banking and Insurance and Senator Yarborough—

Continuing Care Contracts; Revising a requirement for specified information that must be submitted by a provider applying for expansion of a certificated continuing care facility; revising financial institutions in which escrow accounts must be established; revising the timeframe during which the office may exempt certain providers from certain regulatory actions; providing that certain documents relating to a provider's debt service reserve must require certain notice to the office before the withdrawal of debt service reserve funds; specifying the authority of residents' councils and the eligibility of persons to participate in residents' council matters, etc. Effective Date: 07/01/2023

Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

CS/CS/CS/HB 1343, 1st Eng. (SO) by the Committees on Infrastructure Strategies Committee, Ways & Means Committee, Agriculture, Conservation & Resiliency Subcommittee, Representatives Tuck, Truenow and others—

Agricultural Lands; Prohibits counties from levying specified special assessments on lands classified as agricultural; provides exception; authorizes construction or installation of housing for agricultural employees on certain lands; provides requirements for such housing; exempts such housing from certain local government approval; prohibits county or municipality from requiring removal or relinquishment of agricultural land classification for certain lands; requires landowners to provide county or municipality with certain written notice regarding such lands. Effective Date: 07/01/2023

Charter School Capital Outlay Funding; Revising charter school eligibility requirements; providing school district requirements for the distribution of capital outlay funds to eligible charter schools; requiring that any purchase, lease-purchase, or lease be at the appraised value, etc. Effective Date: 07/01/2023

SB 1112 (SO) by Senator Burgess and others—

Middle School and High School Start Times; Providing requirements for middle school and high school start times; requiring such school start times to be implemented by a specified date; providing district school board requirements, etc. Effective Date: 07/01/2023

Reported favorably by the Committee on Education Pre-K -12; reported favorably by the Appropriations Committee on Education; and reported favorably by the Committee on Fiscal Policy

Similar to CS/HB 733(HC) in the Committee on Fiscal Policy

CS/CS/SB 1252 (SO) by the Committees on Fiscal Policy, Transportation and Senator DiCeglie—

Department of Highway Safety and Motor Vehicles; Requiring the department or its authorized agent to issue certain licenses and fuel tax decals; providing that a certain affidavit constitutes proof of ownership and right of possession to a motor vehicle or mobile home the previous owner of which died testate; authorizing permanent registration of certain rental trucks; authorizing a uniform paper or electronic format of the registration certificate for a motor vehicle; requiring that certain information on the driver license or identification card of a sexual offender or sexual predator be printed in red; requiring the department to record in the driver's record that he or she is disqualified from operating a commercial motor vehicle under certain circumstances, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2023

Reported favorably as a committee substitute by the Committee on Transportation; the Appropriations Committee on Transportation, Tourism, and Economic Development reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/CS/HB 1085, 1st Eng.(HC) in the Committee on Fiscal Policy

CS/CS/SB 1084 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Health and Human Services and Senator Trumbull—

Pilot Program for Individuals with Developmental Disabilities; Requiring the Agency for Health Care Administration to implement a pilot program for individuals with developmental disabilities residing in specified Statewide Medicaid Managed Care regions to provide coverage of comprehensive services; authorizing the agency to seek federal approval as needed to implement the program; providing that participation in the pilot program is voluntary and subject to specific appropriation; requiring the Agency for Persons with Disabilities to approve a needs assessment methodology for prospective enrollees, etc. Effective Date: Upon becoming a law
