CS/SB 7044 (SO) by the Committees on Rules, and Regulated Industries (Gruters)—

Homeowners' Associations; Providing requirements for certain community association managers and community association management firms; prohibiting the Regulatory Council of Community Association Managers from requiring more than a specified number of hours of continuing education annually for license renewal; requiring an association to maintain certain documents for a specified timeframe; prohibiting an association and its officers, directors, employees, and agents from using a debit card issued in the name of the association; providing criminal penalties for certain violations related to fraudulent voting activity related to association elections, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Rules

SB 1712 (SO) by Senator Collins and others—

Peer Support for First Responders; Revising the definition of the term "first responder" to include correctional officers and correctional probation officers for the provision of peer support, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Governmental Oversight and Accountability; reported favorably by the Committee on Criminal Justice; and reported favorably by the Committee on Rules

*Similar to **CS/HB 1415(HC)** in the Committee on Rules*

CS/CS/CS/SB 1662 (SO) by the Committee on Appropriations, the Appropriations Committee on Agriculture, Environment, and General Government, the Committee on Governmental Oversight and Accountability and Senator Collins—

Cybersecurity; Providing that certain firms are disqualified from being awarded specified state contracts if certain conditions exist; providing that the Florida Center for Cybersecurity may also be referred to as "Cyber Florida"; providing that the center is established under the direction of the president of the University of South Florida, or his or her designee; requiring the Department of Management Services to contract with an independent verification and validation provider for specified services for all agency staff and vendor work to implement the enterprise cybersecurity resiliency program, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1628 (SO) by the Committees on Fiscal Policy, Community Affairs and Senator Collins—

Local Government Actions; Revising applicability provisions for the enactment or adoption of county and municipal ordinances, respectively, etc. Effective Date: 10/01/2024

Reported favorably as a committee substitute by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/SB 1604 (SO) by the Committees on Fiscal Policy, Criminal Justice and Senator Book—

Digital Voyeurism; Redesignating the offense of “video voyeurism” as “digital voyeurism”; providing reduced criminal penalties for certain violations by persons who are under 19 years of age; redesignating the offense of “video voyeurism dissemination” as “digital voyeurism dissemination”, etc. Effective Date: 10/01/2024

Reported favorably as a committee substitute by the Committee on Criminal Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 1600 (SO) by the Committee on Fiscal Policy and Senator Collins—

Interstate Mobility; Requiring the respective boards of occupations, or the Department of Business and Professional Regulation if there is no board, to allow licensure by endorsement if applicant meets certain criteria; requiring applicants of professions that require fingerprints for criminal history checks to submit such fingerprints before the board or department issues a license by endorsement; requiring the department, and authorizing the board, as applicable, to review the results of the criminal history checks according to specified criteria to determine if the applicants meet the requirements for licensure; designating the “Mobile Opportunity by Interstate Licensure Endorsement Act” or the “MOBILE Act”, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Health Policy; reported favorably by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/CS/SB 1582 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Health and Human Services, the Committee on Health Policy and Senator Rodriguez—

Department of Health; Exempting environmental health technicians from certain certification requirements under certain circumstances; creating the Andrew John Anderson Pediatric Rare Disease Grant Program within the department for a specified purpose; providing that any health care practitioner present at a birth or responsible for primary care during the neonatal period has the primary responsibility of administering certain screenings; revising hearing loss screening requirements to include infants and toddlers; requiring the department to grant certain applicants 90 days to cure deficiencies with their medical marijuana treatment center license applications pursuant to a specified errors and omissions process, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2024

CS/CS/SB 1352 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice and Senator Bradley—

Juvenile Justice; Authorizing certain employees of Department of Juvenile Justice and contracted providers to possess and administer opioid antagonists; replacing the term “gender-specific” with “sex-specific”; providing that juvenile assessment centers are not facilities that are permitted to receive certain children; revising requirements for certain State Board of Education rules to establish policies and standards for certain education programs; deleting provisions related to requiring residential juvenile justice education programs to provide certain CAPE courses, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/SB 1316 (SO) by the Committees on Rules, Judiciary and Senator Berman—

Florida Uniform Fiduciary Income and Principal Act; Specifying the duties of a fiduciary; providing that a fiduciary’s allocation, determination, or exercise of discretion is presumed to be fair and reasonable to all beneficiaries; authorizing a fiduciary to exercise discretionary power of administration under specified circumstances; prohibiting a court from ordering a fiduciary to change his or her decision unless the decision was an abuse of discretionary power; authorizing a fiduciary to adjust between income and principal if such adjustment assists in administering the trust or estate impartially; authorizing the conversion of an income trust to a unitrust; specifying the authority of a fiduciary with respect to the administration of certain trusts, etc. Effective Date: 01/01/2025

CS/SB 1230 (SO) by the Appropriations Committee on Criminal and Civil Justice and Senator Bradley—

Sexual Predators and Sexual Offenders; Revising the definitions of the terms “conviction,” “permanent residence,” “temporary residence,” and “transient residence”; specifying that, in order to qualify for removal of certain registration requirements, certain sexual offenders must meet specified criteria; authorizing sexual predators to report to the Department of Law Enforcement through the department’s online system within a specified timeframe required vehicle information changes after any change in vehicles owned, etc. Effective Date: 10/01/2024

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Fiscal Policy reports the committee substitute favorably

CS/SB 1128 (SO) by the Committee on Education Postsecondary and Senator Martin—

University Carry Forward Balances; Authorizing a university to retain and report a reserve balance exceeding a specified amount; authorizing a university's carry forward spending plan to include a reserve fund to be used for authorized expenses, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Education Postsecondary; the Appropriations Committee on Education reports the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

CS/SB 1064 (SO) by the Committee on Banking and Insurance and Senator Powell—

Wills and Estates; Expanding the types of probate documents that must be recorded; specifying that certain property is either included or excluded from the probate estate at the time of death; defining the term "probate estate"; providing that demands and disputes arising under a certain act must be determined using a specified action; providing that certain rights are forfeited if specified actions are not taken, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect upon becoming a law

Reported favorably by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Banking and Insurance; and the Committee on Rules reports the committee substitute favorably

Reclassification of Criminal Penalties; Requiring reclassification of the penalty for the commission of a felony committed by a person who has a previous specified conviction; defining the term "transnational crime organization"; authorizing reclassification of the penalty for any misdemeanor or felony offense if the commission of such offense was for specified purposes, etc. Effective Date: 10/01/2024

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 1014 (SO) by the Committee on Governmental Oversight and Accountability and Senator Perry—

Public Records/State Banks and State Trust Companies; Providing an exemption from public records requirements for certain information received by the Office of Financial Regulation relating to an application for authority to organize a new state bank or new state trust company; providing an exemption from public records requirements for certain information received by the office relating to an application for authority to organize a new state bank or new state trust company until specified conditions are met; providing for future legislative review and repeal of the exemptions; providing a statement of public necessity, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Rules reports the committee substitute favorably

CS/SB 576 (SO) by the Committee on Community Affairs and Senator Ingoglia—

Law Enforcement and Correctional Officers; Authorizing county sheriffs to establish civilian oversight boards to review the policies and procedures of the sheriff's office and its subdivisions; revising the definition of "political subdivision"; prohibiting a political subdivision from adopting or attempting to enforce certain ordinances relating to the receipt, processing, or investigation of complaints against law enforcement officers or correctional officers, or relating to civilian oversight of law enforcement agency investigations of complaints of misconduct by such officers; authorizing the chief of a municipal police department to establish a civilian oversight board to review the policies and procedures of the chief's department and its subdivisions, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Rules reports the committee substitute favorably

CS/SB 1764 (SO) by the Committee on Transportation, Senator Pizzo and others—

Car Racing Penalties; Increasing the maximum fine for violations of the prohibitions against drag racing, street takeovers, stunt driving, competitions, contests, tests, or exhibitions; revising applicability of the penalty for second violations of prohibitions against drag racing, street takeovers, stunt driving, competitions, contests, tests, or exhibitions; increasing the criminal penalties and fines for any such violations; providing penalties for knowingly impeding, obstructing, or interfering with an authorized emergency vehicle that is on call and responding to an emergency while a person is participating in a drag race, street takeover, stunt driving, competition, contest, test, or exhibition, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Transportation; and the Committee on Rules reports the committee substitute favorably

CS/CS/SB 994 (SO) by the Appropriations Committee on Transportation, Tourism, and Economic Development, the Committee on Transportation and Senator Burgess—

Student Transportation Safety; Revising requirements for signage posted on the rear of a school bus indicating the use of a school bus infraction detection system; requiring a law enforcement agency to send a notice of violation to the registered owner involved in a violation within a specified timeframe after receiving certain information; prohibiting the use of school bus infraction detection systems for remote surveillance; requiring that certain civil penalties be remitted to a participating school district operating a school bus with a school bus infraction detection system to be used for certain purposes, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Appropriations Committee on Transportation, Tourism, and Economic Development; and the Committee on Fiscal Policy reports the committee substitute favorably

CS/CS/SB 962 (SO) by the Committees on Rules, Health Policy and Senator Hooper—

Student Health; Revising a provision to authorize asthmatic students to carry a short-acting bronchodilator, rather than a metered dose inhaler; authorizing licensed pharmacists to dispense short-acting bronchodilators and components in the name of a public school; requiring certain public schools to adopt a protocol developed by a licensed physician for the administration of a short-acting bronchodilator and components by school personnel; authorizing certain students to carry a short-acting bronchodilator at school under certain conditions, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Education Pre-K -12; reported favorably as a committee substitute by the Committee on Health Policy; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 883, 1st Eng.(HC) in the Committee on Rules

CS/CS/CS/SB 868 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Transportation, Tourism, and Economic Development, the Committee on Transportation, Senator Boyd and others—

Transportation Facility Designations; Providing honorary designations of certain transportation facilities in specified counties; directing the Department of Transportation to erect suitable markers; redesignating a specified bridge in St. Lucie County as the "E.C. Summerlin Family Bridge", etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Appropriations Committee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/CS/HB 389, 1st Eng.(HC) in the Committee on Fiscal Policy

CS/CS/SB 850 (SO) by the Committees on Rules, Ethics and Elections and Senator DiCeglie—

Use of Artificial Intelligence in Political Advertising; Requiring that certain political advertisements, electioneering communications, or other miscellaneous advertisements include a specified disclaimer; specifying requirements for the disclaimer; providing for civil and criminal penalties; authorizing the filing of complaints regarding violations with the Florida Elections Commission, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Ethics and Elections; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/HB 919(HC) in the Committee on Rules

CS/CS/SB 804 (SO) by the Committee on Rules, the Appropriations Committee on Agriculture, Environment, and General Government and Senator Hutson—

Gaming Licenses and Permits; Authorizing the Florida Gaming Control Commission to deny an application for licensure of, or suspend or revoke the license of, any person who falsely swears under oath or affirmation to certain material statements on his or her application for a license; providing that such persons are subject to other applicable penalties; requiring applicants for licenses and licensees to notify the commission of certain contact information and of any change in such contact information and providing penalties for failure to comply; revising the timeframe during which a permit holder is required to annually file an application for an operating license for a pari-mutuel facility during the next state fiscal year; authorizing a licensed horse track to receive broadcasts of horse races conducted at horse racetracks outside this state if certain conditions are met, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect July 1, 2024

CS/CS/SB 774 (SO) by the Committees on Rules, Community Affairs and Senator Perry—

Towing and Storage; Requiring certain counties and authorizing certain municipalities to establish maximum rates for cleanup and disposal of hazardous and nonhazardous materials under certain circumstances; prohibiting the division from excluding certain wrecker operators from the wrecker operator system or failing to designate certain wrecker operators as authorized wrecker operators; authorizing towing-storage operators to charge certain fees, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Transportation; reported favorably as a committee substitute by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 179, 1st Eng.(HC) in the Committee on Rules

CS/SB 754 (SO) by the Committee on Transportation and Senator DiCeglie—

Regulation of Commercial Motor Vehicles; Revising federal regulations to which owners and operators of certain commercial motor vehicles are subject; charging the Department of Highway Safety and Motor Vehicles with the administration and enforcement of certain federal regulations; prohibiting the department from issuing a commercial motor vehicle license to a person who is ineligible under certain federal regulations; applying a reinstatement service fee to a person whose privilege to operate a commercial vehicle has been downgraded, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Transportation; the Appropriations Committee on Transportation, Tourism, and Economic Development reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

CS/SB 742 (SO) by the Committee on Community Affairs and Senator Grall—

Public Works Projects; Revising the definition of the term “public works project”; revising applicability of a provision that prohibits the state or a political subdivision that contracts for a public works project from taking certain actions under specified circumstances, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Community Affairs; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

Identical to CS/HB 705, 1st Eng.(HC) in the Committee on Rules

CS/CS/SB 736 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Transportation, Tourism, and Economic Development and Senator Trumbull—

Services Provided by the Department of Highway Safety and Motor Vehicles or Its Agents; Providing that a certain affidavit establishes a presumption of ownership and right of possession to a motor vehicle or mobile home when the previous owner of the motor vehicle or mobile home died testate; prohibiting the department or a tax collector from charging a fee for reissuance of certain certificates of title; authorizing certain disabled veterans to be issued a military license plate or specialty license plate in lieu of a “DV” license plate; authorizing the department to design, issue, and regulate the use of temporary tags when the existing owner of a vehicle has submitted an application to transfer a valid out-of-state title that is subject to a lien, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2024

Reported favorably by the Committee on Transportation; reported favorably as a committee substitute by the Appropriations Committee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/SB 720 (SO) by the Committee on Judiciary and Senator Hutson—

Asbestos and Silica Claims; Revising the information required to be included in a sworn information form for asbestos or silica claims filed after a specified date; specifying that such a form is inadmissible in evidence, and may not be relied upon by a witness, at trial; requiring courts to dismiss certain claims upon a motion by a defendant, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably
